SUBJECT: HB 1445 – RELATING TO HOMELESSNESS

Hearing: Friday, February 10, 2017, 9:30 a.m. Conference Room 329, State Capitol

POSITION: The Governor's Coordinator on Homelessness appreciates the intent of this measure, as it addresses key aspects of the State's work to end homelessness, and offers the following comments.

<u>PURPOSE</u>: The purpose of the bill is to require any Continuum of Care (CoC) to provide a stipend to volunteers assisting in the point-in-time count that is mandated by the U.S. Department of Housing and Urban Development.

The Coordinator notes that the CoCs are largely volunteer organizations with few or no paid staff. While the CoCs may have oversight over federal funds to address homelessness, the use of these funds is often restricted to a specific purpose. The bill, as currently drafted, does not include an appropriation for the volunteer stipend, and CoCs.

Thank you for the opportunity to testify on this bill.

Hearing: February 10, 2017, 9:30 a.m. Conference Room 329, State Capitol

DEPARTMENT'S POSITION: The Department of Human Services (DHS) appreciates the intent of this bill and offers the following comments.

PURPOSE: The purpose of the bill is to require any Continuum of Care (CoC) to provide a stipend to volunteers assisting in the U.S. Department of Housing and Urban Development's (HUD) mandated Point in Time Count (PIT).

The CoCs are primarily volunteer organizations with few or no paid staff. For the PIT the CoCs rely heavily on the member agencies. Many of these member agencies provide staff work time to go out and conduct the PIT.

It is also unclear how this measure intends to fund the stipends. Would the CoCs be responsible for funding the stipend? If so, it should be noted, that the CoCs have some oversight over a small amount of federal funds. These federal funds are restricted to very specific uses. Uses of these funds in unauthorized manner such as providing stipends could mean the agency has to return the money to HUD. DHS defers to the CoCs regarding use of these funds.
