DEPARTMENT'S POSITION: The Department of Human Services (DHS) appreciates the opportunity to testify and provides comments.

<u>PURPOSE</u>: The purpose of the bill is to create and establish various policies to adequately address the various issues concerning the elderly and disabled and the community healthcare industry while ensuring consumer protection for Hawaii's elderly and disabled.

DHS defers to the Department of Health (DOH) regarding all the licensing and reporting sections of the bill. DHS will comment on the rate suggestions and the policy changes for the community care foster homes.

We appreciate the policy goals to increase the availability of affordable long term care options for all. However, to clarify that Community Care Foster Homes (CCFH) were initially developed for Medicaid members because there were not other non-institutional options for their care. As changes to the CCFH program are proposed, it is our interest that continued access by Medicaid recipients be maintained now and into the future. Thus, while DOH is given discretion to allow more than two private-pay individuals in a CCFH under certain circumstances, DHS would seek to add additional protections to ensure that all Medicaid members in need of long term care and services would have access, such as a private pay member would not displace a Medicaid member, or that the CCFH has had a vacancy for more than six months without a Medicaid member looking for placement. Without those kinds of explicit conditions, we would remain concerned about access to the CCFHs in the long term for Medicaid beneficiaries.

The bill also includes increases in compensation for caregivers and case managers. We would like to clarify that DHS Med-QUEST Division contracts with health plans that contract and pay for home and community based services provided by CCFHs and adult residential homes. Additionally, if increases in reimbursement rates were included, DHS would need to seek approval of the increases from the Centers of Medicare and Medicaid Services, the federal regulatory agency for state Medicaid programs. Also, a general funds appropriation would be needed to be able to pay the higher rates.

SUBJECT: HB 1510 - Relating to Health

The State Council on Developmental Disabilities (DD) appreciates the intent of HB1510 and offers comments and/or proposed amendments specific to the appropriate sections of the bill. The purpose of the bill is to create and establish various policies to adequately address the various issues concerning the elderly and disabled and the community healthcare industry while ensuring consumer protection for Hawaii's elderly and disabled.

Comments and/or Proposed Amendments:

- 1. Page 2, SECTION 2 and Page 3, SECTION 3. It is not clear on what is "any community-based care home" in addition to adult residential care home and expanded adult residential care home.
 - A. Are adult foster homes for individuals with DD, DD Domiciliary homes, and community care family foster homes included in "any community-based care home"?
 - B. The reference to "day care center" is not consistent with the reference of "adult day care center" on Page 4, line 7.

Recommendations:

- 1. Define "any community-based care home."
- 2. Clarify day care center or adult day care center throughout the bill.

- 2. Page 4, SECTION 4. The terms, "community-based foster family home and adult foster home" need clarification.
 - A. Are community care family foster homes the same as community-based care home? If so, we recommend the term be reference throughout the bill.
 - B. Is adult foster home for individuals with developmental or intellectual disabilities (D/ID)? If so, we recommend to clarify reference to these homes as Adult Foster Homes as defined in section 321.11.2.
 - C. If Adult Foster Homes are to be included, then we recommend to add "<u>or</u> <u>certification</u>" on line 8 to read, "without a license <u>or a certification</u> shall be guilty of a misdemeanor."
- 3. Page 5, SECTION 7. The Council conveys its concern that "Adult Foster Homes for individuals with D/ID) are included in the list of state-licensed facilities. Adult foster homes for individuals with D/ID are certified and monitored under the Hawaii Administrative Rules, Title 11 Department of Health, Chapter 148 Certification of Adult Foster Homes. This chapter is based substantially upon Chapter 890, "Certification of Foster Family Boarding Home for Children," Public Welfare Division, Department of Social Services and Housing. [Eff. 9/16/54; am 3/20/87]. Basically, the AFHs were intended to be exactly as a Child's Foster Home which the individual lives with a family, in the family's home, in a family environment. AFHs are not facilities, and they were not intended to be a business. They should not be categorized with such businesses because they ARE NOT a State-licensed care facility. Therefore, AFHs should not be included in the list.

However, should the Legislature decide to include AFHs for individuals with D/ID to be subjected to a misdemeanor if they intentionally operate an AFH, we propose the following amendments for your consideration:

- 1. Page 4, line 8: add "<u>or a certification</u>" on line 8 to read, "without a license <u>or a</u> <u>certification</u> shall be guilty of a misdemeanor."
- Page 5, line 12: Add "<u>or state-certified adult foster homes</u>" after "statelicensed care facilities" to read, "state-licensed care facilities <u>or state-certified</u> <u>adult foster homes</u>."
- 3. Page 5, line 16: Replace Developmentally disabled adult foster homes with, "adult foster homes as defined in section 321-11.2"
- 4. Page 6, line 20-21: Add "<u>or state-certified adult foster home</u>" after "statelicensed care facility" to read, "state-licensed care facility <u>or state-certified</u> <u>adult foster home</u>."

- 5. Page 7, lines 5-6: Add "<u>or state-certified adult foster homes</u>" after "statelicensed care facilities" to read, "state-licensed care facilities <u>or state-certified</u> <u>adult foster homes</u>."
- Page 7, line 11: Add "or state-certified adult foster homes" after "statelicensed care facilities" to read, "state-licensed care facilities or state-certified adult foster homes."
- 7. Page 7, lines 13-14: Add "<u>or state-certified adult foster homes</u>" after "statelicensed care facilities" to read, "state-licensed care facilities <u>or state-certified</u> <u>adult foster homes</u>."
- Pages 8-10, SECTIONS 10 and 11. The Council does not support these sections that address the collection of fees for license, relicense, certification and recertification. We recognize the value and importance of the various residential options (Adult Residential Care Homes, Expanded Adult Residential Care Homes, Adult Foster Homes, and Developmental Disabilities Domiciliary Homes) that are currently available for individuals with DD.

The development of Adult Foster Homes and DD Domiciliary Homes for this population was supported by the State to support individuals to transition from an institution into the community as well as to prevent the placement of individuals with DD into Skilled Nursing Facilities because of no other options available to them. The majority of these residential settings are not for profit facilities, who are not salaried employees, but family homes with a family business. The Council is greatly concerned that fees imposed for these homes may have a negative consequence of homes not seeking license, relicense, certification or recertification, thus reducing residential options.

9. Page 18 lines 12-14 and lines 19-21: Based on the language to compensate caregivers and case managers for DD Domiciliary Homes and DD Adult Foster Homes, it appears there is an assumption that the Department of Health or the Department of Human Services pay caregivers directly for care they provide through Medicaid Services. This is not the case, as there are individuals with Developmental Disabilities (DD) who reside in DD Domiciliary Homes or DD Adult Foster Homes do NOT receive any Medicaid Services. DD Domiciliary Homes are operated through a State contract with private, non-profit agencies, and Adult Foster Homes are operated by a family. Case managers for individuals with DD who are receiving services from DD Division, Department of Health are State employees. It would be not be appropriate for them to be compensated as indicated in the language of this section.

> 10. Page 19 lines 20-21 and page 20 lines 3-4: DD Domiciliary Homes and Adult Foster Homes should not be considered as Community health care facilities. These homes for individuals with DD are not a part of the community heath care facilities and they do not have private case management. Case management is provided by case managers who are employed by the State through Department of Health DD Division.

Part V: S321-1-7 Compensation for Caregivers

I strongly support Compensation for caregivers, for at least 3% per year. These caregivers works very hard to assure health and safety of individuals placed on their care. They take pride and joy taking care of the population they served. Particularly the CCFFH, EARCH who are taking care of Hospice / ICF Medicaid clients. They get paid between \$950 - \$1245.00 a month for a 24 hour job, not counting the room and board. With the rising cost of food, water, electricity etc. they barely making it. I strongly recommend that the law makers, Medquest Division as well as the HMO's will evaluate the fee and give them the raise they deserve.

Part V: S321-8 Compensation for case management Agencies

I strongly support this bill. As a Case Manager and an owner of a licensed Case Management Agency, I / We struggle daily to make ends meet. All the Case Management Agencies had a reduction of fee last 2008 by approx. 8-10%. Eight (8) years after, there's no raise at all. The amount of work that we do quadrupled or even more. With the increase of HMO's, we have to go through 6 audits annually including CTA. The Medicad process is getting more challenging to navigate. There is a delayed payment of 3-6 months, problems with costshare, Medicaid eligibility of members erroneously terminated for no reason, conversion of regular Medicaid into a long Term Care Medicaid. The demands of each HMO / Medquest in submission of so many documents is overwhelming. This are just few of the many difficulties we face on a daily basis. We do more paper works now than spending time with our clients, whom they are the reason why we are here. I urge all the lawmakers, HMO and Medquest division, to please carefully evaluate the need to increase our fee at least 3% per year.

Dear Chairs Morikawa and Belatti, and Members of the Committees:

We support HB1510 and offer the following comments.

Reimbursement/Compensation (Section 17). We strongly support adjusting the reimbursement/ compensation rates for Medicaid clients. We have not received an adjustment in almost 10 years. Costs to care for our clients have continued to rise with no corresponding adjustment. We provide the State a valuable service, as we are able to accept clients at a fraction of what other facilities charge. We are one of the only programs where we are required to accept Medicaid clients. Other facilities and homes are not required to accept Medicaid clients. Please kindly consider the requested adjustment so we can encourage others to welcome clients into their home. Otherwise, the State will be caught unprepared as the population ages and more and more need 24/7 care.

Fees (Section 10). We understand the State incurs fees in licensing our homes. However, please set the fees according to the number of beds licensed instead of a flat fee. Please also keep fees reasonable (not more than \$100 per year) and strongly consider granting us an increase in the reimbursement rates, which have not increased for many years.

Private-Pay Clients (Section 14). The foster home program, along with the other long-term care programs, have sufficient space for Medicaid clients, but the inflexible rule of having only one private-pay client is often detrimental to non-Medicaid clients. Clients who are separated from their own family often suffer severe trauma and depression. Outcomes would improve if they were able to live with their own family members like their spouse.

Online Posting of Vacancies. We support the creation of an online forum by DOH where all statelicensed care facilities may post vacancy information to facilitate placement of clients in need. This forum would make it easier for families and those in need to find the appropriate home that best suits their needs.

Penalty for Unlicensed Activity. We support broadening the scope of unlicensed activity to include any person who operates a community-based foster family home without a license. We are proud to provide a high level of professional care. Clients deserve the highest level of care, which can only be ensured if a provider is licensed. More and more are starting to operate unlicensed homes because of the strong demand. The State must do everything it can to protect those unable to help themselves.

For these reasons, we **support** HB1510.

The Arc in Hawaii opposes moving House Bill 1510 and, in particular, STRONGLY OPPOSES the following provisions of House Bill 1510

Part III, SECTION 10, pages 8-9 which imposes licensing fees upon certain vital and underfunded "facilities" that serve Hawaii's most vulnerable and needy citizens, including developmental disabilities domiciliary homes .

The Arc in Hawaii operates 10 very small, non-profit developmental disabilities domiciliary homes on Oahu. The fees will only add to an intolerable financial burden under which these homes labor.

These homes, and others operated by other non-profit agencies and dedicated individuals and families, serve only low-income persons with disabilities. They are primarily funded by the residents themselves, using their meager personal income from federal SSI and a State Supplement to SSI under Hawaii Revised Statutes §346-53 (c). The State Supplement has not been increased since 2008 and the administration and legislature have repeatedly shot down proposals to increase the amount to at least help with cost inflation.

Operating costs constantly increase, but compensation rates do not keep pace. Heaping another cost on the operators creates a dangerous situation. These targeted "facilities" are vital elements in the State's care of disabled and aged citizens. Most of the "facilities" are better described as "homes"- they are not large institutions that can absorb the cost or spread them over numerous clients. Most are operated by individuals, families, or, as in our case, struggling nonprofits.

The operators of developmental disabilities domiciliary homes and adult foster homes for developmentally disabled individuals were created and funded to help close down the Waimano Home institution, and are the first line of defense against requiring such a restrictive and costly large facility again

Adding unnecessary costs to small home providers' current burden may finally tip the scale and cause closure of these "anti—facilities" and the loss of shelter and sustenance by those who need them so badly.

Part V, SECTION 17, pages 18-19, which literally imposes maximum compensation payable to caregivers in certain facilities, including developmental disabilities domiciliary homes .

The language of Part V states that caregivers would be compensated "Not more than" an unstated amount per annum, thus imposing a cap on the amount that employers may pay caregiver employees. This is inconsistent with the stated purpose to "ensure caregivers are fairly compensated."

We see no need to handicap providers of residential services in this way. There has been no showing that caregivers are paid "too much" in Hawaii – quite the opposite. Service providers must have the tools to compete in tight labor markets, and a cap on salary serves no purpose. On this basis, we oppose proposed Part V as written.

However, we suspect that the drafter meant for the Bill to set <u>minimum</u> compensation levels, sort of a specialized minimum wage for caregivers. If that is the case, our opposition is even stronger. Unless the legislatively-dictated minimum rate were set at a level lower than we now pay our staff, imposition of the minimum rate would be a severe financial burden on our already stressed financial. This provision would be acceptable to us ONLY if the statute also mandated that the state would compensate all providers for the extra burden imposed upon them.

Please delete Parts III and V from the Bill if you are inclined to move HB 1510 forward..

I oppose moving House Bill 1510, most especially the following of its provisions:

Part III, SECTION 10, pages 8-9 which imposes licensing fees upon certain vital and underfunded "facilities" that serve Hawaii's most vulnerable and needy citizens, including developmental disabilities domiciliary homes.

I am Director of Development and a donor to The Arc in Hawaii. In both roles I am acutely aware of the everincreasing financial challenges our organization faces in providing residential services in the 10 small, communitybased homes we operate across Oahu for our participants. Asking The Arc and other non-profit agencies, individuals and families to pay licensing fees, on top of the significant burdens we already bear, endangers our ability to serve this historically under-served population.

Coincident with the closure of the state institution, The Arc in Hawaii and others stepped forward to provide homes for individuals with intellectual and/or developmental disabilities: homes within the community, homes where stable relationships could be built and sustained, homes designed around each participant's interests, capabilities and needs. They operate exceptionally well with extremely limited funding. Please do not jeopardize our and others' ability to continue our mission of service and support.

Part V, SECTION 17, pages 18-19, which literally imposes maximum compensation payable to caregivers in certain facilities, including developmental disabilities domiciliary homes.

Whether the language of Part V is intended to impose maximum compensation or its actual intent is the opposite, to impose minimum compensation, it's the wrong approach. Either way (without compensating us for additional costs) the state would be tying our hands and denying us the very flexibility we need to meet our ongoing financial challenges.

I urge you not to move House Bill 1510, particularly the portions I have commented on in detail.

Aloha Chairman and the Committee members, my name is **<u>Elma V.</u>** <u>**Tierra**</u>. I am a Community Care Foster Family Home operator. I am in support of the **HB1510** but with comments on the various sections of the bill.

- 1. I strongly support that all Adult residential care homes, community-based care homes, day care centers shall be licensed to ensure the health, safety, and welfare of the individuals placed therein.
- 2. Unannounced visit doesn't ensure the health, safety, and welfare of our elderly & disabled elderly population. But I totally welcome the people who will conduct the inspection for relicensing or recertification.
- 3. I strongly support that all operator of any community-care home providing healthcare to the elderly or disabled who are un-related to the caregiver family shall be licensed to ensure the health, safety, and welfare of the individuals placed therein.
- 4. Starting January 2015 the department of Health post deficiencies of all the annual inspections on its website. Aside from posting, the bill also requires the department to maintain a forum on the website allowing the care facilities operators to post vacancy, and to inform the public for a prospective home for their loved ones.
- 5. The Office of Health Care Assurance has been persistent for the last 4-5 years, pushing this issue of collecting licensing and re-licensing fees from the care facilities. There are caregivers who take care of Medicaid beneficiaries, they are not compensated enough by the State. It is unreasonable, however, to levy fees on them. I believe \$25-50 is a reasonable fee across the board.
- 6. I strongly support relating two private pay individuals as long as they are couples living together, married, or in a civil union. They shouldn't be restricted in living under the same roof.

HB 1510 RELATING TO HEALTH

Chair Morikawa, Vice Chair Todd, and members of the House Committee on Human Services, and, Chair Belatti, Vice Chair Kobayashi, and members of the House Committee on Health, thank you for this opportunity to provide testimony in strong support for HB1510, Relating to Health.

I am a family nurse practitioner, practicing in Honolulu for the past 20 years. I have been involved in evaluating cases where the elderly disabled have allegedly been neglected or abused in community-based facilities.

It is widely known that there are many, many unlicensed and unregulated care facilities for the elderly in our community. The fact is that elderly persons are placed in homes with lay (not professional) caregivers willing to care for them for remuneration, when family cannot or is not willing to provide on-going care to the aged. The professional research literature strongly indicates that the elderly and disabled are at escalating risk for abuse and neglect as they become more and more dependent on others for their care. We must strive to regulate this industry to mandate accountability for the quality and safety of care being provided to our kupuna. I believe this bill, in expanding the requirement for licensure with the Department of Health, and therefore regulation by the Department, to include community-based foster family homes and adult foster homes, is another step in the right direction.

I respectfully request that HB 1510 pass out of these committees. Thank you for your continued support of the healthcare of our elderly and disabled in Hawai'i, and for the time and consideration of this bill.

My name is Ramon Sumibcay. I am a Care Home Operator in Makakilo. I am in strong SUPPORT to this OMNIBUS Bill for good reasons:

1. There have been allegations that care facilities have been operating without license from the Office of Health Care Assurance (OHCA) or foster homes not certified by the Department of Human Services. HRS 321-15.62 clearly states the requirement of a license to ensure the safety and welfare of seniors placed in home-based care facilities. Also, HRS 321-15.7 states the penalty when engaging in an unlicensed activity providing care to our vulnerable population.

2. The Silver Tsunami is coming. Studies show that Hawaii has the highest population growth rate among the 85+ population. In the next 10 years, there will be close to 300,000 65+ seniors. We need to be prepared to make sure there are enough beds for placement. Currently, HRS 321-15.62 allows for two skilled nursing level residents in an expanded adult residential care home. The statute allows for a third resident but with the discretion of OHCA. With the rapid growth of 85+ seniors and requiring skilled nursing level of care, we need to eliminate the bureaucratic red tape for the third resident. Also, studies show that one of two 85+ seniors will be diagnosed with dementia. Caring for demented 85+ seniors requires many nursing hours due to frequent and close monitoring.

3. Regarding the 2-private pay individuals in a family foster home, we need to consider providing exemption to couples who are married or in a civil union status. They are not that many in numbers, and they are in the twilight years of their lives. We just need to be more compassionate to have the regulations waived in their behalf.

With the cost of living and other expenses rising it has been difficult to keep my care home open and functioning on a sustainable level. I love my work and I really feel that our elderly need proper care but without proper compensation it will be difficult to keep my care home open. Being a caregiver is a very rewarding job, I would like to be cared for in this manner when I get to that age but if caregivers aren't given the respect and appreciation deserved then you will see a lot giving up their homes or finding other means to increase their monthly income.

I have done my due diligence in caring for my clients, meeting all requirements and keeping up with all necessary certifications and truly believe that caregivers like me deserve an increase in monthly reimbursement rates. Large facilities collect a lot more than home caregivers but yet the care for the elderly is not as family oriented. The clients in care homes like mine are given much more attention and love than in larger facilities and I have been told this by family members of my clients and have seen it when my mother in law was in a large care home facility.

I am the sole caregiver, 24/7 and if you ratio that versus our monthly income it doesn't amount to what I am worth to my patients. I fully support the intent of HB 1510 in particular to the Adult Mental Health Division, E-ARCH Care Providers, as us caregivers and case managers are always frequently paid late. As a caregiver myself, I know how hard it is to work with our residents, but I am not complaining because that is what I chose to do as a career in life. But it is so disheartening when you are already working hard, and yet we still have to struggle with our pay from the state because it is always late, and I'm not just talking for days, we have to wait for months to get paid. Some of us in AMHD providers did not get paid for 6 months or more. We do not have much money in our savings to pay for our mortgage, and mortgage is not all that we have to pay. We have to feed our residents, pay our utilities, our gas to bring them to the doctor's appointment.

And, when we are behind our mortgage payment the bank charges us interest and penalties by the thousands. If that happens, late payment and interest should be added to any delinquent or late payment from the state.

We are asking the legislators to please look into this matter, as we would like to be paid on time like everyone else that works for the state.
