Chair Luke and Members of the House Finance Committee,

We are Max Sword and Mona Wood-Sword, writing in strong support of HB534, HD1, which will appropriate funds for the Hawaii Public Housing Authority ("HPHA") to hire an additional security guard to improve security and monitoring at the Alu Street gate of the Kalihi Valley Homes ("KVH").

We reside in the Wilson Tract community and can personally attest to the recent rise in criminal activity in our neighborhood perpetrated by individuals who reside in, or are affiliated with residents of, Kalihi Valley Homes.

Over the past couple of years, we have seen a large portion of our street parking taken by KVH residents, or their associates. While it is legal for them to park on our public street, this has brought a higher rate of crime into our neighborhood, including theft, rampant littering, excessive noise during the night, public intoxication, public defecation and urination, illegal parking, and threatening behavior towards residents.

We have learned that there is ample parking for all residents and their guests at KVH, and many residents who park on our street have the KVH resident permit on their dashboards. However, stricter rules set by the HPHA, approximately two years ago, require the driver to present his/her driver's license and car registration, insurance and current safety check before parking at KVH. As many of these vehicles do not have current paperwork, the drivers have chosen to park in our neighborhood and, as mentioned above, our once quiet, friendly neighborhood turned into "The Nightmare on Wilson Street."

We believe a security guard on duty at the key point of exit and entry to Wilson Tract, at Alu Street, is a strategic and necessary move to curtail the criminal activities mentioned above.

We kindly urge the House Finance Committee to pass HB534, HD1.

My name is Warren Young, I am a 58 year owner-resident of Wilson Tract which is located across Likelike Highway from Kalihi Valley Homes public housing. I am in support of HB534, HD1 in order to provide more security for the residents of Kalihi Valley Homes and Wilson Tract. For several years now the problems for me and my fellow residents are the increase in crime, loitering, graffiti, littering, and reduction of street parking availability for our residents and guests. This is due to residents and visitors to Kalihi Valley Homes now coming into Wilson Tract to park their vehicles daily and for extended periods, or pick-up/drop-off family and friends, or meet their visitors to talk story and drink in front of our homes, and leave their trash on the street and sidewalk.

The solution to this problem is to reopen the Kalihi Valley Homes Alu Street entry/exit access to and from Likelike Highway, and to re-staff the guard station at this entry/exit point to monitor residents and their visitors. The state DOT would have to modify the traffic signal at Likelike Highway and Alu Street so the mauka bound left turn lane into the public housing can be functional again. If you make it convenient for the public housing residents and their visitors to park at their homes, perhaps Wilson Tract residents can again have the peace and quiet we once had for paying our state and property taxes.
