<u>**DEPARTMENT'S POSITION**</u>: The Department of Human Services (DHS) supports the intent of the resolution and offers comments.

<u>PURPOSE</u>: The purpose of HCR 12 is to request the Department of Human Services to provide information regarding the cost of transitioning to a paperless or cost-free application process for the Preschool Open Doors (POD) program and to submit its findings and recommendations to the Legislature for the 2018 session.

Act 169, Session Laws of Hawaii (SLH) 2013, established the POD program as the statewide school readiness program. The POD program assists low and moderate income families who are least able to afford preschool and provide their children with the opportunity to be ready for kindergarten by providing child care subsidies for preschool costs.

Since the 2015-2016 POD year, the current POD contractor, People Attentive to Children (PATCH), has accepted faxed and emailed applications submitted to the POD office on Oahu. Furthermore, PATCH has offices on the islands of Kauai and Maui and has 2 offices on Hawaii. All of the Neighbor Island PATCH offices have assisted families in submitting the POD applications to the Oahu POD office, via fax, if the families go to the PATCH offices on those

islands. The POD program will continue to accept applications submitted through electronic means (e.g. fax or email).

As to an on-line application process, DHS is continuing to develop and design the DHS Enterprise system to update the Department's 30 year old legacy data systems. The Med-QUEST division's KOLEA eligibility application for medical insurance coverage was the first to provide on-line eligibility and determination capabilities as required by the Affordable Care Act.

DHS is currently in the procurement process to add additional functionality to the DHS Enterprise system for the financial assistance programs, Supplemental Nutrition Assistance Program (SNAP) benefits, and Child Welfare Services and Adult Protective and Care Services' systems.

To assure that DHS programs are aligned, DHS is using a multi-generational approach to realign its programs. The 'Ohana Nui framework involves streamlining existing programs and funding to improve efficiencies and outcomes to achieve the greatest return on investment. Once programs are aligned through 'Ohana Nui and the DHS Enterprise system is built, nearly all of DHS programs will be interoperable. The development of multi-generational and interoperable programs through 'Ohana Nui, and improvements to the IT operating system are essential for DHS to move toward a single on-line application for all DHS programs, including medical, financial, SNAP, and child care subsidies, including POD subsidies.

The DHS Enterprise initiative is the Department's priority, with targeted completion date of the end of 2018, to leverage currently available funding from the federal Centers of Medicare and Medicaid Services (CMS). DHS asks for the Legislature's continued commitment and support for the development and maintenance of the DHS Enterprise system. Cost to develop, implement, secure and maintain the DHS Enterprise system are significant, however, at this time providing the cost for a single on-line application process for POD is not available.

In addition to costs associated with the DHS Enterprise system, DHS Child Care Program Office (CCPO) would require additional staffing and resources to address the changes this resolution proposes.

The priority of the CCPO is to bring the state into compliance with changes in federal law. In addition to state funded POD, Hawaii receives \$22 million annually in Child Care and Development Fund (CCDF) grants from the U.S. Department of Health & Human

Services, Administration for Children and Families, Office of Child Care. The CCDF grant funds provides for Hawaii's child care licensing, quality initiatives, and federally funded child care subsidy programs.

On November 19, 2014, President Obama signed the Child Care and Development Block Grant (CCDBG) Act of 2014, Public Law 113-186, reauthorizing the CCDF. The CCDBG Act made significant changes to the health and safety requirements for child care providers and made public access to information a priority. Final regulatory changes, 45 Code of Federal Regulations (CFR) Part 98, were issued September 30, 2016 and became effective on November 29, 2016. While certain deadlines are imminent, the deadline for DHS to complete all of the required changes is September 30, 2018. DHS is focused on complying with these federal law and regulatory changes to preserve Hawaii's access to the federal CCDF grant funds.

Dear Representative Morikawa, Representative Todd and Committee Members:

Thank you for the opportunity to provide testimony on behalf of Hawaii's Early Childhood Action Strategy, a public private collaborative that recognizes the strength of communities and works across sectors to increase the number of young children in Hawaii who are born healthy, developing on track, ready for school when they enter kindergarten, and proficient learners by third grade.

Action Strategy supports HCR7 which urges the Department of Human Services to examine the application process for the Preschool Open Doors program and explore transitioning to a paperless or cost-free application process. The Preschool Open Doors program is a critical support program for some of our state's neediest families. Ensuring an equitable and easy application process is an important step in having this program support those who need it most. When families are struggling to meet their children's basic needs, an application process that is difficult to navigate or requires printing or postage can pose an insurmountable barrier to accessing critical support services.

The Preschool Open Doors program, started in 1990, is essential to supporting Hawaii's families with young children. The average cost of child care in Hawaii is approximately \$8,040 per year. For

most families, child care is their second highest expense after paying for housing. The POD subsidy allows families with low and low-moderate incomes to afford a high quality early learning setting for their children and increases the possibility that parents can work or pursue higher education or training. Access to stimulating, safe child care would not be possible for these families without POD subsidies.

High Quality Early Learning Programs are a critical component of Hawaii's early childhood system because high quality early learning programs:

- support parents and families in nurturing their children
- help track children's development and recommend when screening should occur for developmental delays or developmental differences
- help parents and children benefit from interventions that follow developmental screenings
- help families identify needed community resources
- allow parents to work or pursue their education
- promote the social and emotional development of young children
- prepare children to enter school as kindergarteners.

Action Strategy is committed to ensuring Hawaii's young children are healthy, safe and ready to learn and HBCR7 supports that vision. Please feel free to contact me for additional information. I can be reached at 808-214-9336 or karen@clnhawaii.org.
