Comments: The Hawaii Rifle Association does not support the current language in this bill. HOWEVER: With some minor changes in the language of the bill we can be in full support. We feel that allowing individuals to register their firearms without fear of penalty for late registration is a good thing and should be supported by law enforcement to draw forward those guns that should have been registered but for a myriad of reasons were not. The language changes that we suggest are as follows: We are concerned that stating that the duty to register a firearm is an "ongoing one" could create confusion, implying that firearms need to be re-registered in the future. This can be clarified by striking the following language contained in 134-3 (A) and (B). "provided the duty to register the firearm shall be on ongoing one" and keeping the remaining language, it is clear that a failure to register a firearm within the specified time period does not relieve the duty to register thereafter.
