- EOA's Position: The Executive Office on Aging (EOA), an attached agency to the Department
- 2 of Health, supports this measure, provided that its enactment does not reduce or replace priorities
- 3 within the Administration's executive biennium budget.
- 4 **Fiscal Implications:** This measure appropriates a blank amount of funding for the Aging and
- 5 Disability Resource Center (ADRC) for SFY 2020 and SFY 2021.
- 6 **Purpose and Justification:** EOA notes that the appropriation is a priority of the Ige
- 7 Administration. Governor Ige's budget request proposes \$3,100,000 for EOA's base budget for
- 8 the ADRC FOR SFY2020 and \$3,100,000 for SFY 2021. The ADRC assists individuals and
- 9 their families to identify their long-term services and support needs based upon a person-
- 10 centered process, understand their service options which include publicly funded services such as
- 11 Kupuna Care and the Kupuna Caregivers, and assist in developing and implementing
- comprehensive support plans. These funds will help to sustain the capacity for EOA and the four

- 1 county-based Area Agencies on Aging to operate as a statewide, fully functional ADRC. During
- 2 SFY 2017, a total of 35,007 calls were made to the ADRC statewide, a 30% increase in call
- 3 volume from SFY 2016. The ADRC linked 11,039 older adults to federal and State publicly
- 4 funded long term services and supports, a 35% increase over SFY 2016.
- 5 **Recommendation:** EOA supports \$3,100,000 for SFY 2020 and \$3,100,000 for SFY 2021 in
- 6 the base budget for ADRC and humbly requests advancing this measure, provided that its
- 7 enactment does not reduce or replace priorities within the Administration's executive biennium
- 8 budget.

The State Council on Developmental Disabilities **SUPPORTS HB0466 HD1.** The purpose of the bill is to appropriate funds to the Department of Health for the Aging and Disability Resource Center. (ADRC).

The Council was a member of the State ADRC Advisory Board in April 2006 assisting the Executive Office on Aging (EOA) with receiving a Federal grant to establish a one-stop single entry point for older adults and persons with disabilities. Since then, the project has established a one-stop center on the Islands of Hawai'i, Kaua'i, Maui, and is in the process of developing a Honolulu site. The Council has a Memorandum of Agreement with the Hawai'i County Office of Aging and ADRC, which defines the partner roles and responsibilities related to services provided by ADRC and the Council.

As a systems advocacy agency responsible for statewide planning, coordination, monitoring, evaluation, and advocacy on behalf of individuals with DD and their families, we support a streamlined and user-friendly process for older adults and individuals with disabilities to receive information and be able to navigate the service system to access services and supports. The Council, as well as individuals with disabilities, advocates, public and private service providers, need to be continually involved with the planning and implementation of the ADRCs. We believe identifying and engaging partnerships with all stakeholders will contribute to a seamless approach of accessing long-term services and supports in a manner that respects individual choice and desire, is person-centered, promotes independence and dignity, and provides individual control over the person's life.

The Zonta Club of Hilo supports the requested appropriation to fund fully the Kupuna Care, Aging and Disability Resource Centers Network, Kupuna Caregivers without the daily cap, Healthy Aging, and the Alzheimer's Disease and Related Dementias Coordinator. Zonta is an international organization of business and professional women whose mission is to advance the status of women and girls worldwide.

The Zonta Club **voted recently to support Kupuna Caucus bills relating to Aging,** including Kupuna Care, a "one-stop resource center" for aging and disability services (ADRC), Kupuna Caregivers Support, Alzheimer and Dementia Coordinator, and Healthy Aging. As an organization, we realize that aging issues disproportionately impact women for two main reasons; 1) greater social, medical and economic costs associated with longer life-expectancies for women; and 2) women still bear most of the responsibilities of elder caregiving. Many Zontians are "Baby Boomers" who understand the challenges of being an "elder."

To reduce economic and social costs facing the elders, disabled, and their caregivers, we need collaborative, comprehensive implementation of "best practices." The practices must include a government and community "support net" through adequate funding and user-friendly access.

The Kupuna Caucus funding proposals would reduce the overall societal and economic costs by allowing the elders to age-in-place, surrounded by social supports, and avoiding costly institutional care and caregivers' burnout.

The funding will be helpful for Hawaii County, which has the challenge of being the largest county with strained infrastructure. Our super-rurality makes any delivery of services for elders and disabled more challenging. We continue to have the unfortunate status of being the county with the most "challenging" economic and social negative social indicators, including inadequate public transportation and insufficient primary health care services. Hawaii County's growing elder and disabled population is outpacing the current resources. Over 21% of the population is over 60. The Kupuna Caucus funding bills give us hope.

MCOA's Position: Maui County Office on Aging (MCOA) is in strong support of HB 466, HD 1 MAKING AN APPROPRIATION FOR THE AGING AND DISABILITY RESOURCE CENTER.

Purpose and Justification: Since the inception of the Aging and Disability Resource Center (ADRC) services to the public in Maui County have been much more centralized. Within the last year, all four counties have gained status as fully functioning ADRCs. The use of standardized assessment and referral protocols has helped to ensure that services across the state occur in a much more uniform manner. Without the ADRC funding, staffing levels would be at such a level that individuals and family caregivers would face a much longer wait for initiation of much needed supports and services.

MCOA requests funding for the ADRC in the amount of \$3,100,000. Of utmost importance is that the funding is provided through the **base budget** of the Executive Office on Aging (EOA) for disbursement directly to the four counties on July 1, 2019. If the funding amount is separated with a portion in the base budget and a portion through

a supplemental bill, ADRCs could very well be forced to reduce appropriate levels of staffing on July 1, 2019.

Allowing for the full amount of funding appropriated for these vital services to be included in the EOA base budget ensures a more consistent contracting and service delivery system. When funding has been allocated fully by the State base budget, MCOA has been able to better plan for consistent service delivery throughout the year. Conversely, when funds are released at varying times throughout the year, the process of planning for steady service delivery to frail elders is more difficult. Area Agencies on Aging (AAAs) must wait for the release of funds not appropriated through the base budget for several months; therefore, service delivery cannot be planned in a reliable, steady manner. Knowing on July 1st of each year the exact amount of appropriation for these vital services will allow AAAs to more effectively plan for and meet the needs of eligible seniors.

Thank you for the opportunity to submit written testimony in STRONG SUPPORT appropriating funds ARDC. My name is Linda Dorset and I am a concerned aging resident and live in the Wailuku area. I want to once again emphasize the importance of this program. Maui already has this program and it has been very successful. This is where the frail elderly and disabled citizens can turn to get information on available and suitable services when they find themselves helpless and resourceless. Statistics show that the number of these people living in poverty has risen to 25%, the number unable to perform activities of daily living is 31%, and the number at risk for nutritional deficiency is 61%; more funding is needed to keep up.

ARDC also provides prevention and educational programs such as Healthy Aging and exercise programs. These programs are very popular and proven effective to allow the elderly to avoid living in nursing homes often at public expense. The Maui Executive on Aging recently stated to me that the goal of her agency is to help people avoid needing Medicaid.

I appreciate Senate leadership to fund these services for the aging and disabled; and are thankful this bill includes a clear appropriation in the amount \$3,100,000 for fiscal year 2019-2020 and also for 2020-2021 to ensure there will be a functional statewide aging and disability resource center network to serve as a single-entry point for access to public long-term support programs and benefits.
