The Office of Hawaiian Affairs (OHA) <u>SUPPORTS</u> SB1009 SD1, which seeks to ban the sale of flavored tobacco products. This bill would help protect Native Hawaiian adults and youth—who already exhibit high rates of tobacco product use and chronic disease—from the cumulative and harmful health consequences of e-cigarette and other tobacco use.

OHA has long advocated for meaningful policies which reduce health inequities faced by Native Hawaiians. Most recently, OHA spearheaded the State effort to codify "social determinants of health" through Act 155 (Reg. Sess. 2014) and require state agencies to take a holistic and systemic approach to addressing health disparities seen in Native Hawaiian and other communities. In furtherance with our strategic plan and advocacy efforts, we now seek to improve the conditions of Native Hawaiians by reducing substance abuse, including tobacco and nicotine products.

Smoking and tobacco use have had severe consequences for Native Hawaiians. For example, Native Hawaiian women have the highest rates of asthma in the State,¹ and exposure to tobacco smoke exacerbates such respiratory issues, making asthma very dangerous and difficult to control. Moreover, health data reveals that lung and bronchus cancers associated with tobacco use kill more kāne (31.3%) than any other form of cancer; this trend has remained steady since 1975.² Alarmingly, nearly one in five Native Hawaiians is a current smoker³; and Native Hawaiian youth are more likely than any other ethnic youth group in Hawai'i to use electronic vaping products, with one in three of these users being adolescent females.⁴

E-cigarette use in particular has become "a major health concern" among youth nationwide, according to the United States Surgeon General. To address the skyrocketing rates of vaping in high schools and middle schools, the FDA has recently moved toward a ban on flavored e-cigarettes, menthol cigarettes, and flavored cigars; national advocacy is

also prompting efforts to ban favored tobacco products that are clearly marketed toward and popular among youths. By prohibiting the sale of flavored tobacco products, including e-cigarette "juice," SB1009 SD1 will place Hawai'i at the lead of such efforts to protect children and adults alike, while promoting the well-being of the Native Hawaiian community and a healthier Hawai'i overall.

Accordingly, OHA urges the Committee to **PASS** SB1009 SD1. Mahalo nui for the opportunity to testify on this measure.

Department's Position:

The Department of Education (Department) supports SB 1009 SD1, provided that its passage does not replace or adversely impact priorities as indicated in our BOE approved budget.

The 2017 Hawaii Youth Risk Behavior Survey data indicate that almost half of our high school students have tried e-cigarettes and 25% are now regular users. Although traditional cigarette use has declined in recent years, it is still concerning, with one out of every four youth saying that they have smoked a cigarette.

Since 2009, the Food and Drug Administration (FDA) has banned cigarettes with characterizing flavors other than menthol (e.g., fruit, candy). Menthol cigarettes and flavored e-cigarettes are disproportionately used by youth, partially due the false perception that fruit- and menthol-flavored products are less harmful than those that are tobacco flavored. A 2013 US Food and Drug Administration (FDA) report on the health impact of menthol cigarettes determined that these products lead to increased smoking initiation among youth and young adults, greater addiction and decreased success in quitting smoking.

The nicotine in tobacco products has been found to be addictive and is especially harmful to youth neurologic development. There are numerous other negative health consequences associated with the use of tobacco products and second hand exposure to tobacco smoke and e-cigarette vapor, including higher rates of asthma and respiratory infection. These health conditions may limit a student's ability to attend and participate fully in school and may have long term effects on their educational attainment. In addition to being highly addictive, nicotine adversely affects the heart, reproductive system, lungs, and kidneys. Tobacco is the leading cause of cancer and of death from cancer. An estimated 21,000 children in Hawaii currently under the age of 18 with ultimately die prematurely from smoking.

Pursuant to Act 206, Session Laws of Hawaii 2018, Part II, Section 8(5), it is unlawful for anyone

under the age of 21 to possess a tobacco product or an electronic smoking device (e-cigarette). If a student is found committing this offense on a school campus, he or she is subject to the disciplinary actions of Chapter 8-19, Hawaii Administrative Rules, and may be suspended. E-cigarettes will be seized, forfeited to the school administrator and destroyed by law enforcement following the conclusion of administrative investigation.

The Department is committed to supporting students' well-being by providing a safe learning environment and helping them to develop health literacy skills. The Department is collaborating with the Department of Health to actively engage and educate our youth as to the harmful risks and dangers associated with tobacco products, including e-cigarettes. These efforts include a social media campaign, school-level student-led projects (e.g., video, art, essays, presentations, etc.), displaying posters on school campuses, and embedding curriculum on this topic into health education classes. The Department is also working to raise awareness about this critical health issue among teachers and parents by distributing educational pamphlets and holding family information nights.

The safety and well-being of all of our students is paramount to the Department of Education.

1 **Fiscal Implications:** Hawaii saved one billion dollars in total healthcare savings from 2000 to

2 2017 through prevention with youth and pregnant women, and adult cessation efforts. Reducing

3 future the initiation of tobacco use, and helping people quit tobacco products will ultimately

4 reduce health care costs and improve health outcomes.

5 **Department Testimony:** The Department of Health (DOH) supports Senate Bill 1009, Senate

6 Draft 1 (S.B. 1009, SD1) which proposes to amend Chapter 712, Hawaii Revised Statutes (HRS)

7 by prohibiting the sale or distribution of all flavored tobacco products, including products with

8 menthol, in the State of Hawaii effective January 1, 2020. The Department defers to the Department of

9 the Attorney General (AG) for enforceability.

The unprecedented youth vaping epidemic in Hawaii has is a serious public health
issue. Exposure to nicotine during adolescence can cause addiction and harm the developing
adolescent brain.¹ In contrast to the positive decline in combustible tobacco smoking, use of
electronic smoking devices (ESDs), also known as vaping or e-cigarettes, has increased
dramatically over the last decade, making ESDs the most common tobacco product used among
youth.

Hawaii data showed that from 2011 to 2015, experimentation with vaping among middle
school students increased six-fold while among high school youth it increased by four-fold.²
According to the Hawaii 2017 Youth Risk Behavior Survey, 16 percent of middle school and 26
percent high school youth are current ESD users, and the rates are higher on the neighbor
islands with Hawaii County at 34 percent; Maui County at 32 percent; and Kauai County at 31

percent.³ These percentages are over twice as high as the national average of 13 percent, and
data shows Hawaii has been leading the trend in e-cigarette use by youth.⁴ The 2018 National
Youth Tobacco Survey (NYTS) findings released on February 11, 2019, reported a 78 percent
increase in current e-cigarette use by high school students from 2017 to 2018. The NYTS is the
first national survey to reflect the impact of rising sales of JUUL and other USB-shaped ecigarettes, and the erosion of tobacco prevention progress from 2011 to 2018.⁵

7 Scientific studies are increasingly reporting that flavors are one of the main reasons that youth use tobacco. In recent years, there has also been an explosion of sweet or kid-friendly 8 flavored tobacco products, especially for ESDs and cigars. A 2014 study identified more than 9 10 7,700 unique e-cigarette flavors, with an average of more than 240 new flavors being added per month.⁶ Among student responders to the 2017 Hawaii Youth Tobacco Survey reporting ever-11 12 using ESDs, 26 percent stated the availability of "flavors such as mint, candy, fruit, or chocolate" was their primary reason for using ESDs. Further, one in four said they did not believe ESDs to 13 be dangerous.² 14

The tobacco industry has long used and adjusted the level of menthol to appeal to younger smokers, and according to a 1986 R.J. Reynolds document observed, ". . . once a smoker adapts to smoking a menthol product, the desire for menthol increases over time."¹ Menthol is a chemical compound used to mask the harshness of cigarettes smoke due to its characteristic cooling effects on the mouth and throat.^{7,8} Longitudinal studies show that initiation with menthol cigarettes facilitates progression to cigarette use among young smokers.^{9,10} Nationally, the youngest

cigarette smokers use menthol at the highest rates.^{11,12} Between 2008 and 2010, 57 percent of
 smokers ages 12-17 smoked menthol cigarettes compared with 35 percent of smokers overall.¹³

In Hawaii, menthol tobacco use is especially problematic. A 1983 document from R.J.
Reynolds declared that Hawaii was a "menthol market".¹⁴ According to the 2010 study titled,
Smoking and Tobacco use in Hawaii, 78 percent of Native Hawaiian/ Pacific Islander adult
smokers and 42 percent of White adult smokers consumed menthol cigarettes.¹⁵ The 2017
Hawaii Youth Tobacco Survey (YTS) data showed that 54 percent of high school youth who
smoke usually smoke menthol cigarettes.¹⁶

The 2009 federal Family Smoking Prevention and Tobacco Control Act, prohibited the 9 sale of cigarettes with characterizing flavors other than menthol or tobacco, including candy and 10 fruit flavors with the purpose of deterring youth smoking. (Amongst cigarette flavors available 11 was Camel's "Kauai Kolada" described as, "Hawaiian hints of pineapple and coconut," in 12 special edition packaging featuring a recumbent dark-haired young woman wearing a lime-slice 13 14 lei, bikini top and hula skirt.) This prohibition only extended to flavored cigarettes and their flavored cigarette component parts, such as tobacco, filter, or paper."¹⁷ It did not apply to non-15 cigarette tobacco products, nor the flavors of menthol and tobacco. The absence of regulation 16 has led to the proliferation of flavored tobacco products in the marketplace, enticing new users, 17 particularly youth, to a lifetime of nicotine addiction. This growing market for flavored tobacco 18 products is undermining the nation's overall progress in reducing youth tobacco use. 19

The Department supports this legislation to ban flavored tobacco products. Ending the 1 sale of flavored tobacco products is an issue of both health and social justice. Candy and fruit 2 flavored tobacco products are being marketed to youth intentionally as a way of replacing adult 3 4 smokers of traditional cigarettes. Those who use flavored tobacco products are more likely to 5 progress to regular smoking. The major tobacco companies continue to invest heavily in flavored tobacco products with their own brands or acquired existing e-cigarette companies. 6 7 Global e-cigarette industry grew dramatically and by 2017 was valued at 10.24 billion US dollars. Most recently, Altria, parent company of Phillip Morris, invested 12.8 billion dollars or 8 35 percent stake in JUUL, a product so popular with youth, "to JUUL," is used as a synonym for 9 10 vaping. A flavored pod of JUUL contains as much nicotine as 20 regular cigarettes. The passage of S.B. 1009, SD1 would be a significant policy to close the market of appealing products that are 11 12 addicting our youth and young adults to nicotine.

Honorable Chair Rhoads, Honorable Vice Chair Wakai and Members of the Committee on Judiciary. The Office of the Prosecuting Attorney, County of Hawai'i submits the following testimony in SUPPORT of Senate Bill No. 1009, SD1.

This measure bans the sale of flavored tobacco products.

Electronic smoking device (ESD) use among youth in Hawai'i has reached epidemic levels, and ESDs have surpassed cigarettes as the most used tobacco product among youth.

The tobacco industry claims they are not targeting children, but their actions tell a different story. The rise in youth use of EDSs has been in conjunction with the targeted branding of sweet, candy-flavored tobacco products. The toxic combination of enticing flavors and nicotine have led to a generation of youth addicted to tobacco products.

It is encouraging that the FDA has recognized flavors and ESDs as a national public health concern. It is also clear that we must act NOW to protect Hawai'i keiki from the enticement of candy-flavored tobacco products and a lifetime of addition.

My name is Michael Robinson, Vice President, Government Relations & Community Affairs at Hawai'i Pacific Health. Hawai'i Pacific Health is a not-for-profit health care system comprised of its four medical centers – Kapi'olani, Pali Momi, Straub and Wilcox and over 70 locations statewide with a mission of creating a healthier Hawai'i.

I write in support of SB 1009, SD1 which would ban the sale of flavored tobacco products effective as of January 1, 2020.

Tobacco use remains the leading cause of preventable disease and death in the United States and in Hawai'i. Tobacco use is a serious public health problem in terms of the human suffering and loss of life it causes, as well as the financial burden it imposes on society and our healthcare system. Annually, \$526,000,000 in health care costs are directly attributed to smoking in the State. Flavored tobacco products promote youth initiation of tobacco use and help young occasional smokers become daily smokers by reducing or masking the natural harshness and taste of tobacco smoke, thereby increasing the appeal of tobacco products. Menthol, in particular, is used by the tobacco industry because it has a cooling and numbing effect and can reduce the throat irritation from smoking, thus making menthol cigarettes an appealing option for youth who are initiating tobacco use. Candy and fruit flavors improve the taste and reduce the harshness of tobacco products, making them more appealing and easier for beginners to try tobacco products and ultimately become addicted. The popularity of electronic cigarettes among youth is concerning, as these products contain nicotine.

E-cigarette use or vaping among youth and young adults has become a national public health concern. E-cigarettes are now the most popularly used tobacco product among youth and young adults, surpassing cigarettes. While smoking rates in Hawaii have decreased through the years, ESD use has rapidly increased, threatening significant

public health gains through our Tobacco 21 law and tobacco youth access laws. This is particularly concerning because e-cigarettes provide a new way to deliver the addictive drug nicotine. No matter how it is delivered, nicotine exposure can lead to addiction and harm the developing brain. Studies are also finding that ESDs can lead to smoking cigarettes for new users, including kids. Marketing strategies by the tobacco industry and electronic smoking device industry have significantly increased the introduction and marketing of flavored non-cigarette tobacco products, especially ESDs. Products are glamorized in order to appeal to our youth, using flavors such as candy, fruit, chocolate, mint, Kona coffee, Maui Mango, Shaka strawberry, and Moloka'i hot bread.

Recognizing the increasing public health concerns of flavored tobacco products, other jurisdictions have enacted bans on the sale of those products. Hawaii should also take the step to impose a similar ban.

RE: SUPPORTING SENATE BILL NO. 1009, SENATE DRAFT 1, RELATING TO FLAVORED TOBACCO PRODUCTS.

Chair Rhoads, Vice Chair Wakai, and Members of the Committee:

The Hawaii Primary Care Association (HPCA) is a 501(c)(3) organization established to advocate for, expand access to, and sustain high quality care through the statewide network of Community Health Centers throughout the State of Hawaii. The HPCA <u>SUPPORTS</u> Senate Bill No. 1009, Senate Draft 1, RELATING TO FLAVORED TOBACCO PRODUCTS.

The bill, as received by your Committee, would:

- (1) Prohibit the sale, offer for sale, or possession with the intent to sell or offer to sell a flavored tobacco product;
- (2) Clarify that a statement or claim is made to the consumer or public that the product has or produces a characterizing flavor be prima facie evidence that the tobacco product is a flavored tobacco product;
- (3) Provide that any tobacco product or electronic smoking device in the retailer's possession at the time of the violation be seized and forfeited to the State, and following administrative or judicial proceedings finding that the violation was committed, be destroyed by law enforcement;
- (4) Authorize the levying of civil fines not to exceed \$500 for the first offense, and not less than \$500 but not more than \$2,000 for any subsequent offense;
- (5) Allow any county to adopt rules or ordinances that place greater restrictions on the access of tobacco products and provide that the more stringent restriction prevail;
- (6) Include both savings and severability clauses ; and

(7) Take effect on January 1, 2020.

Federally Qualified Health Centers (FQHCs) provide desperately needed medical services at the frontlines in rural communities. Long considered champions for creating a more sustainable, integrated, and wellness-oriented system of health, FQHCs provide a more efficient, more effective and more comprehensive system of health.

FQHCs have long seen first-hand how tobacco has literally destroyed the lives of our patients and their families. Because of the ubiquity of cigarettes, chewing tobacco, and now electronic smoking devices, the impacts of tobacco affect our citizenry on a generational basis with people experimenting at even earlier ages. From our perspective, the development of flavored products are intended specifically to introduce these products to younger consumers for the purpose of grooming the next generation of smokers, chewers, and vaporers.

TESTIMONY IN SUPPORT OF SB 1009 SD 1 RELATING TO FLAVORED TOBACCO PRODUCTS

Hawaii Youth Network Services, a statewide coalition of youth- serving organizations, supports SB 1009 SD 1Relating to Flavored Tobacco Products.

Elimination of flavored tobacco products across the state of Hawai'i will prevent addiction, reduce continued use of tobacco products throughout one's lifespan, and prevent chronic health conditions such as COPD and cardiovascular disease.

It is important to ban flavored tobacco products as today's marketing targets and encourages youth to take part in this unhealthy behavior. Hawaii has the fifth highest amount of vaping in the United States. E-cigarettes continue to grow in popularity leading to a potential health epidemic. With up to 15,500 flavors, ecigarettes are of particular interest and attraction to Hawai'i's youth. Along with the enticing flavors and packaging, youth perceive e-cigarettes to be less harmful than other nicotine filled tobacco products. Students have shared that vaping is a popular activity that occurs both inside and outside of the academic setting. Youth have the ability to access flavorless tobacco through social media accounts, vape stores without regulation of the 21-year-old age law, and online orders with their parent's credit cards.

Youth do not understand the dangers of this harmful product. E-cigarettes contain toxic chemicals These ingredients result in chronic health consequences including lung cancer, addiction, central nervous system damage, and delay of proper adolescent brain development.

808novape researchers have found that:

- 26% of Hawai'i high school students are using e-cigarettes
- 94% online purchases of e-cigarettes have been successful amongst teens
- 60% of teens believe occasional use of e-cigarettes does little to of harm
- 70% of middle and high schoolers have recently seen e-cigarette advertising

The Hawaii Food Industry Association is comprised of two hundred member companies representing retailers, suppliers, producers, and distributors of food and beverage related products in the State of Hawaii.

The federal government already has in place adequate regulations regarding flavored cigarettes. Tobacco regulations are handled at the federal level for good reason. Enforcing this type of ban on very specific kinds of a product, which are legal at the federal level would require be a potentially logistically difficult and very expensive process. Any additional regulations of these types of products should occur at the federal level.

At the state level tobacco use in Hawaii is already restricted to those who are 21 and older. Kids and adults under 21 don't have legal access to these products and businesses already take measures to ensure that only those 21 and older are buying nicotine products.

This bill unfairly targets and penalizes those who choose to use certain types of products, and the businesses that serve these customers. This type of regulation is not really necessary and can be obtrusive. We thank you for the opportunity to testify.

The Hawaii Dental Hygienists' Association (HDHA) strongly **supports Senate Bill 1009 SD1** which proposes to prohibit the sale or distribution of all flavored tobacco products, including products with menthol, in the State of Hawaii effective January 1, 5 2020.

We congratulate the Legislature for introducing a measure that seeks to address the health dangers caused by flavored tobacco products in Hawaii. The marketing of flavored tobacco products, clearly targets sales to Hawaii's youth as an initiation into the use of other nicotine products. In contrast to the positive decline in combustible tobacco smoking, use of electronic smoking devices (ESDs), also known as vaping or e-cigarettes, has increased dramatically over the last decade, making ESDs and flavored tobacco products the most common tobacco product used among youth.

HDHA believes that the nicotine in tobacco is clearly addictive and has been proven to be especially harmful to the oral health of those using it. Current research shows a direct correlation between smoking and periodontal disease. It has been shown to significantly increase the risk of tooth loss over time and decrease the ability for oral soft tissue to heal.

As the largest association representing Hawaii's licensed dental hygienists', HDHA strongly **supports SB 1009 SD1** to ban the sale of flavored tobacco products in Hawaii. Dental hygienists strive daily to educate patients on ways to improve their oral health, which includes discussing the harmful effects of smoking and tobacco related products. We look forward to working with lawmakers toward our common goal of increased health and decreased dental disease in our great State.

The Hawaii State Teachers Association <u>strongly supports SB 1009, SD1</u> banning the sale of flavored tobacco products.

This measure would ban the sale of flavored tobacco products in the state of Hawaii starting on 1/1/2020.

Flavored tobacco products have been proven as the entry point for youth to start smoking. According to the FDA's 2018 National Youth Tobacco Survey over two-thirds (67.8 percent) are using flavored e-cigarettes, which is a significant increase from 2017. The 2017 CDC, Youth Risk Behavior Surveillance System reported 8.1% of high school students smoked on at least one day in the past 30 days.

Locally the Hawaii's Youth Risk Behavior Survey of public high school students disclosed the following: over 42% of Hawaii high school students have tried using vapor products; over 25% of Hawaii high school students indicated that they are regular users; and neighbor islands high school students reporting even higher numbers with over 31% of Kauai students, over 32% of Maui students, and over 34% of Hawaii county students reported to be regular users.

This data is clear and the reason the Hawaii State Teachers Association asks your committee to **support** SB 1009. We need to protect our youth.

The Hawaii Public Health Association is a group of over 600 community members, public health professionals and organizations statewide dedicated to improving public health. HPHA also serves as a voice for public health professionals and as a repository for information about public health in the Pacific.

HPHA strongly supports SB1009 SD1, which would end the sale of flavored tobacco products, including flavored e-liquids and menthol cigarettes.

Hawai'i is already experiencing a youth vaping epidemic. Studies have shown that 8 in 10 kids start with a flavored tobacco product. It's no coincidence that the rise in youth vaping has coincided with an explosion of sweet e-liquid flavors used to hook kids. With more than 15,500 flavors, these products are being irresponsibly marketed – who is the industry really targeting with flavors like Fruit Hoops, Sour Straws, or Cookie Monsta?

It's also critical to include menthol cigarettes in the flavored tobacco ban. Menthol cigarettes are a popular starter product, as it has cooling properties that mask the harshness of tobacco smoke and nicotine. The tobacco industry has a long history of marketing menthol cigarettes to youth and vulnerable groups, such as the Native Hawaiian community, and has led to health disparities.

We must end the sale of candy-flavored tobacco to protect our youth from a lifetime of addiction. The industry is promoting flavors that mimic popular food or candy to hide the fact that they contain nicotine and with more kids who were never smokers using these products, we have an urgent need to act. HPHA strongly supports SB1009 SD1 and ask you to pass this out of committee.


My name is Danelle Watson, I am the director of Alexander Academy of Performing Arts. I am testifying on SB1009-flavored tobacco ban. The use of candy flavors in tobacco products are advertising and marketing directly to our keiki.

8 in 10 youth who use tobacco product started with a flavored product. 95% of smokers started before they were 21, most with flavored tobacco product. Youth who vape are 10 times more likely to start smoking. 25.5 % of Hawaii high schoolers vape, this is more than 2X national average. 15.7% of Hawaii middle schoolers vape, this is more than 3x national average.

Ending the sale of all flavored tobacco products including menthol will help protect our youth from a lifetime of tobacco addiction.

Dear Senator Baker, Chang, and members of the Commerce, Consumer Protection and Health Committee:

This measure is extremely critical to the health of the children of our state and our entire state as well. Please vote in favor of SB1009, SD1 banning all flavored tobacco products in Hawaii.

I am Executive Director of the Hawaii COPD Coalition and serve 46,015 Hawaii adults diagnosed with COPD in Hawaii (with an estimated equal number still undiagnosed). Since 2007, I have worked in Hawaii, nationally and internationally with countless people who have had their lungs and lives horribly affected by tobacco and nicotine.

We are grateful that this legislature has been the first in the nation to pass legislation banning the sale of tobacco and electronic smoking devices to people under 21 in Hawaii. Unfortunately, that doesn't stem the growing epidemic of young people and adults in our state who are smoking electronic smoking devices, commonly referred to as ESDs, e-cigs, or vaping.

With 168,000 young people in our schools and with 42% of all high school students and 27% of middle schoolers reporting ever having used an "electronic vaping product" in 2017, we have an urgent need to act. All our young people deserve protection from a lifetime of addiction.

While the FDA's proposed plan aims to restrict the sale of flavored e-cigarettes in convenience stores and gas stations, **it still allows e-cigarette products to stay on the market and online without review by the FDA until August 2022**. We know rulemaking at the federal level often takes a long time which is why state-level action on menthol and other flavored products is

needed now. We can't wait to protect our keiki. Additionally, the new proposed policies do not address flavors in any form of smokeless tobacco or hookah.

The chemicals used in e-juice and other products have NOT been tested nor approved for inhalation, particularly butter flavors which has been known to cause popcorn lung, otherwise known as bronchiolitis obliterans (which is a very serious progressive lung condition, basically causing the lungs to disappear from the bottom of the lungs upwards). The people using these products SAY they don't FEEL different and aren't currently having symptoms but the studies show otherwise. The most recent study is the FIRST study to show an independent association of e-cigarette use with chronic respiratory disorders and it's a <u>Hawaii study</u>. Sadly, addicted tobacco smokers often also said they were "fine," up until they were hospitalized with a severe COPD "lung attack" and put on supplemental oxygen for the rest of their lives as well. The over 15,000 flavors of ESDs are designed to entice and attract youth with flavors and designs and packing like sweet candies they love, like gummy bears, jolly ranchers, and more!

We already have over 46,000 Hawaii adults with COPD. The study showing that e-cigarettes cause respiratory disorders shows why it is imperative that this bill be passed NOW, to prevent our state from having ever more young and older people with COPD and the accompanying reduced quality of life.

Please help protect the lungs and lives of our children from these very harmful products that are spreading virally in our schools, from elementary through high school and beyond. We urge you to **please vote in favor of SB1009, SD1 and pass it out of committee so it can become law**. The Hawaii COPD Coalition thanks you very much for your careful consideration of this most important and timely bill.

The Coalition for a Tobacco-Free Hawai'i, a program of the Hawai'i Public Health Instituteⁱ is in **Strong Support of SB 1009** which would end the sale of all menthol and flavored tobacco products in the state.

This measure will help to save lives.

Tobacco use remains a serious threat to public health. Each year, Hawaii spends \$526 million in health care costs and \$141.7 million in Medicaid costs due to smoking. Tobacco products with menthol, sweet flavors, and colorful packaging are designed to attract teens and young adults. Menthol has cooling properties that mask the harshness of tobacco smoke and nicotine, making menthol cigarettes a popular starter product. A report by the U.S. Food and Drug Administration, issued in 2013, found that menthol cigarettes led to 1) increased smoking initiation among youth and young adults; 2) greater addiction; and 3) decreased success in quitting smoking.

In addition, candy flavors such as Fruit Hoops, Sour Straws, Gummy Bears, and Cookie Monsta are designed to appeal to kids, and make nicotine go down easier. With 81% of youth starting with a flavored productⁱⁱ, regulating the flavors designed to capture and addict new customers prioritizes the health and safety of our community over tobacco's special interests.

This measure helps to protect our keiki from a lifetime of addiction. Hawaii is experiencing a vaping epidemic among our young people. The State Legislature has worked hard to protect our residents from the harms caused by tobacco use, but the rapid growth of e-cigarette use is alarming. With 42% of all high school students and 27% of middle schoolers reporting ever having used an "electronic vaping product" and 4.3%ⁱⁱⁱ of adults regularly using ESDs in 2017, we have an urgent need to act.

The industry claims that they're not targeting kids, but their actions tell a different story. With 15,500 e-cigarette flavors and growing, these products are not being responsibly marketed. The industry selects colorful packaging and ads that appeal to taste and pop culture. Tobacco companies have a long history of using these same tactics to entice new and younger users and make them repeat customers. In addition, despite our Tobacco 21 law, several stores to continue to sell to underage minors, as reported in the FDA Compliance Check inspections site^{iv}:

These new products are glamorizing nicotine addiction.

The vaping industry has taken full advantage of delays by the FDA to regulate these products. Large volume (30-60mL), highly concentrated (5-5.9%) nicotine sale e-liquids have entered the market in youth-oriented flavors. Most recently, pod-based systems such as Juul and Suoprin have disrupted the e-cigarette market by creating an easily concealable sleek device that can deliver higher concentrations of nicotine. Tobacco giant Altria, maker of Marlboro, spent \$12.8 billion to purchase a third of Juul, which has 76% of the e-cigarette market share and is worth \$38 billion.



At the risk of allowing these products to remain on the market, we are addicting a new generation to these deadly products. The health of Hawaii's keiki must be protected from the predatory marketing of tobacco companies.

Hawai'i has an opportunity to act now and be the first state to end the sale of flavored tobacco.

Over 180 localities^v have passed restrictions on the sale of flavored tobacco products, and over two dozen restrict the sale of menthol cigarettes. FDA's proposed plan aims to restrict the sale of flavored e-cigarettes in convenience stores and gas stations, however, it still allows e-cigarette products to stay on the market and online without review by the FDA until August 2022. Since recognizing flavors and vaping as a national public health concern, the FDA has only sent warning letters to 18 manufacturers since May 2018. We know rulemaking at the federal level is often a long process, which is why state-level action on menthol and other flavored products is needed now. E-cigarettes are not FDA-approved tobacco cessation products. We have yet to see any scientific evidence, beyond anecdotal data, that e-cigarettes have helped smokers to quit completely from tobacco use. The concern is that with the aggressive and deceptive marketing of these products, we are seeing other consequences: **1**) people who have never smoked are using e-cigarettes, **2**) children are picking them up as a path to smoking, and **3**) smokers are using them to perpetuate their habit instead of to completely quit.

Prohibiting the sale of flavored tobacco products can help to keep kids from ever starting to smoke or vape, and can encourage those addicted to these products, to quit. We appreciate

Hawaii's leadership in tobacco control and the legislature's actions to protect our young people from a deadly addiction. We respectfully urge the committee to **pass SB1009**.

My name is Jamil Folio, I am the Administrative Manager for "The Man Cave" retail business in Kihie, Hawaii. I am a property owner, father of young keiki, concerned citizen and a small business advocate who is proud to call Maui my home.

I am writing in STRONG support of SB1009, the tobacco flavor ban. We sell tobacco products in our store, and understand the trepidation of other business owners/operators concerning potential lost revenue. BUT, we cannot jeopardize the health of our youth and our community by focusing on short term profit.

An alarming number of Maui high school students, 30%, are using flavored vapor products, or e-cigarettes. A good portion of them will go on to use more traditional tobacco products and in case you are unaware that carries significant health risks. Children are 3 to 10 times more likely to start smoking having had exposure to vaping or e-cigarettes in the past.

21,000 children under the age of 18 currently living in Hawaii will die prematurely from smoking.

Dear Chair Rhoads, Vice Chair Wakai, and Members of the Judiciary Committee:

At Blue Zones Projects we are working to make Hawaii a happier, healthier place to live, work and play. We support SB1009 SD1, which will ban the sale of all flavored tobacco products, ultimately reducing the number of users and potential users.

Youth are highly attracted to the variety, 15,500 + and growing, flavors. These are marketed to appeal to young people. With names like Fruit Hoops, Cali Colada, Space Jam, TrollzE, and Blizzard Berry-BRRRST, clearly the industry is targeting children under 21. By attracting young people, the next generation of consumers is being cultivated.

It is targeted, and the messaging is working phenomenally well. Nationally, there was a 78% increase from 2017-2018 in current e-cigarette use among high school students and 48% increase among middle school students. Bringing the total number of middle and high school students currently using to 3.6 million, 1.5 million more than the previous year. Hawaii youth are part of this trend, 42% of HIDOE high school students and 27% of middle school students report having ever used an electronic vaping product.

"Each day more than 2800 adolescents aged 12-17 try smoking with 10.9% of students trying before the age 13. Roughly 700 adolescents transition to daily smoking each day and more than 60% of teen smokers still smoke 5 years later."¹ The fruity flavors are favored by teens because they mask the taste of the bitter nicotine. Children are the target consumer with these flavors that is shown by the increase in products by young people. Our children are becoming addicts, and although the schools have been given the ability to take ESDs away from students and turn the devices over to the police, it is impossible to stop addiction by simply removing the device. We need to target the source of the adolescent addiction.

The fact that young people are the target of the industry through flavored tobaccos to get them hooked, makes sense. "Preventing youth from smoking is important because 90% of smokers start before the age of 18, and very few adults will begin to smoke or use smokeless tobacco products after age 26. An estimated 5.6 million youth <18 will die prematurely from a smoking-related illness; these deaths can be averted through concerted public health measures and regulatory measures."² We cannot address this epidemic nationally, but we can address it here for our Hawaii youth, and be an example for others.



Re: Adopt State-wide Restriction on the Sale of Menthol and all Other Flavored Tobacco Products, Including Flavored E-Juices in Hawaii

The African American Tobacco Control Leadership Council (AATCLC) strongly encourages the Senate Committee on Judiciary (JDC) to restrict the sale of menthol and all flavored tobacco products, including flavored e-juices throughout the State of Hawaii. We already know that 80% of youth's 12-17 start smoking using flavored cigarettes (Ambrose et al., 2015). If the JDC truly wants a healthier Hawaii, and we believe that you do, then it is imperative that the sale of menthol and all other flavored tobacco products be restricted and the predatory marketing of these products be recognized as a social injustice, an issue that disproportionately impacts poorer communities, marginalized groups, youths and communities of color.

This is no minor matter. Menthol and flavored tobacco products are driving tobacco-caused deaths and diseases nation-wide. While the use of non-flavored tobacco cigarettes has been decreasing, the use of menthol cigarettes is on the rise, among youth and adults; among Latinos, Blacks, and Whites (Villanti, 2016). Let's be clear, the majority of women smokers smoke menthol cigarettes; folks from the LGBTQ community disproportionately smoke these products; 47% of Latino smokers prefer menthol cigarettes, with 62% of Puerto Rican smokers using menthol; nearly 80% of Native Hawaiians; a majority of Filipinos; and a majority of smokers with behavioral health issues smoke menthol cigarettes. Frankly, most marginalized groups disproportionately use these "minty" products (CDC, 2010; Fallin, 2015; Forbes, 2013; Delnevo, 2011; Hawaii State Dept. of Health, 2009; Euromonitor, 2008; Hickman, 2015).

Moreover, 85% African American adults and 94% of Black youth who smoke are using menthol products (Giovino, 2013). These striking statistics arise from the predatory marketing of these products in the Black Community, where there are more advertisements, more lucrative promotions, and *cheaper prices* for menthol cigarettes compared to other communities (Henriksen et al., 2011; Seidenberg et al., 2010).

The JDC should be aware that menthol, as if to add insult to injury, masks the harsh taste of tobacco and allows for deeper inhalation of toxins and greater amounts of nicotine. Furthermore,

the presence of menthol makes cigarettes harder to quit compared to other cigarettes (Ton et al., 2015; Levy et al., 2011). The "cool refreshing taste of menthol" heralded by the tobacco industry is just a guise; ultimately, menthol allows the poisons in cigarettes and cigarillos to "go down into the body" more easily.

We all have been reading in the papers about the "JUUL Explosion," where a little thumb drive looking device is used more than regular cigarettes among youth (CDC, 2018). And one of the major drivers of the massive uptake of c-cigarettes among youth is the fact that there are over 15,000 kid friendly flavors available in the marketplace! ((https://www.flavorshookkids.org/2018). The vaporist community would like you to believe that aerosol inhaled by e-cigarette users is only water vapor – nothing could be further from the truth. Here are the facts:

- 1. E-cigarettes are tobacco products that deliver nicotine, an addictive substance that especially in youth can compromise the brains executive functioning (Report of the Surgeon General, 2014).
- 2. The propylene glycol and vegetable glycerin that constitute a large portion of the e-juice and the resulting vapor **are not FDA approved for inhalation.**
- 3. The 15,000+ flavors available on the market may be Generally Recognized as Safe (GRAS) for **ingestion**, but they are not GRAS for **inhalation**.
- 4. There are as many, if not more, metals in the vapor of e-cigarettes than found in cigarette smoke (Williams et al., 2013).
- 5. Many of the same toxins and carcinogens found in regular cigarettes, like benzene, formaldehyde, and tobacco specific nitrosamines, can be found in e-cigarette vapor (Goniewicz et al., 2013). And yes, these toxins and carcinogens are at lower levels than in a regular cigarette; while these lower levels may be safer, this does not mean that e-cigarettes are **safe**!
- 6. The vapor from e-cigarettes activates platelet formation just like regular cigarettes; such platelet activity leads to arterial blockages (Hom et al., 2016).
- 7. E-cigarette aerosol consists of ultrafine particles at levels comparable to or higher than cigarettes. These particles can cause cardiovascular and pulmonary disease. In addition, the particle size in e-cigarettes is often smaller, and thus more dangerous, than those generated by cigarettes (Fuoco FC, Buonanno G, Stabile L, Vigo P. 2014).
- 8. Kids who start with e-cigarettes are more likely to become regular cigarette users, and unfortunately, in many cases dual users (Byrne S et al., 2018).

The AATCLC is calling upon the JDC and the great State of Hawaii to join a growing number of cities, counties and States around the country that are restricting jurisdiction-wide the sales of menthol cigarettes and all other flavored tobacco products, including flavored e-juices. In June 2018, San Francisco voters passed the first ever citywide restriction on the sales of all flavored tobacco products, including menthol cigarettes and flavored e-cigarette juices. This "strongest flavor ban law ever" was rapidly replicated in the City of Richmond the following month. Within

weeks, Beverly Hills followed suit, with their own city wide restrictions. Since November the cities of Alameda, Santa Cruz, San Pablo, Hermosa Beach and Needham in Massachusetts all have adopted their own citywide restrictions, and the county of Marin approved a county-wide ban for its unincorporated areas. Even the Food and Drug Administration has been finally talking about getting rid of menthol cigarettes and flavors in little cigars and cigarillos. Legislation has introduced in Sacramento to ban the sale of menthol and all tobacco flavors statewide. Just last week, the New York City Council's Committee held hearing on including menthol in their existing flavor restrictions, which have been I place since 2010. While these developments are welcomed, we know that the tobacco industry will use all its muscle to slow down and curtail these national and state efforts. Hence, it is imperative that States like Hawaii, take the lead and join the growing movement to remove menthol and all flavored tobacco products from the market place.

Formed in 2008, the African American Tobacco Control Leadership Council is composed of a cadre of dedicated community activists, academics, public health advocates and researchers. Even though based in California, we are national in our scope and reach. We have partnered with community stakeholders, elected officials, and public health agencies, from Chicago and Minneapolis to Berkeley and San Francisco. Our work has shaped the national discussion and direction of tobacco control policy, practices, and priorities, especially as they affect the lives of Black Americans, African immigrant populations and ultimately all smokers. The AATCLC has been at the forefront in elevating the regulation of mentholated and other flavored tobacco products on the national tobacco control agenda, including testifying at the FDA hearings when the agency was first considering the removal of menthol cigarettes from the marketplace.

We here at the AATCLC recognize that you Senators are under extraordinary pressure from the tobacco industry and the vaporist community to put profits above human life by limiting or curtailing restrictions on flavored tobacco products. While retailers may lose some profit and less tax will be generated, still, most importantly, tens of thousands of lives will be saved! Please join your sister cities and States and stand up to the tobacco industry and their allies – Call for: No Selling of Menthol Cigarettes and All Other Flavored Tobacco Products, including Flavored E-Juices Citywide in Hawaii. Say "No" to the continued predatory marketing of flavored tobacco products to our youth, and say "Yes" to the health and welfare of our kids, who are the most vulnerable. In fact, say "Yes" to the protection for all residents of the State of Hawaiii.

We currently own and operate 15 locations statewide and employ over 110 full-time workers to support sales of our products not only here in Hawaii, but to all 50 states as well as over 30 International countries. We stand in opposition to SB 1009 HD1 for the following:

- SB 1009 HD1 would decimate the Hawaiian vapor industry by banning the sale of all electronic cigarette liquids and cartridges. Every electronic cigarette available on the worldwide market is "flavored." Because they do not contain tobacco, electronic cigarettes have no "natural tobacco" taste, or any taste for that matter, without the addition of flavorings. Even electronic cigarettes advertised as coming in "tobacco flavor" are actually just the result of the blending of several different flavorings such as caramel and nut flavors in an attempt to mimic the flavor of tobacco. To use the language of the proposed statute, every electronic cigarette imparts to the user a "distinguishable or distinctive" aroma, or taste other than tobacco. As a result, SB 1009 HD1 will act as a de facto ban of the manufacture and sale of all electronic cigarettes.
- Even if SB 1009 HD1 permitted the sale of electronic cigarettes flavored to taste like tobacco, its enactment would still ban the manufacture and sale of the vast majority of our products. This bill would present more than just a competitive disadvantage for local suppliers and retailers. It would be a death knell for vapor industry in Hawaii. Local consumers will either flavor liquids themselves or purchase from out of state, causing a loss of jobs and tax revenues for the state. Similarly, we will be forced to close our stores and move all or most of our business and operations to the mainland, taking with us jobs and tax revenue that has grown every year since our founding.
- Enactment of SB 1009 HD1 will deal a similar fate to our competitors in the electronic cigarette industry. Between them these businesses have likely created 1000 jobs in Hawaii. All or more of these jobs will be lost as a result of this legislation. Additionally, convenience

stores and other businesses that sell vapor products will feel the impact of consumers purchasing products from the mainland.

- The baseless claims that electronic cigarettes flavors are made to attract children must be weighed against the significant evidence that electronic cigarette flavors are very popular with adult users. The International Journal of Environmental Research and Public Research recently published the most expansive survey performed on the subject. We urge you to read the full text of this study, which we have attached to our testimony. Below are some highlights:
 - Researchers conducted an Internet survey of over 4,500 adult electronic cigarette consumers. The participants' average age was 40 years old. The vast majority (90%) of those surveyed were ex-smokers, with the average respondent having been cigarette-free for approximately one year.
 - Among the survey respondents, the most commonly used flavors were fruits, followed by sweets and tobacco.
 - Those electronic cigarette users who were still smoking ("dual users") were actually more likely to use tobacco flavors than those vapers who had quit smoking.
 - On a scale of 1-5, the average score given by the respondents for the importance of flavor variability in reducing or quitting smoking was 4 ("very important").
 - Almost 50% of the respondents answered that a lack of flavor availability would increase their cravings for tobacco cigarettes and would decrease their chances of remaining abstinent from smoking.

- The use of flavorings in electronic cigarette liquids is one of the driving factors in helping prevent adult former smokers who switch to e-cigarettes from going back to traditional cigarettes. Most users report that after switching to electronic cigarettes and experiencing the pleasant tastes one can enjoy with an electronic cigarette, they no longer find the taste of traditional tobacco cigarettes appealing.
- Enactment of this bill will actually benefit Big Tobacco by stifling their competition. Analysts credit electronic cigarettes, not government intervention, nor traditional nicotine replacement therapy products, with causing cigarette sales to experience larger than forecasted declines in the U.S. and Europe. Regardless of the good intentions involved, every step taken to reduce adult access to electronic cigarettes is really a step towards protecting cigarette markets.
- SB 1009 HD1 exempts traditional Nicotine Replacement Therapy (NRT) products that contain nicotine even though electronic cigarettes have been shown to be a much more effective tool for helping people quit smoking and have been demonstrated to have a similar risk profile as NRT's.

- The most Recent CDC report has shown e-cigarettes have supplanted all other traditional nicotine replacement therapies and are now the most commonly used product by consumers to quit using traditional tobacco cigarettes

- A recent study published by the New England Journal of Medicine concluded that E-Cigarettes are twice as effective for smoking cessation than traditional nicotine replacement therapy products which are not taxed or controlled the same way this bill proposes to tax and control E-Cigarettes. The state should be creating easier access for adult smokers to these products, not tighter regulations that steers current vapers back to tobacco cigarettes

- If flavors are not important in helping adult smokers switch from, or quit traditional cigarettes, why is GlaxoSmithKline's nicotine gum exempt from this bill and sold in flavors?



• SB 1009 HD1 would not successfully remove all flavored e-liquid products from the market. It would simply force local customers to go online and purchase them from vendors across the 49 other states who would not be subject to this ban. It would severely impact local based businesses from competing with businesses from the 49 other states who would not be subjected to this law further lowering jobs and revenues already being created in the state.

While we agree that curbing youth usage and enforcing our current laws prohibiting the sale and use of vapor products is of utmost importance, doing so at the detriment to adults who use these products every day as an alternative to traditional tobacco is not the right way to do it. Aloha,

My name is Dr. Cori Takesue and I am a member of the Coalition for Tobacco-Free Hawai'i as well as a Behavioral Health Specialist and Tobacco cessation treatment provider at Lana'i Community Health Center. I'm writing today to request your support of our 2019 legislative priority to ban flavored tobacco, including e-cigarette products in Hawai'i.

Our Coalition supports the Coalition for a Tobacco-Free Hawaii Youth Council, which is made up of high school and college students from across the state. This year our Youth Council and the Coalition have selected this as our policy priority because we believe something must be done to stop the epidemic of vaping amongst youth. Hawai'i has some of the highest rates of vaping in the country, with 25% of high school students and 15% of middle school students reporting they vaped in the past 30 days. 81% of kids nationwide use a flavored tobacco product as their introduction to tobacco, including vaping. 30% of vapers start using combustible tobacco within 60 days of starting to vape and 95% of current smokers started before the age of 21. It's clear to the members of our Youth Council and our Coalition that banning flavored tobacco is key to breaking this cycle. Flavored tobacco has no place in Hawai'i and we hope you feel the same.

We don't need candy flavored tobacco to entice youth into starting a potentially life-long addiction to nicotine. Thank you for helping to keep Hawaii's keiki safe.

SB 1009, SD1 – RELATING TO FLAVORED TOBACCO PRODUCTS

Cory Chun, Government Relations Director – Hawaii Pacific American Cancer Society Cancer Action Network

Thank you for the opportunity to provide written comments in support of SB 1009, SD1, which prohibits the sale of flavored tobacco products beginning January 1, 2020.

Every year in Hawaii over 6,700 people are diagnosed with cancer. Despite the fact that US cancer death rates have decreased by 26 percent from 1991 to 2015, not all have benefited equally from the advances in prevention early detection, and treatments that have helped achieve these lower rates. Significant differences persist in cancer incidence, survival, morbidity, and mortality among specific populations. Lung cancer remains the leading cause of cancer deaths in Hawaii.

Smoking not only causes cancer, it can damage nearly every organ in the body, including the lungs, heart, blood vessels, reproductive organs, mouth, skin, eyes, and bones. Smoking accounts for about 30 percent of all cancer deaths in the United States, including about 80 percent of all lung and bronchus cancer deaths. The impact of tobacco use goes beyond health. The annual health care costs in Hawaii directly caused by smoking are over \$500 million.

Flavored Tobacco Products

The 2009 Family Smoking Prevention and Tobacco Control Act implemented a federal prohibition of characterizing flavors other than tobacco or menthol in cigarettes. The prohibition included candy-and fruit-flavors. However, the federal law exempts "tobacco, menthol, mint or wintergreen flavors" and flavored electronic cigarettes.

While cigarette smoking rates have declined significantly in recent years, the use of electronic cigarettes has been skyrocketing, especially among youth. During the one-year period between 2017 and 2018, among high school students who currently used e-cigarettes, use of flavored e-cigarettes increased as well. Use of any flavored e-cigarette went up among current users from 60.9 percent to 67.8 percent, and menthol use increased from 42.3 percent to 51.2 percent among all current e-cigarettes users –

including those using multiple products – and from 21.4 percent to 38.1 percent among exclusive e-cigarette users. Flavors in tobacco products are frequently listed as on the top three reasons youth use e-cigarettes. Additionally, kids whose first tobacco product was flavored are more likely to become current tobacco uses than those whose first product was tobacco flavored. Furthermore, evidence indicates that many young people who use e-cigarettes also smoke cigarettes. There is some evidence that young people who use e-cigarettes may be more likely to smoke cigarettes in the future. Using nicotine in adolescence may also increase risk for future addiction to other drugs.

Recent spikes in the use of e-cigarettes makes clear that more must be done to regulate tobacco products and the industry's deceptive marketing practices.

Menthol use in tobacco products

Menthol is a chemical compound that creates a cooling effect, reduces the harshness of cigarette smoke and suppresses coughing. Those effects may make menthol cigarettes more appealing to young, inexperienced smokers. Research shows that they are more likely to addict youth and more difficult to quit than regular cigarettes. Many people who smoke think menthol cigarettes are less harmful. In fact, there is no evidence that cigarettes, cigars, or smokeless tobacco products that have menthol are safer than other cigarettes. This myth has been perpetuated via a decades long campaign by the tobacco industry.

The disparities in flavored tobacco products use in the state are contributing to the negative health disparities that exists and must be addressed. ACS CAN strongly recommends implementing evidence-based policies to prevent the initiation and use of all tobacco products. The use of products containing nicotine in any form among youth is unsafe and can harm brain development.

My name is Stephen Nii. In 2015, my commitment & effort brought home the honor of being the State of Hawaii's Family Business of the Year.

I have the honor to lead our family business, Nii Superette, Inc. which has served Leeward, Oahu for over 100 years through four generations of Nii family members.

Due to the consideration of SB1009 by the Hawaii State Legislature, each lawmaker who supports this bill has now given me the grievous task of preparing my business with 17, full-time employees to close its doors.

Many of the same lawmakers, who profess to be champions of small business and bestowed a great honor to my family three years ago, now create the environment that destroys it with a single piece of legislation.

You may consider this statement overly dramatic, however, please allow me to present you with the **economic butcher's bill of SB1009 to just one local business**, the shop my great grandfather started.

Last year, tobacco sales in our "little mom & pop shop" resulted in over **\$769,897.54 in** sales, generating **\$34,645.39 in GET revenue for Honolulu county**. 98,000 packs of cigarettes were sold through our one venue, resulting in an estimate of **\$313,600.00 in** Tobacco Tax revenue to the state of Hawaii.

Tobacco in the MENTHOL category is responsible for 82.9% of these sales, which amounts to **\$638245.07 sales or \$28,721.03 in GET revenue and \$259.974.40 in Tobacco Tax from just one, little mom & pop shop.**

Other misinformed, mainland lobbyists may have told you that only 35% of smokers choose Menthol products. In Hawaii, the reality is actually the opposite of the Mainland Marketplace. Already, the data becomes inaccurate, the interpretation misleading & its scope inappropriate & ineffective in achieve its goals.

The potential loss of \$638,245.07 is **a fatal injury to my family business**. Would you be able to support such a financial loss for your own family? Mine is not so able.

This loss means the deprivation of over 17, full-time jobs in Waipahu. Jobs that pay well over the current minimum wage, offer stable work schedules and a great environment.

This loss endangers my means to pay for my father's care home stay.

This means that my uncle & my mother lose their business-funded retirement plans.

This is the loss incurred by just one storefront by SB1009.

Now multiply this loss across the various scales of businesses such as Foodland, Times, Walgreens, Walmart, Costco, Sam's Club, every gas station/convenience store with retail sales outlets.

Do we know the real impact of such a bill across the state? Would the state be able to support a potential \$259,974.40 loss of tax revenue from each tobacco retailer? Do we know the impact of this decision? 7 Eleven has 64 storefronts in Hawaii, amounting to a potential of \$16,638,361.60 of annual tax revenue killed by SB1009. There are estimated to be an upwards of 500, convenience-type stores in Hawaii, with a potential annual tax contribution of \$129,957,200.00 now unavailable to the state in 2020? This just one segment of the Tobacco retailers statewide.

How many closures would you force? How many paychecks would you end? How many unemployment, disability, social security, employer funded health insurance contributions would cease due to the ill planned trigger of one act? Who will fund the liability of the insurance companies and their services costs when the business that fund them can no longer afford them? Passing SB1009 means that you are willfully creating another source of **unfunded liability for our health insurance companies**.

I can tell you that you will trigger the closure of my business and beg you to weigh that with the larger goal you are trying to achieve.

I also ask on behalf of the possible thousands of people across each state who are endangered by this decision that you choose another course of action that would achieve the same goal: a better life for all. Instead of a "controlled burn," this policy constitutes an uncontrollable wild fire that will claim the livelihood of thousands. You will be responsible for catastrophe.

As a retailer, I support strict sales regulation & enforcement on minor smokers and retailers. These are laws that already exist but require more support of law enforcement agencies.

I would support a higher tobacco specific sales tax per pack to fund education & preventative services. I believe in truly empowering anyone's choice with verified information. This is how my family's business survived for four generations.

I stand behind education & unable the people's power to choose wisely rather than administration from a policy that has no guaranteed outcome of success but every chance to cripple the life of many business and the people who work for them.

I recognize the intent of this bill to protect the vulnerable, our keiki. However, by law, the vulnerable are already protected by current age ban.

Supporting SB1009 destroys a major economic access point to success that is based on reasoning & voluntary CHOICE, a right that should be afforded to every adult.

There are better options that should be explored. These options would have more impact across Hawaii, such as legislature that would allow our law enforcement agencies to adequately and fairly support the current laws.

As seen by the current fireworks debacle, the lack of law enforcement creates a huge underground market situation that few can influence & so many still participate in without the benefits of traceable purchases, trackable data, due taxation and verifiable quality control measures. Creation of this law would immediately extend the economic opportunities for black markets & illegal drug dealers to entice new customers into their powerfully dark gateways. Criminalizing the product also creates another lever, enabling human traffickers to entice, entrap and deal in another form of lawless currency. In the most tragic of ironies, creating this illegal space means placing the positive results we want to achieve further away from our current grasp.

We must also be aware of the terrible potential outcomes of such well-meaning, but misdirected laws. The facts I present demonstrate the economic impact of just one store, my family's store, shows everyone that we cannot take the risk without assurances. One, small mom & pop loses \$640,000 in revenue, its existence, and damages the lives of 17 people and each of their family members.

Multiply this effect by the hundreds of businesses with now thousands of employees and families linked to this regulated marketplace. Study the loss of fully funded healthcare, contributions to the unemployment insurance market, workman's comp insurance payments, Medicare and Social Security incomes contributed to the state for all its residents. This is a catastrophe in the making.

I beg our leaders to not move forward on SB1009. There are too many lives in the way of its reckless, unstudied path.

Let's explore and commit to a different path. Here is an example of a simpler and more direct solution to this problem: A) enforce the current law which already prohibits sale to those under 21. B) using effective legislation, partner and empower the police to make sure compliance with the current sales laws are enforced. C) create addendums to the current laws and prohibit the general distribution of cigarettes by anyone other than non-licensed & regulated vendors. In other words, dissuade the people who are physically putting cigarettes into the hands of those under 21.

Let the police dept earn back the public trust by doing public benefit and empower them with the opportunity to enforce the current laws by: a) hiring more people for our police force, b) offering them effective training & support and c) increased the current penalties for those who place tobacco in the hands of minors.

There is a better way to accomplish the goal of ending youth smoking, but SB1009, as written, is not the way. It requires too much innocent, human collateral & will send those keiki we want to save, into more dangerous, untouchable arms.

Before we send all these people, including myself and my family, into an irretrievable situation, let's stop, rethink the situation and find another less destructive and more effective path to change. If we work together and support each other, rather than criminalizes and vilify those of us who can make the change possible, we will find doable solutions achieve measurable results.

SB1009 is a law of good intention, but will NOT achieve the goal of better health for all. Its methods will be harmful and lethal to us in other critical ways. We must not support this bill. Please leave SB1009 behind and develop a transition plan of less collateral and catastrophic cost.

Good morning Chairperson Rhoads and members of the Senate Committee on Judiciary. I am Tina Yamaki, President of the Retail Merchants of Hawaii and I appreciate this opportunity to testify.

The Retail Merchants of Hawaii (RMH) as founded in 1901 and is a statewide, not for profit trade organization committed to the growth and development of the retail industry in Hawaii. The retail industry is one of the largest employers in the state, employing 25% of the labor force.

We OPPOSE SB 1009 SD1 Relating to Flavored Tobacco Products. This measure would ban the sale of flavored tobacco products effective 1/1/2020.

This bill would essentially ban all electronic vapor products and e-liquids, compel people to purchase these goods online or try to make it themselves and essentially force many small local businesses who sells these items to shut down, thus leaving many of our family, friends and neighbors out of work.

Currently Hawaii has a law in place that states that it is unlawful for a person under the age of 21 years to purchase electronic vaping devices, e-liquids and tobacco products. However adults that are 21 and older are able to purchase these items and enjoy their electronic vaping device with their favorite flavored e-liquid.

Furthermore, every electronic vaping device and e-liquid available worldwide is "flavored." Because they do not contain tobacco, electronic vaping devices has no "natural tobacco" taste, or any taste for that matter, without the addition of flavorings. These flavored e-liquids are enjoyed by many adults.

In addition, vapor products and e-liquids are NOT the same as a tobacco product. Many electronic vaping devices contains NO tobacco and NO smoke is emitted when vaporized. The New England Journal of Medicine published an article recently that found that electronic vaping devices were nearly twice as effective as conventional nicotine replacement products, like patches and gum, for quitting smoking. The study was conducted in Britain and funded by the National Institute for Health Research and Cancer Research UK.

Kapi'olani Smokefree Families, the tobacco & nicotine cessation program at Kapi'olani Medical Center for Women & Children, **strongly supports SB 1009 to ban the sales of flavored tobacco products in Hawaii.**

At Kapi'olani Medical Center for Women & Children, we often see pediatric patients who are adversely affected by tobacco products in multiple ways. There are babies in the NICU (neonatal intensive care unit) who were born early due in part to the effects of smoke exposure during pregnancy. We see young children routinely coming in with asthma and ear infections because they are being exposed to secondhand and thirdhand smoke. Now, we have teenagers and young kids who are screening positive for e-cigarette or vape use.

One of the biggest concerns with e-cigarettes is the lack of longitudinal studies on health and safety of these products. It took decades for the harmful side-effects of combustible cigarettes to become well-known, and we do not want our youth to be the ones to suffer from any potential health effects of e-cigarettes or vape products.

Initiation of e-cigarette use is almost always associated with a flavored product. Studies have shown that flavored tobacco-use is particularly enticing to youth. The e-cigarette and vape companies use attractive packaging and flavors that are very similar to candy products and sweets that are easily recognizable by children and teens. These flavors include common candies like cotton candy, sweet tart, blue raspberry, and even local Hawaii-inspired flavors like POG (passion orange guava), Hawaii Sweet Roll, and Pele's Papaya.

In the best interest of our local youth, we would like to **request the ban of flavored tobacco products** that have been enticing to the youth. Thank you for the opportunity to provide testimony on this measure.


The American Heart Association supports SB 1009, SD1 "Relating to Flavored Tobacco Products."

The 2014 Surgeon General's Report projects that if current trends continue, 5.6 million of today's youth under 18 will die prematurely in adulthood from smoking-related illness. To protect this vulnerable population, policymakers need to move quickly and ban the use of characterizing flavors, including menthol, from all tobacco products.

The evidence supporting a flavor ban is clear. As we discuss below, flavored tobacco products are highly attractive to youth and have led to increased initiation and use among children and adolescents. The number of flavored products on the market has also increased substantially with the tobacco industry marketing thousands of fruit, candy, and mint flavored products that appeal to children. Allowing these products to remain on the market puts a new generation at risk of a dangerous addiction.

While we understand that some adult tobacco users report using flavored products to transition or switch from combustible cigarettes, there is little evidence supporting their use as a cessation tool. In addition, there is some evidence that flavored tobacco products have enticed adult never smokers to try tobacco for the first time – just as they have with children. We encourage legislators to make protecting children its top priority when considering legislative options for flavored tobacco.

AHA feels that a blanket flavoring ban is needed because a wide array of flavors appeal to youth and young adults, which increases the risk of initiation and continued tobacco use. Also, many of the flavorings, including some of the most popular, contain known toxins. We believe this would make it extremely





difficult to identify specific flavors to ban. Studies show that menthol cigarettes increase initiation, especially among youth.

The number of flavored tobacco products on the market increased substantially after flavored cigarettes were banned. After the 2009 federal ban on flavored cigarettes took effect, the tobacco industry started producing different types of flavored tobacco products that were not subject to the prohibition. This lead to the rise in in the number of youth using flavored cigars, and especially in Hawaii, e-cigarettes. Both the tobacco industry and youth adjusted to the cigarette ban by moving to other tobacco products where flavors were still allowed. If the legislature were to pass a flavoring ban, but limit it to certain types of products or flavorings, we are likely to see the same thing happen again.

The availability of flavors is one of the main reasons youth and young adults use ecigarettes and other noncombustible products. If the legislature wants to decrease youth tobacco use, removing flavors from noncombusted products is key. In addition, current smokers will be motivated to move to noncombusted products – even if they are unflavored – when the nicotine content in cigarettes is reduced through federal regulation.

In Hawaii alone, tobacco use claims 1,400 lives each year and creates \$526 million in annual health care costs directly caused by smoking (\$141.7 million of that is covered by the state Medicaid program). Hawaii residents' state & federal tax burden from smoking-caused government expenditures is \$836 per household. Hawaii's estimated tobacco tax revenue, estimated to be approximately \$110 million per year, does not come close to offsetting the losses to the state caused by tobacco use. Smoking declines caused by state cigarette tax increases directly reduce these smoking-caused economic burdens for all taxpayers, and Hawaii businesses which bear the brunt of employee healthcare costs in our state.

Those who might quit tobacco addiction as a result of a comprehensive flavor ban would then have additional money to spend on taxable products that don't result in over a \$500 million in healthcare costs to the state. The money doesn't go up in smoke or vapor; instead it will likely be spent on more productive things that can benefit the smokers' and/or their families and our state.

It's time to end the use of candy flavors and menthol to entice our children into a deadly addiction.

I humbly ask you to consider creating a WORKING GROUP including LOCAL small businesses that are impacted by this and other legislation to come up with appropriate policies to ensure that our keiki are not going to use e-cigarettes. Speaking with many local small mom & pop vape shops, it is clear that NO ONE wants our under-age youth to vape and they are eager to work with organizations like the DOE and other proponents to address youth vaping. Banning electronic devices and e-liquids will NOT solve the problem. Kids will still be able to access these through the internet because most of the small businesses do not sell on the internet. Banning e-cigarettes/e-liquid will only hurt our local small businesses.

1. NOT ALL E-LIQUIDS CONTAIN NICOTINE

I started at the highest level of nicotine (over 24 mg) and am now at ZERO nicotine. If you ask many of the local vape shops, their biggest sellers are 0 and 3 mg.

In 2018, the Student Health Advisory Committee also actively supported passing the law prohibiting the use of tobacco products on all 10 UH campuses and university-owned facilities. We remain deeply committed to the mission of reducing the use of tobacco products, including electronic smoking devices, among adolescents and young adults.

Electronic cigarettes are now the most commonly used form of tobacco among youth in the United States, surpassing conventional tobacco products, including cigarettes, cigars, chewing tobacco, and hookahs. According to the Centers for Disease Control and Prevention, e-cigarette use among adolescents has increased considerably, growing an astounding 900% among high school students from 2011 to 2015. The sale

of candy-like flavored tobacco products entices minors to start using these harmful products which may cause addiction, lead to dual use of combustible cigarettes and vape products and to damage of the developing adolescent brain. The banning of flavored tobacco products is an imperative next step in tobacco control, if we are committed to protecting the health of adolescents and young adults in Hawaii.

Strong Support of SB1009, Relating to Flavored Tobacco Products

As a public health advocate, I cannot agree more with the Youth Council on this subject of banning flavored tobacco/nicotine products.

We, as the responsible adults in our "family" that is the State of Hawaii, must stand up for our children and young people. The industry says it wants to keep tobacco out of the hands of our children, but they don't want to do anything about it. The surest proof that candy-flavored tobacco is infiltrating our schools is from the DOE. With 168,000 young people in our schools and with 42% of all high school students and 27% of middle schoolers reporting ever having used an "electronic vaping product" in 2017, we have an urgent need to act. All our young people deserve protection from a lifetime of addiction.

In addition, the industry claims they're not targeting our youth, but their actions tell a different story. With 15,500 flavors and growing, these products are not being responsibly marketed. Candy flavors such as Fruit Hoops, Sour Straws, and Cookie Monsta are designed to appeal to our children, and make nicotine go down easier. The packaging and ads are attractive, and the products smell and taste good. All of these help to hook our youth and make them repeat customers. Addiction is the opposite of freedom. We're fighting to keep our children free from the deadly addiction to these products. The health of Hawaii's keiki must be protected from the predatory marketing of tobacco companies.

Included in the flavor ban would be menthol which has cooling properties that mask the harshness of tobacco smoke and nicotine, making menthol cigarettes another popular starter product. The tobacco industry has a long history of marketing menthol cigarettes to youth and vulnerable groups, such as the African American community. In Hawaii, 78% of Native Hawaiian and Pacific Islander smokers use menthol cigarettes. In the Philippines, market share of menthol cigarettes was 55%. The consequences of this are while nicotine and tobacco addiction are deadly for everyone, Native Hawaiians and Filipinos die at higher rates of lung cancer than other groups.

Although some adults claim ESDs have helped them to "quit", ESDs are not FDA-approved tobacco cessation products. We have yet to see any scientific evidence, beyond anecdotal data, that e-cigarettes have helped smokers to quit completely from tobacco use. The issue is with the aggressive and deceptive marketing of these products, we're seeing other things happening: 1) people who have never smoked are using e-cigarettes, 2) children are picking them up as a path to smoking, and 3) smokers are using them to perpetuate their habit instead of to completely quit. Even more troubling is because of the historic declines in smoking, big tobacco has decided to focus on candy flavors and nicotine delivery solutions. Tobacco giant Altria, maker of Marlboro, is investing in the popular vaping company Juul, which has 76% of the e-cigarette market share and is worth \$16 billion.

If Hawaii's tobacco stores are truly supportive of keeping the community healthy, then they must be fine offering products for sale other than cotton candy or gummy worm-flavored e-juice. Our residents are proud to support local, but not when these products directly contribute to the youth vaping epidemic. If we don't remove candy flavors, the cost to our kids will be a lifetime of addiction to tobacco.


