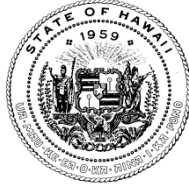

The Department of Transportation (DOT) **supports** S.B. 1378, S.D. 1, H.D. 1.

This bill allows an owner of a shipping container chassis to keep a duplicate copy of the certificate of registration within the shipping container chassis provided that the original certificate of registration is available for inspection at the principal place of business.

We believe that this bill affords the owner of the shipping container chassis the ability to protect the original registration from being lost, damaged or stolen and provides accessibility for its inspection for verification at the principal place of business should the need arise.

Aloha Chair Luke and committee members. I am Gareth Sakakida Managing Director of the Hawaii Transportation Association (HTA) with over 375 members involved with the commercial ground transportation industry.

HTA supports this bill.

A shipping container undergoes tremendous hardships in their normal working environment. They are subject to contact with towing equipment, other containers, and anything else it may be in proximity to. They are constantly exposed to weathering: salt air spray, blazing sun, and pouring rain.

In short, containers take a beating and whatever receptacle houses its' legal documents face the same conditions. It is too perilous an existence to trust such valuable legal documents to.

Dear Chair Luke, Vice Chair Cullen, and Members of the Committee on Finance,

Matson strongly supports SB1378, SD1, HD1 Relating to Transportation.

A shipping container chassis is a wheeled frame that is designed to carry a shipping container over the road. It is a simple device composed of a steel frame, tires, brakes, and a lighting system. Typically, a container is loaded to a chassis and then hooked up to a truck, which delivers the container. Matson owns the chassis but does not own the truck that hauls the container and the chassis.

Currently, owners of shipping container chassis must keep the original copy of the chassis registration with the chassis. Chassis do not contain compartments that allow for storage of registration documents. In addition, it is unfeasible to keep a copy of the chassis registration in a truck because Matson does not assign specific shipping container chassis to specific trucks to ensure containers are able to move in the most efficient manner. While Matson has tried to secure the original copies to the chassis, it is very impractical because of the chassis design.

This measure enables owners of the chassis to keep the original copy of the chassis registration in the principal place of business for inspection. This provision is similar to allowing rental car companies to keep the original copy of the motor vehicle registration available for inspection at the principal place of business. This measure also makes it clear that owners of shipping container chassis are not required to keep copies of the chassis' registration, motor vehicle identification card, certificate of insurance, and certificate of inspection on the chassis itself, which completely addresses the problems that arise from being required to keep documentation on the chassis itself.
