1 **Fiscal Implications:** Unspecified general fund appropriation.

2 **Department Testimony:** The Department of Health (DOH) takes advantage of mandatory and

3 discretionary grants to help fulfill the mission of protecting and improving the public's health. In

4 addition to prevention and wellness, DOH grant-funded programs also address social welfare and

5 human services programs such as the Women, Infants, and Children program, Supplemental

6 Nutrition Assistance Program, early intervention services, children with special health needs, and

7 developmental disabilities-related programs.

8 The federal agencies with which DOH works are numerous and include the US Centers for

9 Disease Control and Prevention, the US Environmental Protection Agency, the US Substance

10 Abuse and Mental Health Administration, the US Health Resources Services Administration, the

11 US Agency on Aging, the US Department of Agriculture, the US Centers for Medicare and

12 Medicaid Services. Private foundations like the Robert Wood Johnson Foundation, Pew

13 Charitable Trusts, and others also offer funding opportunities.

14 Dedicated capture managers, as proposed by SB529 SD2, would likely increase federal funds

and private funds into the State of Hawaii and improve the department's overall effectiveness. A

16 pilot is an appropriate means to test the hypothesis and report findings.

- 1 DOH respectfully requests an appropriation of \$100,000 in general funds to establish the
- 2 temporary exempt position for three years, including other administrative costs associated with
- 3 operations, fringe benefits, and evaluation services.
- 4 Please note that since this request is unbudgeted, any appropriation should not supplant priorities
- 5 in the Executive Budget Request. Thank you for the opportunity to testify.

DEPARTMENT'S POSITION: The Department of Human Services (DHS) supports this bill and appreciates the amendments made by the Committees on Commerce, Consumer Protection, & Health, and Human Services establishing a three-year full-time temporary exempt position for the duration of the pilot plus one year to develop internal capacity, to provide support to the grant successfully obtained, and to develop a sustainability plan to support a robust development program.

DHS requires an appropriation of \$100,000 in general funds to establish the temporary exempt position for 3 years, including other administrative costs associated with grants development and evaluation. DHS considers a salary range of \$80,000 – \$85,000, with additional funds for IT, data analytics, training, travel, and other fees. DHS requests that this appropriation not supplant any fiscal priority identified in the Executive Budget.

DHS also offers comments that the term "human services" also commonly referred to as "social services" describes a broad range of services that may include: education, income transfer, health, housing, employment-training, and personal social services. The National Organization for Human Services describes "[t]he field of Human Services is broadly defined, uniquely approaching the objective of meeting human needs through an interdisciplinary knowledge base, focusing on prevention as well as remediation of problems, and maintaining a commitment to improving the overall quality of life of service populations."

PURPOSE: The purpose of the bill authorizes the Department of Humans Services and the Department of Health to contract the services of dedicated capture managers responsible for securing grant and other funding opportunities for each department. Appropriates funds.

DHS actively pursues grant or technical assistance opportunities that support the department's transformation to become an integrated multi-generational human services delivery system. Having a person dedicated to designing, applying, and coordinating applications would be a benefit for the department, the workforce, and ultimately our recipient population.

Chairs Mizuno And San Buenaventura and Members of the Committees:

The Department of the Attorney General provides the following comments.

This bill would establish contracted and temporary exempt positions within the Department of Human Services and the Department of Health for the purpose of securing grants and other funding opportunities from public and private sources on behalf of their respective departments.

Article III, section 14, of the Hawaii State Constitution provides in relevant part that "No law shall be passed except by bill. Each law shall embrace but one subject, which shall be expressed in its title." Thus, a bill that addresses subjects outside its single subject title violates article III, section 14, of the Hawaii State Constitution.

Here, the title of the bill properly refers to one subject, human services, and section 2 authorizes the Department of Human Services to establish a three-year temporary full-time exempt position and to contract for a grant capture manager, and sections 3 and 4 appropriate funds to the Department of Human Services. The bill goes beyond the single subject in sections 5, 6, and 7, by authorizing the same positions and appropriations for the Department of Health. Because the Legislature has created two separate departments - the Department of Health and the Department of Human Services - and tasked each with distinct roles, the bill may be subject to challenge as violative of article III, section 14, of the Hawaii Constitution.

In order to avoid any potential legal challenges, we suggest that the bill be amended to delete references to the Department of Health in section 1, and delete sections 5, 6, and 7 in their entirety.

In the alternative, wording could be added to section 1 of the bill that would help to justify how the grant opportunities and activities of the Department of Health are considered human services rather than simply health services. This would reduce (but not eliminate) the possibility of a successful legal challenge by making clear that the contents of the bill in regard to the Department of Health are clearly related to the subject of the title - human services.

We respectfully ask the Committee to make the suggested changes if this bill advances. Thank you for the opportunity to provide these comments.

Chair Mizuno, Chair San Buenaventura, and Members of the Committee:

The Hawaii Primary Care Association (HPCA) is a 501(c)(3) organization established to advocate for, expand access to, and sustain high quality care through the statewide network of Community Health Centers throughout the State of Hawaii. The HPCA <u>SUPPORTS</u> Senate Bill No. 0529, Senate Draft 2, RELATING TO HUMAN SERVICES.

The bill, as received by your Committee, would:

- (1) Authorizes the Department of Human Services (DHS) and the Department of Health (DOH) to each contract a grant writer to serve as a capture manager for their respective Departments;
- (2) Require DHS and DOH to report to the 2020 and 2021 Legislatures lists of grant or funding opportunities sought or applied for, grants awarded and funding received, and recommendations and proposed legislation;
- (3) Appropriate an unspecified amount of general funds for fiscal year 2018-2019 to contract the services of a dedicated capture manager for DHS and DOH;
- (4) Provide that the appropriations authorized not lapse and the end of the fiscal biennium but that unencumbered funds shall lapse as of June 30, 2022; and
- (5) Take effect on July 1, 2050, and sunset on June 30, 2022.

Federally Qualified Health Centers (FQHCs) provide desperately needed medical services at the frontlines in rural communities. Long considered champions for creating a more sustainable, integrated, and wellness-oriented system of health, FQHCs provide a more efficient, more effective and more comprehensive system of health.

Because the majority of our patients are Medicaid recipients, reimbursement for services provided at FQHCs is extremely complex given the multiple streams of funding received from the federal and State governments. The availability of funding is often volatile due to changes in federal and State laws as well as the manner in which these laws are implemented and enforced. In this environment, it is not only prudent but necessary for the State to seek new sources of funding and devise creative ways of capturing and securing resources.

Accordingly, we **<u>SUPPORT</u>** this measure and urge your favorable consideration.

From a technical perspective, we note that this bill is substantively similar to a measure that the HPCA supported last year -- Senate Bill No. 2526, RELATING TO HUMAN SERVICES. It should be noted, however, that Senate Bill No. 2526 did not include language that would have established a grant writer position within the DOH.

The HPCA agrees that the establishment of such a position within the DOH services the public good. We therefore fully support the Senate Bill No. 529, as it is presently drafted.

Should concerns be raised as to whether the inclusion of the DOH language goes beyond the scope of the bill's title, RELATING TO HUMAN SERVICES., we urge this Committee to seek guidance from House attorneys to ensure that such a measure will pass muster.
