## Statement of LEO R. ASUNCION

Planning Program Administrator, Office of Planning before the

in consideration of SB 908, SD 2, HD 1 RELATING TO SUSTAINABILITY.

Chair Luke, Vice Chair Cullen, and Members of the House Committee on Finance:

The Office of Planning supports SB 908, SD 2, HD 1, provided that its passage does not replace or adversely impact the priorities indicated in the Executive Budget. SB 908, SD 2, HD 1, establishes a Statewide Sustainability Division within the Office of Planning to ensure long-term planning, coordination, and implementation of Hawaii's sustainability goals and policies.

It is the Office of Planning's intent that the Sustainability Coordinator position will serve as the administrator of this proposed Statewide Sustainability Division, and the corresponding staff proposed in this measure will serve under the management of the Sustainability Coordinator.

Pursuant to Hawaii Revised Statutes (HRS) § 226-108, the Sustainability Priority Guidelines and Principles of the Hawaii State Planning Act, and the Supplemental Appropriations Act of 2016, the Office of Planning filled a new Sustainability Coordinator position in June 2017 to provide statewide sustainability planning, coordination and collaboration for the implementation of Hawaii's many sustainability goals and policies.

This sole Sustainability Coordinator position recently assisted the Hawaii State Auditor's Office on behalf of the Office of Planning to provide and publish a statewide measurement update to the Hawaii 2050 Sustainability Plan, pursuant to an unfunded decennial update requirement established through Act 8 Special Session Laws of Hawaii 2005, as amended by Act 210, Session Laws of Hawaii 2006. Published in March 2018, the ten year measurement update of the Hawaii 2050 Sustainability Plan, the first of its kind over the past decade, reviewed the data collected over the course of ten years and evaluated the metrics and indicators measuring Hawaii's progress toward sustainability according to the Hawaii 2050 Sustainability Plan's original 5 goals, 9 "2020 benchmarks," 22 strategic actions, and 55 indicators.

The State of Hawaii has lacked a permanent governmental sustainability coordinating entity to assist with the implementation of the Hawaii 2050 Sustainability Plan and the State of Hawaii's numerous sustainability goals and policies. SB 908, SD 2 establishes a stronger legal framework to focus on the planning, coordination, and collaborative implementation of Hawaii's long-term sustainability to serve as a foundation for the State of Hawaii's sustainability policies in addition to the Hawaii State Planning Act's Sustainability Priority Guidelines and Principles set forth in HRS § 226-108.

Additionally, the recent update of the 2018 State of Hawaii's Multi-Hazard Mitigation Plan recommended to "develop a sustainability program at the state-level, headed by the Sustainability Coordinator. Currently the Sustainability Coordinator is funded, but has no operating budget. Task coordinator with developing the program, establishing a clearing house for sustainability information and initiatives, coordinate with departments and agencies, and track implementation of projects and programs."

SB 908, SD 2, HD 1, establishes a governmental sustainability coordinating entity within the State's Office of Planning and provides the necessary staffing and operating expenses to support comprehensive statewide sustainability coordination with recognized responsibilities and authorities to develop, coordinate, and support the implementation of Hawaii's sustainability goals, priorities, and planning throughout government.

The Office of Planning finds that SB 908 is complimentary and consistent with the purpose of the Office of Planning found in HRS §225M-1, as follows:

"The purpose of this chapter is to establish an office of planning to assist the governor and the director of business, economic development, and tourism in maintaining an overall framework to guide the development of the State through a continuous process of comprehensive, long-range, and strategic planning to meet the physical, economic, and social needs of Hawaii's people, and provide for the wise use of Hawaii's resources in a coordinated, efficient, and economical manner, including the conservation of those natural, environmental, recreational, scenic, historic, and other limited and irreplaceable resources which are required for future generations.

The establishment of an office of planning in the department of business, economic development, and tourism, for administrative purposes, is intended to:

- (1) Fix responsibility and accountability to successfully carry out statewide planning programs, policies, and priorities;
- (2) Improve the efficiency and effectiveness of the operations of the executive branch;
- (3) Ensure comprehensive planning and coordination to enhance the quality of life of the people of Hawaii."

**Ulupono supports SB 908 SD 2 HD 1**, which establishes a statewide sustainability division within the Office of Planning to ensure long-term planning, coordination, prioritization, and implementation of Hawaii's sustainability goals and policies.



On behalf of the U.S. Green Building Council (USGBC), our nearly 9,000 member companies nationwide, and our strong community in Hawai'i, we appreciate the opportunity to provide this letter of support for Senate Bill 908/SD2 HD1, regarding establishing and funding a statewide sustainability division.

USGBC and LEED in Hawai'i

USGBC is a nonprofit organization committed to transforming the way all buildings and communities are designed, built, and operated to support a more sustainable, resilient, and prosperous environment that improves the quality of life for all.

Our flagship green building rating system, LEED, is a critical tool that has been proven effective at creating high performing buildings in Hawai'i, with industry stakeholders, including building owners, developers, and tenants. In fact, Hawai'i again made our list of the Top 10 States for LEED this year, with projects such as the Hawai'i Convention Center (awarded Gold, LEED v4 Operations and Maintenance). LEED continues to grow in the Hawai'i market, with over 200 certified projects amounting to more than 19 million square feet in total. Moreover, high performing green building creates opportunities for the creation of quality, local jobs.

SB908 will Benefit Hawai'i Sustainability and Resilience

We support this bill, and the establishment of a statewide sustainability division within the Office of Planning to ensure long-term planning, coordination, and implementation of Hawaii's sustainability goals and policies. Providing structure, funding, and permanence to this office is critical to ensure that policies are coordinated and efficient.
