SENATE BILL NO. 3040 RELATING TO PESTICIDES

Chairperson Gabbard and Members of the Committee:

Thank you for the opportunity to testify on Senate Bill 3040 that will require that the Department of Agriculture prepare and submit an annual report to the legislature no latter than twenty days prior to the convening of each regular session. The proposed bill also provides for increased fines for administrative and criminal penalties.

For this proposed bill the Department provides these comments. The Department currently produces quarterly and annual reports to EPA under which much of the proposed reporting requirements are covered. The reports are quite detailed and comprehensive and do focus on compliance inspections including, complaints, market surveillance inspections (pesticide products licensed to sell in Hawaii), certified applicator recordkeeping requirements (for Certified Applicators of Restricted Use Pesticides), Worker Protection Standard, and pesticide use inspections in general. Those records also include any issues that are associated with endangered species and critical habitats, high level episodes, and water quality compromise. Because pesticide use is quite common across the economic landscape the reports also include information on inspections of non-agricultural applications, fumigations, Restricted Use Pesticide Dealer establishments, Producer Establishment inspections, and



Experimental Use Permit inspections. Because each inspection is unique the amount of time it takes to complete an investigation that stems from an inspection can vary widely. Some complaints can be resolved in a matter of hours but others, due to the scope of the investigation, can take weeks. All inspections are currently reviewed by case developers and are formally closed if no violation is determined. In the case of suspected violations, the case developers present the details for legal review and determination of the appropriate penalty. All inspections the Department conducts are done under complete confidentiality. Releasing locations of the inspections could violate that confidentiality and disclose private information, not only for the one for which the complaint has been lodged but also for the complainant.

We are supportive of the increase in fines for violations of the Pesticide laws.

Providing additional teeth for enforcement could be persuasive for applicators to make smart legal decisions when using pesticides if the penalty is severe enough.

Chair Gabbard and Members of the Committee:

I am Tim Lyons, Executive Director of the Hawaii Pest Control Association, an association composed of pest control operators who perform structural pest control operations. We are opposed to this bill.

Our oppositions lies in the fact that we think it is not a "balanced" bill. If it were, the annual report which contains the information called for in the bill, would call for a complete picture of the information. As an example, in item number four (4), on page four (4), information is specified as that which is the outcome of pesticide inspections including any enforcement actions taken, however it should also include those inspections where no violation was found.

Additionally, we believe there should be an item number six (6), which should read something to the effect of "[T]he benefit that each application resulted in, including the pest controlled, the damages curtailed, the adverse health effects prevented and the products or services which were saved or maintained".

We also find that the increase in the fines are drastic. The majority of pest control operators are small businesses, some which are "one man shows" or with two (2) or three (3) employees. There must be a less painful way of putting them out of business other than hitting them with a \$10,000.00 fine. The current \$5000.00 fine would be difficult enough to overcome. We realize that the language in the bill calls for "not more than" \$10,000.00 and we realize that there is language regarding considering the size of the business however, that is just general instructional language without any real structured application.

Lastly, we would have similar comments as to the increase in the fines from \$25,000.00 to \$35,000.00 and think that those are <u>outrageous</u> except for in the most <u>outrageous</u> of cases, however we don't find anything in this language that dictates a mitigation of this application.

We have also not heard of cases or situations where the current fines have been insufficient.

Based on the above, we oppose passage of this bill.

My name is Jun Shin. I am a Sophomore at the University of Hawai'i at Mānoa. I am the Environmental Justice Action Committee Chair for the Young Progressives Demanding Action (YPDA). YPDA advocates for public policies that reflect the values of young people throughout the State of Hawai'i. YPDA is in **Strong Support** of **SB3040**, Relating to Pesticides, which would require the Department of Agriculture to provide annual reporting on pesticide inspection and compliance investigations. Increases monetary fines for pesticide violations.

YPDA was a part of the coalition that supported the passage of Act 45 in 2018. One of the reasons for doing so was due to our continued dedication to our keiki and their future in our advocacy, striving to create a better world for them. It is for the sake of future generations that we need to demand further accountability and meaningful enforcement of our pesticide laws. We deserve to live in healthy communities where we don't have to live in fear of pesticide drift.

For years now there have been incidents, notably in Kaua'i, Maui and Moloka'i in which toxic (and banned) pesticides have drifted into schools, communities, and even our environment in our lands and our waters. This is a serious public health issue. Article XI Section 9 of the Hawai'i State Constitution makes it very clear that, "Each person has the right to a clean and healthful environment, as defined by laws relating to environmental quality, including control of pollution and conservation, protection and enhancement of natural resources." These constitutional rights are not being protected and as a result, in

November of 2019 we saw Monsanto now Bayer pled guilty and paid \$10 million as part of a plea agreement with the United States Environmental Protection Agency for illegally using the banned pesticide Penncap-M on Maui and Molokai. This could have been avoided, and SB3040 seeks to address this.

What SB3040 is trying to do is important. In the past, pesticide fines were either not enough or were significantly reduced. Even Bayer's \$10 million plea agreement doesn't cover how much damage has already been done prior to the environment, to the community, and the field workers. Pesticide fines will be increased and to ensure the Department of Agriculture is doing their part to investigate, inspect, and enforce, they will also need to submit annual reports to the legislature.

Many other communities have successfully transitioned away from toxic pesticides to organic land management practices, we can do that by starting here with keeping violations in line. Please protect our keiki and the communities they live in. Young Progressives Demanding Action is in **Strong Support** of **SB3040**. We respectfully ask for you to pass it through your committee.

Dear Chair Gabbard

On behalf of the Western Plant Health Association (WPHA), I am writing to express our **opposition** to SB 3040, which would increase fines for pesticide violations and substantially increase reporting requirements on the Hawaii Department of Agriculture (HDOA). WPHA represents the interests of fertilizer and pesticide manufacturers, agricultural biotechnology providers, and agricultural retailers in Hawaii, California, and Arizona.

WPHA appreciates the author's interest in assuring the safe use of pesticides to protect the public and environment. We understand that while the intent of the bill is that by increasing fines for pesticide violations, growers and applicators will be more attentive in their use of pesticides. However, we believe this bill is unnecessary and will result in higher costs to farmers.

SB 3040 would dramatically increasing fines for pesticide violations, including increasing potential fines for misdemeanors to \$35,000. WPHA is concerned that requiring the Hawaii Department of Agriculture (HDOA) to increase penalties for any first-time violations or misdemeanors will result in fewer individuals contacting HDOA for guidance on the use of a product. We believe that one of the strengths of regulatory agencies like HDOA is their ability to act as an educational tool for the regulated community. If growers and distributors believe they could be putting themselves at risk of substantial fines for misdemeanors, they will be less willing to reach out for the educational expertise that HDOA can provide. WPHA could understand the rational for increased fines if there were any indicators of a growing trend of violations by applicators or agricultural users. WPHA is unaware of any increase in the number of violations by

agricultural users, or failures by growers or applicators to observe pesticide rules. WPHA is opposed to increasing fines without a justification of need.

SB 3040 would also mandate the HDOA annually compile a comprehensive report that would include the number of inspections, violations, investigations undertaken and the number completed – including a description of each inspection and investigation. WPHA believes this will result in a tremendous cost increase to HDOA. HDOA is currently finalizing a new reporting mandate for restricted use pesticides that was passed by the legislature just two years ago. We believe it is premature to require additional reporting requirements on HDOA while they are seek to finalize the legislatures current reporting mandates. WPHA believes that this additional requirement will require HDOA to redirect resources that could be better spent on actual educational and enforcement efforts with growers and the public. Additional mandates for reporting should not be required unless additional resources are allocated by the legislature to HDOA for this requirement.

We believe increasing fines without a demonstration of need sends a false message about compliance by growers and applicators of pesticide use rules. Requiring additional reporting mandates on HDOA without any demonstrated need for additional reports and without additional financial support from the legislature will negatively impact HDOAs ability to fulfill their educational and enforcement mission. For these reasons we **oppose** SB 3040 ask for your **no** vote. WPHA thanks you for your consideration of our comments and welcomes any questions you may have.

Aloha Honorable Senator's Gabbard and Rudermann + Committee on agriculture and environment,

I support raising fines for pesticide violations and I support SB 3040!

Too often pesticide violations are considered an acceptable "cost of doing business" by large industrial operations. These violations are a threat to our keiki, farmworkers and the public in general. The current low fine threshold does not create a sense of urgency to change behavior and stop repeat violators.

The low fine threshold is a lost opportunity for the department of Agriculture to obtain the funds they need to better implement their programs and new laws around pesticide use in Hawai`i.

I support transparency in the process and the reporting associated with pesticide violations. The community deserves the right to know how complaints are being addressed and what the result of the investigations were.

### **Background & Details**

Illegal use of pesticides threatens to harm adjacent, non-target species, and contributes to short and long-term contamination of the state's soil, air and waters. Despite these risks, pesticide misuse has, and continues to occur within the State.

The current state fines for pesticide use violations are only a maximum of \$1,000 dollars for individuals and \$5,000 for commercial applicants. Even in cases where the commercial applicant knowingly violates pesticide labels and laws the maximum state fine is currently only \$25,000. SB3040 would propose to change the maximum allowable fines to \$5,000 for an individual, \$10,000 for a commercial applicator and \$35,000 for a commercial applicant that knowingly violates.

SB 3040 is a step in the right direction but still a relatively small increase compared to the costs involved with misuse of pesticides and the federal fine limits. State fine limits

could be increased to much higher values then even the increase proposed in this measure. The EPA has the ability to fine pesticide violators millions of dollars and even then they often end up paying a fraction of the maximum, or originally issued fine.

In cases, such as the 2016 and 2017 Syngenta (Kaua'i) failure to adhere to pesticide use instructions, exposing farmworkers to the (now banned) neurotoxin pesticide chlorpyrifos and injuring their health or the very recent Monsanto/Bayer guilty plea regarding their illegal use of the banned pesticide Penncap-M on Maui and Molokai, the state should have had the ability to issue a fine that is reasonable and representative of the crime, especially considering they are multinational chemical corporations. Bayer profited over \$13 BILLION dollars in 2019. Yet, the maximum the state could have fined them for this severe violation would have been \$25,000.

Exposure to Penncap-M has been linked to impaired neurological development in the fetus and in infants, chronic fatigue syndrome, and Parkinson's disease. What is the fine amount that matches the true cost of the impact to the health and life of our people? The maximum allowable state fines should be raised to represent the full damages to our communities and environments and the exposed workers in the fields.

I pray that because your record has been so incredible, that you will continue to see the justice for the citizenry and families of Hawaii & enact this critical measure that simply enforces health safety we've already fought so hard to attain,

## SB 3040, RELATING TO PESTICIDES

FEBRUARY 12, 2020 - SENATE AGRICULTURE AND ENVIRONMENT COMMITTEE - CHAIR SEN. MIKE GABBARD

**POSITION:** Support, with amendments.

**RATIONALE:** IMUAlliance supports and suggests an amendment for SB 3040, relating to pesticides, which requires the Department of Agriculture to provide annual reporting on pesticide inspection and compliance investigations, and increases monetary fines for pesticide violations.

In the debate over regulating local agriculture, there is one thing that everyone should agree to condemn: causing harm to other people. Unfortunately, Hawai'i's pesticide code allows chemical abuse to go unchecked. Today, the State Department of Agriculture must warn pesticide abusers before investigating potential legal violations. A farm that fails to take caution when using harmful chemicals, then, may suffer no consequences for its actions, since the warning gives owners time to hide evidence of their crimes. Even when caught, chemical criminals face minimal penalties. State law currently grades pesticide abuse as a merely a misdemeanor offense, meaning farm operators who apply dangerous doses of chemicals face a maximum one-year prison sentence.

In the islands, pesticide abuse poses major health risks. According to an investigation conducted by the *Cascadia Times*, pesticide application by four large agrichemical companies on Kaua'i—Syngenta, BASF Plant Science, DuPont Pioneer, and Dow AgroSciences—is ten times the national average. In their report, *Cascadia* found that a number of restricted use pesticides were overused, including chlorpyrifos, atrazine, and paraquat. A study published in the medical journal *The Lancet* 

*Neurology*, in March of 2014, found that the neurotoxin chlorpyrifos led to developmental disabilities in children. Similarly, atrazine and paraquat are banned in the European Union. Atrazine is known to contaminate groundwater supplies, while paraquat has been linked to the onset of Parkinson's disease. Yet, both herbicides remain widely popular in the United States, where the Environmental Protection Agency prematurely declared with "reasonable certainty" that neither carry a significant risk of harm.

Pesticide abuse is not limited to the outer islands. On O'ahu, IMUAlliance has provided services to cancer-stricken sprayers of restricted use pesticides, some of whom have are also victims of labor trafficking. Not only were our clients provided with little to no information about the health risks of pesticides placed in their hands, they were also not given equipment to protect themselves from harm. To protect against pesticide drift impacting sensitive educational areas and making children ill—as happened in 2007 at Kahuku High and Intermediate, in which a dozen students fell ill when a nearby sod farmer ignored windy weather while applying pesticides, and in 2008 in Waimea on Kaua'i, where dozens of students got sick after farmers applied pesticide on a nearby seed corn plot—it is incumbent upon lawmakers to crack down on pesticide abuse.

In addition to raising penalties for restricted use pesticide violations, as this measure does, we urge you to consider eliminating, rather than revising, the warning notice requirements from the state's pesticide code under HRS §149A-41, thereby allowing investigators to probe allegations of noncompliance without tipping off their targets. It's time that we started fully prosecuting those who sacrifice people's health to personal profit, even when the weapons involved are chemical carcinogens.

In 2018, elected officials passed SB 3095, banning chlorpyrifos and establishing increased disclosure requirements for pesticide applications. It is imperative that political leaders stand up for safety again during this year's legislative session, given recent court rulings curtailing county jurisdiction over pesticide use and land management. If you wait, our children will breathe in the fallout for generations to come.

My name is Lauryn Rego and I am the Director for the Hawai'i Center for Food Safety (CFS). CFS is a nationwide public interest, sustainable agriculture nonprofit organization whose missions include the promotion of agricultural production methods that are beneficial to the ecosystem. We have over 950,000 farmer and consumer members across the country, including nearly 14,000 in Hawai'i. On behalf of CFS and our members, I thank you for the opportunity to submit testimony today regarding this important bill.

CFS has been dedicated to addressing the human health and environmental impacts of our increased reliance on pesticide use in food production, both in the State of Hawai'i and nationally. We were instrumental in providing legal and communications support in the passage of numerous ordinances relating to pesticide use and disclosure, such as Kaua'i's Bill 2491 and Act 45 (Session Laws of Hawai'i 2018). Since 2014, we have worked closely with community members across the state, in all counties.

I am writing in strong support of SB3040 which increases fines for pesticide use violations and requires the Department of Agriculture to prepare and submit an annual report detailing these violations.

The study entitled "Pesticide Use by Large Agribusinesses on Kaua'i", published in May 2016 by the independent Joint Fact Finding Study Group, points out the need for more timely pesticide inspections and compliance investigations, as well as better reporting on the results of pesticide inspections and investigations. According to the same study, the use of drift-prone pesticides should be more strictly monitored through inspections and proven violators should be fined.

In light of the recent history of known pesticide violations, we strongly support SB3040, which will help establish a written public record of violations, and incentivize compliance.

The people of Hawai'i have the right to decide that the risks associated with the improper use of toxic pesticides in commercial agriculture are unacceptable. The public deserves access to the knowledge of such violations to take action to reduce and prevent the potential negative impacts of such misuse.

HAPA is committed to working to protect our communities and local environment from the impacts of pesticide exposure. Over the last few years we have worked consistently on these efforts, focusing on areas surrounded by heavy pesticide use.

Too often pesticide violations are considered an acceptable "cost of doing business" by large industrial operations. Pesticide violations are a threat to our keiki, farmworkers and the public in general. Illegal use of pesticides threatens to harm adjacent, non-target species, and contributes to short and long-term contamination of the state's soil, air and waters. Despite these risks, pesticide misuse has, and continues to occur within the State.

The state's current low fine threshold does not create a sense of urgency to change behavior and stop repeat violators.

The current state fines for pesticide use violations are only a maximum of \$1,000 dollars for individuals and \$5,000 for commercial applicants. Even in cases where the commercial applicant knowingly violates pesticide labels and laws the maximum state fine is currently only \$25,000. SB 3040 would propose to change the maximum allowable fines to \$5,000 for an individual, \$10,000 for a commercial applicator and \$35,000 for a commercial applicant that knowingly violates.

In cases, such as the 2016 and 2017 Syngenta (Kaua'i) failure to adhere to pesticide use instructions, exposing farmworkers to the (now banned) neurotoxin pesticide chlorpyrifos and injuring their health, or the recent Monsanto/Bayer guilty plea regarding the illegal use of the banned pesticide Penncap-M on Maui and Molokai, the state should have the ability to issue a fine that is reasonable, especially considering they are multinational chemical corporations. Bayer profited over \$13 billion dollars in 2019. The maximum the

state could have fined them for this severe violation would have been \$25,000. Any increase to this amount should be supported.

Exposure to Penncap-M has been linked to impaired neurological development in the fetus and in infants, chronic fatigue syndrome, and Parkinson's disease. What is the fine amount that matches the true cost of the impact to the health and life of our people? The maximum allowable state fines should be raised to represent the full damages to our communities and environments and the exposed workers in the fields.

SB 3040 is a step in the right direction but still a relatively small increase compared to the costs involved with misuse of pesticides and the federal fine limits. State fine limits could be increased to much higher values then even the increase proposed in this measure. The EPA has the ability to fine pesticide violators millions of dollars and even then they often end up paying a fraction of the maximum, or originally issued fine.

Furthermore, the low fine threshold is a lost opportunity for the department of Agriculture to obtain the funds they need to better implement their programs and new laws around pesticide use in Hawai`i.

We support transparency in the process and the reporting associated with pesticide violations. The community deserves the right to know how complaints are being addressed and what the result of the investigations were.

This bill is an important step to better protecting our farmworkers, communities and the environment from pesticide misuse and I strongly urge you to support SB 3040.

Aloha Chair Gabbard, Vice Chair Ruderman, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawaii Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide, and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic and educational interests of our diverse agricultural community.

The Hawaii Farm Bureau believes that SB 3040 is unnecessary and will do more harm than good. We are concerned about the unintended consequences of SB 3040, and offer the following comments:

- We agree that pesticides must be used properly. We also agree that stringent enforcement of the strict federal and State pesticide laws and regulations, as well as timely and routine inspections and compliance investigations of potential misuse of pesticides, are crucial to protecting public health and ensuring public confidence in the State's oversight of pesticide use.
- It is clear from the examples cited in SB 3040 that the bill is unnecessary -- complaints **are** being investigated immediately, routine inspections and investigations **are** being conducted appropriately, and severe and extraordinary fines **are** being exacted from those who violate the law.
- In addition, just last year, after working for several years with the community and the Board of Agriculture, the Department overhauled and revised its pesticide rules to be even more stringent, and nearly tripled its fees.
- Requiring the Department to submit a report to the legislature on what the
  Pesticide Branch has accomplished in the prior year is appropriate and is already
  being done. However, it is not appropriate to require detailed information on
  complaints, inspections, and investigations prior to the closure of a case.

Anyone can allege a complaint. Some complaints may be altogether without merit, while others may require a protracted investigation to determine whether or not a violation has occurred.

- It would be an infringement upon the basic judicial rights of the accused *and* the complainant to publicly post complaints and investigations before determining the facts.
- Pesticide use is a fact of life worldwide, and especially in locations like Hawaii, where there are year-round insect-breeding and weed-growing seasons. Eliminating pesticides or demonizing their use ignores the reality that they can and are being used safely, and that they are very much needed to prevent human and animal diseases, to protect the watershed and other natural resources, and to safeguard our homes and crops, among other things.

Honorable Committee Members:

My name is Marghee Maupin. I am a primary care provider on Kauai. I have worked in health care for 35 years, the majority of this time on Kauai. I have never been more distressed about the poor health of a community as I am about the west side Kauai population.

I am pulling from some prior, yet still applicable testimony from 2013. Unfortunately, there has been few concrete actions taken to protect the people and the environment from the pesticides on West Kauai. Up to 90 pesticides are regularly sprayed up to 16 times a day most days of the year. Additionally, by layering or mixing these chemicals, unique chemical cocktails of experimental and restricted use pesticides are formed. No one (including the agrochemical scientists) know what these novel chemical compounds are and how they affect people and the environment.

As a group of health care providers on Kauai we are very concerned about the effects of pesticide exposure on our patients, especially the children. We believe that the aberrant illnesses and patterns of illness we are seeing may be the result of the agricultural practices conducted by the agrochemical companies. And thousands of peer reviewed studies have shown associations between pesticides and numerous serious health conditions.

No formal quantitative studies of the pesticide effects have been done on Kauai. We do have many examples that lead us to believe that there may be higher than average numbers of serious health conditions occurring to our west side Kauai population. Some of our individual and collective concerns have been:

- A higher than normal occurrence of birth defects and miscarriages than we have seen in other geographic areas where we have practiced.
- Abnormally high rates of severe gout in healthy populations.
- Rare types of cancers at a higher than expected rate for our small island population.

- Almost daily reports of respiratory symptoms in patients who do not have a h/o
  respiratory disease. Many of these respiratory symptoms are not responding as
  would be normally expected by implementing healthy lifestyle changes or treating
  the patients with pharmacological interventions.
- Hormonal changes affecting our patients including excessive facial and body hair on women and higher levels of infertility.
- · Reoccurring nose bleeds in children.
- Patients reporting a "metallic taste" in their mouths
- Recurring skin rashes with no previously known sensitivity to any environmental factors and again, minimal improvement with conventional treatments.

I think that it is also important to mention that although the disease statistics gathered by the JFFG group is not statistically significant (because of population size) all but one of the health conditions counted were highest on the west side as compared to the rest of Kauai

While all of us have not seen all or some of these unique patient circumstances and ailments, we all share a deep concern for the health of our patients and the concern of what may be happening to our community by being exposed to these toxic chemicals on a regular basis, acutely and long term.

We as health care providers need mandatory full disclosure of what chemical toxins are being sprayed, how often they are being sprayed, and how close our patients live to the specific areas being tested with these pesticides. We do not know how to treat patients when we do not know what offending agent has made them ill.

We also agree that mandatory reporting and transparency of pesticide application violations (along with more stringent fines) should be in place in an effort to better protect the health of the people and communities at risk.

We humbly ask the committee to thoroughly consider the proposed bill SB3040 (vote Yes) and the potential consequences to our community if no improvements are made to the current application of poisons and pesticides on the lands surrounding our community.

Aloha Chair Gabbard, Vice Chair Ruderman and Members of the Committee,

My name is Mary Lacques and I am a resident of Haleiwa.

I am submitting testimony in STRONG SUPPORT of the much needed and long overdue SB 3040, which would increase fines for pesticide use violations and requires the Department of Agriculture (HDOA) to prepare and submit an annual report detailing these violations.

As you are aware, the following incidents and violations are noted within the language of SB 3040, but I think the serious nature and blatant disregard for the residents, visitors and ecosystems of Hawai'i warrants repeating, especially in light of the most recent revelations from the Monsanto Maui settlement, just two months ago, in which the company was found guilty of knowingly and deliberately using, transporting and storing a banned pesticide at its South Maui, Maalaea and Kaunakakai, Molokai facilities.

Monsanto admitted in the court documents that it used Penncap-M, even though the company knew its use was prohibited after 2013 pursuant to an order issued by the Environmental Protection Agency (EPA). The company further admitted that, after the 2014 spraying, it told employees to re-enter the sprayed fields seven days later, even though Monsanto knew that workers should have been prohibited from entering the area for 31 days.

On Kauai, in 2018, a commercial pesticide applicator was fined only \$168,535 for misusing a combination of restricted-use pesticides on Kaua'i. The fine grossly under funds the true costs of improper and illegal use of pesticides in our communities and the restoration of ecosystems damaged by pesticide pollution.

Also on Kauai, in 2016 and 2017, Syngenta failed to adhere to pesticide use instructions, and improperly used the (now banned) neurotoxin pesticide chlorpyrifos, exposing the dangerous pesticide to farmworkers and injuring their health. Although an investigation by the EPA initially proposed a pesticide fine of \$4.9 million, the fine was significantly reduced to just over \$500,000.

Not mentioned in SB 3040 is that here on O'ahu, in May of 2017, a former employee of Waialua's DuPont Pioneer operations alleged in a lawsuit that the company dangerously mishandled herbicides, potentially exposing the Waialua community. The lawsuit alleged that the company sprayed its fields even on days when the winds exceeded safety rules. Pioneer's former Waialua farm is adjacent to Waialua High and Intermediate School and a nearby subdivision.

Over the years I have observed in both the House and Senate Agriculture Committee hearings that many discussions regarding the HDOA end with the fact that they are woefully underfunded. Passing SB 3040 and raising the current low fine threshold is a simple and direct way for the HDOA to obtain the funding needed to better implement the inevitable new laws around pesticide use in Hawai`i.

This commonsense bill is a good step towards keeping farmworkers, keiki and kÅ «puna, Hawai'i's communities and ecosystems protected from the improper uses of toxic pesticides-particularly from drift-prone chemicals.

The current low fines do not discourage the profit making of multinational chemical corporations such as Bayer, Monsanto, Syngenta, or known violators in the past.

These companies have been forewarned and were quite aware of the dangers. Some have even been guilty of using BANNED chemicals. These small increases in state fines will not discourage their billions of dollars in profits. More is needed. Raising the fines would help establish better implementation for the regulation needed.

SB 3040 is a step in the right direction but still a relatively small increase compared to the costs involved with misuse of pesticides and the federal fine limits. State fine limits could be increased to much higher values then even the increase proposed in this measure. The EPA has the ability to fine pesticide violators millions of dollars but even then they often end up paying a fraction of the maximum, or originally issued fine.

The state should be a watchdog and act more quickly to ensure safety precautions, enforce restoration after accidents and curb intentional violators, with much higher fines appropriate to the damage and number of infractions.

Current Hawaii fines for pesticide use violations are a maximum of \$1,000 dollars for individuals and \$5,000 for commercial applicants. In cases where the commercial applicant knowingly violates pesticide labels and laws, the maximum state fine is currently only \$25,000. SB3040 would propose to change the maximum allowable fines to \$5,000 for an individual, \$10,000 for a commercial applicator and \$35,000 for a commercial applicant that knowingly violates. Current fines are hardly a deterrent. Rather, they are often viewed as an acceptable "cost of doing business" by large industrial operations.

The safety of our children, farmworkers and the public deserve laws with teeth. For the behavior of violators to change, they must be held accountable. This includes reporting transparency. Communities deserve the right to know how complaints are addressed and the outcomes of such complaints.

Increased revenue from fines should be reinvested in programs associated with safe pesticide procedures and enforcement. While the safety of our citizens is uppermost in our minds, we can not overlook the threat to non-target species, as well as the needless contamination of our soil, water and air.

This is an urgent request. When we consider what is at stake, the fines and reporting outlined in this bill remain modest when compared to federal fines for pesticide misuse. The EPA has the ability to fine pesticide violators millions of dollars. Even so, violators often end up paying a fraction of the originally issued fine.

Current state fines are not an adequate deterrent to violators. Consider the the recent cases below:

The 2016 and 2017 Syngenta (Kaua'i) failure to adhere to pesticide use instructions, exposing farmworkers to the (now banned) neurotoxin pesticide chlorpyrifos and injuring their health.

The very recent Monsanto/Bayer guilty plea regarding their illegal use of the banned pesticide Penncap-M on Maui and Molokai.

In these cases, the state should have had the ability to issue a fine reasonable and representative of the crime. Bayer, a multinational chemical corporation, profited over \$13 BILLION dollars in 2019. Yet, the maximum the state could have fined them for this severe violation would have been \$25,000.

Exposure to Penncap-M has been linked to impaired neurological development in the fetus and in infants, chronic fatigue syndrome, and Parkinson's disease. What, I ask, is the fine amount that matches the true cost of the impact of such needlesss exposure to the health and life of our people?

I urge you to raise maximum allowable state fines to better represent the full damages incurred by our communities and environments from illegal pesticide use.

SB 3040 is a step in the right direction but still a relatively small increase compared to the costs involved with misuse of pesticides and the federal fine limits. State fine limits could be increased to much higher values than even the increase proposed in this measure. The EPA has the ability to fine pesticide violators millions of dollars and even then they often end up paying a fraction of the maximum, or originally issued fine.

In cases, such as the 2016 and 2017 Syngenta (Kaua'i) failure to adhere to pesticide use instructions, exposing farm workers to the (now banned) neurotoxin pesticide chlorpyrifos and injuring their health or the very recent Monsanto/Bayer guilty plea regarding their illegal use of the banned pesticide Penncap-M on Maui and Molokai, the state should have had the ability to issue a fine that is reasonable and representative of the crime, especially considering they are multinational chemical corporations. Dear Honorable Hawaii Legislators,

The Guardian published Aug. 23, 2015, pediatrician Carla Nelson reported there have been nine babies born in five years in Waimea with a severe heart malformation requiring complex surgery. Nelson said this is more than 10 times the national rate, and she and other physicians feel it was caused by the biotech pesticides.

The Garden Island reported 2013, a 4 year study found pesticides chlorpyrifos, bifenthrin, and metolachlor in the breathing air, and atrazine in the drinking water of WCMS. This occurred with a 300 foot buffer to Syngenta's spraying of those pesticides. SB 3095 requires only a 100 foot pesticide buffer. 300 to 100. 3 to 1. We can estimate that with SB 3095's 100 foot buffer 3 times as much chlorpyrifos, bifenthrin, and metolachlor would be in the breathing air, and 3 times as much atrazine would be in the drinking water of Waimea's pregnant women as was measured in WCMS.

Research by Corteva (formerly DowDupont), the maker of chlorpyrifos, omitted key results on the brain-harming effects of the pesticide, undermining the Environmental Protection Agency's ability to accurately assess its safety, according to this 2018 peer-reviewed study published by the Environmental Health journal. https://ehjournal.biomedcentral.com/articles/10.1186/s12940-018-0421-y

The Lancet medical journal published, 2014, that chlorpyrifos damages the developing nervous system, associated with lowered IQ at school age, at current levels of exposure.

Proceedings of National Academy of Science, 2012, reports MRI scans reveal chlorpyrifos prenatal exposure at non-acute low levels, like those levels measured in the air of Waimea Canyon Middle School, is positively correlated to 1) brain defects, 2) inversely correlated to IQ scores, and 3) positively correlated to "disruption of normal sexual dimorphisms in brain structure, which reverses

# normal sex differences in learning, memory, and emotional behaviors." Corteva still owns the copyright to chlorpyrifos.

The Center for Food Safety reports biotech corporations in Waimea spray over 17 times the amount of pesticides compared to other American farms.

Thus anything you can do to protect Waimea children, especially at Waimea Canyon Middle School (WCMS), and to protect pregnant mothers in Waimea, is of utmost importance. You should please create another law which bans clorpyrifos permits and extends the Waimea pesticide buffer to 1/4 mile as California law requires for schools.
