### **RELATING TO THE STATE CAPITOL**

Chair Brian T. Taniguchi and Members of the Committee:

Good afternoon, Chair Taniguchi and members of the Committee, my name is Charlotte Carter-Yamauchi and I am the Director of the Legislative Reference Bureau (LRB). Thank you for providing the opportunity to submit written comments on S.B. No. 3057, Relating to the State Capitol.

The purpose of this measure is to establish within the Public Access Room (PAR) the position of a tour guide, who shall conduct tours of the State Capitol, and to appropriate funds for the position.

The Bureau takes no position on this measure but submits the following comments for your consideration.

PAR was established in 1994 to help enhance the public's ability to participate in the legislative process; it became part of LRB in 1996. PAR's office and services are utilized year-round, offering equipment, services, and facilities to enhance the public's ability to participate in the legislative process. This measure provides funds for a permanent full-time equivalent position of tour guide to be placed within PAR but provides no guidance on the scope envisioned for a capitol tour program established under PAR. If the intended scope is broad (such as providing tours for classes of school children), PAR would need additional space within the Capitol building to ensure that tours do not interfere with PAR's current

services, especially during the legislative session when the PAR room is often filled to capacity.

We note that PAR has no expertise with respect to managing or conducting a tour program. Historically, a capitol tour program has been housed in the Office of the Governor, most recently in its Community Relations area. The Office of the Governor currently has a "Hawai'i State Capitol Tours" page on its website that includes a virtual tour and a self-guided tour brochure. Given its historical expertise in running a tour program, the Office of the Governor may be the more appropriate entity in which to place a Hawaii State Capitol tour guide, especially given that jurisdiction over the capitol building resides with the executive branch, rather than the legislative branch. Should the Committee decide that it would like the Legislature to take over responsibility for capitol tours and establish a tour guide position in PAR, we respectfully ask the Committee to clarify the tour guide's scope of work and consider the spatial challenges that such a position would create within PAR.
