Chair Yamane and Members of the Committee:

The Department of the Attorney General provides the following comments.

The purpose of this bill is to add a chapter to the Hawaii Revised Statutes (HRS) regarding use of a health information exchange. The chapter would (1) require health care and wellness service providers to submit health information about their patients to a state-designated health information exchange for the purposes of facilitating the use and disclosure of health information among health care and wellness organizations, (2) require wellness service providers to submit a complete and accurate record of each patient's health care and wellness related treatments to the state-designated entity for inclusion in the health information exchange, and (3) allow health care and wellness service providers to use the information provided to them from the state-designated entity to establish portals that allow patients to access their own health information.

The bill defines "state designated entity" on page 2, lines 3 through 7, as "an entity designated by the State . . .," but it is unclear what qualifies an entity to be "state-designated." There is no state department mentioned that would be responsible for the designation, and no criteria is provided for that designation. The proposed new chapter is silent on whether the health information exchange is intended to be a state system, a state contracted system, or a private system. As a result, the proposed statute appears too vague to be implemented and enforced. We recommend that the Committee set forth the qualifications for being designated the health information exchange and which

department would be responsible for the designation. For example, the Committee might consider including requirements such as insurance requirements and presence within the state. We are available to assist the Committee with any amendments in this regard.

Although the proposed chapter requires the exchange to comply with the Health Insurance Portability and Accountability Act (HIPAA), the bill appears to lack an enforcement mechanism to ensure HIPAA compliance. Furthermore, it does not provide the health care and wellness providers with legal protections or spell out the respective responsibility of the parties if data breach or other inappropriate disclosure of the health information provided to the state designated entity occurs. The Committee might consider setting forth data breach requirements such as those set forth in chapter 487N, HRS.

An individual has a significant privacy interest in "[i]nformation relating to medical, psychiatric, or psychological history, diagnosis, condition, treatment, or evaluation." <u>See</u> section 92F-14(b)(1), HRS. This privacy interest is protected by section 6 of article I of the Constitution of the State of Hawai'i, which provides:

The right of the people to privacy is recognized and shall not be infringed without the showing of a compelling state interest. The legislature shall take affirmative steps to implement this right.

In evaluating this bill, the Committee should confirm, and articulate, that there is a compelling state interest to require all health care and wellness providers to participate in this data exchange.

Additionally, page 1, lines 6 - 8, of the bill provides the definition of "de-identified protected health information." This term, however, is not used in the bill and should be deleted.

**DEPARTMENT'S POSITION**: The Department of Human Services (DHS) appreciates the intent and vision, provides comments, and defers to the Department of the Attorney General.

**PURPOSE**: Requires all health care and wellness service providers to submit health information to a health information exchange, to be operated and maintained by a state designated entity, for the purposes of facilitating the use and movement of health information among organizations.

DHS appreciates the importance of a Health Information Exchange and understands as described by the federal Office of the National Coordinator for Health Information Technology, that "Health Information Exchange allows health care professionals and patients to appropriately access and securely share a patient's medical information electronically."

However, as written, the proposal would potentially require DHS to provide personally identifiable information that is prohibited by federal and state law. DHS can provide a certain level of aggregate data on multiple programs that it administers. However, with the degree of sophistication and technology that exists, it would not be hard to match data to identify individuals. DHS contracted providers are also held to the same federal and state laws

regarding safeguarding individual client data as the program that funds the contract. Like DHS, these organizations may likely have information being defined as "social determinants of health" and may be considered to be a "wellness service provider" as is defined in this measure.

Amongst other things, DHS respectfully requests clarification as to the intended "state designated entity" envisioned to carry out this measure, and the information being requested; in the alternative, DHS requests that it and its contracted services providers, be exempted from the provisions of this measure.

If the measure proceeds as written, DHS would require general fund appropriations for additional human and fiscal resources, to develop appropriate data sharing and other required agreements, modify contracts, and IT systems to facilitate any data exchange. DHS will likely also require additional funds for contracted providers to do the work requested.

# **Strong Support for HB 1106**

Aloha Chair Yamane:

The Hawai'i Health Information Exchange (HHIE), the state's designated entity for health information exchange for the past 15 years, strongly supports HB 1106, which will require healthcare and wellness service providers to submit health information to HHIE because it will take health information exchange and healthcare in Hawai'i to a new level — without the use of state general funds.

The ability to securely and efficiently exchange patient health information electronically has become vitally important to improve health outcomes for Hawai'i's patients, reduce healthcare costs, and connect Hawai'i's healthcare providers together even though they may use disparate electronic health record systems. Nationwide, health information exchanges have become critical to managing the pandemic.

HHIE plays a key role in transforming Hawaii's healthcare delivery system. HHIE's technological platform is currently used by more than 340 health systems, health plans, community clinics and provider organizations with more than 3,000 providers and users authorized to access the health records through HHIE. The ability to share patient information with each other reduces redundancy in diagnostic testing and speeds treatment procedures using accurate, real-time data. This has also facilitated greater collaboration within Hawai'i's healthcare community.

Although there has been steady progress in linking the majority of the state's healthcare providers together through HHIE, there is much more we can do as a state to accelerate change. HB 1106 is key legislation that will move Hawaii further along to keep pace with the progress other states have made health information exchange a priority.

HHIE looks forward to supporting the state's efforts, optimizing our existing assets and sharing our expertise to keep Hawai'i moving forward.

My name is James Lin, MD, and I am the Vice President of Information Technology at Hawai'i Pacific Health. Hawai'i Pacific Health is a not-for-profit health care system comprised of its four medical centers – Kapi'olani, Pali Momi, Straub and Wilcox and over 70 locations statewide with a mission of creating a healthier Hawai'i.

I write to provide comments on HB 1106 which requires all health care and wellness service providers to submit health information to a health information exchange for the purposes of facilitating the use and movement of health information among organizations.

The goal of making health care and wellness information accessible to patients is laudable. However, the bill broadly requires every entity and provider that delivers health care and wellness services in the State to report every patient's record of health care and wellness related treatments to a state entity. For many patients, treatment and care is an ongoing process, resulting in numerous changes to the patients' records. Reporting all such records is daunting and places an onerous burden on the health care and wellness providers. The bill also does not take into consideration the fact that not all patients agree that their health care information become part of a large data base accessible by many other health care or wellness providers who may be unknown to the patient.

# Strong Support for HB 1106

Aloha Chair Yamane:

The Cancer Center of Hawaii strongly supports HB 1106, which will require healthcare and wellness service providers to submit health information to the State Designated Entity to advance the goal of having complete and accurate medical records for cancer patients needing radiation.

From a state designated entity's shared medical database, real-time and efficient medical information exchange through standardized secure health messaging system provide better care of our cancer patients. Without assistance of a shared medical database (such as HHIE – Hawaii Health Information Exchange), obtaining this information could potentially take weeks, resulting in inadvertent delayed cancer patient care. The current challenges still remains, as there are medical centers which are not **fully** invested in the participation with a HIPPA compliant database center, as it is not a requirement. Having a centralized shared HIPPA compliant database will help improve the care for our radiation patients throughout the state of Hawaii.

For example, there was a patient, who had a tumor compressing the spine, causing pain and weakness (signs of potential paralysis). A medical personnel documented the neurologic symptoms and ordered a MRI to figure out the cause. Both physician document of the patient's symptoms and MRI imaging reports were present in patient's chart at an outside medical center, but this information was delayed in reaching out to me, for numerous reasons. Despite the delay, I was able to provide appropriate radiation care to address the tumor compressing the spinal cord; though, the success rate to address the symptoms may have improved if there were no delay.

Sharing medical information among medical centers, providers, free standing practices with a state designated entity will expedite and improve patient care. HB 1106 is a key legislation that will move Hawaii further along to keep pace with the progress other states that have made health information exchange a priority.
