I. OVERVIEW OF PROPOSED LEGISLATION

HB1176 HD1 proposes to establish a job corps program within the Department of Labor and Industrial Relations (DLIR) similar to programs administered by the U.S. Department of Labor (DOL), to help address the unemployment impacts of COVID-19 pandemic and support economic diversification.

DLIR <u>appreciates the intent</u> provided that it does not conflict with the priorities as identified in the Governor's Supplemental Budget request, and has comments on the measure.

II. COMMENTS ON THE HOUSE BILL

DLIR recognizes the importance of assisting and retraining the state's unemployed residents and diversifying the state's economy. DLIR notes that the intent of the measure involves establishing an existing federal program at the State level. Currently, the Hawaii Job Corps Center in Waimanalo helps to administer the education and career technical training program authorized by Title I-C of the Workforce Innovation and Opportunity Act of 2014 through the DOL.

If the legislation is passed and funded by the Legislature, DLIR will work with Department of Business, Economic Development and Tourism (DBEDT), the

Department of Land and Natural Resources (DLNR), the Hawaii JOB Corps Center and other educational partners to build upon any existing programs similar to those proposed in this measure and establish a curriculum and training program.

The DLIR believes that there are a number of variables, including the number of anticipated participants, number of educational entities and program costs, the award amount(s), and application time frame, that would cause difficulty in estimating the appropriation required to fund the State's establishment and operational costs for this measure.

My name is Kevin Chang and I am the Co-Director of Kua'āina Ulu 'Auamo (or KUA). KUA works to empower grassroots rural and Native Hawaiian mālama 'āina groups -fishers, farmers, families- to celebrate their places and pass on their traditions to better Hawai'i and achieve 'āina momona— an abundant, productive ecological system that supports community well-being.

KUA employs a community-driven approach that currently supports a network of more than 36 mālama 'āina community groups collectively referred to as E Alu Pū (moving forward together), 40 fishpond projects and practitioners called the Hui Mālama Loko I'a, and a growing hui of Limu practitioners all from across our state.

KUA generally supports HB 11766 HD 1. This bill establishes a state job corps program within the department of labor and industrial relations to help address the unemployment impacts of the COVID-19 pandemic and support economic diversification. Appropriates funds KUA for this purpose

A primary function of KUA includes development of an 'auwai, a stream of resources, tools, bridges, relationships, and networks that help to cultivate and take our communities' work to greater levels of collective impact. A core catalyst for the flow in this 'auwai includes increasing the percentage of our economy which helps to manage and better the condition of the natural resources systems that sustain us. Indeed, the University of Hawai'i Economic Research Organization, with input from KUA and a number of partners (DLNR, Kupu, TNC, KS,OHA etc.) now tracks natural resource workforce development as a key part of a "Green Economy."

We are also excited for what this opportunity could mean for increased environmental comanagement, co-governance and uplifting an ethic of mālama 'āina. Our current state institutions lack in resources but also in institutional ethos and policies could better bolster citizen stewardship of our home. Key new generation staff members -such as exist within the Division of Aquatic Resources community-based subsistence fishing area and DOCARE Makai Watch programs- that do more work in partnership with communities are the future of environmental stewardship.

A state job corps that can build a conservation workforce for Hawai'i is a necessary pathway toward uplifting the environment which sustains and undergirds the "economy" for our state. It also further places our island community like others in the Pacific as a leader for environmental leadership and adaptation.

Aloha e Chair Luke, Vice Chair Cullen, and Honorable Committee Members,

My name is John Leong, and I am the Chief Executive Officer and co-founder of Kupu, a statewide youth-focused conservation organization. On behalf of Kupu, I am pleased to testify in **strong support** of **H.B. 1176, Relating to a Jobs Corps Program**. As written, this measure would establish a jobs corps program within the Department of Labor and Industrial Relations (DLIR) focused on providing job opportunities and diversifying our economy. Having administered a CARES Act-funded program that is highly similar to this proposal, Kupu agrees with the value and need of establishing such a program on a permanent basis.

Kupu was established in 2007, in the early stages of the Great Recession. Today we are a statewide organization, developing youth and young adults through hands-on service training in conservation and natural resource management professions. Since 2007 we have trained close to 5,000 youth in conservation, sustainability, and environmental education. Young adults served by Kupu have provided more than 3 million service hours during this time, which included planting over 1 million native plants and removing over 100,000 acres of invasive species. This has created a cumulative \$155+ million in impact for Hawai'i with a 1:3 cost to benefit ratio. We believe more investment in the green economy - as this bill provides - would enable similar economic benefits to our state, create jobs in related fields, and help diversify our economy.

In the early stages of the pandemic, Kupu saw the economic devastation happening in Hawai'i and wondered what more we could do to help. We created a new program -- in concept -- that would help unemployed and underemployed people of all ages work in the green economy during the pandemic. This program, called the Kupu 'Āina Corps, received funding and partnership from DBEDT thanks to the foresight of the legislature and the support of Governor Ige, as provided by Act 9 (SLH 2020). With this program Kupu helped over 350 displaced workers and recent graduates connect with work, training, and the dignity of helping themselves and their communities. We are humbled that our program was mentioned in the background portion of this legislation as an example of what a permanent fund of this nature could achieve.

The ecological, economic, and human benefits of the Kupu 'Āina Corps were clear. Over 90 percent of our participants completed the program, gaining its full benefits and helping 150 different host sites across the state. Based on a post-program evaluation survey completed by participants, one in three remained employed or were moving on to other employment at the end of the program. Logging over 89,000 work hours, these participants produced an economic benefit estimated at \$6.55 million, based on a formula developed by Columbia University. (This was more than twice the cost of the program.) Additionally, these participants collectively improved over 21,700 acres of land across our state. Community-based conservation corps around the nation have inquired about the program, which has also received national media coverage.

While the funding and authorization for the Kupu 'Āina Corps has ended, the need for this kind of program has not. We believe that future partnerships, like what is possible through this bill, can continue to provide urgent relief for underemployed kama'āina and struggling green entrepreneurs in the immediate term, and gradually help the long term pivot towards the kind of diversified economy that Hawai'i needs. For these reasons, we strongly support H.B. 1176 and urge the committee to pass this bill.

A high-visibility youth service project can be effective in the moment and transformative over the longer term. It can be a multi-pronged initiative that young people, their families, and their communities can embrace enthusiastically. By working in, and learning about, ecology from the mountains to the sea, participants can come to understand interrelationships and see the issues of human settlement whole.

Such a program could include: Upland forest conservation and renewal; Watershed recharge; Streambed cleanup and planting; Point-source and brown-water pollution cleanup; Sustainable diversified agriculture; Kalo cultivation; Community gardening; Regulation of tourist-intensive nature resources; Restoration of historic and cultural sites; Protection and cleanup of beaches and reefs; Management of nearshore fisheries, and Fishpond restoration.

My personal testimony is from my experience working in a national forest as a teenager. It was challenging and one of my best experiences. In my work life, I wrote and directed the PBS film "May Earth Live" about preservation of the native forest, recently reprised by the nonprofit Ulana Inc. in Hilo and Mindful Hawai`i on O`ahu. In the past year I have been involved in conversations with culturally-based ecologists such as KUPU, KUA, `AINA MOMONA, and others. The need is huge, and the means of filling it is readily available. The State of Hawai`i initiative of 2020, in which the contractor KUPU used CARES money to support 360 young people, demonstrated community capacity to mount such an effort. With years of background, KUPU placed young people in no fewer than 150 community partners. I am sure this merely scratched the surface of both supply and demand.

As a result of fumbling between the Governor and the Legislature, available CARES money shrank from \$36 mil to \$10 mil to \$5 mil. The time window for doing the field work likewise shrank. If government had performed even a little more effectively, the results could have been many times more far-reaching.

Now, with an environmentally-conscious national administration prepared to spend money on economic recovery, we in Hawaii have our opportunity. The

biggest challenge is yours—to activate government's capacity to serve as a facilitator of a CARES-funded program stretching across 2021 and 2022.

My caveat regarding HB1176 is trying to do this through DLIR. Logically, it should go through the Department of Land and Natural Resources because of its familiarity with environmental problems and its enormous responsibilities in that regard. Further, in Chapter 193 HRS, DLNR already has the vehicle for a Youth Conservation Corps. DLIR or other venues such as DBEDT would be short-term fixes that will disappear when the unemployment rate goes down. Our environment and people together are our greatest resource. This is our chance to do something visionary for the long term.

I am the program manager for Skyline Conservation Initiative. I am writing today in strong support of HB 1176 which if passed will provide "green jobs" for Hawai'i's residents, some who are struggling to find work during these troubling times. This is an amazing opportunity to get local residents off of unemployment and trained with a multitude of land stewardship skills that will benefit the aina and our local communities in many ways. In 2020, CARES act funding allowed for the Kupu Aina Corps program to create green jobs. The community restoration project I manage in Pohakuokala Maui was selected as a host site and we received a crew of 4 amazing community members who were able to get off unemployment and support our essential conservation work. Our entry-level crew was trained In safety working around heavy equipment, chainsaw safety, emergency first aid, GIS technology, invasive species identification / landscape scale weed control methods, native species identification, seed collection, propagation, and outplanting techniques. In addition to working in our project area, we also supported 6 different partner conservation project sites. This way our crew was able to experience heavy field work days along side some of the most knowledgeable conservation practitioners on Maui. After completing the 2 month contract our crew has since moved on to various land stewardship jobs (when available,) intermittent tourism jobs, and partial unemployment. Our biggest wish is that this Kupu Aina Corps program that creates essential conservation / land stewardship jobs could be replicated and upscaled to provide long-term contracts. If HB 1176 funding is procured, the program I work for can continue providing robust vocational training cirriculum at our facility for many new employees while also supporting partner conservation programs who can really use the help of skillful laborers for special projects. This is truly an amazing collaborative partnership for many stakeholders to leverage resources in a very productive way. Passing bill HB 1176 is an honorable strep forward in diversification of our local economy and helping put unemployed people back to work. This is comparable to one of the most successful programs of FDR's "New Deal" in 1933 which was the creation of the Civilian Conservation Corps which created 300,000 green jobs and provided financial stability for many American families in a post Great Depression society.
