In consideration of HOUSE BILL 1176, HOUSE DRAFT 1, SENTATE DRAFT 1 RELATING TO A JOB CORPS PROGRAM

House Bill 1176, House Draft 1, Senate Draft 1 proposes to establish a job corps program within the Department of Land and Natural Resources (Department) to help address unemployment impacts of the COVID-19 pandemic, support economic diversification, and focus on resiliency and green sector jobs, and appropriates funding. **The Department supports this bill.**

The State of Hawaii's commitment to uphold the Paris Climate Accord and progressive move towards zero emissions clean economy by 2045 requires that we actively invest in the community and emerging economic sectors and provide residents with the education and training opportunities they need to succeed. A job corps program designed specifically to address the State's climate change goals would be beneficial in helping the growing green sector scale up efforts to address climate change, and provide diversified training opportunities to a displaced workforce, supporting a resilient local economy.

Aloha Chair, Vice-Chair and Committee members

My name is Kevin Chang and I am the Executive Director of Kua'āina Ulu 'Auamo (or KUA). KUA works to empower grassroots rural and Native Hawaiian mālama 'āina groups -fishers, farmers, families- to celebrate their places and pass on their traditions to better Hawai'i and achieve 'āina momona— an abundant, productive ecological system that supports community well-being.

KUA employs a community-driven approach that currently supports a network of more than 36 mālama 'āina community groups collectively referred to as E Alu Pū (moving forward together), 40 fishpond projects and practitioners called the Hui Mālama Loko I'a, and a growing hui of Limu practitioners all from across our state.

KUA generally supports HB 1176 HD1 SD1. This bill establishes a state youth green job corps program within the DLNR to help address the unemployment impacts of the COVID-19 pandemic and support economic diversification. Appropriates funds KUA for this purpose

A primary function of KUA includes development of an 'auwai, a stream of resources, tools, bridges, relationships, and networks that help to cultivate and take our communities' work to greater levels of collective impact. A core catalyst for the flow in this 'auwai includes increasing the percentage of our economy which helps to manage and better the condition of the natural resources systems that sustain us. Indeed, the University of Hawai'i Economic Research Organization, with input from KUA and a number of partners (DLNR, Kupu, TNC, KS,OHA etc.) now tracks natural resource workforce development as a key part of a "Green Economy."

We are very excited for what this opportunity could mean for increased environmental comanagement, co-governance and uplifting an ethic of mālama 'āina. Our current state institutions lack in resources but also in institutional ethos and policies could better bolster citizen stewardship of our home. Key new generation staff members -such as exist within the Division of Aquatic Resources community-based subsistence fishing area and DOCARE Makai Watch programs- that do more work in partnership with communities are the future of environmental stewardship.

A state job corps that can build a conservation workforce for Hawai'i is a necessary pathway toward uplifting the environment which sustains and undergirds the "economy" for our state. It also further places our island community like others in the Pacific as a leader for environmental leadership and adaptation.

Please pass this bill out of your committee and mahalo for this opportunity to testify.

Testimony in Strong Support of H.B. 1176 H.D. 1, S.D. 1, Relating to a Jobs Corps Program

Aloha e Chair Dela Cruz, Vice Chair Keith-Agaran, and Honorable Committee Members,

My name is John Leong, and I am the Chief Executive Officer and co-founder of Kupu, a statewide youth-focused conservation nonprofit. On behalf of Kupu, I am pleased to testify in **strong support** of **H.B. 1176 H.D. 1, S.D. 1, Relating to a Jobs Corps Program**. As written, this measure would expand the state's existing conservation corps program by authorizing an initiative focused on providing conservation and sustainability-related job opportunities and diversifying Hawai'i's economy. Having administered a CARES Act-funded program that is highly similar to this proposal, Kupu agrees with the value of establishing such a program on a longer-term basis as part of Hawai'i's economic and natural resource management strategy.

Kupu was established in 2007, in the early stages of the Great Recession. Today we are a statewide organization, developing youth and young adults through hands-on service training in conservation and natural resource management professions. Since 2007 we have trained close to 5,000 youth in conservation, sustainability, and environmental education. Young adults served by Kupu have provided more than 3 million service hours during this time, which included planting over 1 million native plants and removing over 100,000 acres of invasive species. This has created a cumulative \$155+ million in impact for Hawai'i with a 1:3 cost to benefit ratio. We believe more investment in the green economy - as this bill provides - would enable similar economic benefits to our state, create jobs in related fields, and help diversify our economy.

In the early stages of the pandemic, Kupu saw the economic devastation happening in Hawai'i and wondered what more we could do to help. We created a new program -- in concept -- that would help unemployed and underemployed people of all ages work in the green economy during the pandemic. This program, called the Kupu 'Āina Corps, received funding and partnership from DBEDT thanks to the foresight of the legislature and the support of Governor Ige, as provided by Act 9 (SLH 2020). With this program Kupu helped over 350 displaced workers and recent graduates connect with work, training, and the dignity of helping themselves and their communities. We are humbled that our program was mentioned in the background portion of this legislation as an example of what a longer-term program of this nature could achieve.

The ecological, economic, and human benefits of the Kupu 'Āina Corps were clear. Over 90 percent of our participants completed the program, gaining its full benefits and helping 150 different host sites across the state. Based on a post-program evaluation survey completed by participants, one in three remained employed or were moving on to other employment at the end of the program. Logging over 89,000 work hours, these participants produced an economic benefit estimated at \$6.55 million, based on a formula developed by Columbia University. (This was more than twice the cost of the program.) Additionally, these participants collectively improved over 21,700 acres of land across our state. Community-based conservation corps around the nation have inquired about the program, which has also received national media coverage.

While the funding and authorization for the Kupu 'Āina Corps has ended, the need for this kind of program has not. We believe that future partnerships, like what is possible through this bill, can continue to provide urgent relief for underemployed kama'āina and struggling green entrepreneurs in the immediate term, and gradually help the long term pivot towards the kind of diversified economy that Hawai'i needs. Additionally, like many witnesses who testified in previous committees, we support the current version of this bill and the decision to place this program under the administration of DLNR. For these reasons, we strongly support H.B. 1176 and urge the committee to pass this bill unamended.

Finally, we would like to highlight that the new initiative that would be created through H.B. 1176 would provide a structure to better-position Hawai'i for various federal funding opportunities that are emerging or anticipated. This includes not just the American Rescue Plan and the American Jobs Act but also other conservation, climate change, and natural resource and cultural resource legislation that could fund jobs and stimulate the economy.

Please pass <u>H.B. 1176 H.D. 1, S.D. 1 unamended</u>. Mahalo for this opportunity to testify in strong support of this important bill.

Hawai'i SEED strongly supports the creation of local jobs for local needs. These are jobs that will enhance of community environment. By creating jobs such as these, they will bring benefits to the present and the future of Hawai'i. We need diversification to create solid security for all our needs and situations.

Prior to the coronavirus disease 2019 (COVID-19) pandemic, Hawaii had one of the lowest unemployment rates in the nation. The COVID-19 pandemic has placed tens of thousands of Hawaii residents out of work, and the current state unemployment rate is among the nation's highest. In addition, tourism, the State's largest industry, has dropped considerably because of the COVID-19 pandemic, providing a unique opportunity for the State to build a more resilient, equitable, and diversified economy. The effects of the COVID-19 pandemic also highlighted the need for increased and diverse workforce development initiatives in the State. The when and how tourism will look in the future, one thing is for certain, we must eat, we must feed our guests, and we must grow our own nutrition on our land. It is an untapped source of jobs, revenue and savings for families, business and institutions. Just think of all the money we spend, looping back into the hands of home-grown businesses.

A model exists for the creation of such initiatives to support the State's ailing workforce. The Civilian Conservation Corps program that was implemented as a major part of President Franklin D. Roosevelt's New Deal after the Great Depression was a federal work relief program

that helped employ Americans on conservation projects, alleviated economic distress, and supported the protection and responsible development of natural resources and agricultural land use.

The federal Job Corps program is a no-cost education and career technical training program administered by the United States Department of Labor that helps young people ages sixteen to twenty-four improve the quality of their lives through career technical and academic training. The Hawaii Job Corps Center supports the federal Job Corps program's mission to teach eligible young people the skills they need to become employable and independent, place them in meaningful jobs, or further their education.

We find that the federal Job Corps program is a no-cost education and career technical training program helps young people improve the quality of their lives through career technical and academic training. The Hawaii Job Corps Center supports the federal Job Corps program's mission to teach eligible young people the skills they need to become employable and independent, place them in meaningful jobs, or further their education. The creation of a state-administered green job corps program would provide Hawaii residents who were economically impacted by the COVID-19 pandemic with opportunities to learn new skills and increase their prospects of employment within the resiliency and green sectors, including local agriculture, conservation, climate adaptation, renewable energy, cesspool conversion, and technology industries.

The legislature also finds that the Aloha Connects Innovation program of the Economic Development Alliance of Hawaii and Kupu 'Āina Corps, two workforce development initiatives launched by the State with federal Coronavirus Aid, Relief, and Economic Security Act funds are potential programs to integrate and build upon in establishing a state-administered green job corps program. The State can also capitalize on the report titled "From Today to Tomorrow: A Talent Roadmap to Support Economic Recovery" produced by the Hawaii Executive Collaborative, which provides a framework to establish a state-administered green

job corps program by outlining a talent development strategy through expansion of workbased learning, retraining, credentialing programs, industry-driven solutions, and partnerships.

Please establish a green job youth corps program within the department of land and natural resources to help address the unemployment impacts of the COVID-19 pandemic and support economic diversification with a focus on resiliency and green sector industries; and alternative career employment opportunities, with purpose and an investment in our future. Designate the department of land natural resources to administer or enter into an agreement or agreements for the administration of a green jobs youth corps program that provides temporary work and training opportunities in one or more of the following fields: natural resource management, agriculture, conservation, renewable energy, or other sustainability professions.

The Nature Conservancy (TNC) <u>supports</u> HB 1176, HD1 SD 1, which establishes a state job corps program within the Department of Land and Natural Resources to help address the unemployment impacts of the COVID-19 pandemic and support economic diversification, and appropriates funds for this purpose.

Hawai'i's natural environment is the engine that drives our state's economy and a natural, recreational, and cultural treasure supporting our island lifestyle and livelihoods. HB 1176, HD 1 SD1 provides the platform and funding for additional Kupu internships and other green jobs across our islands. As we work together to create a diversified economy, green jobs can and must play a role. By providing immediate relief and opportunity for local jobs while also paving the way for long-term green jobs, environmental expertise, and local leadership, this legislation is an important step in the right direction, and we urge the committee to pass it.

Aloha Chair Dela Cruz, Vice Chair Keith-Agaran and Committee Members,

I am providing testimony today in strong support of HB 1176, HD1, SD1 which proposes to establish a state job corps program to help address the unemployment impacts of the COVID-19 pandemic and support economic diversification by giving youth and adults an opportunity to engage in meaningful work on the land and in emerging sectors. This program would provide individuals with an opportunity to upskill and/or retool for our changing economic landscape.

I am a resident of Hawaii Island and graduated high school in the same year that the Hamakua Sugar Co. closed. Three generations of my family worked for that plantation, my dad being one of those who worked until its closure. I witnessed firsthand how difficult it was for my dad to transition into another industry. Today, he is a member of the tourism industry and while he is eligible for early retirement, he is trying to hang on a few extra years for full retirement benefits. The current state of tourism on our island has us wondering if there will need to be one more "career change" for him or if he will need to just settle for early retirement benefits.

These are not the types of decisions we want our island residents to face after spending most of their life contributing to society. Yet, for my dad, he finds himself at another one of these crossroads with about a quarter of a century between two devastating economic disasters that impacted his career.

As I keep one eye on my dad and his situation, I keep my other eye on my teenage son who is keenly watching what is happening in the world around him. I am fully aware that how our island bounces back from this pandemic is likely to determine whether my son decides to stay on island or in the state after high school or not. I work in the field of education as a state employee and if there is one thing that I would like to impress upon us, it is this - let us learn from our own history and do what we can to prevent history from repeating itself. We cannot predict when the next economic disaster will hit Hawaii, but we can better prepare our workforce with the necessary, progressive, and transferable skills that can support them in being more adaptive and responsive to change, and at the same time, we must also cultivate a more sustainable and resilient economy that will be able to better withstand different tests over time.

That is why I strongly support HB 1176, HD1, SD1. While intended to help address short-term and immediate unemployment impacts of the COVID-19 pandemic, I see potential longer term benefits for our island residents and our island economy. As we look at rebuilding our economy, we must look at how to rebuild our workforce and a state job corps program would be a great start toward that endeavor.
