Dear Senator Rhoads and Senator Dela Cruz:

The Hawai'i Police Department **strongly supports** House Bill 1366, HD 1, with its purpose to amend the Class C felony offense of manufacturing, purchasing, or obtaining firearm parts to assemble a firearm having no serial number to also prohibit possession of those firearm parts; also to amend Act 74, Session Laws of Hawai'i 2020, to repeal language that specified the prospective application of that Act.

We here in Hawai'i have been a lot safer than certain other locations in the United States in terms of gun violence. This safety factor is not one of happenstance, but rather a result of working very hard on both laws and the enforcement of laws to keep firearms out of the hands of those who are by law disqualified from their possession. We are in agreement that these amendments will strengthen Act 74, Session Laws of Hawai'i 2020 which was passed to ensure that Hawai'i continues to address the concerns of law enforcement and the community as it relates to firearms.

It is for these reasons, we urge this committee to approve this legislation. Thank you for allowing the Hawai'i Police Department to provide comments relating to House Bill 1366, HD 1.

Dear Chair Rhoads and Chair Dela Cruz:

On behalf our members in Hawaii, I would like to communicate our strong opposition to House Bill 1366 (HB 1366).

HB 1366, retroactively applies, Act 74 of the 2020 session. Act 74 was an effort to ban homemade firearms and so called "ghost guns".

The language of Act 74 is vague and overly broad as to what exactly could constitute a part or parts that could subject a person to felony penalties. Making it is far too easy for a well-intentioned, and otherwise law-abiding gun owner to accidentally run afoul of the law.

This legislation only compounds the problem but applying the law looking backwards, potentially subjecting well intentioned persons, who engaged in their craft lawfully to be subject to harsh penalties.





The Church of the Crossroads was founded in 1922 as Hawaii's first intentionally multiethnic church. We are a Just Peace Church of almost 200 members. **We have voted unanimously to support a ban on Ghost Guns.** 

We support HB 1366's expansion of the State's Ghost Gun law to assure the law is construed as banning possession of Ghost Guns as well as the key components in creating such firearms. This will prevent those who own these firearms from claiming they were acquired before the effective date of the 2020 Ghost Gun ban.

The State should prohibit the possession of firearm parts for the purpose of assembling firearms having no serial number, as this evades important permit procedures and related background checks that are intended to protect the public prior to anyone acquiring a firearm.

Firearms registration and permit requirements provide essential protections for public safety by requiring criminal background checks, mental health background checks, certain standards for safety training for firearms, and other legal requirements.

The State has a strong interest in assuring that all firearms are subject to the same stringent requirements for registration, permit and background checks, based on a unique serial number that accurately identifies each firearm in the State. Any efforts to evade those requirements by "grandfathering" Ghost Guns acquired or created before the 2020 Ghost Gun ban, should be prohibited.

#### I OPPOSE HB1366

This bill may affect my possession of repair parts for my firearms. The Act 74 of 2020 originally banning the acquisition of "ghost guns" is vague and broad on exactly what parts are legal and what parts are not. I own many firearms and have repair parts on hand to fix them cause like anything mechanical, things break. I have not bought any more repair parts kits since Act 74 was enacted because they could be used to **build a rifle or fix a rifle.** This bill could potentially ban my repair parts kits I already own, but I don't know.

- "a) A person who is not licensed to manufacture a firearm under section 134-31, or who is not a dealer licensed by the United States Department of Justice, shall not, for the purpose of assembling a firearm, possess, purchase, produce with a three-dimensional printer, or otherwise obtain separately, or as part of a kit:
- (1) A firearm receiver that is not imprinted with a serial number registered with a federally licensed manufacturer;
- (2) A firearm receiver that has not been provided a serial number that may be registered in accordance with section 134-3(c); or
- (3) Any combination of parts from which a firearm having no serial number may be readily assembled; provided that the parts do not have the capacity to function as a firearm unless assembled."

If I intend to build a firearm in the future, the kit is banned. But if I intend to use the same kit to repair my current guns it's legal? I'm not sure. Does this kit have to be serialized and registered with the police?

For people who buy a legal receiver to assemble a firearm from the parts they want, would this now make them a criminal. Since HPD cannot handle appointments in a timely manner how can anyone complete a project and register with the timeframe you list in this bill. If you want support for this bill, it should be for the recieiver only...ie...the same part that is recognized by the ATF and written into law. I have parts for the same firearm to cover repairs, hunting conditions (raining or dry), competition, sport, practice, again, all with the same firearm.

As the bill is written it conflics with current laws as only the receiver of a firearm must have a serial number. Some firearms have over 200 parts, it is not possible for people to serialize all those parts and HPD does not have the time to pull apart every firearm to record each parts serial number.

I am a long time owner of guns and I've complied with all of the rules and regulations related to firearms in the State of Hawaii. I am not opposed to registration (as that is the case here), nor am I opposed to control over "ghost" guns per se (the intent of this bill) but what I am concerned about is sentence three in the proposed bill ...

(3) Any combination of parts from which a firearm having no serial number may be readily assembled; provided that the parts do not have the capacity to function as a firearm unless assembled."

This is so vague that it could be applied to any gun part, intended or not. Most parts that comprise a firewarm do not have serial numbers; only the receiver and sometimes barrels have them. I believe sentence three should be striken from the bill as one could envision this law to be used to stop the sale, production of all parts. If I were to carve grips for a firearm, that part could fall under the proposed law and I would be subject to a class C felony. I do not believe that is the intent; therefore the law has to be specific and not general in nature to avoid unintended interpretations in the future. To me, a bill is like a contract, the parties that crafted and executed it could be of the same understanding but future events and parties may not have that same understanding.

I am opposed to HB1366. Section 3, striking the language apparently intending to make the new provisions retroactive, is unconstitutional. In addition, the Second Amendment provides that "the right of the people to keep and bear Arms ... shall not be infringed." The right to have parts of firearms is not different from the right to have a firearm. For decades, there was uncertainty among lower courts about whether those words protect an individual right or only a collective right. Compare, e.g., Silveira v. Lockyer, 312 F.3d 1052 (9th Cir. 2002) (collective right), with Silveira v. Lockyer, 328 F.3d 567, 568 (9th Cir. 2003) (Kozinski, J., dissenting from denial of rehearing en banc) (individual right); id. at 570 (Kleinfeld, J., dissenting from denial of rehearing en banc) (same). The Supreme Court resolved that uncertainty in Heller, concluding after an exhaustive textual and historical analysis that the Second Amendment protects an "individual right to possess and carry weapons" for self-defense. 554 U.S. at 592. The Court then held that the law at issue in the case, a District of Columbia ordinance banning the possession of operable handguns in the home, violated the Second Amendment under "any of the standards of scrutiny that we have applied to enumerated constitutional rights"—that is, any standard of scrutiny stricter than rational basis review. Id. at 628 & n.27.

In McDonald v. City of Chicago, 561 U.S. 742 (2010), the Court held that the "right to keep and bear arms for the purpose of self-defense" recognized in Heller is "fully applicable to the States" because it is "among those fundamental rights necessary to our system of ordered liberty." Id. at 750, 778. Accordingly, the Court explained, states and municipalities must comply with the individual right protected by the Second Amendment and may not simply "enact any gun control law that they deem to be reasonable." Id. at 783 (plurality opinion); see also Caetano v. Massachusetts, 136 S. Ct. 1027 (2016) (vacating state court decision on Second Amendment grounds). In the years since Heller and McDonald, the Ninth Circuit has developed a two-step framework for adjudicating Second Amendment claims. First, a court "asks if the challenged law burdens conduct protected by the Second Amendment, based on a historical understanding of the scope of the right." Silvester v. Harris, 843 F.3d 816, 821 (9th Cir. 2016). If so, the court analyzes the law under heightened scrutiny, with the degree of scrutiny varying depending on "how close the challenged law comes to the core of the Second Amendment right, and ... the severity of the law's burden on that right." Id.; see Jackson v. City & Cty. of San Francisco, 746 F.3d 953, 960-61 (9th Cir. 2014).

I oppose House Bill 1366, sponsored by Representative Patrick Branco, that amends language regarding home-built firearms. Specifically, I oppose any ban on possession of certain unfinished firearm components, as well as home-built firearms; especially when those "...firearm components..." are not specifically identified, listed, and written into the law.

HRS Section 134-10.2 – forbids manufacturing, purchasing, or obtaining firearm parts to assemble a firearm having no serial number; unless licensed to manufacture a firearm under section 134-31, or who is not a dealer licensed by the United States Department of Justice.

HRS Section 134-10.2 — without providing a time limitation; makes it a class C felony for an individual to; for the purpose of assembling a firearm; purchase, produce with a three-dimensional printer, or otherwise obtain separately, or as part of a kit:

- 1. A firearm receiver that is not imprinted with a serial number registered with a federally licensed manufacturer:
- 2. A firearm receiver that has not been provided a serial number that may be registered in accordance with section 134-3(c); or
- 3. Any combination of parts from which a firearm having no serial number may be readily assembled; provided that the parts do not have the capacity to function as a firearm unless assembled.

One of the skills a gunsmith needs to have is to know how to make replacement parts for firearms. Very often, the repair is on a firearm that does not have replacement parts available. The very skill to fabricate is the art of gunsmithing and House Bill 1366 infringes on the First Amendment. Indeed, the ingenious gas and spring recoil powered bolt designed by David Marshall Williams was the forerunner of many automatic and semi-automatic weapons in use today. The M-1 Carbine was developed by Williams while at Winchester Arms. It was carried by more than 8 million U.S. soldiers in World War II.

The design of the M-1 Carbine would not have been possible under the restrictions imposed by House Bill 1366 and HRS 134-10.2. And without the ability to utilize 3D printing to develop prototype models or actual parts; will further delay any development of firearms' community safety improvements.

"Carbine" Williams began gunsmithing as a "trusty" in the blacksmith shop at Caledonia, a Halifax County prison, while serving a 30-year prison term for the murder of a deputy. Williams began drafting innovative gun designs from scraps. His designs drew the attention of Colt Firearms, whose representatives visited him in prison.

The Supreme Court has said that the First Amendment protects works which, taken as a whole, have serious literary, artistic, political, or scientific value, regardless of whether the government or a majority of the people approve of the ideas these works represent.

The M-1 Carbine killed millions. Gunsmiths, such as David Williams built, created, innovated, or restored firearms(works); as an art form. If it is necessary to censor gunsmiths by making it illegal to possess the trade components needed in the performance of their art, because it runs so far afoul of the community's concept of decency that it is legally obscene; gunsmiths should not be targeted because of any particular mass shooting or murder is found to be offensive.

The Supreme Court has also said that "in our system, undifferentiated fear or apprehension of disturbance is not enough to overcome the right to freedom of expression."

Senators of the Judiciary + Ways and Means Committees,

I reemphasize my **opposition** to **HB 1366 HD 1** because its goal to remove Section 6 of Act 74, now codified in Section 134-10.2 of the Hawaii Revised Statutes (HRS), will still execute the very essence of an ex post facto law. "Every law that makes criminal an act that was innocent when done, or that inflicts a greater punishment than the law annexed to the crime when committed, is an ex post facto law within the prohibition of the Constitution" (EX POST FACTO LAWS, n.d.). This measure turns a citizen that lawfully possesses a firearm receiver with no serial number *prior* to enactment of Act 74 into a felon. I find it very disturbing that the prospective enactment of HB 1366 HD 1 punishes a citizen for simply holding on to a piece of metal, especially since that citizen has no mechanism to take corrective legal action upon implementation of the measure. Moreover, the addition of the word "possess" to HRS Section 134-10.2 makes the revised statute overly broad whereby the statute can be maliciously applied to firearms repair kits, thereby turning owners of such repair kits into felons, despite the fact that there is no viable evidence that would prove that such repair kit owners will assemble a firearm using a non-serialized receiver. This situation continues to establish a dangerous precedent for citizens and puts them at undue legal risk for simply maintaining passive legal possession an inanimate object, such as a non-serialized firearm receiver in this case, prior to an arbitrary time period.

Inanimate objects do not and cannot pose a public safety threat. Inanimate firearm receivers—serialized or non-serialized—cannot act on their own and accordingly cannot initiate any activity on their own.

I will continue to urge that the members of the Senate Judiciary as well as the Ways and Means committees **keep Section 6** of Act 74 so that innocent citizens are not automatically turned into felons based upon a misguided measure that does not substantively improve public safety whatsoever. In the midst of a pandemic, precious time can be spent on other bills relating to COVID-19 relief so that the safety and wellbeing of Hawaii's citizens can be objectively and substantively improved.

Opposition for H.B. 1366, H.D. 1, Relating to Firearms

I am Lori Shinsato and not submitting testimony on behalf of any group. Professionally, I am a social worker in the health care and mental health settings. I do not normally get this involved with the legislative process; however, I am now, which is reflective of my concern with this bill. My speaking up is late, yet, I respectfully ask that you consider my testimony for your decision. I strongly oppose H.B. 1366, H.D. 1, Relating to Firearms, which amends the class C felony offense of manufacturing, purchasing, or obtaining firearm parts to assemble a firearm having no serial number to also <u>prohibit possession</u> of those firearm parts.

I have read through the many testimonies submitted for this bill. Those in support of this bill are in support of protecting Hawaii, which I am in agreement with. Unfortunately, this bill does not protect Hawaii. According to the State of Hawaii, Department of the Attorney General, Crime Prevention and Justice Assistance Division (CPJAD), A Review of Uniform Crime Reports for 2017, data released in 2019 [more recent data for the State is not available]:

"Of the 3,010 murders, robberies, and aggravated assaults reported statewide in 2017, 43.3% were committed using strongarm weapons; 26% with "other" or unknown weapons; 19.0% with knives or other edged weapons; and 11.7% with firearms."

After a closer review of the breakdown of the 2017 data, there were 39 murders reported. Of the murders, 4 involved firearms and 35 murders were done by other means including strongarm weapons (hands, fists, feet, etc.), other or unknown weapons, and knives. There were 1,894 aggravated assaults. Of those assaults, 1,715

were by strongarm weapons, other or unknown weapons, and knives. There were 1,077 robberies reported. 910 of those robberies were done without firearms involvement. Again, strongarm weapons, knives, and other dangerous weapons were involved. In the State of Hawaii, a person is more likely to be victimized by someone using their hands and feet, knives, or another dangerous weapons. In the State of Hawaii, a perpetrator is least likely to be using a firearm.

I am pro-police, which means, I cannot imagine our community without police presence. When I call 911 to report a crime, I want to know that the police will respond. I want the criminals to know the police will be responding. Those in support of this bill are in support of protecting our police officers. I agree that we need to take care of our police officers. I do not think this bill does that. According to the same CPJAD report, in 2017, 298 police officers were assaulted in the line of duty. The report states,

"The use of 'strongarm' physical force is most often the means of assault on police officers. In 2017, 69.1% (206) of the assaulted officers were attacked by hands, fists, or other bodily means. 'Other' dangerous weapons were used in more than a quarter (82, 27.5%) of the assaults." Knives were involved in 7 cases and firearms were involved in 3 cases. The report also states that, "Most of the assaults on police officers in 2017 occurred when the officers were responding to disturbance calls, or when officers were performing 'other' (i.e., responding to civil disorders, interacting with mentally deranged persons, etc.) types of duties."

After reviewing crime statistics, it is clear that in the State of Hawaii, firearms do not need further restrictions. Our current laws are very restrictive already, as supported by the crime data. The aggression in people needs to be addressed.

Whether it is the intention of this bill or not, if passed, this bill will end up increasing class C felony charges overnight. Many law-biding citizens will be criminalized on January 1, 2022, just because they are in possession of firearm "parts" that is vaguely defined in this bill. There are many parts involved for a firearm to operate. This bill does not distinguish which parts a person should not be in possession of. It is also worth noting that the "parts" that citizens possess were legally acquired at a significant financial investment to the individual, both of which this bill does not care to address. These concerns have been stated by many in opposition of this bill. It has also been mentioned that the art of gunsmithing requires "parts." Those in opposition have mentioned the specialized skill, knowledge from studying, craftsmanship, dedication, and artistry necessary for gunsmithing, in which the purpose is to create a firearm that is accurate. Accuracy is needed for sportsmanship hunting and competition shooting.

Shooting is a recognized Olympic sport. I suppose Hawaii will never have an Olympian nor gold medalist this category, because our athletes will only shoot with factory parts.

I would also like to point out that these restrictive firearm laws are anti-female, especially in the State of Hawaii. Statistically, the most likely way to be murdered or assaulted is by stronghold force. In a self-defense situation, a female, typically smaller and weaker, will have less chance of survival if being attacked by a male. Realistically, a firearm may be the only option for the female's survival in a life threatening situation. With that being said, a firearm may be the only option for survival for non-violent, lawabiding citizens in a life threatening situation. A non-violent, lawabiding citizen will not have the aggression necessary and/or may not know how to physically fight back if attacked by an aggressive person with a knife.

I believe in education as a form of prevention. More discussion is needed on firearms safety, awareness, education, and routine practice of skills for additional safety. Improving firearms education would be a far better option than living in fear of firearms or worse, violating the constitutional rights of those who wish to own firearms.

This bill has already taken up a lot of time [the previous bill included]. Passing this bill into law will take up even more time, unnecessarily, and for what outcome. The police in particular will have to enforce the law, which appears to be targeting firearms and law-abiding citizens who own firearms. Plus, this bill will not reduce violent crimes.

To protect the State of Hawaii and to ensure that our police officers are being used to their highest and best use, we should be focusing on improving mental health services, community resources, and education, which in turn would reduce anger, aggression, violence, and crime. People need support. This bill does not support anyone. If this bill is passed, it will be proof that as a community we are missing the bigger picture, because we live in fear of what is happening on the mainland. Let's take care of Hawaii the right way, our way, and be the example for the rest of the nation.

I humbly ask, please do not pass H.B. 1366, H.D. 1.

I am an undergraduate student at the University of Hawai'i at Manoa Thompson School of Social Work, and I strongly support bill H.B.1366 HD1, With its purpose to Amend the class C felony offense of manufacturing, purchasing, or obtaining firearm parts to assemble a firearm having no serial number and also prohibit possession of those firearm parts. In connection, Amends Act 74, Session Laws of Hawaii 2020, to repeal language that specified the prospective application of that Act.

Additional public safety depends on this bill's passage; This bill would help close any remaining loopholes surrounding "Ghost guns" as they are assembled from firearm components to create a new firearm that has no registration, serial number, or permit. Simultaneously having no serial number, those firearms evade the permit and registration process, thus not protect the public as to who can acquire such guns. However, I oppose any law changing that would make possession before the law's effective date legal. This would directly contradict this bill's purpose by enabling hundreds if not thousands of unidentified members of the community to use their "Ghost guns" freely, continuing the cycle of potential gun violence. Although gun violence is relatively low in Hawai'i compared to other locations in the U.S, we are in no position to allow room for any unforeseen tragedies regarding gun violence.
