- 1 **Fiscal Implications:** This measure may impact the priorities identified in the Governor's
- 2 Executive Budget Request for the Department of Health's (Department) appropriations and
- 3 personnel priorities.
- 4 Department Testimony: With the marked increased in the feral chicken population, the
- 5 Department appreciates the intent of HB 524 and offers comments. This bill prohibits feeding or
- 6 attempted feeding of feral chickens on public or private property. It requires the Department to
- 7 enforce the prohibition and authorizes county police departments to issue citations.
- 8 The bill suggests that when Department inspectors witness the feeding of feral chickens,
- 9 the Department shall, using its enforcement authority issue a Notice of Violation. It also
- authorizes the county police departments to issue citations. In practice, having two agencies to
- enforce the law is confusing. The Department respectfully suggests that only one agency be
- responsible for enforcement and that the county police departments would be more expeditious
- in responding and issuing citations.
- In certain circumstances, enforcement is a necessary tool. However, the Department
- believes that education and community outreach is more appropriate when dealing with behavior
- and cultural norms.

Honorable Legislators of Hawaii,

We understand that the legislature plans to pass a feeding ban for feral chickens. While well-intentioned, we do not believe that a public feeding ban will have any tangible effect on the population of feral birds.

Feral chickens are peculiar to Hawaii and rarely occur in any significant numbers in other US states. Like other pest birds, chickens are able to breed rapidly and produce many offspring once established. In other areas of the USA, the population of feral chickens is kept in check by raptors and other ground predators. The best option for Hawaii to get the population under control is to **stop the breeding**, "birth control" for birds.

Innolytics is the manufacturer of OvoControl (0.5% nicarbazin). The active ingredient is very safe, non-toxic, and environmentally benign. Treated birds are not harmed but instead, lay unfertilized eggs. The existing population declines through a natural process of attrition.

We understand that in a previous round of testimony that there was concern that people would eat the treated chickens and eggs. While we do not recommend human consumption of treated or even untreated feral chickens, the active ingredient has been approved by FDA for chicken use as a coccidiostat for more than *60 years*. The compound is supported by a tolerance limit and does not pose a health or safety threat to the public. There is infinitely more public health risk to eating a feral chicken than consuming some residue of the active ingredient.

We are happy to support the registration of OvoControl for feral chicken use with the Department of Agriculture in Hawaii.
