The Department of Defense (DOD) provides written comment for testimony of HB 835.

This measure, if passed would, appropriate funds to support the ongoing operations of the Hawaii National Guard Youth Challenge Program. There is appropriated out of the general revenues of the State of Hawaii the sum of \$1.7M for fiscal year 2021-2022 and the same sum or so much thereof as may be necessary for fiscal year 2022-2023 to support the ongoing operations of the Hawaii National Guard Youth Challenge Program. Our work with "at promise youth" has allowed us to teach our youth about the potential they have for impacting our communities in very profound and substantial ways. The Youth Challenge cadets are learning to reframe their challenging lived experiences as assets, and to understand how those assets constitute much of the promise they bring to the State of Hawaii.

The DOD does not support this measure if it impacts or replaces the priorities set forth in the Executive Budget.

Aloha,

I am a counselor at Hilo High School and have been here for over 20 years. Throughout those years, I have had many students who found coming to school a challenge for whatever reason. As much as we try, we are not able to engage with these students and must offer some kind of alternative, if not, they will become society's problem. One of the most successful alternatives that we can offer is the Youth Challenge Program. Although it may not be 100% fool-proof, it is a great alternative that turns students around! When a student sees no hope for their future and everything in their lives has failed them, YC gives them that structure that they actually need. Personally, it is that freedom of choice that was allowed them that has gotten them to this point in the first place. I had one student tell me, "No Miss, when I get in, that's when I will behave and follow rules, until then, I don't need to."

The students need the structure and want to be held accountable. They thrive in this environment because their family structure and environment is absent. One of my students that graduated entered after her father committed suicide and her younger brother just dropped out of middle school. In order to get signatures, I went to their home and was appalled by what I saw. I can't imagine my student's thoughts when she saw the living conditions she was going to have in YC. I'm sure there must be other students in YC that have far worse conditions than my student. Youth Challenge not only changes the person, discipline wise, but the program opens students eyes to options and better futures. When my student graduated, I made every effort to go because I wanted her to see how proud I was of her and to let her know that I was there for support if she ever needed it in the future.

I currently have a student that is awaiting to enter into YC when he turns 16. His father is in and out of jail and he hasn't engaged in school since middle school. Without YC, he may follow his father's footsteps.

On behalf of my students, past and present, I write this testimony and ask that you continue to fund this much needed program. Without it, many of my future students will continue to not have hope for a better future!

Aloha, Rep Ilagan,

Please consider this my testimony in support of Bill 835, providing funding for Youth Challenge Academy.

Until December 31, 2020, when I retired, I hosted a weekly interview program and did radio news reporting, since 2004. I've lived in Kona since 1994. I had occasion to do stories plus an interview about Youth Challenge Academy several years ago. It was clear then that the program has the potential to be life changing.

Within the past several months, I had the opportunity to interview two people who were students at the YCA, young people headed in completely the wrong direction, who credited the YCA with turning their lives around.

One is now a Hawaii County Police Officer who has been recognized three times, I believe, for his good work as Officer of the Month by the Kona Crime Prevention Committee. He told me he was hanging out with the wrong crowd and knew he would continue down the wrong path if not for Youth Challenge Academy. He told me he is so impressed by YCA that he has on occasion suggested to high school students whom he was called to deal with as an officer that they should consider YCA to help them get on the path to positive adulthood.

Another graduate is a young woman who is now a successful college student. She told me she was, before entering YCA, spending time with an older man, in an inappropriate situation, and was not motivated by her at-the-time high school here on the island. Her mother got her enrolled in YCA, and the young woman said the discipline and leadership there helped her turn her life around. She is not only in college in Hilo, but also is working. I know her mother and knew her as a child, and I can attest, she is now on the road to being a successful adult, with proper motivation and ambition.

This is a really important facility for our island. It has really been good for the community, in helping create great citizens. Please help this fine program continue here on the Big Island, as it is sorely needed.
