Chair Baker and Members of the Committee:

MEASURE:S.B. No. 1386TITLE:RELATING TO THE PUBLIC UTILITIES COMMISSION.

**DESCRIPTION:** Requires the chairperson of the public utilities commission to appoint an administrative assistant, a research assistant, and legal counsel to assist each member of the public utilities commission with commission duties. Prohibits the chairperson from dismissing or re-assigning appointed staff members without the prior written approval of the affected commissioner.

## **POSITION:**

The Public Utilities Commission ("Commission") offers the following comments for consideration.

## COMMENTS:

This measure would require the Chair of the Commission to appoint an administrative assistant, research assistant, and legal counsel to assist each Commissioner.

Commissioners currently have access to all staff resources and are free to request their assistance as they see fit. Staff members are assigned by our section chiefs to various dockets and other projects in accordance with their background and specialties, in a manner that most efficiently supports the Commission as a whole. This approach involves creating numerous combinations of staff members across docket teams, which lends to the Commission's collaborative approach to its work. Assigning staff to specific Commissioners would complicate these internal processes, reduce efficiencies, and likely require reclassification of several positions.

The Commission understands that the proposed process of assigning staff to specific Commissioners may exist in a very limited number of utility-regulating bodies in other states. However, this practice does not tend to exist in commissions with similar, collaborative structures.

For these reasons, the Commission believes that the proposed changes would create unnecessary challenges without clear benefits. However, the Commission will implement the provisions of this measure if so directed by the Legislature.

## On the following measure: S.B. 1386, RELATING TO THE PUBLIC UTILITIES COMMISSION

Chair Baker and Members of the Committee:

My name is Dean Nishina, and I am the Executive Director of the Department of Commerce and Consumer Affairs' (Department) Division of Consumer Advocacy. The Department offers comments on this bill.

The purposes of this bill are to: (1) require the chairperson of the Public Utilities Commission (Commission) to appoint an administrative assistant, a research assistant, and legal counsel to assist each commissioner, and (2) prohibit the chairperson from dismissing or re-assigning appointed staff members without the prior written approval of the affected commissioner.

The Commission and the Department have been dealing with significant workloads across all of the regulated industries under the Commission's oversight, and the Commission has generally met procedural timelines and has been willing to establish aggressive timelines, such as for the Phase 1 renewable energy projects resulting from Docket No. 2017-0352. The proposed organizational change may require either: (1) additional funds to add the staff positions to be assigned to each commissioner; or (2) a reorganization that would reassign staff members, who are currently part of the pool of analysts serving Commission objectives, to serve individual commissioners' needs.

The Department generally defers to the Commission on the need for this bill and whether it would improve the Commission's efficiency and/or productivity.
