TESTIMONY ON SENATE BILL 513 RELATING TO ENFORCEMENT OF LAWS. By Max N. Otani, Director

Chair Nishihara, Vice Chair English, and Members of the Committee:

The Department of Public Safety (PSD) offers comments on Senate Bill (SB) 513, which would increase the fireworks display permit fees and increase the maximum fines for fireworks violations. The measure would also create a separate criminal offense for the illegal sales of certain display fireworks, aerial devices, and pyrotechnic articles and increase the penalty for removing or extracting the pyrotechnic contents. In addition, SB 513 would require the Department of the Attorney General to establish an explosion detection technology working group and require PSD to develop and implement a webbased firework reporting tool. The measure also seeks to authorize PSD's Sheriffs Division to enforce the fireworks control laws and appropriates funds for that purpose.

PSD supports SB 513's proposal for increased fees and penalties to deter the illegal use of fireworks. The Department also supports the implementation of a program to disrupt the flow of illegal fireworks and respectfully offers the following additional comments. In our view, the establishment of a viable enforcement program will require consideration of the inherent dangers in the improper handling and removal of explosives materials from fireworks. These considerations necessitate the specialized training of personnel in the safe detection, handling, and disposal of explosive materials, beyond their basic training in law enforcement. LEOs assigned to a fireworks enforcement team must be further trained in the recognition and classification of consumer fireworks (Department of Transportation [DOT] classification 1.4) and display fireworks (DOT classification 1.3). An additional explosive detection canine and handler will also be required to round out the team. PSD respectfully requests the authorization for the hiring of five LE Officers to be specially trained in this initiative, as well as for one explosive detection canine and handler team.

The Department must also develop a shipping container inspection program and be given authorization to review domestic and foreign shipping manifests to narrow the scope of shipping containers to be inspected. In addition to National Guard assets, PSD shall coordinate with the U.S. Coast Guard Service, the federal Consumer Product Safety Commission, State of Hawaii DOT Harbors Division, and the U.S. Department of Homeland Security.

Appropriations of approximately \$950,000 per year must be allocated to PSD for the effective detection, safe storage, and disposal of illegal fireworks.

Appropriations of approximately \$150,000 per year must be allocated to PSD for the development and maintenance of the web-based fireworks reporting system.
