RELATING TO INVASIVE SPECIES

The Department of Budget and Finance (B&F) offers comments on this bill.

House Bill No. 1179: establishes a pilot program within the Aina Mauna Legacy Program of the Department of Hawaiian Home Lands (DHHL) to remove and harvest gorse from Mauna Kea and develop it as a marketable product to expand economic opportunities for native Hawaiians; requires DHHL to submit reports to the Legislature; appropriates an unspecified amount of general funds for FY 22 for the pilot program; and takes effect on July 1, 2021 and will be repealed on June 30, 2025.

B&F notes that, with respect to the general fund appropriation in this bill, the federal Coronavirus Response and Relief Supplemental Appropriations Act requires that states receiving Elementary and Secondary School Emergency Relief (ESSER) II funds and Governor's Emergency Education Relief II funds must maintain state support for:

 Elementary and secondary education in FY 22 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and Higher education in FY 22 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

Further, the federal American Rescue Plan (ARP) Act requires that states receiving ARP ESSER funds must maintain state support for:

- Elementary and secondary education in FY 22 and FY 23 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and
- Higher education in FY 22 and FY 23 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

The U.S. Department of Education has issued rules governing how these maintenance of effort (MOE) requirements are to be administered. B&F will be working with the money committees of the Legislature to ensure that the State of Hawai'i complies with these ESSER MOE requirements.

HB 1179 RELATING TO INVASIVE SPECIES

Aloha Chair Nakashima, Vice Chair Matayoshi, and members of the Committee:

Thank you for the opportunity to testify on House Bill 1179. This bill establishes a pilot program within the Aina Mauna legacy program of the Department of Hawaiian Home Lands (DHHL) to remove and harvest gorse from Mauna Kea and develop it as a marketable product to expand economic opportunities for native Hawaiians. The Department supports the intent of this measure as long as it doesn't affect the priorities identified in the Governor's Supplemental Budget request.

Gorse is a highly invasive thorny shrub that creates impenetrable thickets which can be over 12 feet tall. DHHL Aina Mauna lands contain Hawaii's largest infestation of gorse, covering over 10,000 acres which prohibits homesteading and other land uses. The ecology and characteristics of this invasive species, which include abundant and early seed production, is easily spread and an over 30-year seedbank life, make containment, removal and long-term control of gorse very difficult and costly. The importance of eliminating this plant cannot be overstated. DHHL spends a great amount of time, effort and resources to control gorse annually and continues to look for the most feasible, efficient and effective long term solution to the gorse infestation on the Aina Mauna lands of Humuula and Piihonua. Any assistance in this effort is greatly appreciated.

Re: HB 1179 Realting to Invasive Species

Thank you for this opportunity to support HB 1179 that will provide funding for the removal of gorse a difficult to eradicate invasive species that has become detrimental and wide spread on Mauna Kea because of its aggressive seed dispersal system.

An economic opportunity will be created by the utilization of harvested gorse in a research project to make feed for animals from local agricultural products. Initially feed will be made for pigs by combining gorse with waste algae from Cyanotech and macadamia nut hulls. Then feed for cattle will be worked on utilizing a special algae grown by Symbrosia at NELHA. Requests have been received for chicken, fish and feed for other aquatic animals to be developed.

A group of Korean natural pig farms are working to increase production for a market on
Oahu. These farmers have been faced with a huge increase in the price of feed for their animals
when it is available because of Covid and the 47% increase of shipping cost by Young
Brothers.

This funding will assist with the removal of gorse on Mauna Kea so Department of Hawaiian Homes will be able to assigned the cleared land to native homesteaders waiting for assignments, production of animal feed from local agricultural products, and local produced feed for animals.
