ON HOUSE BILL NO. 124

RELATING TO ELECTIONS

February 1, 2022

Chair Nakashima and members of the House Committee on Judiciary & Hawaiian Affairs, thank you for the opportunity provide comments on House Bill No. 124. This bill requires the chief election officer to develop and distribute a voter information guide for all candidates running for state office, including candidates running for any trustee position of the office of Hawaiian affairs.

We believe an informed electorate is important for the health of our democracy, however, our office must remain apolitical. As such, to compile a voter information guide, we would ask all candidates to submit a statement for inclusion in a voter information guide when they file their nomination paper. After the candidate filing deadline, we would translate and compile these statements and publish a notice in the newspapers that it is available on our website. The voter information guide would need to be available at least 45 days before the primary election to coincide with ballots being sent to uniformed and overseas voters. Our initial cost estimate is \$50,000 to provide a voter information guide in this manner.

To print and insert a separate notice to include in the ballot packet for the primary and general election would raise the cost by approximately \$60,000. With this, the total estimated cost would be \$110,000.

If we were required to print and disseminate the voter information guide, we estimate it would be 200 pages. We are also assuming this would be disseminated before the primary election only. Target mailing	\$2,700,000
Publish the full guide	\$910,000
Libraries	\$50,800

We would also ask that the effective date for this measure be January 1, 2023, for the 2024 Elections.

HB 124 - SUPPORT FOR VOTER INFORMATION GUIDES

Aloha Chair Nakashima, Vice Chair Matayoshi and Members of the Committee!

My name is Kat Brady and I am the Coordinator of Community Alliance on Prisons, a community initiative promoting smart justice policies in Hawai`i for more than two decades. This testimony is respectfully offered on behalf of the more than 4,103 Hawai`i individuals living behind bars or under the "care and custody" of the Department of Public Safety or the corporate vendor on any given day. We are always mindful that 1,113 of Hawai`i's imprisoned people are serving their sentences abroad thousands of miles away from their loved ones, their homes and, for the disproportionate number of incarcerated Kanaka Maoli, far, far from their ancestral lands.

HB 124 requires the Chief Elections Office to develop and distribute a voter information guide. Community Alliance on Prisons is in support of this measure. vibrant democracy depends on an informed electorate. A responsible and responsive democracy is inclusive and accessible. We respectfully share some important things to think about when developing this guide.

- Ensure that it is nonpartisan, written in plain language, and is accessible to all.
- To ensure wide user-ability, the guide must be translated into the languages spoken in Hawai`i including, but not limited to Chuukese, Chinese, Hawaiian, Ilokano, Japanese, Samoan, Tagalog, Tongan, Vietnamese, etc.
- To ensure wide accessibility, besides the normal channels, newspapers, websites, social media, community newsletters, the guide should be available at local businesses and places where people gather banks, grocery stores, libraries, community centers, government buildings, jails, etc.

Many states have voter guides and many have them translated into the languages spoken by their people. A quick look showed that Alaska's guide is translated into 12 different languages! Community Alliance on Prisons looks forward to the day when incarcerated persons will be treated as citizens and afforded the right to vote! Please pass this measure.

For almost twenty years I have brought requests to the Legislature, asking for a voter information guide. When I lived in Alaska earlier, the voting guide helped farflung residents around the state understand what they would see on their ballots. Now it is time for Hawai`i to step up and join those states that believe in disseminating voting information -- neutral and easily understandable.

VOTE411, the website made available by the Hawai`i League of Women Voters, has become the single website where voters can learn about candidates and issues. Speaking from personal experience, I can tell you that voters are fulsome in their praise for the site. However, it requires hundreds of hours of volunteer work and some expense to the organization to be able to post the information. As much as LWV tries to publicize the site, many voters do not hear of it and vote blindly. Furthermore, many voters do not have access to the internet.

The responsibility for a voter quide that is disseminated through many avenues belongs to the state. Please support HB124.
