## Testimony of the Office of the Public Defender, State of Hawai'i to the House Committee on Consumer Protection & Commerce

February 2, 2022

H.B. No. 1486: RELATING TO THEFT

Chair Aaron Ling Johanson, Vice Chair Lisa Kitagawa and Members of the Committee:

The Office of the Public Defender respectfully opposes H.B. No. 1486, which would amend HRS § 708-830.5 to add theft of a motor vehicle as defined under section 291C-1 of the Hawai'i Revised Statutes to the crime of Theft in the First Degree. The bill also adds "motorcycles and motor scooters" to be included in the amended statute. As it currently stands, the majority of motor vehicle theft is prosecuted as a class C felony offense punishable by up to five years in prison and/or a \$10,000 fine, as most vehicles are valued at \$750 or above. The proposed amendment to the Theft in the First Degree statute would make motor vehicle theft a class B level felony offense punishable by up to ten years in prison and/or a \$20,000 fine. Thus, H.B. 1486 is strictly a punitive measure that seeks to double the maximum prison term for motor vehicle theft from five years to ten years.

We want to stress that this bill will have no effect on deterring auto theft. The idea that the existence of a particular criminal offense serves as a deterrent to criminal activity has long been rejected. Those who engage in criminal conduct do not stop to weigh the judicial consequences of their actions. Our current penal code adequately addresses different scenarios commonly involved in auto theft. Carjacking is prosecuted as either Robbery in the First Degree (20-year maximum prison term) or Robbery in the Second Degree (10-year maximum prison term) under HRS § § 708-840 and 708-841(1). Unauthorized Control of a Propelled Vehicle in the First Degree under § 708-836 (operating a stolen vehicle) and Unauthorized Entry into Motor Vehicle in the First Degree (breaking and entering into a vehicle with intent to steal) under § 708-836.5 are both punishable by up to five years in prison.

This proposed legislation is also overly broad in that theft of a "motor vehicle" stands to include "motorcycles and motor scooters". The definition of "motor scooter"

would include any electric or gas scooter with a handlebar and seat attachment regardless of value. <sup>1</sup> Thus, almost *any* type of two-wheeled, self-propelled vehicle, could potentially be covered under this definition. In today's era of modern advancements and affordable technology, this could include a myriad of lithium powered electric gadgets with wheels.

If the legislature is inclined to pass this amendment, it needs to consider that our correctional facilities will quickly become more overcrowded and the burden on our already limited social services will grow exponentially. Our jails and prisons are filled above not only design capacity but also operational capacity. A significant portion of the State's prison population are incarcerated in a contracted private, forprofit prison in Arizona; they are exiled thousands of miles away from their families, friends, and crucial support networks. According to a recent study by the Prison Policy Initiative, in 2018, Hawai'i had an incarceration rate of 487 per 100,000 people.<sup>2</sup> Although Hawai'i ranked 37th among the 50 states, if every state was an independent nation, Hawai'i would have the 43rd highest incarceration rate in the world.<sup>3</sup> Only three foreign countries have a higher incarceration rate than Hawai'i. Thus, Hawai'i locks up a higher percentage of its people than many wealthy democracies do.<sup>5</sup> With the recent nationwide review of criminal justice policies, it is concerning that the trend in the State of Hawai'i is to increase penalties.

In conclusion, the proposed bill does nothing to deter motor vehicle theft, is a purely punitive measure, and is simply not necessary. As noted above, our penal code is adequately structured to cover a multitude of motor vehicle theft-related scenarios. What this bill will have an effect on doing is exacerbating our already overcrowded jail facilities and further clog our judicial system.

SUBJECT: House Bill No. 1486, Relating to Theft

I am Jarod Hiramoto, Captain of the Criminal Investigation Division of the Honolulu Police Department (HPD), City and County of Honolulu.

The HPD supports House Bill No. 1486, Relating to Theft.

Currently, when a suspect is arrested for a stolen vehicle, they are charged with Section 708-836, Unauthorized Control of a Propelled Vehicle in the First Degree of the Hawaii Revised Statutes (HRS) or Section 708-836.1, Unauthorized Control of a Propelled Vehicle in the Second Degree, HRS. However, the suspect has to have control of the vehicle to be charged with these violations. Simply being in possession of or having access to the stolen vehicle is insufficient to sustain a charge of theft of a vehicle. Amending the offense of Theft in the First Degree to include the theft of a motor vehicle will enhance law enforcement's capabilities to arrest and charge a suspect for this violation.

One area of concern is the language under Section 291C-1, Definitions, HRS, where the definition of a "motor vehicle" excludes mopeds. The exclusion of a moped will need to be addressed by the legislative body, as it leaves a gray area where law enforcement and the prosecution will have difficulty resolving this issue in a court of law.

## TESTIMONY IN SUPPORT OF HOUSE BILL 1486

Honorable Chair Johanson, Vice-Chair Kitagawa and Members of the Committee on Consumer Protection & Commerce. The County of Hawai'i, Office of the Prosecuting Attorney submits the following testimony in strong support of House Bill 1486.

This bill was drafted to establish Theft of a Motor Vehicle as a subsection of Theft in the First Degree. Currently, most motor vehicle thefts are prosecuted as Theft in the Second Degree and/or Unauthorized Control of Propelled Vehicle in the First Degree, both of which are class C felony offenses. By increasing the penalty to a class B felony offense, we promote respect for the law, ensure that offenders receive an appropriate sentence that reflects the seriousness of the offense, provide adequate deterrence for future criminal activity, and protect the public.


Hawai`i Island is composed of rural communities, with limited mass public transit accommodations to service the needs of our residents. As a result, citizens rely heavily upon personal vehicles for their daily transportation, livelihoods, and to support their families. Victims of motor vehicle theft often share the hardships incurred as a result of losing their sole means of transportation. In addition, these motor vehicles often times contain personal property including but not limited to work related tool and trade equipment, child safety equipment (car seats, strollers, etc.), money, mobile electronic devices, and confidential and personal information, which may subject the victim to additional crimes and/or vulnerability.

Over the past year, our Office has met with community groups, local government leaders, law enforcement officials, and members of the public about their concerns and interests regarding the criminal justice system. Given recent crime trends and in consideration of the criminal matters that are handled by our Office, we collected data through an online survey in hopes of addressing our community's concerns and prioritizing the safety and well-being of Hawai`i Island residents. A total of 1,422 individuals participated in our online legislative

initiatives survey, which ran from December 9, 2021 through December 30, 2021. Of those 1,422 participants, 1,265 or 89.21% of those surveyed, supported establishing Theft of a Motor Vehicle as a class B felony offense. Please see the graph below for more information.

#### BACKGROUND

Currently most car thefts are prosecuted under the offenses of Unauthorized Control of a Propelled Vehicle in the First Degree (operating a vehicle or changing the vehicle's identity without the owner's consent) and Theft in the Second Degree (theft of property which exceeds \$750 in value), both of which are only class C felony offenses, and carry a maximum penalty of five (5) years in prison. In order to prosecute a felony theft as a class B felony, the stolen property in question (a motor vehicle or motorcycle) would have to be valued at an amount greater than \$20,000.

Under HRS 708-830.5, Theft in the First Degree is a class B felony offense and carries a maximum penalty of ten (10) years in prison.

#### PROSECUTORS PROPOSAL

The Office of the Prosecuting Attorney proposes establishing "Theft of a Motor Vehicle and/or Motorcycle" as a subsection of Theft in the First Degree to eliminate the need to provide an estimated value of a vehicle or motorcycle in order to prosecute a class B felony theft. Furthermore, by increasing the maximum penalty, we promote respect for the law, ensure that offenders receive an appropriate sentence that reflects the seriousness of the offense, provide adequate deterrence for future criminal activity, and protect the public.
