MAKING AN APPROPRIAITON FOR A KONA HOSPITAL SITE ASSESSMENT

The Department of Budget and Finance (B&F) offers comments on this bill.

House Bill No. 1638 appropriates \$1,000,000 in general funds for FY 23 to the Hawai'i Health Systems Corporation to conduct a site assessment to identify and evaluate viable locations for a new hospital site in North Kona on the island of Hawai'i.

B&F notes that, with respect to the general fund appropriation in this bill, the federal Coronavirus Response and Relief Supplemental Appropriations Act requires that states receiving Elementary and Secondary School Emergency Relief (ESSER) II funds and Governor's Emergency Education Relief II funds must maintain state support for:

- Elementary and secondary education in FY 22 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and
- Higher education in FY 22 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

Further, the federal American Rescue Plan (ARP) Act requires that states receiving ARP ESSER funds must maintain state support for:

- Elementary and secondary education in FY 22 and FY 23 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and
- Higher education in FY 22 and FY 23 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

The U.S. Department of Education has issued rules governing how these maintenance of effort (MOE) requirements are to be administered. B&F will be working with the money committees of the Legislature to ensure that the State of Hawai'i complies with these ESSER MOE requirements.

Aloha Chair Yamane, Chair Johanson, Chair Luke, and Members of the Committees:

I thank you for the opportunity to testify in support of HB 1638, relating to making an appropriation for a Kona Hospital Site Assessment. My testimony is submitted in my individual capacity as a member of the Hawai'i County Council and Chair of the Hawai'i County Council Climate Resilience and Natural Resource Management Committee.

The purpose of this measure appropriates moneys to the Hawaii Health Systems Corporation to conduct a site assessment to identify and evaluate viable locations for a new hospital site in North Kona on the island of Hawaii.

Hawaii is known to be one of the safest places in the world. The 2020 Census shows that for the first time Hawaii Island has over 200,000 residents, gaining over 15,000 people in this 10 year period. These numbers were assessed before the pandemic housing buying frenzy we have heard about and felt in our communities.

The distance from Kona Pier to Kona Community Hospital is 10.5 miles, that's a 20 minute trip that could be the difference between life and death.

The stretch of highway just north of Kona International Airport has the highest number of fatality crashes on our island. In an emergency going south will take over 30 minutes (20 miles) to Kona Community Hospital, and if you go north it will take you over 25 minutes (40 miles) to get to North Hawaii Community Health Center. These routes are on Queen Ka'ahumanu, our single lane highway that has little or no shoulder in some areas.

On January 21st there was a fire in Kealakekua. Traffic was so backed up and Fire and Rescue could not use the Mauka route on Queen Kaahumanu Highway to get to the fire, they had to go all the way Makai to Ali'i Drive past the scene then backtrack to get to the scene. In cases of emergencies, our limited facilities and accessibilities could add stress and time to already dire situations for our community members.

For the reasons stated above I urge the Committee on Health, Human Services, and Homelessness; the Committee on Consumer Protection and Commerce; and the Committee on Finance to support this measure and make an appropriation for a Kona Hospital Site Assessment for North Kona.
