- 1 **Fiscal Implications:** This measure will not impact the priorities identified in the Governor's
- 2 Executive Budget Request for the Department of Health's (Department) appropriations and
- 3 personnel priorities.
- 4 **Department Testimony:** The Department supports HB1642 HD1 to amend Hawaii Revised
- 5 Statutes (HRS) Section 342G to establish minimum postconsumer recycled content requirements
- 6 for all deposit beverage containers imported into or manufactured within the State.
- 7 In fiscal year 2021, approximately 376,000,000 plastic deposit beverage containers were
- 8 imported into or manufactured in the State. Approximately 218,000,000 of those plastic bottles
- 9 were redeemed for recycling. While the current redemption rate of 58% needs to be improved,
- there is a significant quantity of plastic containers being redeemed to provide quality feedstock to
- meet a modest goal of 15% in six years.
- Unfortunately, the cost to manufacture plastic beverage containers using virgin
- 13 polyethylene terephthalate (PET) is slightly cheaper than the cost to manufacture plastic
- beverage containers using recycled PET flakes. This disincentivizes recycling. The Department
- supports implementing a targeted market intervention that will increase the demand for recycled
- 16 products and create additional incentives to redirect deposit beverage containers away from
- 17 landfills and towards recycling.

Aloha Chair Ling Johanson and Members of the Committees:

I thank you for the opportunity to testify in support of HB 1642 HD1. My testimony is submitted in my individual capacity as a member of the Hawai'i County Council and Chair of the Hawai'i County Council Climate Resilience and Natural Resource Management Committee.

The purpose of this Act is to establish minimum postconsumer recycled content requirements for deposit beverage containers.

Minimum postconsumer recycled content requirements for deposit beverage containers are needed to reduce waste, transition the State toward a circular economy, and encourage interest in recycling among deposit beverage distributors. The implementation of a minimum postconsumer recycled content requirement for deposit beverage containers will divert waste from landfills and direct them to recycling, thus reducing waste.

It is also important to adjust the minimum postconsumer recycled content percentage required pursuant to this section; report requirements by deposit beverage distributors of deposit beverage containers subject to this part; provide penalties or fees; and any other matters as may be necessary in order to implement this part.

The American Chemistry Council (ACC) would like to offer the following comments on HB 1642 HD 1, legislation that would establish requirements that beverage containers utilize the following minimum percentage of recycled material (PCR):

- No less than 15 percent by 12/31/28.
- No less than 25 percent by 12/31/33; and
- No less than 50 percent by 1/1/35.

ACC appreciates recent amendments that address some of the concerns previously raised by stakeholders. As stated in earlier testimony, ACC supports the overall intent of this legislation. As more states establish similar PCR requirements, coupled with many consumer brand companies utilizing recycled material in their packaging a substantial increase in the amount of PCR material available in the marketplace will be necessary. More households will need access to recycling collection systems and significant enhancements will need to be made to sorting systems as well as the recycling infrastructure to boost the available supply of recycled material.

Mechanical recycling will need to expand, and new advanced recycling¹ facilities will need to come online to improve recycling rates and increase the amount of recycled plastic available for use in packaging applications.

ACC also encourages you to consider comments submitted by the American Beverage Association and the International Bottled Water Association. While HB1642 HD1 directs the Department of Health to develop implementing regulations, additional specificity around such issues as how the department will adjust minimum PCR requirements should be spelled out in the statute.

Additionally, should HB1642 HD1 move forward, ACC believes an amendment is necessary that would allow companies to calculate PCR percentages either by weight "or another metric as determined by the department." This language was incorporated into similar legislation adopted in New Jersey² and is important as more recycled resin gets produced via "advanced recycling" technologies.

Unlike mechanical recycling, which essentially cleans, chops, and melts plastic into reused plastic, advanced recycling breaks down waste to the molecular level to create renewed resources. Companies can use a "mass balance" formula to trace, measure and report the amount of recycled material that is blended into new packaging. Mass balance principles are used by several industries, including in the renewable energy sector.

These methods are third-party certified to ensure accuracy and transparency to track certified recycled content through critical points in the value chain. In evaluating a mass balance formula, ACC would urge the department to convene a stakeholder group of interested parties and experts during the regulatory implementation phase and we would welcome the opportunity to participate in such a discussion.

Written Testimony of David Thorp, American Beverage Association

Before the House Committee on Consumer Protection & Commerce Opposition to H.B. 1642, HD 1: Relating to Postconsumer Recycled Content February 23, 2022

Good afternoon Chair Johanson, Vice Chair Kitagawa and members of the committee. Thank you for the opportunity to provide comments in opposition to H.B. 1642, HD 1 – relating to postconsumer recycled content.

I am David Thorp, Vice President, State Government Affairs West for the American Beverage Association (ABA). The American Beverage Association is the trade association representing the non-alcoholic beverage industry across the country and here in Hawaii.

Increasing the use of post-consumer recycled material in our packages is a top priority for the beverage industry and our member companies are working to meet their own recycled content goals in the coming years.

Increasing recycled content in plastic bottles is, however, just one aspect of our overall goal to reduce plastic waste; the beverage industry is also actively engaged in policy advocacy and investing in recycling to facilitate the increase of recycled content in its packaging.

Several states are or have considered legislation to mandate minimum recycled content in plastic beverage bottles and other packages and products. Mandating these targets is not, by itself, a sufficient response to the significant barriers that stand in the way of achieving a circular U.S. economy.

Mandates to use recycled content do not directly address issues of insufficient supply of material, which is the case with recycled PET, for example.

State-specific recycled content standards also conflict with the realities of a diverse and globalized supply chain for consumer goods including beverages. Production occurs regionally or even in one or two national locations for some products, and inventory is not designated for sale in one particular state or group of states. The supply chain from producer to warehouse to distributor to retailer is not structured to serve just one state, or even one country.

Recognizing these limitations to mandated content standards, we also acknowledge that there is active discussion around legislation in this area and we as an industry have actively engaged with stakeholders to help shape those legislative proposals. However, H.B. 1642, HD 1 at this point falls short of providing the principles and parameters for these mandates.

The Hawaii Food Industry Association is comprised of two hundred member companies representing retailers, suppliers, producers, and distributors of food and beverage related products in the State of Hawaii.

HFIA supports the intent of this measure to increase recycled content in packaging. Many of our member companies have set aggressive goals to increase the recycled content in their packaging. We believe that the most effective way to accelerate the percentage of post-consumer recycled content in products and packaging is through collaborative efforts with manufacturers, incentives, and by creating and supporting recycling infrastructure. Unfortunately, our State has chosen to not prioritize recycling as a waste management strategy. There are currently no large-scale recycling operating in Hawaii that manage the materials mentioned in this bill.

Beverage manufacturing is an important local industry. Hundreds of types of sodas, juice drinks, water, beer, and other beverages are bottled and canned right here on Oahu in Kapolei. This includes multinational brands as well as small local drink brands. This industry creates jobs, generates tax revenue, and provides products for Hawaii consumers. We believe that better outcomes will be achieved by taking a collaborative approach and working with these companies, rather than imposing arbitrary percentages on a rapid timeline. We urge the Committee to hold this measure and we thank you for the opportunity to testify.
