Chair Rhoads, Chair Dela Cruz, and Members of the Committees:

My name is Chelsea Fukunaga, and I am the Executive Officer of the Board of Nursing (Board). The Board appreciates the intent of and offers comments on this bill.

The purpose of this bill is to allow for temporary permits to be issued to registered nurses and licensed practical nurses from a territory or foreign country that are seeking a State license by endorsement.

The Board appreciates the bill's intent to expand the eligibility for a temporary permit to certain registered nurses and qualified licensed practical nurses from other territories and foreign jurisdictions to allow more qualified healthcare professionals to quickly find employment and enter the State's healthcare industry.

For the Committee's information, all applicants for temporary permits by endorsement are required to meet all licensing requirements, which includes, but is not limited to: (1) satisfactory evidence of passing a professional licensing examination recognized by the Board; (2) proof of authorization to work in the United States; (3) fingerprinting for criminal history checks; and (4) proof of graduation from a nursing program at an educational institution in the United States or any territory or possession under the jurisdiction of the United States, or proof of graduation from a nursing program at an educational institution in a foreign jurisdiction and have had their transcripts evaluated by professional evaluators designated by the Board, and are considered qualified as determined by the Board.

As such, the amendments proposed in this bill will expand the pool of qualified applicants without undermining the strength of the Board's current screening process.

Comments on HB 1758, HD2, SD1

Chairs Rhoads and Dela Cruz, Vice Chairs Keohokalole and Keith-Agaran, members of the Senate Committee on Judiciary, and members of the Senate Committee on Ways and Means, thank you for the opportunity to provide **comments on HB 1758, HD2, SD1.**

Hawai'i is a currently facing a nursing workforce shortage. Improving access to care by nurses is critical to ensuring the people of Hawai'i receive healthcare when they need it, and by high-quality healthcare professionals. In 2021, the Center for Nursing reported that the current workforce shortage has several contributors including the pandemic's impact on the workforce, pre-existing challenges including our nursing faculty shortages, efforts in new-graduate nurse recruitment, as well as other factors such as difficulty in recruiting travel nurses, cost of living and housing availability in Hawai'i, and other issues. The problem is complex and there is a need to address nursing workforce supply using a multifaceted approach. The Center recognizes a long history of recruitment of internationally trained nurses. In addition, the Center acknowledges the important role of the legislature in supporting local and foreign graduates of nursing to pass the entry to practice licensing exams, as well as enabling nurses who are licensed and in good standing under the laws of another state, territory, or foreign country to become licensed by endorsement in Hawai'i.

The Center defers to the Board of Nursing and the Department of Commerce and Consumer Affairs as it relates to the processing and reviewing eligibility of applications by endorsement for temporary permitting.

We commend the State Legislature for identifying solutions address access to healthcare in Hawai'i. Thank you for providing opportunties to comment on this measure.

The Hawai'i Friends of Civil Rights submits testimony in **Support of House Bill1758, HD2, SD1** which seeks to allow temporary permits to be issued to registered nurses and licensed practical nurses from a territory or foreign country who are seeking a state license by endorsement.

Hawai'i's capacity to meet the state's demand for nursing care may already be at a critical tipping point as the pandemic extends into its third year and exhausted health care providers retire or leave the profession. According to the Hawai'i Department of Commerce and Consumer Affairs, almost 5,000 nurses left the field between 2019 and mid-year 2021, shrinking the total active workforce from 33,410 to 28,548 in mid-2021. Hawai'i employers have turned to traveling nurses, throughout the pandemic, to fill the gaps left by the nursing shortage and our increased pandemic-related health care needs.

An aging U.S. population will further increase the demand for nursing care across the nation and in Hawai'i. In its December 2021 report, *The Elderly Population in Hawaii: Current Living Circumstances and Housing Options,* the Department of Business, Economic Development and Tourism reports Hawai'i's percentage of elderly persons (ages 65 and over) at 19% in 2020 or approximately 1 in 5 persons. Accounting for aging baby boomers and increased life expectancy rates, Hawaii's percentage of elderly residents is projected to increase to 22.6% in 2030 and 23.7 % by 2040.

To obtain a work visa to enter the United States, foreign nurses must have at least a bacherlor's degree from an accredited academic nursing institution <u>and</u> a minimum of two years of relevant work experience. They also must pass rigorous background checks by the United States Citizenship and Immigration Services. The largest groups of immigrant nurses are from the Philippines, India, and Canada.

Immigrants comprise 23.4% of Hawai'i's registered nurse workforce according to a May 2021 report published by the New American Economy. Their prior work experience brings added value to hospitals and other health care providers. And multi-lingual registered nurses may also be relied upon to reliably communicate vital medical information to limited English proficient patients.

Dear Committee Members,

The Hawai'i Coalition for Immigrant Rights (HCIR) SUPPORTS HB 1758 HD2 SD1, Relating to Nurses. HB 1758 HD2 SD1 allows for temporary permits to be issued to registered nurses and licensed practical nurses from a territory or foreign country that are seeking a state license by endorsement.

First, this bill fixes the inequitable treatment between registered nurses and licensed practical nurses from a territory or foreign country and those from non-Hawai'i U.S. states. All nurses without a Hawai'i-based license must obtain one to practice nursing in Hawai'i. Currently, for nurses who are licensed in other U.S. states, certain qualified applicants for licensure by endorsement are eligible for a temporary permit. This allows these nurses to begin practicing immediately as their application undergoes the verification and review process. For nurses licensed in a U.S. territory or foreign country, however, the otherwise similarly-situated qualified applicants for licensure by endorsement do not currently have this option for a temporary permit. There is no reason for the discrepancy in treatment of these experienced, qualified nurses.

Second, this bill is an important step in lowering the barriers for immigrant professionals to contribute to our economy and our community. Many immigrants end up leaving behind their professional careers when they come to the United States in search of a better life for their families. One HCIR member shares that her mother was a health care professional in their country of origin. When they moved to the United States, her mother gave up that career because of the practical and economic barriers in obtained a new license. Immigrants should not be made to choose between their profession and their communities in the United States. Hawai`i is worse off if experienced, highly qualified nurses are unable to use their skills due to bureaucratic barriers. The passage of this bill will allow nurses to quickly find employment with the temporary permit while they wait for their permanent licenses to process, thus lowering the economic barriers to entering the nursing profession here in Hawai`i.

Finally, this bill is a critical piece in addressing Hawai'i's well-documented nursing shortage. It will allow qualified nurses to tackle Hawai'i's critical health care needs immediately. Even

before COVID-19, the nursing shortage in Hawai'i was a prominent problem, and COVID-19 exacerbated that problem, straining Hawai'i's health care system to unprecedented levels. The shortage leaves Hawai'i particularly vulnerable due to the remote location. This month, the effects of the shortages were acutely felt, as significant numbers were unable to work due to COVID-19 infections or exposures, with one day seeing 1,500 frontline caregivers out of work (10% of the workforce).²

As many have noted, we are heading into the next chapter of the fight to end COVID-19 and recover economically. This bill will allow registered nurses and licensed practical nurses from a territory or foreign country to more quickly and easily join that fight. That would be to the benefit of the whole Hawai'i community. We support HB 1758 HD2 SD1.

I am writing in SUPPORT of HB 1758, HD2, SD1 which would allow temporary permits to be issued to registered nurses and licensed practical nurses from a territory or foreign country who are seeking a state license by endorsement.

Under the licensing statutes, licensure by endorsement is available to licensed practical nurses who are licensed and in good standing in other states, territories, or foreign countries. Certain qualified applicants for licensure by endorsement who are licensed in another state are eligible for a temporary permit to practice in the State while their applications are verified and reviewed. Making it possible for qualified nurses from another territory or foreign country to be eligible for a temporary permit would create a pathway for more nurses to enter the workforce quickly. This process may encourage nurses from another state, a territory or foreign country to relocate to Hawaii.

We write today in **support** of this measure, which seeks to allow temporary permits for licensed practical nurses (LPNs) and registered nurses (RNs) that are seeking a state licensure in Hawaii by endorsement. Staffing shortages have become a major issue for our healthcare providers due to the pandemic. Many staff are retiring or leaving the healthcare profession due to burnout, and the increasing contagiousness of variants of COVID-19 have caused massive staff absences during community outbreaks. This affects all types of healthcare organizations, from the state's largest hospitals, to long-term care facilities caring for vulnerable residents, to small hospice agencies providing compassionate care at the end of life.

My name is Selwyne Jei Matillano and I am a nursing student at The University of Hawaii Maui College. I am writing in **strong support of HB1758**, which allows for temporary permits to be issued to registered nurses and licensed practical nurses from a territory or foreign country who are seeking a state license by endorsement.

During my clinical rotation at multiple units at the hospital, I have seen the difficulties and the stress nurses go through during times when they are short staffed. As a current hospital employee, I can see this first hand. Working in the emergency department, sometimes we are short nurses because they are burnt out or sick due to being overworked. Being overworked, and burnt out poses a major risk for multiple "near-miss" incidents. Having these extra staffing available in our local hospitals could help alleviate some of the emotional and physiological strain that comes with being short staffed.

Having this bill passed, will allow for nurses from other states to be licensed temporarily in the states that need the most nursing help. Once we get the help and the sufficient staffing that we need, the risk for "near-miss" incidents will decrease, the retentation rate for local nurses practicing in their home states will increase, and nurses will be able to provide better quality care not only for our local residents, but to our visitors as well. Chair Dela Cruz and Chair Rhoads,

I write in strong SUPPORT of HB 1758 HD2 SD1, Relating to Nurses, which allows for temporary permits to be issued to registered nurses and licensed practical nurses from a territory or foreign country that are seeking a state license by endorsement.

This bill allows immigrant nurses and nurses from the territories to have the same opportunities as nurses from non-Hawai`i U.S. states. Currently, qualified applicants for licensure by endorsement who are licensed in another U.S. state are eligible for a temporary permit, while their counterparts licensed in a territory or foreign country are not. Expanding the eligibility would fix this unequal treatment and lower barriers for these nurses to enter the health care profession in Hawai`i.

Hawai'i is lucky to have many Filipino and Filipina nurses that have immigrated to the state and are currently under-employed. Many of them are working within the healthcare or elder care system but at lower levels than their capacity or training. This bill would help address Hawai'i's nursing shortage, which was already a long-standing problem and has been exacerbated by COVID-19. It would also mean that we have more bilingual and culturally-competent nurses, which has been shown to improve healthcare outcomes.

I SUPPORT HB 1758 so that experienced, highly qualified nurses can tackle Hawai'i's critical health care needs immediately while they wait for their permanent licenses to process. This is important not only to Hawai'i's immigrant communities but to its economy and public health.
