

# HB1986 RELATING TO THE BOARD OF EDUCATION Ke Kōmike Hale o ka Hoʻonaʻauao House Committee on Education

The Office of Hawaiian Affairs (OHA) <u>SUPPORTS</u> HB1986, which would require at least one at-large member of the Board of Education (BOE) to be a Hawaiian immersion expert selected from a list of nominees submitted by the 'Aha Kauleo Kaiapuni Hawai'i. With at least one at-large BOE member with Hawaiian immersion expertise will be an important resource to facilitate the State of Hawai'i's and Department of Education's (DOE) goals and policies.<sup>1</sup>

OHA is the constitutionally-established body responsible for protecting and promoting the rights of Native Hawaiians.<sup>2</sup> In its last strategic plan, OHA adopted **Ho'ona'auao** as one of its strategic priorities, which focused on maximizing the choices of life and work via Native Hawaiians gaining knowledge and exceling in educational opportunities at all levels. OHA's 2020+ Strategic Plan continues to incorporate **Educational Pathways** as a strategic direction, based on strategic foundations of 'Ohana, Mo'omeheu, and 'Āina. As such, OHA has been and continues to be a consistent and ardent advocate for education policies that address the needs of Native Hawaiians and the greater community. The perpetuation of 'Ōlelo Hawai'i, through Hawaiian immersion, is critical to the evolving culture, health, and well-being of Native Hawaiians, and this measure may be crucial to ensuring the BOE is equipped with needed expertise for kaiapuni equity.

Kula Kaiapuni celebrates over two decades of growth, expansion and success necessitating needed representation and expertise on the BOE. The success of the program is admired nationally and internationally but much of this success is due to the commitment and diligence of 'ohana as well as the hard work of kumu or teachers. This Legislative body has consistently supported the Hawaiian Language Immersion Program over the past twenty years, seeing it as a crucial vehicle in carrying out the provisions of Article X, Section 4, and Article XV, Section 4, of the Constitution of the State of Hawai'i and provisions of Act 133, Session Laws of Hawai'i 2004, and Act 159, Session Laws of Hawai'i 2005. The Hawaiian language immersion program continues to play a central

role in the perpetuation of Hawaiian culture, history, language, values, and practices as provided for by the Constitution of the State of Hawai'i. 'Aha Kauleo has previously directly advised the BOE, and currently advises the Office of Hawaiian Education. In a parallel approach to provide needed expertise on the BOE, this bill will facilitate equity for kaiapuni as the demand and interest continues to increase.

The strength and endurance of 'Ōlelo Hawai'i is intrinsically connected to the health and wellbeing of the Native Hawaiian people, and it is part of what makes Hawai'i an authentic, unique, and beautiful place for all our local keiki to enjoy, learn, and ultimately thrive. **E ola mau ka 'Ōlelo Hawai'i**!

Accordingly, OHA urges the Committee to **PASS** HB1986. Mahalo nui for the opportunity to testify on this important issue.

Aloha mai e nā po'o a me nā lālā o ka 'Aha Ōlelo,

My name is Jonathan K Osorio and I am an educator, a supporter of Kula Kaiapuni and a member of 'Aha Kauleo. I am testifying in favor of HB2284 - Relating to Equitable Distribution of Grow Our Own Resources for Hawaiian Immersion Teachers. The requirement to teach our language and our culture is enshrined in the 1978 amendments to the State Constitution. But Hawai'i has moral and practical imperatives as well as legal obligations to vigorously support 'Ōlelo Hawai'i as the State's second language. Strengthening the cultural identity of our Native Hawaiian kamali'i widens and fortifies the educational pipeline for Kanaka Maoli children to higher education and better economic opportunities while weakening the pipeline to houselessness, dependency and prisons.

With regard to HB 1986:

- BOE currently has Hawaiian immersion advocates who understand the pedagogy and methodology of Hawaiian immersion education. There should be an advocate with a dedicated seat.
- Kaiapuni have unique opportunities and challenges warranting needed expertise on the Board of Education.
- The Board of Education comes up with many solutions for English medium education without considering affects on Hawaiian immersion education.
- This solution would mover toward equitable access to resources and education specifically for Hawaiian immersion education on all islands in Hawai'i's public schools, and uphold guidelines set forth in BOE policy 105-8.
- This does not cost additional funds for the State.
- This will provide needed expertise to the BOE and help to stabilize its decision making and leadership.
- This bill will ensure that the State upholds its constitutional responsibility to Article X, Section 4, and Article XV, Section 4 of the Hawaii State Constitution (1978).

I urge the Committee to PASS HB1986. Mahalo for the opportunity to testify.

# House Bill 1986, Relating to the Board of Education

Dear Chair Woodson, Vice Chair Kapela, and Members of the Committee:

The Board of Education ("Board") respectfully provides <u>comments</u> on HB 1986, which would require that at least one at-large member of the Board be a Hawaiian immersion expert selected from a list of nominees submitted by Aha Kauleo Kaiapuni Hawaii.

The Board takes no position on legislation relating to the Board's membership, as the Board believes it is most appropriate for the Legislature and Governor to decide such matters. The Board will endeavor to provide the Legislature with any relevant information relating to Board membership matters to enable to the Legislature to make informed decisions.

The Board has demonstrated through Board policy and deliberations at Board meetings that it strongly supports Hawaiian immersion education and Kula Kaiapuni. In fact, two current members of the Board often bring their significant experience with Hawaiian immersion education to Board discussions on a variety of relevant matters. There is clear value to this perspective on the Board.

We caution, however, that other stakeholders with different specific educational interests, such as special education or multilingualism, may also want a similar requirement to select experts on their respective interests to serve on the Board should the Legislature pass this measure. This could open the door for the Legislature needing to make policy decisions prioritizing which educational interests are of such importance that they require explicit representation on the Board.

Thank you for this opportunity to testify on behalf of the Board.

Chair Woodson, Chair Takayama, and Committee members:

The Hawaii State Teachers Association <u>supports HB 1986</u>, relating to the Board of Education. This bill requires that at least one at-large member of the Board of Education be a Hawaiian immersion expert selected from a list of nominees submitted by Aha Kauleo Kaiapuni Hawaii.

There is a shortage of Hawaiian immersion teachers and it has reached a crucial point in the last decade. Approximately fifty Hawaiian immersion teacher vacancies were advertised this year and another thirty positions will be needed to address school growth. We need to promote Hawaiian immersion programs consisting of language, culture, and history in the public schools, including our public charter schools, by ensuring that one of the at-large appointees for the BOE is an expert on Hawaiian Immersion to help this state goal toward expanding and promoting Hawaiian Immersion in our public schools, including our public charter schools.

The current law does not require any member of the board of education to be an individual who has expertise in Hawaiian studies, the Hawaiian language, or Hawaiian immersion education. <u>The Hawaii State Teachers Association</u> <u>believes that in order to better promote the study of Hawaiian culture,</u> <u>history, and language in public schools, as required by the state</u> <u>constitution, there must be some representation of the Hawaiian</u> <u>community on the Board of Education</u>

There is a constitutional requirement to promote the study of Hawaiian culture, history, and language. Native Hawaiians currently make up almost twenty-four per cent of the entire student population in the State. Due to the high presence of Native Hawaiian students in the public school system, it is imperative that the State guarantee appropriate representation on the board of education to fulfill its constitutional duty to promote Hawaiian studies and the Hawaiian language and to provide a voice for Native Hawaiian students, teachers, and faculty.

Hawaii State Teachers Association asks your committee to <u>**support**</u> this bill, to move forward on this promise.

Kamehameha Schools <u>supports</u> HB 1986, which requires that at least one at-large member of the board of education be a Hawaiian immersion expert selected from a list of nominees submitted by 'Aha Kauleo Kaiapuni Hawai'i.

'Ōlelo Hawai'i is the language of our home—being used and celebrated by thousands across Hawai'i in government, education and commerce alike. In 1978, through a state constitutional convention, the convention delegates restored the Hawaiian language as an official language and instructed that a Hawaiian education program be provided in the public schools to revive and preserve 'ōlelo Hawai'i to rectify the ill effects of Hawaiian language suppression.

Adopted in 2015, Board of Education Policy 105-8 ("Ka Papahana Kaiapuni") establishes seven (7) goals of the Kaiapuni Educational Program, which range from providing a bicultural and bilingual education for parents and students to developing curriculum standards with appropriate stakeholders, like the 'Aha Kauleo, to the development and proper administration of appropriate formative and summative assessment tools. We celebrate the great strides made under the leadership of the Office of Hawaiian Education for Kaiapuni and advocate for the requirement that the same expertise be seated in perpetuity on the Board of Education.

Founded in 1887, Kamehameha Schools is an educational organization striving to restore our people through education and advance a thriving Lāhui where all Native Hawaiians are successful, grounded in traditional values, and leading in the local and global communities. We believe that community success is individual success, Hawaiian culture-based education leads to academic success and local leadership drives global leadership.

The Council for Native Hawaiian Advancement (CNHA), a member-based 501(c)(3) non-profit organization with a mission to enhance the cultural, economic, political, and community development of Native Hawaiians, <u>SUPPORTS</u> HB1986 which would require that at least one at-large member of the Board of Education be a Hawaiian immersion expert selected from a list of nominees submitted by 'Aha Kauleo Kaiapuni Hawai'i.

The State of Hawai'i Board of Education policy 105-7 states: "[t]he Board of Education recognizes that appropriate support for and implementation of Hawaiian education will positively impact the educational outcomes of all students in preparation for college, career and community access," and that "Hawaii's public education system should embody Hawaiian values, language, culture and history as a foundation to prepare students in grades K-12 for success in college, career and communities, locally and globally."<sup>1</sup> <u>CNHA believes that there is no better manifestation of "appropriate support" through the Board of Education than to have Board member(s) with the capacity, training, and expertise to best advance Hawaiian education in a manner that is consistent with the values, beliefs, and self-determination of the Native Hawaiian community.</u>

As a Board recognized entity responsible for the development of curriculum and standards for the Ka Papahana Kaiapuni (Kaiapuni Educational Program) and a consortium comprised of nā Kula Kaiapuni (Hawaiian Immersion Schools), Hawaiian language charter schools, and various support organizations, 'Aha Kauleo Kaiapuni Hawai'i is in the best position to advance a list of effective candidates to serve as Board member(s) to provide appropriate support for Hawaiian education.

# Aloha mai kākou,

I am first a parent of a child who attends Ke Kula Kaiapuni o Maui ma Kalama (Hawaiian Immersion school at Kalama Intermediate). I have been an active parent in supporting our 501c3 non-profit parent support group, Nā Leo Kāko'o o Maui, since my son started in the year 2015. Our non-profit supports doing fundraisers that provide opportunities for our keiki to go on various field trips, cultural events, and graduation events. It also supports our teachers with any necessary supplies that are not provided by the DOE. We also host educational events that teaches our community of the value of Kaiapuni education and how we can grow and support our keiki in this school.

I am writing today as the President of Nā Leo Kāko'o o Maui, who supports over 500 families who have keiki in Ke Kula Kaiapuni o Maui ma Pā'ia, Kalama, and Kekaulike (Hawaiian Immersion schools at Pā'ia Elementary, Kalama Intermediate, and Kekaulike High School).

I am testifying in favor of HB1986.

For the last few years, the BOE has had members who not only advocates, but also understands the pedagogy and methodology of Hawaiian immersion education. We have seen the support that is provided to our schools and teachers, and we would like to secure such an advocate with a dedicated seat.

The Board of Education often comes up with many solutions for English medium education without consideration on how it affects Hawaiian medium education and is often not a solution for and can directly impact Hawaiian medium education. We need someone who can anticipate those impacts.

Article X, Section 4 of the Hawaii State Constitution (1978), states that:

The State shall provide for a Hawaiian education program consisting of language, culture and history in the public schools. The use of community expertise shall be encouraged as a suitable and



essential means in furtherance of the Hawaiian education program. [Add Const Con 1978 and election Nov 7, 1978]

Article XV, Section 4 states that:

English and Hawaiian shall be the official languages of Hawaii, except that Hawaiian shall be required for public acts and transactions only as provided by law. [Add Const Con 1978 and election Nov 7, 1978]

This bill will help to ensure that the State will uphold this constitutional responsibility in support of the Hawaiian language and Hawaiian education, by specifically supporting the guidelines set forth in the BOE policy 105-8. This policy ensures equitable access to resources and education specifically for Hawaiian immersion education on all islands of Hawai'i's public schools. We need someone on the Board of Education who is aware and seeks to uphold fulfillment of these requirements which will help to stabilize the BOE decision making and leadership.

As a final highlight, this would not cost any money for the State, and would only help the progression of education within our public school system.

In conclusion I am writing in STRONG SUPPORT of HB1986.

# RE: STRONG SUPPORT for HB 1986, Relating to the Board of Education - requires at least one at-large member of the BOE be a Hawaiian language immersion expert. Hearing on February 3rd, 2022

The Aha Kauleo (AKL) is the statewide council for the Papahana Kaiapuni which provides proactive leadership, direction, and advocacy for the development and growth of its Hawaiian medium schools, and advises directly through the Office of Hawaiian Education of the Department of Education. AKL consist of parent and teacher representatives per elementary (K-6) and secondary grades (6-12) and/or from each Hawaiian medium education site, and a principal representative, along with representatives from the University of Hawaii Hilo and Manoa, Brigham Young University-Hawaii, University of Hawaii-Maui College, Aha Punana Leo, Office of Hawaiian Affairs, Kamehameha Schools/Bishop Estate, and the Queen Liliuokalani Children's Center.

The 'Aha Kauleo **strongly supports** HB 1986 that would require at least one at-large member of the Board of Education be a Hawaiian language immersion expert.

The Board of Education has a constitutional mandate to uphold Article X, Section 4 of the Hawai'i State Constitution, "The State shall promote the study of Hawaiian culture, history and language. The State shall provide for a Hawaiian education program consisting of language, culture and history in the public schools. The use of community expertise shall be encouraged as a suitable and essential means in furtherance of the Hawaiian education program."

Hawaiian and Hawaiian language immersion education continue to be a critical component to the survival and revitalization of the Hawaiian language and is in fact one of the most successful indigenous language education programs in the world. This development and advancement is a testament to the commitment made by the State of Hawai'i in 1978 and by the Board of Education through their forward policies on Hawaiian education in BOE policies 105.7 and 105.8.

These educational innovations in the last three decades have helped to produce a pool of experts in Hawaiian and Hawaiian language immersion education. A dedicated seat for a Hawaiian and Hawaiian language immersion education expert will ensure the most current and effective

pedagogies and methodologies will be employed to further develop the present policies that have helped to advance Hawaiian and Hawaiian language immersion education.

Passage of this bill would be a significant cornerstone in the history of public education in Hawai'i in line with the 1978 constitutional commitment to Hawaiian education, the establishment of Hawaiian Studies program in 1970 and the founding of Hawaiian language immersion in 1987.

A vote in favor of this bill is a vote to further progress the State of Hawai'i's commitment to the revitalization and advancement of Hawai'i's indigenous people and language through education.

I am Christine Noelani Chow, a current parent of 1 Kaiapuni Hawaiian Immersion student and 2 former Kaiapuni students. I am in support of HB 1986. I have been a part of Hawaiian Immersions schools as a parent, a part time teacher, substitute teacher and volunteer for 10 years. I believe there should be at least 1 BOE at large member who is an expert in Kaiapuni. It is needed, pono and fair. I have seen how difficult it is to find quality kumu that will stay in the profession. I have had to step up without a teaching degree and without complete 'olelo Hawai'i capabilities to fill in vacancies at my childrens' schools. The DOE has shortages of teachers. Finding teachers for Immersion Schools are 5 times harder! At my child's current school, Ke Kula Kaiapuni o Waimānalo, there has been teacher vacancies in each grade level since opening in 2019. We currently have 2 kumu teaching 4 grade levels and both those kumu came from other Kaiapuni schools, leaving vacancies that needed to be filled there. We need more incentive to attract more quality kumu to our schools and to keep them there. Additional pay for our kumu will make it more attractive and feasible for our kumu to stay in the face of the difficult times they face in general in the classrooms and on top of that the hardships of lack of curriculum, resources and the additional responsibilities that Kaiapuni kumu have in teaching content through Hawaiian as a second language. Please malama our kumu, please give us the representation at the BOE decision making level so that funding and systems can be set to support our schools. Our children deserve it. Our language and the education of our children depend on it.

This project works in collaboration with HIDOE to develop and administer assessments in the Hawaiian language for Kaiapuni students in Grades 3 - 8 for the purpose of state and federal accountability. In my current work with the  $K\bar{A}$ 'EO, the Board of Education has been a key partner in ensuring that policy is reflective of the responsibility that Hawai'i's educational system has to its two official languages, both English and Hawaiian (as articulated in Article X, Section 4, and Article XV, Section 4 of the Hawaii State Constitution (1978)). The Hawai'i Department of Education (HIDOE) executes these policies in support of this dual language pathway in various ways, but has articulated it specifically in a memo released on October 21, 2020. The memo acknowledges the dual language pathway of our system:

As the Hawai'i Department of Education (HIDOE) is committed to being a bilingual system, this memo serves as an affirmation to all stakeholders of the state's adoption of a single set of standards with two language paths, English and Hawaiian.

The fact that HIDOE has documented this kind of support for the dual language pathway of our educational system is a key indicator of the importance of having board members who understand the challenge that Hawaiian immersion education faces in the current educational

system. We do not want to leave this up to chance – without a dedicated seat that understands Hawaiian immersion education and can knowledgably consider the impacts of any of the board's decision not just on the state's English medium students, but also its Hawaiian medium students, we run the risk of denying equitable access and resources to the students and families who choose the Hawaiian language pathway of education within our state.

From my perspective, this is a no-brainer – this bill will not cost the state any money and is a simple way to ensure that representation on the Board of Education justly reflects the dual language pathways of Hawai'i's educational system.
