#### In consideration of HOUSE BILL 1988, HOUSE DRAFT 2 RELATING TO CORAL

House Bill 1988, House Draft 2 proposes to prohibit the sale, import, or export of coral products, with certain exceptions and requires the Department of Land and Natural Resources (Department) to amend its administrative rules accordingly no later than 12/31/2022. The **Department supports this bill and offers the following comments.** 

The Department requests that the deadline for rulemaking be pushed back to December 31, 2024. The Department has a long list of active and planned rulemaking priorities that are aimed to improve the sustainability of coral reef species for ecosystem health, local food security, cultural practices, and recreation. Even absent other rulemaking priorities, a 2022 deadline is highly ambitious considering the procedural requirements of Chapter 91, Hawaii Revised Statutes.

#### In **SUPPORT** of House Bill 1988 HD 2 **Relating to Coral**

House Bill 1988 HD 1 prohibits the sale, import, or export of coral products with certain exceptions. It requires the department of land and natural resources to amend its administrative rules accordingly no later than 12/31/2022.

In the State of Hawaii, coral is a precious asset particularly to the native Hawaiian culture.

The Kumulipo, the Hawaiian Creation Chant is an authentic source of information on Hawaiian religion, ancient culture and way of life. It is the beginning of everything, and in this ancient chant is the refrain "*Hanau ka 'Uku ko'ako'a hanau kana, he Ako'ako'a puka* (Born was the coral polyp, born was the coral). The Kumulipo, and the coral is honored and revered by native Hawaiians on all the Islands. For this alone, all sale, import, or export of coral products with certain exceptions should be prohibited.

We <u>SUPPORT</u> the passage of House Bill 1988 HD2 and ask that this measure be adopted. Mahalo nui for the opportunity to testify on this important measure.

### RE: OPPOSE HB 1988 HD2; RELATING TO CORAL, UNLESS AMENDED

Dear Chairs Gabbard and Inouye and Members of the Senate Water & Land and Agriculture & Environment Committees:

For the Fishes, Conservation Council for Hawaii, Kai Palaoa, Moana Ohana, Sierra Club of Hawaii Moku Lua Group, Kalanihale, Center for Biological Diversity, Friends of Hanauma Bay, Legacy Reef Foundation, Haereticus Environmental Laboratory, Hawaii Reeff & Ocean Coalition, Environmental Caucus of the Democratic Party of Hawaii, Fair Wind Charters and Ocean Defenders Alliance-Hawaii ask for your **OPPOSITION to HB1988, Relaing to Coral, unless the bill is amended**, as noted below.

As drafted <u>this bill protects corals that grow outside Hawaii, BUT excludes Hawaii corals from those</u> <u>same protections.</u> This measure would prohibit the import, export, and sale of products such as jewelry and trinkets made from corals that grow outside Hawaii but still allow for commercial sales and exports of those products if they are made from *Hawaii* corals, which can be harvested under state issued Commercial Marine Licenses or federal permits, dependent upon the location.

The bill claims to recognize that "the commercial use of coral contributes to the decline and degradation of the State's coral reefs," yet completely fails to protect Hawaii's own corals. This grave exception also exposes the state to dormant commerce clause issues given that as drafted, it would only exclude the sale of out of state sourced products, and not serve the local interests, or protecting the natural resources of, the state.

Allowing for the sale of jewelry and trinkets made from Hawaii coral, while prohibiting the sale of those products made from corals from outside Hawaii products is **unenforceable**. It is impossible for DOCARE to differentiate between the numerous coral products, species, their origin and what may have been legally versus illegally harvested.

Further, prohibiting the sale of non-Hawaii corals could have **disastrous consequences** on our own corals by increasing demand, increasing harvesting efforts, and with that, the likelihood of poaching, including taking coral species that have long been prohibited from harvesting. These issues can be addressed by **equally applying sales prohibitions to all products**. The state legislature rightfully did this for shark fins (2010) and ivory products (2016) by prohibiting the sale of all products, regardless of their source, particular species or origin.

Importantly, Black coral, 'ēkaha kū moana, is a living native Hawaiian ancestor. Hawaiian history and culture is grounded in the kumulipo, where all life begins from the sacred coral polyp. Allowing commercial exploitation of these corals is disrespectful to native Hawaiian cultural values, traditions and practices.

The bill is **supportable only if it is** amended to prohibit the sale of all coral products for commercial purposes by adding the below:

#### Page 1, line 16- 17 adds harvest

"~187A- Sale, import, <u>harvest</u> or export of coral products; prohibited. (a) It shall be unlawful for any person to import into, export from, sell in, <u>harvest</u> or offer for sale in the State any coral product.

#### Page 2, lines 15, 16 deletes "state-permitting" and adds under a Special Activity Permit for noncommercial purposes and clarifies the existing allowed issuance of federal permits if for noncommercial purposes.

(b) This section shall not apply to: (1) Coral products imported, exported, sold, <u>harvested</u> or offered for sale for the purposes of:

(1) Coral products imported, exported, sold, <u>harvested</u> or offered for sale for the purposes of:...

# (F) State [-permitted] harvesting <u>under a Special Activity Permit for non-commercial</u> <u>purposes;</u> and

#### (2) Coral products <u>or harvesting</u> expressly authorized by federal law or federal permit <u>for non-</u> <u>commercial purposes</u>

We have no objection to existing exemptions in the HD2 allowing for the harvesting of corals, in state or federal waters, as needed, for *non-commercial purposes* such as research, education and replanting, or for use in native Hawaiian cultural practices as protected under our state constitution.

Thank you for your consideration of these critical amendment, should the Committees decide to move this measure forward.

#### **The Hawai'i Reef and Ocean Coalition COMMENTS** that it respectfully **OPPOSES THIS BILL UNLESS IT IS AMENDED TO ALSO PROHIBIT HARVESTING AND COMMERCIAL SALE OF HAWAI'I CORALS!**

The Hawai'i Reef and Ocean Coalition supports the bill's intent to prohibit the import, export and sale of coral products. However, as drafted, the bill will unintentionally lead to increased harvesting and potential poaching of local coral, because it exempts commercial sale of Hawai'isourced coral products, while prohibiting commercial sales of coral products from elsewhere. **This ironically would be worse for Hawaii corals than the status quo.** 

DLNR's Division of Aquatic Resources (DAR) reportedly does not issue permits for coral takes, only Special Activity Permits's for non-commercial research and replanting, which HIROC doesn't oppose. Apparently, anyone can harvest coral with a \$100 Commercial Marine License, and self-report takes after the fact. With no verification and little enforcement (since it will be nearly impossible to determine the species and origin of the coral jewelry and different products), **this bill will essentially produce open season on Hawaii's corals.** 

The Hawai'i Reef and Ocean Coalition believes that a prohibition on harvesting and commercial sale of coral products regardless of origin (including Hawaii-sourced corals), is needed to protect corals, which are under stress from multiple causes. The Hawai'i Reef and Ocean Coalition **OPPOSES the bill unless it is amended to protect Hawaii-sourced corals**.

The Hawai'i Reef and Ocean Coalition proposes the following simple but critical amendments:

SECTION 2. Chapter 187A, Hawaii Revised Statutes, is amended by adding a new section to part I to be appropriately designated and to read as follows: "§187A- Sale, import, or export of coral products; prohibited. (a) It shall be unlawful for any person to **harvest**, import into, export from, sell in, or offer for sale in the State any coral product.

(b) This section shall not apply to:

(1) Coral products imported, exported, sold, or offered for sale for the noncommercial purposes of:

(A) Research or scientific identification by an accredited museum or university;(B) Rehabilitation or restoration of historic and culturally significant Hawaiian sites;(C) Cultural practices and sacraments performed by native Hawaiians;

(D) [Use as limestone or construction materials, cosmetics, or medicines]; (E) Education; or

[(F) State permitted harvesting for non-commercial purposes; and]

[(2) Coral products expressly authorized by federal law or federal permit for noncommercial purposes.]

HD1 currently provides an exemption for the sale of Hawaii-sourced coral if the coral is collected under a NOAA issued federal permit. Hawaii should lead by example and clearly exclude the commercial sale of any and all Hawaii-sourced coral as well. This is consistent with other laws (shark fins, ivory products) where federal agencies may issue.

Please pass this bill, but only if it is amended to protect Hawaii's corals!

#### Re: COMMENTS AND REQUESTED AMENDMENTS FOR HOUSE BILL 1988 HD2 - RELATING TO CORAL.

Aloha Chair Inouye, Chair Gabbard and Members of the Committee,

Please accept these comments submitted by the Center for Biological Diversity (Center) requesting **crucial amendments to House Bill 1988 HD2**, which would prohibit the sale, import, or export of coral products, with certain exceptions and requires the Department of Land and Natural Resources to amend its administrative rules accordingly.

The Center is a non-profit 501(c)(3) membership corporation dedicated to the protection of native, threated, and endangered species and the habitats they depend on to survive. Through science, policy, and environmental law, the Center is actively involved in conserving marine ecosystems. The Center has more than 88,000 members throughout the United States, including Hawai'i, with a direct interest in ensuring that imperiled species are properly protected from destructive practices in our oceans. In pursuit of this mission, the Center has worked extensively to protect ocean ecosystems in Hawai'i and nationwide from various threats including improper commercial exploitation. The Center is highly invested in conserving fragile and impacted Hawaiian coral reefs and the marine species that depend on them.

Coral reefs are in crisis. The world has lost a third of its coral reefs due to climate change and other factors in the past 30 years. Ocean warming and acidification, caused by greenhouse gas emissions, has caused large-scale coral bleaching events resulting in unprecedented coral mortality and associated reef decline during the past decades. These mass bleaching events have increased in frequency, severity, and magnitude, and are projected to continue. We must do all we can to protect our coral reefs.

Between 2014 and 2017, a massive warming-induced coral bleaching event swept across the planet killing millions of corals on hundreds of reefs from Hawai'i to the Great Barrier Reef. As a result, Hawaiian coral has substantially declined in recent years. Scientists predict that the frequency and severity of warming events in the Pacific will increase and are likely to cause stronger mass coral bleaching placing all coral, including our imperiled Hawaiian corals, at a high risk of extinction.

The Center would like to support this bill, however, the amendments made in earlier committees unfortunately added an exemption allowing for the continued commercial sale of coral if the coral was harvested in Hawai'i. Allowing for the sale of Hawaiian coral, while prohibiting the sale of corals from outside Hawai'i, is likely unconstitutional under the Dormant Commerce Clause and is entirely unenforceable. It would be impossible for DOCARE to differentiate between the numerous coral products, species, their origin and what may have been legally versus illegally harvested.

It is imperative that this legislature protect our coral for scientific and cultural reasons. Native Hawaiians have long recognized the importance of our coral. In the Kumulipo (Hawaiian creation chant) for example, coral is revered as the first organism created:

Hanau ka 'Uku-ko'ako'a, hanau kana, he 'Ako'ako'a, puka Born was the coral polyp, born was the coral, came forth

#### AEN/WTL Committees,

I support HB1988 HD2 and think House members have done a fair job making amendments based on science and not emotion. For decades our state and nation have allowed corals sourced, harvested, and trafficked by foreign nations without sustainable peer reviewed science, harvesting practices oversight, or a record of chain of custody. This has encouraged unethical commerce which has been confusing to consumers attempting to differentiate unsustainable products from locally harvested and made coral jewelry. Our small coral fishery is the most studied precious coral fishery in the world. It has been well managed by the state of Hawaii and NOAA. Federally regulated coral beds have quotas which have rarely been met. I fact correspondence with NOAA Fisheries and the Western Pacific Fishery Management Council as of 03/15/2022 state:

"While there are **currently no permit holders**, we have implemented bed specific annual catch limits (ACL) and accountability measures (AM) for precious corals, including black corals in the Au Au Channel since 2012 and catches at all beds have remained below the ACL since we implemented the system of ACLs and AMs."

I respect the many testifiers right to their **opinion** in opposition of this bill but encourage Senate members to pass legislation based on the best know peer reviewed science conducted by NOAA, UH, and our states scientists and not on emotionally driven misinformation.

One testifier representing "For the Fishes" Inga Gibson claimed in her written testimony to the House: "...according to NOAA, there is a stockpile of existing harvested coral that coral dealers enter into the market as needed, based on consumer demand"

The largest coral bed in our state the Au Au channel has seen an entire decade of catches below the annual catch limit. There are currently no permit holders. And other than myself am unaware of any other harvesters in the State. Because such statements can manipulate the truth and perception within our community and law makers I reached out to NOAA find out if this claim had any validity. The following is a verbatim email I received from Keith Kamikawa Fisheries Management Specialist with NOAA today.

"Dear Mr. Chun,

Thank you for your communication on March 8, 2022, regarding the State of Hawaii Legislature's House Bill 1988 relating to corals, which if approved, would prohibit the sale of legally harvested black coral from Federal and State waters. You also provided a copy of public testimony submitted by the group For the Fishes that states, "...according to NOAA, there is a stockpile of existing harvested coral that coral dealers enter into the market as needed, based on consumer demand" and asked for NOAA Fisheries' position on this statement.

Our understanding is that, historically, black coral fishermen would collect coral trees and store them for times when there was market demand. However, **most of the fishermen who participated in this practice have since retired and/or passed on, so NOAA Fisheries cannot confirm that there remains a stockpile of existing harvested corals anymore.** 

NOAA Fisheries and the Western Pacific Fishery Management Council manage the precious coral fisheries in Federal waters around the main Hawaiian islands under the Fishery Ecosystem Plan for the Hawaii Archipelago (Hawaii FEP) and implementing regulations at Title 50 Code of Federal Regulations, Part 665, Sections 665.250-665.270 (50 CFR 665.250-665.270). While there are currently no permit holders, we have implemented bed specific annual catch limits (ACL) and accountability measures (AM) for precious corals, including black corals in the Au Au Channel since 2012 and catches at all beds have remained below the ACL since we implemented the system of ACLs and AMs.

We are currently in the process of preparing new ACLs and AMs for Hawaii precious corals for the 2022-2025 fishing years, as required by 50 CFR 665.269. The federal fishing year for precious corals begins July 1 and ends June 30 the following year. You can find more details on this process by reviewing the ACLs and AMs for the 2019-2021 fishing years for Hawaii precious coral on our website (Pacific Island Fisheries 2019-2021 Annual Catch Limits and Accountability Measures).

Thank you again for your communication Keith Kamikawa"

I hope this email shed more light on the current state of the black coral fishery. I applaud the state for drafting several pieces of legislation in the past few years to put Hawaii at the forefront of conservation. I encourage our decision makers to continue following sound science in their decision making process. There are many dire issues that require immediate attention and deserve the time and effort of our community, scientists, and politicians. Political tribalism has gained a lot of traction nationwide now more than ever. We have well studied and sustainable fisheries here in Hawaii that have come under fire from "don't touch don't take" non profit organizations. Lets make sure to analyze our fisheries with deep regard while passing new laws.

Finally I would like to remind committee members of the AEN/WAL that precious corals in Hawaii are not the same as shallow reef building corals, have a low level of participation, are found at depths far beyond recreational dive limits, require divers to hand harvest (no dredging or dragging), have no proven scientific publications supporting a threat to the resource, and Black Coral is our state gem. The coral fishery and coral jewelers in Hawaii have long fell victim to unfair trade practices competing with unknown foreign corals harvested, sourced, and shipped without the rightful and watchful eye of our own regulations. I thank you for the opportunity to comment on this measure.
