Aloha House Members of the Education Committee:

Hawaii Catholic Schools, the largest private school network in the state of Hawaii and subsidiary of the Roman Catholic Church in the State of Hawaii supports this bill with the appropriate modification to include the Hawaii Catholic Schools Office as the compliance agency to oversee non-licensed but accredited Catholic schools who are not full members of the Hawaii Association of Independent Schools and submits the following comments.

Private schools recognize that licensure is a baseline to the criteria and requirements of national and local accrediting agencies. As such, the original bill was enacted to ensure that schools met either the baseline requirements of licensure under the Hawaii Council of Private Schools (HCPS) or the more stringent requirements of local or national accrediting agencies such as the Hawaii Association of Independent Schools (HAIS), Western Association of Schools and Colleges, Western Catholic Education Association, and others referred to in Section 1, part d, subsection 3. HCPS recognized a loophole where a private school that was not in compliance with all state requirements continued without penalty or enforcement of health and safety measures. The school in question was not in the Catholic school network.

Fortunately, the Hawaii Catholic Schools office already functions in the same capacity as HCPS for all parochial Catholic schools which are not members of HAIS but are fully accredited by at least two nationally recognized agencies. In agreement with HAIS and HCPS, the Hawaii Catholic Schools Office wishes to remain autonomous in providing oversight for all state compliance measures regarding the health and safety of our schools in accordance with the compulsory attendance law.

The Hawaii Catholic Schools office will continue to monitor our safety checklist which exceeds the requirements currently reviewed by HCPS and includes but are not limited to fire safety inspection reports, Department of Health food inspection reports and reports for immunization, Department of Transportation safety inspections, all required licensure and certification requirements by the Department of Human Services, and additional safety requirements from the Department of Labor.

In agreement with HAIS, we request modification of the current bill Section 1, part d, subsection 3, page 2, lines 6, 7, and 8 to read:

"and submits health and safety documentation to the Hawaii Council of Private Schools <mark>OR</mark> <mark>the Hawaii Catholic Schools office</mark> on an annual basis."

We support this bill in collaboration with HAIS and HCPS with the stated modification.

Aloha Chair Woodson, Vice Chair Kapela and Members of the Committee:

My name is Philip Bossert and I am the Executive Director of the Hawaii Association of Independent Schools (HAIS).

HAIS and its subsidiary, the Hawaii Council of Private Schools (HCPS), supports HB 2248. HAIS currently serves 94 independent schools and over 33,000 students in Hawai'i. Member schools include several of the largest independent schools in the U.S., as well as some of the smallest. While distinctive with respect to mission and philosophy, HAIS member schools are united in helping children achieve personal and academic excellence.

There are 111 independent (non-public) K-12 schools in Hawaii. Of that total, 89 schools are currently licensed or pending licensure by HCPS in accordance with Act 227 and 21 schools are compliant with Act 227 by virtue of being accredited by one or more national accrediting agencies recognized by HCPS.

All HCPS licensed schools must submit annual verifications of the health and safety information documents required by various State and County agencies in Hawaii (Dept. of Health, Fire Dept., Dept. of Transportation). However, compliant schools are not required to submit these annual verifications; and, as a result, such documentation is only verified during reaccreditation visits once every 5 to 10 years. And often, such verifications are overlooked by accreditation visiting teams. It is possible that some schools may not be in full compliance with Act 227 for several years due to the lack of such verification and, as a result, may pose a danger to their faculty, staff and students.

HCPS became aware of this issue recently when a licensed school was not able to obtain its annual fire safety inspection certificate due to various facility and equipment issues on its campus. To avoid becoming unlicensed, the school decided to rely instead on its accredited status and become compliant, in which case it would not have to verify its fire safety inspection document for perhaps another 3 to 5 years.

HB 2248 will close this loophole and require both licensed and compliant schools to submit annual verifications of their health and safety documentation. The bill as currently written specifies that these annual verification reports should be submitted to HCPS. Since the Hawaii Catholic Schools Office performs a similar annual verification of health and safety documentation for its compliant schools, HAIS and HCPS are in support of the amendment proposed by Hawaii Catholic School Superintendent Llewellyn Young that would allow the annual verifications to be submitted to either HCPS or the Hawaii Catholic Schools office.

We respectfully ask for your support on this measure and pass it out of committee. I am available to answer any questions you might have about this issue.
