Aloha Chair Wakai, Vice Chair Misalucha and members of the Senate Committee on Energy, Economic Development, and Tourism:

I am the Chair of the State of Hawai'i Environmental Advisory Council (EAC) and submit this testimony in **SUPPORT** of HB 2256 on behalf of the EAC.

This bill proposes to establish a Department of Environmental Protection on July 1, 2026. Further, it creates a Department of Environmental Protection working group to address the logistics required for the State to establish a Department of Environmental Protection, and requires the working group to submit a report to thelegislature prior to the 2025 regular session of the Legislature.

With the growing challenge brought to Hawai'i with ongoing — and worsening — climate change, environmental actions would surely benefit from a more cohesive, integrated approach from the State of Hawai'i. Currently, environmental policy and programs — and priorities — are scattered among many State agencies and offices. A Department of Environmental Protection would focus Hawai'i's governmental resources, providing much greater coordination than currently exists.

The EAC believes that the proposed working group is a critical component that should precede the creation of a new State department. We would suggest that the membership of the working group be expanded to include a representative from the EAC as well as representatives from the neighbor islands.

#### In consideration of HOUSE BILL 2256, HOUSE DRAFT 1, SENATE DRAFT 1 RELATING TO A DEPARTMENT OF ENVIRONMENTAL PROTECTION

House Bill 2256, House Draft 1, Senate Draft 1 proposes to establish a Department of Environmental Protection and to create a working group to develop an organizational and functional plan and a plan for the orderly transition of existing departmental functions and resources to the new department. The working group shall finish its work by July 1, 2026. **The Department of Land and Natural Resources (DLNR) respectfully opposes this bill.** 

DLNR notes that in 2021, Senate Bill 968 and its companion, House Bill 423 were introduced but not heard. Both bills provided an extensive history of the efforts to create a Department of Environmental Protection, the reasoning for such a department, and a blueprint for transitioning existing laws and functions to a new department. This bill does not reflect any of that work.

DLNR believes that a department should have a clearly stated mission to frame its policy objectives. The proposed measure mentions, in section one, that there is no department to carry out the environmental policy goals enacted by the Legislature. Rather this policy is fractured among several departments, and some of those departments have internal conflicts. But the bill does not offer a proposed mission statement that would clearly frame the Legislature's intent.

DLNR is also concerned that the bill does not address how a Department of Environmental Protection would affect its own mission and functions and those of other agencies. If, for example, the DLNR becomes the Department of Land Management, those changes would also need to be addressed through legislation.

DLNR is concerned that there is no budget attached to this bill, for what will be difficult and time-consuming work, done under a tight deadline. We also note that the working group will likely not start until after the change in administration. This will push the working groups efforts back by at lease six months if not more, as new directors get up to speed in their departments.

Finally, DLNR is not convinced that even after all of this work is done, the creation of a new department would address environmental protection as envisioned by the Legislature. Will it have enough funding to do its job, or will more departments have less funding?

- 4 **Department Testimony:** There would be certain advantages, as outlined in the bill's preamble,
- 5 to creating a department with the core mission of environmental protection. However, the
- 6 logistical challenges to a successful transition involving so many different existing departments
- 7 and offices should not be underestimated. Additionally, the department notes that there is no
- 8 budget attached to this bill. Departments and offices asked to provide members to the working
- 9 group may find it difficult to divert enough staff time to focus on this task.
  - To cite one example of challenges that must be overcome by the working group, the Hazard Evaluation and Emergency Response Office and branches within the Environmental Management Division of the department are still recovering from losing about 25% of their staff when these offices were moved from Kewalo Basin to Waimano Ridge less than five years ago. The offices were moved to facilities owned by the department to avoid paying costly rent and potentially facing relocation on a short timeline when the Kewalo Basin lease was ended by the new owner. If these offices become part of a new Department of Environmental Protection, will they remain in their present location? If these offices must move again, where will they go and what effect will another move have on personnel issues, including retention and hiring?

The Office of Planning and Sustainable Development respectfully offers **comments** on HB 2256 HD1 which establishes a department of environmental protection by July 1, 2026. Creates a department of environmental protection working group to address the logistics required for the State to establish a department of environmental protection. Requires the working group to submit a report to the legislature prior to the 2025 regular session.

With the recent passage of Act 45, Session Laws of Hawai'i 2020, Act 152, Session Laws of Hawai'i 2021, and Act 153, Session Laws of Hawai'i 2021, the Office of Planning and Sustainable Development continues to transition rapidly despite the office's limited funding and staffing to meet the statewide sea level rise adaptation coordination, sustainability and climate adaptation planning and coordination, economic recovery and resiliency planning, affordable housing collaboration and environmental review requirements over the past six months.

The Office of Planning and Sustainable Development agrees with the preamble of the bill that the ongoing climate crisis is one of the overarching issues of modern times, the protection of the State's environment and natural resources are extremely critical. The Office of Planning and Sustainable Development believes that the State of Hawai'i's sustainability, climate change mitigation, and climate change adaptation requires a <u>multi-agency approach</u> throughout all branches, departments, and agencies of the State of Hawai'i's government and it's counties.

The Honolulu Board of Water Supply (BWS) supports House Bill (HB) 2256, House Draft (HD) 1, Senate Draft (SD) 1. The bill proposes amending Hawaii Revised Statutes (HRS) Section 26-4 to create a department of environmental protection.

A state department of environmental protection centralizes the work to protect and preserve our environment and natural resources, which will further protect Hawaii's drinking water now and into the future. One example is the California Environmental Protection Agency that uses the latest science based information and research to develop, implement and enforce environmental laws to restore, protect and enhance the environment, to ensure public health, environmental quality and economic vitality of the state.

The BWS recommends amending the bill to require the department of environmental protection report to a seven member board in a new stand-alone Section added to the HRS, entitled "Board Oversight," that provides:

"The Department of Environmental Protection will report to a seven member board that consists of one member appointed by each of the following:

- (1) the Office of the Governor;
- (2) the Hawaii State Senate;
- (3) the Hawaii State House of Representatives;
- (4) the Honolulu City Council;
- (5) the Kauai County Council;
- (6) the Hawaii County Council; and
- (7) the Maui County Council."

On behalf of the non-profit WAI: Wastewater Alternatives & Innovations and the Cesspool Task Force (a coalition of 40 members and groups), I am writing in **strong support of HB2256 HD1 SD1.** This bill would create a Working Group to address the logistics required for the State to establish a Dept. of Environmental Protection (DEP).

WAI is a non-profit dedicated to protecting our drinking water, groundwater and near-shore ecosystems by reducing sewage pollution from cesspools and failing septic systems. Our goal is to help find more innovative, affordable, and eco-friendly solutions to wastewater management. Currently, we work with the Dept. Of Health's Wastewater Branch and Clean Water Branch on these issues, but they and many other environmental programs are understaffed, need more independent authority and would benefit from having their own Dept. of Environmental Protection (DEP).

Unlike most other states, Hawaii has no executive-level department dedicated to the mission of environmental protection and implementing the environmental policy goals enacted by the Legislature. Instead, these functions are dispersed among multiple state departments and agencies with differing missions, internal conflicts and bureaucratic obstacles.

The protection of the State's environment and natural resources is more critical now than ever. We are experiencing increasing environmental problems such as the Red Hill petroleum spill and threats to our drinking water from stormwater & wastewater pollution. We face an ongoing climate crisis that requires a more proactive and integrated DEP. Our environment has always been a central attraction in Hawaii for tourism and economic development, but it's also an essential part of the culture and Hawaii's identity. We must be more in protecting our Island Home!

Almost all issues are multi-jurisdictional, but creating an executive-level department like a DEP under one administrative umbrella should lead to greater efficiency in addressing Hawaii's environmental issues. Restructuring environmental agencies will be complex and challenging, but this bill appropriately provides for a working group with affected agency parties to address the logistics required for the State to establish a Department of Environmental Protection.

I agree with DLNR's cautionary testimony on this bill. I support it, but let's be smart about this department. The Department of Health already "protects" human health risks from environmental sources, e.g. pollution. DLNR "protects" natural ecosystems and the many ecosystem services they provide. Hawaii has its own version of the National Environmental Policy Act (NEPA), known as HEPA. I do think we need an independent small department to provide advice and coordination on cross-agency environmental issues, such as achieving greenhouse gas neutrality. The state task forces, commissions, and other volunteer-led and often un(der)funded groups do good work, but they are too easily ignored or left out of important conversations and decisionmaking. There should be a strong state legal mandate for the official involvement of the DEP in policy- and decision-making on issues affecting the environment. A multi-agency working group can identify those areas and how such a department could help cut across agency boundaries. Such a department can identify the inefficiencies and duplications, and how depts may work at cross purposes. They can even help address the underfunded challenges of other state agencies and propose creative solutions, such as public-private/nonprofit partnerships, such as the Hawaii Invasive Species Council and Hawaii Association of Watershed Partnerships. Give them the freedom and the responsibility to think critically and creatively rather than bogging them down with routine tasks with inadequate funding and personnel.
