Department's Position:

The Hawaii Department of Education (Department) supports HB 2494 to provide funding for professional development and classroom resources related to the Hawaii Core Standards in Social Studies (HCSSS), adopted by the Hawaii State Board of Education (BOE) in 2018, and the establishment of 1.00 FTE civic education resource teacher position in Social Studies.

Such actions will provide much needed support to help students become critical consumers of information; take civic action such as voting, volunteering, and serving in leadership positions; increase informational literacy skills; and participate fully in the community.

The realization of these goals will be much more likely with curricular and personnel support. Such support would include materials and resources to assist schools across the state to implement the new shifts of the HCSSS in the following ways:

- From narrow perspectives to global perspectives;
- From a predominately Western viewpoint to multicultural viewpoints;
- From merely learning about citizenship to practicing democratic citizenship within communities;
- From individualism to collaboration, dialogue, and deliberation; and
- From memorizing facts to the application of knowledge to solve real-life issues,

problems, and concerns.

<u>Impact on Professional Learning</u>: The paradigm shifts in social studies teaching and learning require focused efforts to provide both the necessary tools in the form of resources and materials and a position to provide the professional development needed to learn, practice, and incorporate these shifts. The supports in this bill will assist schools and complexes by:

- Identifying knowledge gaps;
- Collaboratively developing iterative, data-informed plans for teacher development and student support;
- Providing high-quality professional development;
- Creating structures for standards implementation;
- Strengthening school and complex area social studies leadership and relationships; and
- Focusing on highly effective, student-centered practices that improve schools and raise student achievement.

<u>Impact on Students</u>: One of the longtime goals of public education is to produce young people who are fully ready to participate in the democratic process. This requires high-quality social studies instruction and curricular materials. These materials will assist students to:

- Apply civic virtues and democratic principles;
- Practice source analysis with documents, images, visual and audio media, and artifacts;
- Develop media literacy skills to discern bias, authenticity, and relevance; and
- Engage in collaborative civic dialogue and deliberative processes to address issues and problems in government and civic society.

By supporting students with meaningful and appropriate resources and powerful instruction, they will become critical thinkers and communicators who know how to take meaningful action.

The Department appreciates this proposal and the inclusion of funding but asks that any additional funding does not affect the Department's top budget priorities to restore funds that were reduced as a result of the fiscal fallout from COVID-19 and the funding of existing budget shortfalls that were included in the Department's supplemental budget request. Without those funds, the Department will face severe constraints on its ability to continue to promote equity and access to needed resources and support for all students.

RELATING TO CIVIC EDUCATION

The Department of Budget and Finance (B&F) offers comments on this bill.

House Bill No. 2494 establishes 1.00 full-time equivalent position and

appropriates \$184,000 in general funds for FY 23 for the expansion of civic education in

public schools.

B&F notes that, with respect to the general fund appropriation in this bill, the

federal Coronavirus Response and Relief Supplemental Appropriations Act requires that

states receiving Elementary and Secondary School Emergency Relief (ESSER) II funds

and Governor's Emergency Education Relief II funds must maintain state support for:

- Elementary and secondary education in FY 22 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and
- Higher education in FY 22 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

Further, the federal American Rescue Plan (ARP) Act requires that states receiving ARP ESSER funds must maintain state support for:

- Elementary and secondary education in FY 22 and FY 23 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and
- Higher education in FY 22 and FY 23 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

The U.S. Department of Education has issued rules governing how these maintenance of effort (MOE) requirements are to be administered. B&F will be working with the money committees of the Legislature to ensure that the State of Hawai'i complies with these ESSER MOE requirements.

Bill No. and Title: House Bill No. 2494, Relating to Civic Education

Purpose: Appropriates funds for the expansion of civic education in the public schools and for one full-time equivalent permanent civic education resource teacher position.

PACE Commission Position: Strong support

The PACE Commission strongly supports this bill which would be a significant step toward improving civic education in Hawaii's public schools. Currently, the Department of Education (DOE) does not have a position solely focused and dedicated to supporting civic education. There is also a significant shortage in resources, professional development, training and support for developing teachers to teach civics and to support those who are teaching civics. This bill appropriates necessary funds to expand civic education, including through professional development and classroom resources. Further, and critically, this bill appropriates funds to hire a full-time permanent civic education resource teacher. Currently, the DOE has an Educational Specialist for Social Studies who has statewide responsibilities related to civic education, but who also has multiple other broad statewide duties far beyond civics. To have the type of resources, training and development needed for robust civic education from K-12 in public schools, it is imperative to have focused attention in this important area.

The PACE Commission was created last year because many in our State recognize the need to focus on civic education in our schools and in our community. The more we can improve civic education and civic engagement, the more we can improve civic knowledge and participation in our democracy and in our communities. It is important at this time to take action in this area and this bill is a crucial step in the right direction.

Brief background of the PACE Commission:

The PACE Commission was created pursuant to Rule 23 of the Rules of the Supreme Court of the State of Hawai'i, issued on January 7, 2021. The purpose of the PACE Commission is to promote and advance civic education for students and citizens throughout Hawai'i. The commission has fourteen members appointed according to Rule 23 by the following: Chief Justice of the Hawai'i Supreme Court, Governor, President of the Senate, Speaker of the House, Office of Hawaiian Affairs, Superintendent of the Department of Education, Chief Judge of the U.S. District Court for the District of Hawaii, President of the University of Hawai'i, Dean of the William S. Richardson School of Law, Hawaii State Bar Association, Hawai'i Association of Independent Schools, and two members selected by the other appointed members.

The commission began meeting in April 2021 and meets monthly. It also has two committees, one focused on civic education in the schools and one focused more generally on civic engagement in the community. The mission statement adopted by the PACE Commission is: "To create, implement and amplify sustainable programs, resources, and practices that improve place-based, constitutionally informed and culturally sensitive civic education and engagement in Hawai'i schools and communities."

The Hawaii State Teachers Association <u>supports HB 2494</u>, relating to civic education. The purpose of this bill is to fund the expansion of civic education in public schools, including professional development and classroom resources related to the Hawaii core standards in social studies. It also appropriates funds for one full-time equivalent permanent civic education resource teacher position.

The Hawaii State Teachers Association stresses the importance of expanding civic education in our public schools to prepare students to participate in the public and political lives of their communities. Civic education helps develop critical thinking skills in our students that are vital to the functioning of a democratic nation, including how to recognize social problems, evaluate possible solutions to problems, separate evidence-based claims from opinions, and to take action.

Hawaii is among the ten states with the lowest voter turnout in the nation. Cultivating social and political engagement among students through civic education is an important strategy available to increase voter turnout and citizen engagement over the long term, but not just for voting, also to know how to become more involved in community issues as they arise. Civic education helps them evaluate what others have tried, what has worked, and make a plan of action for creating change needed to solve problems together.

Aloha Esteemed Members of the EDN Committee,

I wholeheartedly support the intent of HB 2494. However, I ask that you consider making some improvements.

It's time for our laws related to education to:

- 1. Include sustainability provisions;
- 2. Provide for distance learning;
- 3. Specifically state measureable outcomes for financial expenditures; and
- 4. Make all non-confidential documents available to the public online.

As written, HB 2494 does not accomplish these goals. Therefore, I suggest the following revisions. (Strikeout indicates deletion. Underline indicates insertion.)

SECTION 2. There is appropriated out of the general revenues of the State of Hawaii the sum of \$84,000 or so much thereof as may be necessary for fiscal year 2022-2023 for the expansion of civic education in public schools, including professional development through the creation of a K-12, publicly-available, online curriculum and classroom resources related to the Hawaii core standards in social studies that provides a solid education in civic responsibility in the United States and Hawaii.

The sum appropriated shall be expended by the department of education for the purposes of this Act.

SECTION 3. There is appropriated out of the general revenues of the State of Hawaii the sum of \$100,000 or so much thereof as may be necessary for fiscal year 2022-2023 to hire one full-time equivalent (1.0 FTE) permanent civic education resource teacher position <u>responsible for the creation of the K-12, publicly-available, online curriculum content and classroom resources related to the Hawaii core standards in social studies that provides a solid education in civic responsibility in the United States and Hawaii.</u>

SECTION 4. Candidates for the position described in Section 3 must have prior experience as a curriculum developer.

ARGUMENTS IN SUPPORT OF MY SUGGESTED REVISIONS

If the State develops its own curricula, the State owns it and this is a one-time expense rather than paying publishers' annual license fees for 3rd-party curricula.

If the State owns the curricula, it's easy to modify and customize to the State of Hawaii.

If the curricula is available online and publicly available, everyone is free to use it and LEARN. Since I became involved with the Hawai'i public education system 16 years ago, I have never understood the secrecy issue – why not make ALL non-confidential information available to everyone? I still don't get it.

We should be thinking of ways to move forward in this technological world, and start putting ALL the curricula online.

Plan ahead, and take EVERYONE into consideration. If you develop systems that accommodate the disadvantaged, you accommodated everyone.

I really don't want one more "resource teacher" position created in the DOE to be filled with someone who is not competent to do the job required, or a job that is so nebulous there are no defined, measurable outcomes.

Aloha Chair Woodson, Chair Quinlan, and Committee Members:

I am Colin Moore, Director of the Public Policy Center at the University of Hawai'i at Mānoa. I served as the content lead for the new civics standards that were included in the Hawai'i Core Standards for Social Studies, which were approved for adoption by the Board of Education in October 2018.

I strongly support HB 2494. This bill provides desperately needed resources to the Department of Education to implement these excellent new civics standards. A fulltime permanent civic education resource teacher will ensure that appropriate professional development opportunities and resources are available to teachers as they develop new lessons and materials.

Our democracy is sustained through the participation of all citizens in civic life, yet rates of civic engagement have been declining across the nation for years. This decline is particularly alarming here in Hawai'i, a state that once had some of the highest voter turnout rates, but now ranks among the ten worst states in the nation.

We can reverse this trend, but it will require the state to support civic learning in our public schools. Young people must be provided with the civic knowledge and skills to understand the processes of government. They need to learn civic values that will lead to an appreciation for free speech and civil discourse. Finally, they need to develop the confidence to engage in civic behaviors like voting and attending public meetings. The new Hawai'i civics standards provide students with all of these skills, but teachers need extra support to adopt them.

That's why I urge you to support HB 2494. It will provide teachers with the resources and training to help our students learn the skills and gain the confidence to make their own contributions to our democracy.
