# TESTIMONY OF THE STATE FOUNDATION ON CULTURE AND THE ARTS TO THE HOUSE COMMITTEE CULTURE, ARTS, & INTERNATIONAL AFFAIRS Wednesday, March 23, 2022/Conference Rm 329 via Videoconference 10:40am H.C.R. 119/H.R.119

Chair Gates and members of the Committee, I am Jonathan Johnson, Executive Director of the State Foundation on Culture and the Arts (SFCA), and we are grateful for the opportunity to testify in **SUPPORT** of H.C.R. 119/H.R.119.

H.C.R. 119 requests that the State Foundation on Culture and the Arts "provide a report on the total amount of funding expended from the Works of Art Special Fund for the curation of art produced by an individual of Native Hawaiian decent ("Native Hawaiian art"), number of Native Hawaiian art pieces acquired, percentage of all works collected through the Works of Art Special Fund that is Native Hawaiian art, cost per Native Hawaiian art piece acquired, and percentage of the cost of all works collected through the Works of Art Special Fund attributed to the cost of acquiring Native Hawaiian art."

SFCA looks forward to providing a report as outlined by H.C.R. 119 which will address the SFCA's efforts and support of Native Hawaiian artists. This report is important because by looking at data, we are able to make informed decisions and dispel misleading narratives that hinder progress.

To better understand the collecting practices of the SFCA, the agency contracted Native Hawaiian curators Drew Kahu`āina Broderick, Ka'ili Chun, and Kapulani Landgraf to stage an exhibition at the Hawaii State Art Museum titled *Mai ho'ohuli i ka lima i luna*. The 2020 exhibition, featured art from the Art in Public Places Collection of the SFCA by Native Hawaiian artists. The curatorial essay in response to the exhibition, helps us to better understand where we have been, and where we are going in recognizing and honoring Kānaka artists. Currently, the Hawaii State Art Museum (HiSAM) is one of the host sites for the Hawai'i Triennial 2022 *Pacific Century - E Ho'omau no Moananuiākea*, a citywide exhibition in Honolulu featuring artists from Hawaii, Asia-Pacific and beyond. The exhibition, inclusive of Kānaka artists, is the largest perodic exhibition of contemporary art in Hawai'i. I invite all who are interested in the concepts behind HCR119 to visit and take in the exhibition at HiSAM.
