My name is Lee Ann Teshima, and I am the Executive Officer of the Board of Nursing (Board). The Board appreciates the intent and offers comments on this bill with respect to section 3 of the bill only, which proposes amendments to Hawaii Revised Statutes chapter 457.

The purposes of this bill are to: (1) clarify that access to abortion care is inclusive of all pregnant people in the State; (2) repeal a criminal penalty for violations of certain abortion provisions; and (3) clarify that advanced practice registered nurses (APRNs) may provide abortion care.

The Board appreciates the amendments specified in section 3 that would clarify existing language in the current law to authorize APRNs, to perform medication or aspiration abortions of a nonviable fetus for a "pregnant person" and redefining the penalties for knowingly violating this section.

The Hawai'i Section of the American College of Obstetricians and Gynecologists (HI ACOG) **supports SB2282** which would strengthen and protect inclusive access to abortion and the full range of sexual and reproductive health care by clarifying and amending state law.

Not since the United States Supreme Court's Roe v. Wade decision in 1973 has access to abortion been more threatened. Texas and Mississippi currently have challenges at the US Supreme Court that very realistically could undermine or completely overturn Roe v. Wade. With these federal protections for abortion access at very real risk, the State of Hawai'i, who has always been a leader in protecting access to abortion care, needs to do all we can to rectify any statutory gaps and solidify our state laws.

Abortion is a necessary aspect of comprehensive reproductive health care. **One in four women** in the US will have an abortion in her lifetime.¹ In addition, people of all genders have comprehensive sexual and reproductive health needs, including women, transgender people, nonbinary people, and those who are otherwise gender-diverse.

Abortion is extremely safe.²³ In the US, approximately 90% of abortions occur within the first trimester, when abortion is the safest. The risk of death associated with childbirth is 14 times higher than that with abortion.² In contrast, historical and contemporary data show that where abortion is illegal or highly restricted, pregnant people may resort to unsafe means to end an

Chair Rosalyn H. The Hawai'i Public Health Association (HPHA) is a group of over 450 community members, public health professionals, and organizations statewide dedicated to improving public health. Our mission is to promote public health in Hawai'i through leadership, collaboration, education and advocacy. Additionally, HPHA aims to call attention to issues around social justice and equity in areas that extend beyond the traditional context of health (e.g., education, digital equity, cultural sensitivity), which can have profound impacts on health equity and well-being. Therefore, as stewards of public health, HPHA is also advocating for equity in all policies.

We are providing this testimony in **strong support of SB 2282 SD1**, which takes steps to safeguard equitable abortion access for all pregnant people. Protecting access to safe abortion care ensures that individuals are able to make their own decision about the most personal and significant medical decisions that impact their life. The impact of not getting abortion care can be devastating. Data shows that persons denied a wanted abortion experience four times greater odds of living below the Federal Poverty Level; are more likely to experience life threatening complications of pregnancy such as eclampsia; and are more likely to stay in a relationship with an abusive partner.

Individuals who are most harmed by gaps in access to safe abortion care are individuals with low income or without savings. People with low socioeconomic status are more likely to be Black, Latinx, Native Hawaiian and Pacific Islander due to generations of systemic racism. People who face additional barriers to health care include those in rural and remote areas, young people, and LGBTQ communities. As advocates for diversity, equity and inclusivity in all policies, HPHA supports SB 2282 SD1 to ensure equal access to safe abortion care.



We support SB 2282 SD1 and respectfully ask that you pass this measure. Thank you for the opportunity to provide testimony on this important public health issue affecting members of our community.

Dear Chairs Baker, Chair Rhoads, and Members of the Committees,

Planned Parenthood Alliance Advocates – Hawai'i ("PPAA") writes in strong support of SB 2282. With federal protections for abortion care in grave danger, our state cannot afford to have statutory gaps in state law that put access to abortion at risk. This housekeeping bill ensures that all pregnant people in Hawai'i – including transgender and gender nonbinary people – have the right to abortion care; provides statutory consistency across state abortion codes; and repeals archaic provisions that threaten criminal punishment for abortion providers.

Last year was the worst year of state attacks on abortion in nearly 50 years, with over 100 abortion restrictions enacted into law nationwide. For over six months, Texas has blocked abortion access almost entirely for pregnant people in Texas. Thousands of Texans are being forced to either make costly trips hundreds of miles across state lines to access constitutionally-protected health care or carry pregnancies. The Supreme Court has repeatedly failed to stop Texas's deliberate nullification of the constitutional right to abortion and now, is set to decide on a 15-week Mississippi abortion ban that directly challenges Roe v. Wade. If Roe is overturned, 26 states will likely move to ban abortion in 2022, jeopardizing access for over 36 million women, trans men, and non-binary people. Patients are scared; patients are confused; and Planned Parenthood health centers continue to get flooded with calls from people trying to figure out where they can turn for health care.

The combination of the court green-lighting a near-total abortion ban in Texas and the impending demise of Roe means one thing: we should all be alarmed. Even here in Hawai'i, where we proudly support the right to abortion, too many people do not have meaningful access to care. Last year, Hawai'i lawmakers took a step in the right direction by passing a law allowing Advance Practice Registered Nurses to provide abortion care; this has increased access to abortion across the state and alleviated the pressures of the doctor shortage and the strain that the pandemic has placed on our health system. But there is still so much Hawai'i must do to fortify abortion access, especially with the nation facing the very real threat of abortion access disappearing in over half the country.

SB 2282 is a bill that will protect abortion access in Hawai'i in three ways:

First, this bill makes a housekeeping amendment to clarify that all pregnant people in the state have the right to access abortion care, including transgender and gender nonbinary people. Transgender and gender nonbinary communities already have to navigate tremendous barriers when accessing health care; they experience disproportionately high rates of discrimination, harassment, and assault in health care settings and face cost barriers and insurance gaps. Those seeking sexual and reproductive health care particularly face hurdles, as many providers assume trans or gender-diverse patients do not need basic reproductive and sexual health services, such as pelvic exams, contraceptive counseling, or abortion care. Using gender-neutral language in the Hawai'i abortion statutes will help safeguard the right to abortion care for transgender and gender nonbinary people and will encourage destigmatized, inclusive care across our state.

Second, this bill eliminates the archaic provisions that threaten criminal punishment for health providers who are providing safe and basic abortion care. Hawai'i already faces an abortion provider shortage, which leads to higher costs, unnecessary travel, long wait times, and delays to time-sensitive care for patients. Threatening criminal punishment against providers singles out and stigmatizes abortion care and forces providers to weigh the benefits of providing safe health care with the threat of prosecution. In a moment where abortion providers across the country are facing increasingly hostile environments and the possibility of prosecution, Hawai'i should eliminate language that threatens criminal prosecution against providers for simply doing the work they were trained to do.

Third, this bill makes housekeeping amendments to provide statutory consistency across state abortion codes. The clarifications in this bill will leave no doubt that the intent of the legislature is to ensure that physicians and advanced practice registered nurses may legally provide abortion care, both medication and procedural. Lawmakers must ensure consistency between the physician and nursing codes of the Hawai'i Revised Statutes to provide clarity and avoid confusion.

Access to abortion care ensures people have the freedom and power to control their own body, decisions, and lives. With the right to abortion care at a federal level hanging in the balance, Hawai'i must show up stronger than ever in its support of reproductive health care. We cannot allow the reality of Texas to become the reality of this country, and we need Hawai'i lawmakers to do everything in their power to safeguard abortion access.

Thank you for this opportunity to testify in strong support of this important legislation.

Hello Senate Committee and everyone, my name is Madison Filanc and I am a Junior studying Social Work at the University of Hawai'i at Manoa. For House Bill 2210 I am strongly in support of this proposed bill and providing testimony in regards to this. I urge you to pass this bill and its companion bill HB 2210.

I was born and raised here on the island of O'ahu and I identify myself as a cisgender woman. I feel so blessed to live in a state where my reproductive rights are protected and that I have access to abortion care here in Hawai'i. Unfortunately, not everyone in the United States or the world has these same privileges. With what is going on in places like Texas it is extremely important to protect people with uteruses and not allow for any loopholes in the law to get in the way of access to abortion care. While Hawai'i is a proabortion state with many laws in place that protect women's reproductive rights, it is equally as important to stand with our transgender and non-binary ohana as they should have access to abortion care as well.

This bill will further protect women and people with uteruses as it will use gender-neutral language which enables more protection for transgender and non-binary people seeking abortion care, as queer people may often be discriminated against when seeking medical care. Access to this care should always be a right and should be inclusive regardless of gender.

Additionally, we are living on Hawaiian land, and historically queer-identifying people such as Mahu who were seen as a third gender were treated equally in society, and therefore we should honor that history and further safeguard transgender and LGBTQ+ people's rights to abortion care.

As a woman with a uterus, I may one day seek abortion care, and I would like to feel protected, and that transgender and non-binary people who I stand with will as well. Seeing the regression of laws in certain states in the mainland, absolutely terrifies me, as I know that not all women will be able to make their own decisions about their bodies. Bodily autonomy is a right that all people should have, and abortion care should always be a part of that.

The added precautionary language in this bill will put people experiencing the same fear as I am, at ease about their reproductive rights here in the state of Hawai'i. Abortion care should always be an option available to people, and I urge you to pass this bill as it will continue to allow for that option and promote inclusivity in this state.

Last year, we saw the culmination of a nationwide strategy to end abortion access in this country when the Supreme Court allowed Texas to effectively ban all abortion care in the state. Now, with the Supreme Court Hawai'i cannot afford to have statutory gaps in state laws that put access to abortion at risk.

What happens to access in abortion in Hawai'i if Roe v. Wade falls?

Lawmakers Must Pass This Housekeeping Bill to Safeguard Abortion Access in Hawai'i. With federal protections for abortion care in grave danger, legislators must show up stronger than ever in their support of abortion access. This housekeeping legislation will protect abortion access by:

• Clarifying that all pregnant people in the state have the right to access abortion care, including transgender and gender nonbinary people.

• Providing consistency across state abortion codes.

• Eliminating archaic provisions that threaten criminal prosecution against providers for providing safe and basic abortion care.

Access to abortion care ensures people have the freedom and power to control their own body, decisions, and lives. She came from a family of over 100 cousins and her grandfather had 12 brothers and sisters. A large family was a blessing and she had dreamed of having many children. That dream was shattered after having her second child and finding that her partner blamed what he called her "lack of remembering to take her pill" on every spill or mishap that their current children caused or got into. Can you imagine that? Her not taking birth control turns into it being her fault that a child spilled something on the floor or broke something unintentionally?

It is no one else's business to judge a person who desires an abortion. Everyone has a story behind their reason or intentions and no amount of banning or putting up road blocks is going to put a stop to people who are mentally, physically, sexually, verbally abused who then have to carry the child of their abuser. While they will love and care for their child, they will also have to endure shaming and blaming by their abuser for becoming pregnant, possibly labeled a bad mother and endure more abuse because the perpetrator will use the child as leverage to keep in contact with them, no matter what they try.

Please assure that abortion is easily acessible through quality health care providers and that SB2282 passes for those persons seeking peace over being controlled by an abuser who will throw this child's existence and very being in their face for the rest of their life.

Testimony in Support of SB 2282 SD1

My name is Lauren Rapoport and I am a Masters in Social Work student at the University of Hawaii at Manoa, a former documentary-film producer/researcher, and a resident of Honolulu. I spent last semester of my program researching abortion laws in the United States for my policy class, and as a result of what I learned I am testifying in support of SB2282 SD1.

The US has the highest rates of teen pregnancy of all industrialized nations (Cannonier, 2012). However, abortion restrictions have been proven by a multitude of studies to be ineffective in reducing abortion rates; One 2020 study examined 2415 datapoints on pregnancy and abortions that were collected from 166 countries during the years of 1990–2019 (Bearak et al., 2020). The study found that abortion restrictions were not associated with lower abortion rates (Bearak et al., 2020). In fact, data suggested that "the proportion of unintended pregnancies ending in abortion increased in countries where abortion was legally restricted" (Bearak et al., 2020). While extremely restrictive abortion policies do not bring abortion rates down, they do increase the danger in terminating a pregnancy (Bearak et al., 2020; Fox, 2018).

Additionally, teenage mothers often drop out of school and their children are more likely to become teenage parents (Maclaggan, 2014). Young moms, especially poor young moms, are often reliant on social services to provide for a child (Cannonier, 2012). This is likely true for nonbinary and transgender parents as well. In short, teen childbearing (and likely unintended pregnancy in general) costs state governments in lost wages of parents and an increased reliance on social services (Daverth, 2017). It is in the state's financial interest to ensure that abortion care prior to fetal viability is accessible to residents who choose to seek it.

Hawaii has been a trailblazer in legalizing abortion access; Hawaii was the first state to legalize abortion on March 13, 1970, 3 years before Roe V. Wade (1973) (Smith et al., 1971). 1973 Supreme Court ruling Roe V. Wade strengthened these protections when it established that states cannot place restrictions on medical abortion procedures that take place during the first trimester of pregnancy. The ruling states that during the second trimester of pregnancy, the state may impose regulations on abortion, but only if doing so is in the interest of bettering maternal health (Roe v. Wade, 1973). Roe v. Wade (1973) also establishes that during the third trimester, which it defines as fetal viability, states are allowed to fully regulate abortions, except in cases where the life and health of the mother or the fetus is at risk. In a related ruling on Doe v. Bolton during the same year, the Supreme Court established that a state is not permitted to "unduly burden the exercise of that fundamental right with regulations that prohibit or substantially limit access to the procedure" (Shimabukuro, 2021). In 1992, The Supreme Court case Casey v. Planned Parenthood further helped to establish that the state cannot interfere with abortion of pre-viable pregnancies, but it may regulate abortion post-viability (Legal Information Institute, n.d.). The U.S. Supreme court has reaffirmed the right to abortion a multitude of times since the original Roe ruling (Guttmacher Institute, 2021).

Unfortunately, abortion laws throughout the country have become progressively more restrictive since 2010 (Guttmacher Institute, 2021), attacking the protections outlined in *Roe V. Wade* (1973). The Texas Heartbeat Act and Mississippi's Gestational Age Act, which the Supreme Court has failed to strike down, have inspired a number of similar bills in other states eliminating or severely restricting abortion access. This leaves the fate of abortion protections in the United States vulnerable and unknown. In the face of these threats, lawmakers in Hawaii must be vigilant in ensuring the strength and inclusiveness of state laws regarding abortion access.

Laws regarding abortion access or restriction fail to address those who identify as non-binary or transgender, and instead only address females and women. Part of ensuring inclusive access to care and strengthening our laws in the state includes amending language that prevents access to care. One should not need to identify as a woman to be deserving of access to abortion-related care. I believe that amending the terminology to "pregnant persons" achieves this inclusion.

Additionally, ensuring statutory consistency with Act 576, which allows registered nurses and physicians to provide medication and procedural abortion care, is essential to ensure that residents living in rural areas of Hawaii have access to the care that they are constitutionally entitled to. I would argue that inability to access care due to one's geographical location restricts a person's right to healthcare autonomy, and may interfere with the constitutional rights awarded by the aforementioned Supreme Court Cases.

In conclusion, I stand in strong support of SB 2282 SD1 in order to protect abortion access (prior to pregnancy viability) for all pregnant persons in Hawaii, rather than just for women. Such access, by extension, may lessen the financial strain that unintended and unwanted pregnancy and births place on Hawaii's state budget. Furthermore, Hawaii's lawmakers have an inherent duty to protect the rights, well being, and health of those who are vulnerable, including pregnant persons, women, people who are transgender, and people who are nonbinary. I ask that you vote in support of SB 2282 SD1 to fulfill this duty. Mahalo nui loa for your consideration and time.

Hawaii Women Lawyers submits testimony in **strong support of S.B. 2282, S.D. 1**, which amends prior measure S.B. 2282 by providing for technical, non-substantive amendments made for the clarity and consistency. Hawaii Women Lawyers reiterates its strong support for the underlying bill of S.B. 2282 and appreciates that it affirms that access to abortion care is inclusive of all pregnant people in the State of Hawaii, repeals a criminal penalty for violations of certain abortion provisions, and clarifies that advanced practice registered nurses ("*APRNs*") may provide abortion care.

The mission of Hawaii Women Lawyers is to improve the lives and careers of women in all aspects of the legal profession, influence the future of the legal profession, and enhance the status of women and promote equal opportunities for all.

Although the need for responsible family planning measures has increased astronomically during the pandemic, access to abortion care across the United States has never been more imperiled. And while abortion has been legal in Hawaii since the 1970s, there are certain statutory gaps and "loopholes" in our laws that must be closed in order to ensure safe and legal access to abortion care is available for all persons. The right to choose when and whether to start a family and to have autonomy over one's body is a fundamental right of all people that must be protected.

HWL supported the passage of legislation in 2021 that allowed APRNs to join physicians in being able to provide medication and procedural abortion care, and appreciates the intent of S.B. 2282, S.D. 1 in providing statutory consistency between the physician and nursing sections of the Hawaii Revised Statutes, as well as removing the provisions for criminal punishment with respect to health providers engaging in safe and basic abortion care. I fully support the underlying bill S.B. 2282 and appreciate that it affirms that access to abortion care is inclusive of all pregnant people in the State of Hawaii, repeals a criminal penalty for violations of certain abortion provisions, and clarifies that advanced practice registered nurses ("*APRNs*") may provide abortion care.

Although the need for responsible family planning measures has increased astronomically during the pandemic, access to abortion care across the United States has never been more imperiled. And while abortion has been legal in Hawaii since the 1970s, there are certain statutory gaps and "loopholes" in our laws that must be closed in order to ensure safe and legal access to abortion care is available for all persons. This housekeeping bill ensures that all pregnant people in Hawai'i – including transgender and gender nonbinary people – have the right to abortion care; provides statutory consistency across state abortion codes; and repeals archaic provisions that threaten criminal punishment for abortion providers.

As we see a nationwide strategy to end abortion access in this country Hawai'i cannot afford to have statutory gaps in state laws that put access to abortion at risk. If Roe is overturned or gutted, Hawai'i law will continue to protect the right to abortion. However, lawmakers must take steps to safeguard equitable abortion access for all pregnant people.

The impact of not getting access to safe abortion care can be devastating. A pregnant person who is denied a wanted abortion and is forced to carry an unwanted pregnancy to term experiences four times greater odds of living below the Federal Poverty Level (FPL). They are more likely to experience pregnancy complications from the end of pregnancy, including eclampsia and death. They are also more likely to stay in a relationship with an abusive partner and to suffer anxiety and loss of self-esteem after being denied wanted abortion care.
