Aloha Chair Johanson and Members of the Committee:

My name is Keali'i Lopez and I am the State Director for AARP Hawai'i. AARP is a nonpartisan, social mission organization that advocates for individuals age 50 and older. We have a membership of 38 million nationwide and over 140,000 in Hawai'i.

AARP Hawai`i appreciates and supports this measure to extend the renewal period for older drivers from two to four years. The COVID-19 pandemic has impacted the driver license renewal process for all Hawaii drivers as local motor vehicle stations reduced the daily number of customers served and made other operational changes due to public health safety. This has resulted in extensive backlog and delays which have made it increasingly difficult for everyone to renew their license on a timely basis. Extending the renewal process from two to four years for older drivers reduces the frequency to update their driver's license. This alleviates the license renewal burden on the driver as well as the local department of motor vehicle stations.

I urge you to move this bill forward. I went through the two year renewal process in the midst of the pandemic. Fortunately, I was able to renew by mail, something which should be a permanent option. That option was only aviable for several months and I met the criteria. This was at a time when COVID numbers were high and drivers' license offices were closed for days and weeks on end because employees had tested positive.

People live much longer than they used to. Most people in Hawaii are active in their 70s and 80s. Some even into their 90s. The current President of the United States is 79 and will turn 80 this year. The immediate past President is 75. If people in their 70s and 80s can lead our nation, then certainly people of that age can be trusted to drive without having to renew their driver's licenses every 2 years. This bill recognizes and respects the rights and abilities of people as they age rather than treating them as being less competent than the rest of the population. #### RECOMMENDED AMENDMENT TO SB 2679

The previous chairs seem to go back and forth on whether to change the renewal to 4 years for everyone, or revert back to 2 years for anyone over 80 years old. Legislators seem to have this innate ability to overregulate and complicate things. I highly recommend changing the renewal period to 4 years for anyone over 72 years old and leave it at that for the following reasons:

- 1) The City & County of Honolulu Mayor's Package introduced HB 1433/SB 2109 which simply required changing the period of renewal from 2 to 4 years for anyone over 72 years of age. The City & County administers the driver license renewals and the DMV understands the most efficient way to deal with them. We should give strong consideration to the DMV version.
- 2) The vast majority of states do not have a staggered system; after a certain age usually 72 most normally change the renewal period to X number of years and leave it at that. More specifically 13 states allow the older population to renew their license every 8 years (same as the general population). 10 states allow renewal for the older population every 5 years, and 14 states allow renewal for elders every 4 years. Only 7 states (including Hawaii) have a 2 year renewal period for drivers 72+ (not staggered). The balance complicate the matter.
- 3) A 71 year old driver in Hawaii can renew their license for 8 years which means they will be 79 years old before they have to renew again, where the 72 year old would have to renew at age 74. This staggered system is unfair and blatantly discriminatory.
- 4) When a driver's license is renewed at the DMV the only item that gets checked is one's eyesight. This is DMV's sole criteria determining an older person's ability to drive, so it is an <u>assumption that simply because someone</u> is old they must therefore be bad drivers needing constant observation. Statistics indicate that fatalities of older drivers have been on a steady decline. In other words, we may be assuming something that may not be supported by facts.
- 5) I believe most older drivers know when they are not able to drive and will stop on their own (even though they can pass the eye exam). Ex. My mother in her 80s quit driving at night because she felt it was too dangerous, but continued to drive during daylight hours.

#### S.B. 2679, S.D. 2, H.D. 1 RELATING TO DRIVER'S LICENSES

House Committee on Consumer Protection & Commerce

The Department of Transportation (DOT) **supports** S.B. 2679, S.D. 2, H.D. 1, which extends the renewal period from 2 years to 4 years for licensees who are 72 years of age or older but younger than 80 years of age.

The DOT has not found local data to indicate drivers 70 years or older are at higher risk of causing or being involved in crashes. Also, based on a review of an American Automobile Association study, which included information on age-based license renewals from 51 jurisdictions, only 21 of the United States jurisdictions polled have a shorter renewal cycle based on the age of the driver. Those age-based policies were generally longer than 4 years.
