Chairperson Hashem, and Members of the Committee:

Thank you for the opportunity to testify on Senate Bill No. 2989 SD1. The bill requires the Department to establish a healthy soils program, defining the terms "healthy soils" and healthy soils practices", creating a statewide soil health assessment, providing farmers with outreach and technical assistance, establishing standards, and providing awards to incentivize farmers to implement appropriate farming practices contributing to healthy soils.

The Department appreciates the intent of this bill recognizing the importance of healthy soil for sustainable agricultural production and increase of carbon sequestration in Hawaii. The Department acknowledges there is another measure SB3325 SD1 that describes in detail a program to be administered by the Office of Planning and Sustainable Development (OP/SD) to incentivize carbon sequestration activities and improving soil health through incentive contracts that provide compensation to participating farmers and landowners. OP/SD also heads the Greenhouse Gas Sequestration Task Force which includes similar objectives of identifying practices that



improve soil health, increase use of compost, and result in increasing agricultural and aquacultural product yield (Section 225P(a)(2) and (3)).

The Department believes that SB 3325 SD1 is a more comprehensive vehicle to establish and implement a healthy soils program and the building of soil carbon stocks.

# RELATING TO AGRICULTURE

The Department of Budget and Finance (B&F) offers comments on this bill.

Senate Bill (S.B.) No. 2989, S.D. 1, adds a new section to Chapter 141, HRS, to establish a Healthy Soils Program (HSP) within the Department of Agriculture to: define the terms "healthy soils" and "healthy soils practice"; create a statewide soil health assessment with a list of practices specific to the State that are effective in improving soil health and building soil carbon stocks; provide farmers with education and technical assistance to implement practices that contribute to healthy soils; establish standards that apply to the HSP based on the findings of reports completed by the Greenhouse Gas Sequestration Task Force; and issue awards and other financial incentives to implement practices that contribute to healthy soils. This bill also establishes the HSP Special Fund (HSPSF), appropriates an undetermined amount of general funds in FY 23 to be deposited into the HSPSF, and appropriates an undetermined amount of special funds out of the HSPSF in FY 23 to effectuate the HSP.

B&F notes that, as a matter of general policy, the department does not support the creation of any special fund which does not meet the requirements of Section 37-52.3, HRS. Special funds should: 1) serve a need as demonstrated by the purpose, scope of work and an explanation why the program cannot be implemented successfully under the general fund appropriation process; 2) reflect a clear nexus between the benefits sought and charges made upon the users or beneficiaries or a clear link between the program and the sources of revenue; 3) provide an appropriate means of financing for the program or activity; and 4) demonstrate the capacity to be financially self-sustaining. Regarding S.B. No. 2989, S.D. 1, there does not appear to be any significant source of revenues to support the HSPSF aside from appropriations from the general fund.

B&F also notes that, with respect to the general fund appropriation in this bill, the federal Coronavirus Response and Relief Supplemental Appropriations Act requires that states receiving Elementary and Secondary School Emergency Relief (ESSER) II funds and Governor's Emergency Education Relief II funds must maintain state support for:

- Elementary and secondary education in FY 22 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and
- Higher education in FY 22 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

Further, the federal American Rescue Plan (ARP) Act requires that states receiving ARP ESSER funds must maintain state support for:

- Elementary and secondary education in FY 22 and FY 23 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and
- Higher education in FY 22 and FY 23 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

The U.S. Department of Education has issued rules governing how these maintenance of effort (MOE) requirements are to be administered. B&F will be working with the money committees of the Legislature to ensure that the State of Hawai'i complies with these ESSER MOE requirements.

The Hawaii Farmers Union United (HFUU) is a 501(c)(5) agricultural advocacy nonprofit representing a network of over 2,500 family farmers and their supporters across the Hawaiian Islands. **HFUU strongly supports SB2989** and the development of a robust soil health program within the Hawaii Department of Agriculture.

The Hawaii Healthy Soils Program (HSP) is intended to house multiple incentives, like those for cover crops (<u>SB2675</u> and <u>SB2990</u>) and compost (<u>SB3004</u>) and <u>SB2288</u>). This approach is similar to <u>California's Healthy Soils Program</u> which funds demonstration and implementation grants that support myriad conservation agriculture practices.

The forthcoming GHG sequestration task force report will further delineate best practices that can be incorporated into future incentives. The Hawaii HSP will serve as a mechanism to expand resourcing of these and similar incentives. Conceivably the HSP, similar again to CA's approach, could be stewarded by an expert support panel, akin to or utilizing the GHG sequestration task force.

As initial incentives, compost application and cover cropping were selected because they are among the top conservation agriculture practices incorporated into NRCS plans for Hawaii farmers and from discussion with conservation planners.

On behalf of the Hawai'i Alliance for Progressive Action (HAPA) I am submitting testimony in <u>support of SB2989 SD1</u>.

SB2989 SD1 requires the Department of Agriculture to establish a Healthy Soils Program.

HAPA supports a sound program and plan to build our soil structure, nutrient capacity and soil biodiversity. These practices prevent soil erosion by wind and water, which can further enhance air and water quality and have cascading positive impacts in our environment.

Healthy soil is the basis for establishing lasting soil that sustains communities, environmental services, farms, and farmers, for generations. In recent decades we have learned a great deal about the importance of microbial life, and soil biodiversity in over soil "health". As we realize the mistakes we have made over the last 60 or so years, moving our focus to more industrialized agriculture practices, we must move away from the outdated practices of sterilizing lands with pesticides and herbicides and killing the soil microbes and life<sup>1</sup>, and instead support the biodiversity of insects and microbes that are beneficial to soil health<sup>2</sup>.

In addition to important things like composting, crop rotation, covercroping and other ways that we can increase organic content, we need to be looking at rehabilitation of old and previously cleared and graded soils to restore soil biodiversity along with organic

content. A well structured program would include qualified soil biologists that could bring these new scientific understandings about soil ecology into the program.

Soil biodiversity provides fertile ground for advancing global sustainability because it integrates so many challenges including climate regulation, water quality, pollution remediation, food and fiber production, and habitat for organisms aboveground and underwater.<sup>3</sup>

Healthy soil is by far the most biologically diverse part of Earth. The soil food web includes beetles, springtails, mites, worms, spiders, nematodes, fungi, bacteria, and other organisms. These organisms improve the entry and storage of water, resistance to erosion, plant nutrition, and break down of organic matter. These vital ecosystem services are often forgotten and even destroyed through intensive industrialized agriculture<sup>4</sup>.

HAPA believes that SB2989 SD1 can help to address a range of important issues we face related to degraded and damaged soils, restore and improve soil biodiversity, while also improving the overall quality of our environment and working to sequester carbon. SB2989 SD1 is therefore not just important for our local food production agricultural sector but is good for our local environment.


The Hawaii Farm Bureau supports SB 2989, SD1, which requires the Department of Agriculture to establish a Healthy Soils Program.
