## In consideration of HOUSE BILL 1183 RELATING TO STATE PARKS

House Bill 1183 proposes to exempt parking lot operations at state parks and operation of concessions at certain state parks from the bidding requirements for concessions operating on public property. The **Department of Land and Natural Resources (Department) strongly supports this measure.** 

Cooperative agreements for stewardship and management with private partners, including non-profit organizations, have proven to be an effective management tool to increase quality of experience and resource protection in our state parks. While a number of non-profit partners have long-term leases to provide experiences and value-added services within parks, none of them have yet included assistance with visitor management or parking lot operations, which are defined in Hawai'i Revised Statutes (HRS) 102-2 as a concession, and therefore subject to a competetive bid process. As the State Park System has expanded its parking and entry fee collection to ten parks, with potential for more, a natural outcome is to integrate co-mamnagement with affected communities and non-profit partners. This idea was piloted in 2020 at the Hā'ena State Park integrated parking and shuttle reservation system, in the wake of a paradigm-shifting master planning proceess. However, due to the lack of an existing exemption in HRS Section 102-2, State Parks cannot negotiate a long-term lease or management agreement to our non-profit partner at Hā'ena, Hui Maka'āinana O Makana. They presently manage this critical, highly successful visitor management system via a month-to-month revocable permit.

Particularly notable is the proposed amendment adding a new Section 2(b)(11) which exempts bidding requirements for concessions within state parks which are "environmentally, culturally, historically, or operationally unique and are supported by nonprofit corporations". This is a very specific exemption, and

Hā'ena certainly fits within this definition, and great potential exists for other culturally and environmentally unique parks to benefit from this model, such as Kealakekua Bay and Kīholo (Hawai'i) and Ka'ena Point (O'ahu).

My name is Chipper Wichman and I am a resident of Hā'ena Kaua'i and have been involved in conservation of natural and cultural resources for almost 50 years. I am a founding Director of the Hui Maka'āinana o Makana (1998) and just retired as the President of the National Tropical Botanical Garden after working there since 1976.

I currently serve on the Board of Directors of the Hui Maka'āinana o Makana and am testifying today in my position as the Secretary of the Hui. Our Board is in strong support of HB 1183 as it will allow State Parks to negotiate directly with non-profit organizations like the Hui to manage not only the natural and cultural resources found in numerous State Parks across the pae 'āina (archipelago) but to also assist with visitor management or parking lot operations.

In Hā'ena we have been able to implement true regenerative tourism through our partnership with State Parks and the visitors are excited to know that their money is being used to help take care of our 'āina and our community. Although the Hui has a 22-year successful track-record in partnering with State Parks, and we have been managing the parking, entry and shuttle operations for 2 years under a revocable permit the AG has advised DSP that they can't enter into a long-term lease with the Hui because (HRS) 102-2 defines parking lot operations as a concession which then makes it subject to a competitive bid process.

<u>We ask for your support in passing HB 1183</u> which will fix this problem and allow DSP to work with their non-profit partners like the Hui to provide holistic management of

parks that are "environmentally, culturally, historically, or operationally unique and are supported by nonprofit corporations".
