Dear Chair Lowen, Chair Ichiyama and Members:

Subject: House Bill 1212: Relating to Water Neutrality

The Honolulu Board of Water Supply (BWS) supports House Bill (HB) 1212, which establishes the water neutrality task force to develop a plan for Hawaii to become water-neutral by the year 2050. Water neutrality is defined in the measure as a process that balances water use through reduced water usage and investment in projects that increase the supply of fresh water.

The BWS is a strong advocate of water conservation and sustainable water supply development, including groundwater, water reuse and desalination.

Under subsection (d), the BWS recommends including a director-level representative(s) or designee(s) from a county agency with authority over water supply with an extensive water conservation program. If the water neutrality plan is required to include reducing water usage and increasing fresh water supply, in addition to increasing water reuse, then a county water supply representative is needed to fill the apparent gap. Therefore, the BWS requests adding an amendment to subsection (d) to include:

(6) The Manager and Chief Engineer, or the Manager's designee, from each county board, or department, of water supply.

By finding new ways to reduce consumption of potable water it is important to plan wisely for our future. Emerging issues such as climate change sea level rise, droughts, extreme precipitation and flooding continue to have a profound global impact. Water neutrality is a concept for managing water resources and this can be integrated into the framework.

# In consideration of HOUSE BILL 1212 RELATING TO WATER NEUTRALITY

House Bill 1212 proposes to establish a task force to develop a plan for Hawai'i to be water-neutral by the year 2050, and requires the task force to submit a report to the Legislature. The Department of Land and Natural Resources (Department) acknowledges the intent of this measure and offers comments and amendments.

The Department's Commission on Water Resource Management (Commission) is responsible for ensuring that water is available for future generations. This is accomplished through the Commission's regulatory, hydrologic monitoring, and planning programs. Hawai'i Revised Statutes (HRS) Section 174C-2, Declaration of policy, provides in subsection (b) that it is the Commission's policy to develop "a program of comprehensive water resources planning to address the problems of supply and conservation of water. The Hawaii water plan, with such future amendments, supplements, and additions as may be necessary, is accepted as the guide for developing and implementing this policy." The impacts of climate change are expected to reduce water availability in many areas of the state of Hawai'i. It is important to consider actions that can be taken now to ensure that water is available to meet future water demands while continuing to protect the public trust purposes of water. The proposed Water Neutrality Task Force and report would help to guide future actions to improve water use efficiency, increase water supplies, and inform water resource management policies.

House Bill 1212 proposes to establish a task force within the Department of Health (DOH) to create a water neutrality plan. As stated in HRS Section 174C-66, Jurisdiction over water quality, DOH administers the State's water quality program including water reuse and recycling. The proposed water

neutrality plan shall include plans to reduce water usage and increase in the supply of fresh water including the increase of water reuse and recycling. The focus of the water neutrality plan seems focused on water quantity, which falls under the purview of the Commission. Additionally, convening a large task force and conceiving a comprehensive plan to achieve water neutrality for the State of Hawai'i is a complex and time-consuming task that should also include community and stakeholder input. The Department does not believe that a meaningful water-neutrality plan could be accomplished in the short timeframe proposed in this measure and that funding would be necessary to complete a functional and realistic plan. Thus, the Department suggests that the task force should be established within the Commission, additional time allowed for the plan, and funding appropriated, and offers the following amendments (grey highlight):

- SECTION 2. (a) There is established within the [department of health] commission on water resource management for administrative purposes the water neutrality task force.
- (b) The task force shall create a plan for Hawaii to become water-neutral by the year 2050. The water neutrality plan shall include plans to:
  - (1) Reduce water usage;
  - (2) Increase water reuse and water recycling; and
  - (3) Increase the supply of fresh water.
- (c) The task force shall consist of the following members or their designees:
- (1) The [deputy director for environmental health administration of the department of health] chairperson of the commission on water resource management or their designee, who shall serve as the chairperson of the task force;
- (2) The [chairperson of the board of land and natural resources] deputy director for environmental health administration of the department of health;
  - (3) The chairperson of the board of agriculture;
- (4) [A] The member of the commission on water resource management[, other than the chairperson of the board of land and natural resources] with substantial experience or expertise in traditional Hawaiian water resource management techniques expertise;

- (5) The chairperson of the house of representatives committee with subject matter purview over water and land; and
- (6) The chairperson of the senate committee with subject matter purview over water and land.
- (d) In addition to the members specified in subsection (c), the chairperson shall invite the following individuals to be members of the task force:
- (1) A director-level representative from a county agency with permitting or implementation authority over water reuse in that county;
- (2) A representative from a public agency with permitting or implementation authority over wastewater;
- (3) A representative of the Fresh Water Council of Wai Maoli: Hawaii Fresh Water Initiative;
- (4) The environmental program director of the Hawai`i Community Foundation, or the director's designee; and
- (5) Any other individual whom the [deputy director] chairperson of the task force determines would provide a benefit to the task force.
- (e) Private members of the task force shall serve without compensation but may be reimbursed for actual expenses, including travel expenses, incurred in the performance of their duties.
- (f) The task force shall consider the recommendations made by the water reuse task force established pursuant to H.C.R.No. 86, S.D.1 (2018).
- (g) The task force shall submit a report to the legislature no later than twenty days prior to the convening of the regular session of [2024]2026. The report shall include the water neutrality plan, findings, recommendations, and any proposed legislation.

(h) The task force shall cease to exist on June 30, [2024]2026.

SECTION 3. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ or so much thereof as may be necessary for fiscal year 2023-2024 to establish a water neutrality task force and water neutrality by 2050 plan.

The sums appropriated shall be expended by the department of land and natural resources for the purposes of this Act.

SECTION [3]4. This Act shall take effect upon its approval.

The Environmental Caucus of the Democratic Party of Hawai'i stands in strong support of HB 1212. This measure establishes the water neutrality task force to develop a plan for Hawaii to become waterneutral by the year 2050 and requires the task force to submit a report to the Legislature.

The Hawaii State Constitution, Article XI, Section 7, entitled WATER RESOURCES provides:

**Section 7.** The State has an obligation to protect, control and regulate the use of Hawaii's water resources for the benefit of its people.

The legislature shall provide for a water resources agency which, as provided by law, shall set overall water conservation, quality and use policies; define beneficial and reasonable uses; protect ground and surface water resources, watersheds and natural stream environments; establish criteria for water use priorities while assuring appurtenant rights and existing correlative and riparian uses and establish procedures for regulating all uses of Hawaii's water resources.

The Democratic Party of Hawai`i Platform plank on the environment provides that its members are to "protect and preserve Hawai'i's environment and achieve energy sustainability, advance measures to reestablish a healthy climate and environment for humans and fellow species, including actions to urgently address climate change, and work towards 100% renewable energy goals.

We believe that all people have the right to live in a clean, healthy and safe environment. We believe that the preservation of our natural environment and its ecological well-being is essential to ensuring a safe, healthy, bountiful life for future generations in Hawai'i. We support policies that create a more sustainable society. We support the restoration, preservation, and protection of native ecosystems.
