In consideration of HOUSE BILL 1278 RELATING TO GREEN INFRASTRUCTURE

House Bill 1278 proposes to establish green infrastructure objectives and policies for transportation systems, infrastructure, and projects, and establishes the Green Transportation Infrastructure Task Force to examine, evaluate, and develop policies for the design, implementation, and maintenance of green transportation infrastructure. **The Department of Land and Natural Resources (Department) supports this measure.**

This measure is aligned with the mission of the Department's Kaulunani Urban and Community Forestry Program. The Kaulunani Program builds capacity in our communities to plan for, establish, manage, and protect green infrastructure including street-trees, urban forests, green spaces, bioswales and related natural areas. The urban tree canopy in Honolulu is declining, and with it, the benefits provided by urban green infrastructure as stated in the bill. This measure would help reverse that trend.

Chairs Todd and Lowen, Vice Chairs Kila and Cochran, and Members of the House Committees on Transportation, and Energy and Environmental Protection:

The Office of Planning and Sustainable Development (OPSD) offers the following **comments** on HB 1278. HB 1278 is generally in alignment with the work of the <u>State Greenhouse</u> <u>Gas Sequestration Task Force</u> and the recommendations of the State of Hawai'i's decennial climate and sustainability strategic action plan—the <u>Hawai'i 2050 Sustainability Plan: Charting a Course</u> for the Decade of Action (2020-2030).¹

OPSD supports the development and expansion of green infrastructure across the state. Specifically, the Hawai'i 2050 Sustainability Plan recommended to:

Focus Area 4: To advance the development of sustainable and adaptive communities in Hawai'i

- 1. "Increase the urban tree canopy and increase dedicated bike lane miles." (Recommended Action #142, Page 103)
- 2. "Increase public availability of outdoor spaces and provide areas to interact with nature and reduce urban heat island effects." (Recommended Action #144, Page 103)
- 3. "Study and implement green infrastructure design guidelines and policies." (Recommended Action #158, Page 103)
- 4. "Support and expand on-site rainwater harvesting and stormwater harvesting." (Recommended Action #159, Page 103)
- 5. "Expand and integrate permeable pavement and concrete opportunities." (Recommended Action #160, Page 103)

Focus Area 7: To preserve Hawai'i's natural environment:

1. "Evaluate the use of green infrastructure along Hawai'i's shoreline, and throughout the coastal zone, with the dual-benefit of controlling erosion and other shoreline processes

while mitigating the impacts of land-based pollution and inland flooding." (Recommended Action #216, Page 106)

- "Sponsor symposia and trainings on green infrastructure installation and maintenance for professionals, property owners, and advocates." (Recommended Action #217, Page 106)
- "Identify adaptations needed to implement green infrastructure successfully in Hawai'i's unique conditions (topography, climate, soils, and development patterns." (Recommended Action #218, Page 106)
- "Study the efficacy, cost, and lifespan of green infrastructure and traditional water management techniques compared to 'grey' infrastructure currently utilized in Hawai'i." (Recommended Action #219, Page 106)

The Greenhouse Gas Sequestration Task Force organized a <u>Permitted Interaction Group</u> on Urban Green Infrastructure, which included the Department of Transportation and the Department of Land and Natural Resources and produced a report identifying various forms of green infrastructure.

The OPSD supports the goals and responsibilities directed in the proposed "Green Infrastructure Task Force" which tasks OPSD to serve as a task force member. OPSD supports the need to examine, evaluate, and develop best practices to guide the design, implementation, and maintenance of green transportation infrastructure to advance Hawai'i's sustainable and climate resilient transition. The OPSD defers to the appropriate agencies on the administrative requirements of the bill.

Aloha, Chair Lowen, Vice Chair Cochran, and Committee Members:

The Environmental Caucus of the Democratic Party of Hawai'i has an enrolled membership of more than 7,000 voting residents here in Hawai'i. We strongly support HB 1278, which would establish green infrastructure objectives and policies for transportation systems, infrastructure, and projects. It would create a Green Transportation Infrastructure Task Force to examine, evaluate, and develop policies for the design, implementation, and maintenance of green transportation infrastructure.

The hideous Honolulu Rail disaster has blighted our landscape with a worthless monstrosity that cannot meet its proposed goals and will bankrupt the City at a cost of about \$20 billion if it ever gets "completed." Honolulu's Rail is a poster-child demonstration of how NOT to develop transportation infrastructure – starting with the falsehoods by which it was "sold" to an unsuspecting public; the powers who made the decisions; the process; the values and political pressures that dictated the design; the horrendously ugly design itself, with massive amounts of concrete; the route that runs through landfill; a failure to secure a station at Ala Moana Center; the idea that "somebody else will ride the rail so I can continue to drive on the freeway". All of these are not the way to develop transportation infrastructure. We definitely need to change the direction of transportation projects in Hawaii by making them environmentally friendly and better adapted to human needs.

It is inspiring indeed to read the introduction of this bill, which states, in part: "Hawaii is world-renowned for its lush vegetation and citizens and tourists actively seek out green spaces. Increasing the number of parks and green spaces in Honolulu's urban core will increase the quality of life of residents and visitors."

And we are very pleased that the bill transforms these broad goals into very specific and well-focused plans to make those goals actually happen. The bill requires projects to incorporate green infrastructure to achieve climate and sustainability design objectives. Those objectives include: (1) Minimizing stormwater runoff and [maximizing] replenishment of the water table; (2) Reducing the urban heat island effect by providing shade that reduces heat absorption over

hardened surfaces; (3) Providing cooler shaded transit for pedestrians, bicycle users, and micromobility users; and (4) Encouraging the removal, sequestration, and storage of pollutants and greenhouse gas emissions.

This is the proper way urban planning should move forward. For these reasons, we strongly support this bill. We would propose one amendment at this time: Insert "maximizing" before "replenishment of the water table" on page 3, line 10 of the bill, as shown in our quotation of this portion of the bill, above.

If this bill is enacted into law in its present form, or something close to it, and if it is implemented conscientiously and competently, it has the potential of transforming much of Hawaii's urban and suburban landscape in a truly beneficial way. We need this transformation. Full stop. Everyone will benefit, even the developers.

This bill would amend HRS Chapter 264, relating to highways. We note that this Committee will be considering today another bill that is very similar, HB 837, which would amend the Hawaii State Planning Act, which is HRS Chapter 226. Both of these bills have exceptional merit, and we would be very pleased to see both of them made into law.

On behalf of the Environmental Caucus, we urge you to PASS HB 1278 (as well as HB 837). We thank you very much in advance for your favorable consideration of this bill.

Dear Representatives,

The Outdoor Circle has advocated for beautiful and scenic roads and landscapes for over 110 years, and has backed up that advocacy with projects throughout the state that have resulted in many beautiful and treed roadways, parks, schools, military bases and much more.

We strongly agree on the need for HB 1278 to further our collective goals for all of the benefits listed in the bill preamble and rationale and others not listed but well-known.

We would offer a friendly amendment under (b) (5):

"Requiring the Department of Transportation and its contractors to adopt uniform best practices when planting, caring for, and maintaining trees and green infrastructure by following ANSI A300 standards for tree care practices."

ANSI A300 is a national standard for best tree care practices, but there are some instances where our unique environment may not be in all circumstances be comprehensively covered by ANSI A300 standards completely, so we would suggest a simple change of the last few words of this to read:

"by following ANSI A300 or similar best practice standards appropriate for Hawaii for tree care."

to allow for local expert arborist flexibility in incorporating best tree care practices.

We would also suggest that this type of green infrastructure legislation be further required of all state agencies, departments, jurisdictions and contractors for such.

The Office of Hawaiian Affairs (OHA) offers the following <u>COMMENTS</u> on HB1278, which would establish the Green Transportation Infrastructure Task Force to examine, evaluate, and develop policies for the design, implementation, and maintenance of green transportation infrastructure. OHA asks that the Legislature amend this measure to include OHA on this necessary task force.

OHA makes this request as the principal public agency in the State responsible for the performance, development, and coordination of programs and activities relating to Native Hawaiians,¹ who are disproportionately represented among having the worst health conditions in the State – conditions that the preamble of this measure identifies as a major impetus for the development of green infrastructure.

Nā Pou Kihi ("The Corner Posts") is a Hawaiian framework for achieving social and health equity² at a time of ever-worsening health inequities and disparities faced by the Native Hawaiian people.³ Native Hawaiians are afflicted with chronic disease at a rate three times higher and a decade earlier than the general population of Hawai'i.⁴ Native Hawaiians have the shortest life expectancy in their own homeland.⁵ The four interconnected corner posts of Nā Pou Kihi are Ke Ao 'Ōiwi (Indigenous Cultural Space), Ka Mālama 'Āina (Environmental Stewardship), Ka Wai Ola (Social Justice), and Ka 'Ai Pono (healthy consumption) – together, they support an interwoven protective canopy over a collection of ideals that give hope to a people in great need; ideals, like culturally relevant and natural – green – living environments.

Unfortunately, the fetid flow of historical injustice over the past 130 years has systemically severed Native Hawaiians from their 'āina (the natural world), their traditions, and their cultures. Accordingly, Native Hawaiians now endure some of the worst socioeconomic conditions among all peoples in this State, with ongoing inequities and disparities that continue to undermine Native Hawaiian existence. One of the most challenging social determinants of health for Native Hawaiians is interconnected with the health of the environment. The late Dr. Noa Emmett Aluli once observed, "the health of the land is the health of the people." Native Hawaiians, i ka wā kahiko (in the time long before), intimately understood the need to develop systems and practices – like mālama 'āina – that would ensure the survival of the people into perpetuity. It has become preeminently clear, over the long struggle to address the inequities and disparities associated with the disturbing status of Native Hawaiian health, that the greatest hope for recovery is through the dismantling of these tangled systems that have kept Native Hawaiians living within unsustainable conditions.

OHA appreciates the opportunity to support this measure with the recommended amendment to grant OHA a representative seat on the Green Transportation Infrastructure Task Force. Mahalo nui loa.
