In consideration of HOUSE BILL 1394, HOUSE DRAFT 1 RELATING TO THE DEPARTMENT OF LAND AND NATURAL RESOURCES

House Bill 1394, House Draft 1 proposes to appropriate funds to the Department of Land and Natural Resources (Department) Division of Forestry and Wildlife to manage hotspots at trailheads as part of the Nā Ala Hele Trail and Access Program (Program). The Department strongly supports this measure provided that its passage does not replace or adversely impact priorities indicated in the Department's Executive Budget request.

The Department acknowledges the Hawai'i Tourism Authority's Destination Management Action Plan initiative, which identified a series of destination "hotspots" across the State that are presenting management challenges to the agencies tasked with managing the hotspot areas. Program staff are currently actively engaged in a strategic planning effort to address the challenges associated with visitor use and have initiated programs and projects statewide to help mitigate the impacts of a rapid rise in outdoor recreation.

The funding proposed by this Act will allow the Department to put personnel and planning efforts in motion to address a number of these hotspots, including trailheads in the Koke'e region of Kaua'i, the Maunawili Falls and Ka'iwa Ridge trails on O'ahu, multiple areas on Maui, Naha Trail on Lāna'i, and Pololū Valley, Waipi'o Valley, and Maunakea on Hawai'i island. The six positions proposed will enable enhanced active management of the Division of Forestry and Wildlife's recreational inventory.

For many years, the Na Ala Hele program has struggled to manage our state's trail and access system with insufficient staffing and resources. It is a program that continues to grow both in terms of its geographic importance, but also in its cultural and recreational value to visitors and residents alike. For many, the experiences and opportunities offered by this program represent their "face of Hawaii."

Lack of support has placed a difficult burden on this important program, forcing it into a triagelike prioritization process to allocate its limited resources and hampering Na Ala Hele's ability to function at a programmatic level. One of the symptoms of Na Ala Hele's struggle is the hotspot issue referenced in this Bill. One of the consequences of Nā Ala Hele's insufficient staffing and resources is the hotspot problem that HB1394 HD1 seeks to address.
