#### HOUSE BILL 1397, HD1, SD1 RELATING TO SUPPORTIVE HOUSING

Chair Dela Cruz, Vice Chair Keith-Agaran, and members of the committee, thank you for the opportunity to submit testimony on House Bill 1397 HD1, SD1.

The State Procurement Office (SPO) supports the intent of the bill, however, objects to the procurement exemption for the selection of a qualified non-profit organization. While the SPO believes there is a compelling purpose for supportive housing, there is no compelling reason to grant exemptions from chapter 103D and 103F, Hawaii Revised Statutes (HRS). The SPO testifies that the selection of a qualified non-profit organization should be in accordance with chapters 103D and 103F HRS to ensure fair, open competition and to prevent favoritism, collusion, or fraud in awarding of contracts.

Exemptions to the Procurement Code mean that all procurements made with taxpayer monies will not have the same oversight, accountability and transparency requirements mandated by those procurements processes provided in the code. It means that there is no requirement for due diligence, proper planning, or consideration of protections for the state in contract terms and conditions, nor are there any set requirements to conduct cost and price analysis and market research or post-award contract management. As such, Agencies can choose whether to compete any procurement or go directly to one contractor. As a result, leveraging economies of scale and cost savings efficiencies found in the consistent application of the procurement integrity laws.

The SPO recommends the following changes below.

Page 5, SECTION 2, lines 11 to 17 set forth below.

"The Hawaii public housing authority shall <u>comply with</u> be exempt from chapter 103D, Hawaii Revised Statutes, in selecting a qualified nonprofit organization to administer the rent supplement payments and-may, without regard to chapter 91, Hawaii Revised Statutes, establish rules and qualification standards for participants of the supportive housing pilot program."

Page 6, lines 9 to 15 set forth below.

"The statewide office on homelessness and housing solutions shall <u>comply</u> <u>with</u> be exempt from chapters 103D and 103F, Hawaii Revised Statutes, in selecting a qualified nonprofit organization to administer the supportive services payments and may, without regard to chapter 91, Hawaii Revised Statutes, establish rules and qualification standards for participants of the supportive housing pilot program."

Relieving some public bodies from some laws by exempting or excluding them from compliance with a common set of legal requirements creates an imbalance wherein the competitive environment becomes different among the various jurisdictions and the entire procurement process becomes less efficient and costlier for the state and vendors.

**DEPARTMENT'S POSITION**: The Department of Human Services (DHS) supports this measure, suggests an extended effective date to facilitate planning, and defers to the Governor's Coordinator on Homelessness, the Hawaii Housing Finance and Development Corporation, the Hawaii Public Housing Authority, and the Department of Health. DHS respectfully requests that any appropriation in this measure not replace or adversely impact priorities identified in the executive budget and Governor's Messages.

**PURPOSE**: The purpose of the bill is to establish a supportive housing pilot program in the Statewide Office on Homelessness and Housing Solutions (SOHHS). The bill appropriates funds and establishes positions. Effective 7/1/2050. (SD1)

The HD1 amended the measure by:

(1) Clarifying that the \$500 monthly project-based rent supplemental payments to project owners are for units that are rented to eligible residents participating in the Supportive Housing Pilot program to assist the project owners maintaining rentals at levels affordable to eligible households with incomes at or below third percent of the area median income;

- (2) Clarifying that the SOHHS shall administer payments for supportive services under the Supportive Housing Pilot Program;
- (3) Changing the appropriations to unspecified amounts; and
- (4) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.

The SD1 further amended the measure by:

- Deleting language that would have capped project-based rent supplement payments at \$500 per month to grant HPHA more flexibility regarding the project-based rent supplement payments;
- (2) Including employment services as a supportive services to be provided to residents participating in the pilot program;
- (3) Clarifying that supportive services funding shall be not more than \$800 per unit per month;
- (4) Exempting the SOHHS from chapter 103F, HRS, in selecting a qualified nonprofit organization to administer supportive services payments under the pilot program;
- (5) Extending the deadlines for the joint interim report and joint final report to the Legislature of the findings and recommendations relating to the Supportive Housing Pilot Program by one year;
- (6) Inserting appropriation amounts of:
  - A. \$50,000.000 for supportive housing projects or supporting housing units in rental projects targeted for certain special needs individuals and families for the establishment of one full-time equivalent Permanent Housing Finance Specialist I position;
  - B. \$14,000,000 for contracts with new supportive housing rental projects or supportive housing rental units in rental projects for project-based rent supplement payments for the Pilot Program and for the establishment of fulltime equivalent Permanent Public Housing Specialist position;
  - C. \$10,500,000 for the provision of supportive services for qualified individuals and families in new supportive housing projects and the establishment of one full-time equivalent permanent position; and
  - D. \$500,000 for the development of a supportive housing information system.
- (7) Updating section 1 to reflect its amended purpose and further specifying the compelling and public purposes for granting certain exemptions from the State Procurement Code;
- (8) Inserting an effective date of July 1, 2050 to encourage further discussion; and
- (9) Making technical, nonsubstantive amendments for the purposes of clarity and consistency.

The Department agrees that there is a need for significant public financing of

supportive housing since the free market is not generating the essential inventory despite the

demand. While a one-time appropriation can support upfront housing construction, sustained

funding is needed to ensure continued rental subsidies and supportive services for clients served by the pilot program to maintain housing over time.

The bill proposes that supportive services funding for the pilot be matched with federal Medicaid funds. The Med-QUEST Division (MQD) is piloting the Community Integration Services (CIS) program, which provides pre-tenancy and tenancy supports to households experiencing or at risk of homelessness. However, participation in CIS is limited to households currently enrolled in a QUEST, and the CIS program cannot use Medicaid funds to pay for rent. If this measure proceeds, DHS will continue discussing with the SOHHS and other stakeholders how the CIS program could support households participating in the proposed supportive housing pilot.

In addition, as drafted, this measure intends to serve "individuals with special needs," a broader population than the State's Housing First program that serves "chronically homeless" individuals and families. The measure contemplates a supportive housing strategy that combines housing and supportive services for a wide range of households with acute needs and is not limited to those experiencing homelessness.

For example, supportive housing programs may serve survivors of domestic violence, individuals with intellectual or developmental disabilities, and older adults. However, CIS does not explicitly serve survivors of domestic violence, individuals with intellectual or developmental disabilities (I/DD), and older adults. Unfortunately, the presence of domestic violence alone would not qualify a person for CIS; however, if a survivor of domestic violence had medical or behavioral health needs and was eligible for Medicaid, they would qualify. DHS defers to the Department of Health's Developmental Disabilities Division for services available for the I/DD population. Regarding older adults, if older adults met the Level of Care for Activities of Daily Living, were at risk of institutionalization (e.g., Nursing facility), and are eligible for Medicaid, then yes, they would qualify for CIS.

DHS notes the difference between supportive housing, as described in this measure, and the Housing First program, the permanent supportive housing (PSH) program currently administered by the DHS Homeless Programs Office (HPO). The Housing First program specifically serves "chronically homeless" individuals and families as required by section 346-378, Hawaii Revised Statutes. The State's Housing First program is very successful, with a

retention rate of 94%, reflecting the percentage of participating chronically homeless individuals and families who remained in their permanent housing placement with the assistance of rental subsidies and supportive services.

Developing a broader supportive housing program to serve individuals with special needs will require additional recurring general funds and time to plan amongst agencies, communities, and stakeholders; therefore, DHS respectfully suggests an extended effective date.

Aloha Chair Dela Cruz, Vice Chair Keith-Agaran and Committee Members,

I am writing in support of HB1397 HD1 and to offer comments.

This bill is aligned with the Governor's priorities on homelessness, which include an emphasis on supportive housing to reduce unsheltered homelessness.

The program proposed by this bill would provide an important complement to existing permanent supportive housing programs that reduce homelessness, such as the Housing First program, which is focused on "chronically homeless" individuals, i.e., individuals who have a diagnosed physical disability, mental illness, or addiction <u>and</u> who are verified as having been "homeless continuously for at least twelve months or, homeless on at least four separate occasions in the last three years..." (HRS §346-378). Many individuals experiencing homelessness may not meet the definition of "chronically homeless." Others meet the definition, but cannot obtain or retain the necessary documentation, such as verification of their diagnosis or the duration of their "chronicity" needed to qualify. In addition, anyone who is homeless, but enters a hospital, treatment program, or jail for ninety days or more no longer qualifies as "chronically homeless," even if they still have no housing upon discharge and are therefore returned to the street. Supportive housing not limited to "chronically homeless" individuals, as proposed in this bill, can help fill these gaps.

I applaud the targeting of households at or below thirty per cent of area median income, as those experiencing homelessness typically fall within this income range.

With regard to Section 2.(c) and the development of supportive housing projects, I defer to the Hawaii Housing Finance & Development Corporation on Section 2.(c). I also defer to the Hawaii Public Housing Authority Section 2.(d) and the creation of a project-based rent supplement program, and to the Department of Human Services regarding the use of Medicaid funds to match state funds for supportive services as described in Section 2.(e).

Members are residents from diverse backgrounds representing mental health service providers and recipients, students and youth, parents, and family members. Members include representatives of state agencies on mental health, criminal justice, housing, Medicaid, social services, vocational rehabilitation, and education. Members include representatives from the Hawaii advisory commission on drug abuse and controlled substances and county service area boards on mental health and substance abuse.

Catholic Charities Hawai`i (CCH) is a tax exempt, non-profit agency that has been providing social services in Hawai`i for over 75 years. CCH has programs serving elders, children, families, people experiencing homelessness, and immigrants. Our mission is to provide services and advocacy for the most vulnerable in Hawai`i. Catholic Charities Hawai'i has a long history of working in the areas of affordable housing and homelessness.

This is a key bill for planning future housing and services to vulnerable populations in our state. Supportive housing is a growing need not only to address homelessness but also for the growing number of elders, developmentally disabled and other people who need housing and coordinated services. The lack of a supportive housing system not only impacts on the ability of these individuals to live independently and positively in the community, but it can result in costly institutional care and other high public costs. The 2018 report that evaluated Honolulu's Housing First program (Pathways Project) found that health care costs decreased by 76%, resulting in a cost savings of \$4,247/per person/per MONTH. Incarceration costs showed a decrease of 40%-60%. Stable housing with regular services enables more preventative and ongoing care which can shift medical needs from the ER to regular out-patient settings.

We strongly support the amendments included SD1 which provide greater flexibility for

**this pilot program**. Creating a new, comprehensive system to meet these growing needs requires this flexibility to adequately address the wide range of incomes and needs. This comprehensive bill includes the 3 key elements for success: rental subsidies, services and construction funds for affordable rentals. This bill provides an even greater opportunity for success by establishing the Supportive Housing Pilot Program within the Statewide Office on Homelessness and Housing Solutions (SOHHS). The SOHHS can provide the collaboration and oversight to take this big step forward! By coordinating with state, county and community agencies, as well as developers, the SOHHS would have the tools needed to build successful supportive housing models. Developing successful models through this pilot program will benefit not only houseless individuals but other vulnerable populations who need these types of affordable housing with ongoing services.

The price may seem big, but our emergency rooms, hospitals, jails, prisons, and our streets are overwhelmed. By working to end homelessness, great savings can be achieved. Please contact our Legislative Liaison, Betty Lou Larson at (808) 527-4813 if you have any questions.



#### Hawaii Substance Abuse Coalition Supports SB1397 HD1:

ALOHA CHAIR, VICE CHAIR AND DISTINGUISHED COMMITTEE MEMBERS. My name is Alan Johnson. I am the current chair of the Hawaii Substance Abuse Coalition (HSAC), a statewide organization for substance use disorder and co-occurring mental health disorder treatment and prevention agencies and recovery services.

Connection, support, sobriety, employment, and quality of life—these are all significant outcomes for people in <u>recovery</u>.

Supportive Housing (SH) is community-based housing targeted to low-income households with that combines housing with case management and wrap around care.



The Hawai'i Supportive Housing Work Group was formed by the Hawaii Interagency for

Homelessness through funding by the 2022 Hawaii State Legislature to establish a broad stakeholder group that could benefit from supportive housing, by pairing a housing unit with a rental subsidy and supportive services that fit the residents' needs.

- This combination enables housing stability for community members with higher needs who may not be able to stay housed with a housing unit alone.
- Local and national studies demonstrate the benefits of supportive housing on individual residents, our public systems, and our entire community.

SH is not formal treatment but has elements similar to treatment in that they involve peer support and other addiction recovery aids.<sup>1</sup> It's important to have various housing options for people because recovery is unique to each person.

- 1. Choice Making informed, healthy choices that support physical and emotional wellbeing.
- 2. Home–A stable and safe place to live.
- 3. Purpose–Meaningful daily activities, such as a job, school, volunteerism, family caretaking, or creative endeavors, and the independence, income and resources to participate in society.
- 4. Community–Relationships and social networks that provide support, friendship, love, and hope.

Supportive Housing (SH) helps to develop and provide housing and related supportive services for higher needs people moving from homelessness to independent, supportive living.<sup>3</sup> Program funds help homeless people live in a stable place, increase their skills and their income, and gain more control over the decisions that affect their lives.

Services include housing subsidies, transitional housing, outreach, case management, childcare, social skills development, job training/placement, health care, and transportation. Medicaid or Supplemental Security Income (SSI) can help with funding. Supportive housing combines non-time-limited affordable housing assistance with wrap-around supportive services for people experiencing homelessness, as well as other people with disabilities including substance use disorders and mental health disorders.

Study after study has shown that supportive housing not only resolves homelessness and increases housing stability, but also improves health and lowers public costs by reducing the use of publicly-funded crisis services, including shelters, hospitals, psychiatric centers, jails, and prisons.

- The SH model has been demonstrated to permanently keep the majority of persons who enter the program from ever becoming homeless again.
- A primary goal is to address those significant challenges to help people avoid future episodes of homelessness.
- It's a higher level than a shelter that often limits the hours when a person can be onsite resulting in homeless individuals wandering through the neighborhood during the day.

#### **Core Components**

Supportive housing links decent, safe, affordable, community-based housing with flexible, support services designed to help the individual stay housed and live a more productive life in the community. There is no single model for supportive housing's design.

There are three approaches to operating and providing supportive housing:<sup>4</sup>

- 1. **Purpose-built or single-site housing**: Apartment buildings designed to primarily serve tenants with the support services typically available on site.
- 2. **Scattered-site housing**: People lease apartments in private market or general affordable housing apartment buildings using rental subsidies. They can receive services from staff who can visit them in their homes as well as provide services in other settings.
- 3. Unit set-asides: Affordable housing owners agree to lease a designated number or set of apartments to tenants who have exited homelessness or who have service needs, and partner with supportive services providers to offer assistance to tenants.

Pacific Housing Assistance Corporation is a Hawaii nonprofit organization that works to develop and operate affordable housing for very low to moderate income families, seniors, and persons with special needs. We have partnered with nonprofit service providers over our 43-year history to construct, acquire, or renovate 31 projects, providing 338 affordable permanent supportive housing units for very low-income persons with physical, intellectual, developmental, and severe mental disabilities and other special needs groups. It has been our experience that developing and operating permanent supportive housing, especially for those earning 30% of AMI and below, is extremely difficult to achieve without government subsidy and support.

We strongly <u>support</u> HB1397 HD1 SD1 as it not only provides targeted development funds but delivers long term rental assistance and supportive service funding that are even harder to locate and secure. HB1397 HD1 SD1 will enable the creation of a variety of permanent housing solutions for a diverse and historically underserved population. There may be a shovel-ready supportive housing project or two in our community that is currently in the development process. These are the extremely rare projects that were able to cobble together scarce resources presently available in our community. The value of HB1397 is that it will create a new pipeline of supportive housing projects that did not exist at this time. HB1397 is critical in producing, facilitating, and expediting the creation of sorely needed affordable housing for our wide and diverse special need population.



#### POSITION: STRONG SUPPORT

**HB1397 HD1** is a pilot program that has the potential to create more accessible housing, increase their quality of life, and encourage independence. Currently, there are barriers to housing that must be addressed. Many individuals experiencing homelessness may not meet the definition of "chronically homeless". Another issue is that qualified individual(s) cannot obtain or retain the necessary documentation for verification of their diagnosis or the duration to meet the standard of "chronic".

Furthermore, quoting the Governor's Coordinator Homeless James Koshiba shows how individuals can fall through the cracks because of the failure of policy or lack thereof. Mr. Koshiba states:

"[A]nyone who is homeless, but enters a hospital, treatment program, or jail for ninety days or more no longer qualifies as "chronically homeless," even if they still have no housing upon discharge and are therefore, returned to the street."

There needs to be continuity in the intent of policy so that the continuum of care system is more effective. I believe that increasing the supply and maintaining supportive housing opportunities for individuals. In addition, the issue of homelessness can be even more daunting for Individuals transitioning from incarceration. Those individuals may face additional barriers to securing appropriate affordable housing.

Addressing this issue is not just an emotional argument, taking a cost-benefit analysis approach to these issues, studies conducted on homelessness suggest that services that with supportive housing measures in place addressing one of the largest social determinants of health the State of Hawaii may realize cost savings of \$4,200 a month. These savings are realized mainly through supportive housing and greater utilization of outpatient care rather than Emergency room care and resources. Adjusted for inflation according to the US Bureau of Labor and Statistics CPI (Consumer Price Index) calculator \$4,200.00 in 2018 when the study was conducted translates in 2023 to \$5,097.60 cost savings per month.

Therefore, the conclusion based on the data, a movement toward legislative policies that will increase supportive housing efforts such as the passage of HB1397 HD1 is fiscally responsible. This may also have the added benefit of the need and creation of more housing through additional federal resources. The need for housing is in long-term rental housing, that can special consideration be given to accessibility issues for people with mobility and communication disabilities.

My name is Linda Dorset, a resident of Wailuku, Maui. I thank you for the opportunity to submit written testimony regarding the above referenced legislation. I strongly support HB1397 which extends the period for a notice of termination of the rental agreement from five business days to ten calendar days; requires landlords to engage in mediation; and creates an emergency rent relief program.

Hawai'i already established these programs in the beginning of the COVID-19 pandemic in early 2020, and they have kept tens of thousands of families stably housed during the pandemic. HB1439 will help build a bridge towards more permanent rental assistance and mediations programs in the future.

Evictions are harmful to the landlords who rely on rent payments and are especially harmful to the individual or family losing their home. The cost of eviction includes: interrupted employment and school, loss of wages, negative health impacts, and impaired legal records which make it harder to find future housing.

Hawai'i's estimated 2,500 annual evictions led to over \$30 million in public costs such as: the need for emergency shelters, in-patient care emergency room at hospitals, and foster care and juvenile detention. According to research by Hawai'i Appleseed Center for Law and Economic Justice, for every tax dollar spent on rental assistance and landlord-tenant mediation programs, the public saves six dollars on homeless services.

**Please PASS HB1439 to help prevent evictions and keep our island residents housed.**

#### Testimony in support of H.B. 1397, H.D. 1, S.D. 1, Relating to Supported Housing

Thank you for this opportunity to provide testimony on H.B. 1397, H.D. 1, S.D. 1. My name is Sandra Oshiro and I coordinate the Hawaii Young Adults in Transition, a support group for individuals on the autism spectrum and their families.

I am submitting written testimony in support of H.B. 1397, H.D. 1, S.D. 1, which creates a pilot program to support and serve populations who are homeless or in danger of homelessness in the state. Among them are those with intellectual or developmental disabilities, including individuals with autism spectrum disorder. ASD is a growing health issue. The U.S. Centers for Disease Control and Prevention estimates that it now affects 1 in every 36 children.

ASD is a lifelong disability. Many adults on the spectrum have difficulty finding employment as well as housing because of intellectual, communication, and mental health challenges. Without the support of family members, including parents who are now aging and will soon be unable to care for them, individuals with ASD can find themselves living on the streets.

For a good part of 2022, a broad-based work group brought together by House Majority Leader Nadine Nakamura and representing advocates for the homeless, veterans, those with substance dependencies, and a host of other underserved populations met regularly to come up with supported housing recommendations for the Legislature's consideration. H.B. 1397, H.D. 1, S.D. 1 reflects many of these recommendations.

Supported housing has been shown to effectively shelter vulnerable individuals while helping them address physical, mental, and other challenges that can otherwise result in a continuing cycle of homelessness.

Hawaii's housing crisis has defied government effort, with those at or below 30 percent of the area median income particularly underserved. This measure's comprehensive approach, including project-based rent supplements, significant rental housing revolving funds, resources for support services, and needed data collection, represents a major step in addressing what Gov. Josh Green has rightly declared a housing emergency.

As others have testified to previously, we ask that the committee closely consider the need for broad exemptions as called for in the bill from Chapter 91, Hawaii Revised Statutes. Transparency and public access are key to government trust, so a balancing of interests is necessary in addressing our housing crisis.

With passage of bills like H.B. 1397, H.D. 1, S.D.1 we can make measurable progress in ensuring there is affordable, equitable housing for those who are most in need. We look forward to your support.
