### **1 Fiscal Implications:** N/A.

- 2 **Department Testimony:** The Department of Health (DOH) discharges a ministerial role
- 3 regarding vital records, which is to officially record and preserve certain major life events. The
- 4 department does not usually make determinations of factual accuracy for vital records, rather
- 5 accepting prima facie common life events like births, adoptions, deaths, and marriages that are
- 6 submitted from trusted sources.
- 7 The department is currently authorized to amend birth certificates for persons who have had
- 8 appropriate treatment for gender transition as affirmed by a United States licensed physician or
- 9 physician assistant, pursuant to <u>section 338-17.7(a)(4)</u>, <u>Hawaii Revised Statutes</u>.
- 10 DOH offers the following comments and observations on implementing HB485 HD2:

### 11 Sex vs Gender

- 12 The vital records program authorized by the US Centers for Disease and Prevention only
- 13 document "sex," as defined by a serios of biological markers such as chromosomes, gametes,
- 14 and reproductive organs, etc. "Gender" is a cultural construct governing social expectations of
- 15 the sexes that vary with time, place, historically and geographically.

### 1 <u>Birth Certificates</u>

Although out of scope for the title of HB485 HD3, incongruent information on the birth
certificate and marriage certificate will be a complication. A future measure may address
amending circumstances under which the sex of the registrant is amended beyond what is
currently authorized in statute.

### 6 <u>Civil Unions</u>

- 7 Although out of scope for the title of HB485 HD3, individuals and couples under civil unions
- 8 should have equal opportunities to amend a marriage certificate for these same purposes.

### 9 <u>Effective Dates</u>

- 10 The department recommends an effective date of January 1, 2024, to accommodate amendments
- 11 to marriages prior to 1991. In addition to the creation of blank templates that are tamper-proof
- 12 and counterfeit-resistant, declared middles names were not an option prior to 1991 and time is
- 13 required to determine how to accommodate.
- 14 The Department of Health looks forward to assisting the Legislature to develop appropriate 15 procedures and criteria for the purposes of this measure.

# Re: H.B. No. 485, H.D.3, S.D.1

The Hawai'i Civil Rights Commission (HCRC) has enforcement jurisdiction over Hawai'i's laws prohibiting discrimination in employment, housing, public accommodations, and access to state and state-funded services. The HCRC carries out the Hawai'i constitutional mandate that no person shall be discriminated against in the exercise of their civil rights.

The HCRC supports H.B. No. 485, H.D.3, S.D.1 which provides for the replacement of marriage certificates for individuals who have changed their gender, sex, and, if applicable, name.

The Legislature previously passed H.B. No. 1165 in 2019, enacted as Act 142, expanding gender options on government identification. Recent awareness of the discrimination and other issues faced by transgender and non-binary individuals has provoked greater consciousness of the difficulties with official documents that can arise. This bill would allow transgender individuals who are married to correct their marriage certificates to accurately reflect their gender identity, filling a gap not yet addressed. This bill will advance fair treatment and address discrimination faced by the transgender community, allowing much needed legal documents to align with an applicant's gender identity.

Recognizing the importance of fair treatment and inclusiveness, the HCRC supports H.B. No. 485, H.D.3., S.D.1

Aloha Chair Rhoads, Vice Chair Gabbard and Committee Members:

The ACLU of Hawai'i strongly supports **H.B. 485**, **H.D. 3**, **S.D. 1** Relating to Marriage that requires the Department of Health to provide for the replacement of certificates of marriage for individuals who have changed their gender, sex, and, if applicable, name.

The ACLU of Hawai'i has a long history of supporting the civil rights of transgender people, recognizing the pervasiveness of gender identity discrimination within employment, housing, public accommodations, education and credit. Transgender people are also subjected to high rates of violence.

Currently, Hawai'i has laws that provide a process for the transgender community to update their birth certificate, driver's license and other documents to reflect their gender identity. *However, there is no legal process for an individual to update their marriage certificate to reflect their gender identity and if applicable, name*. Forcing anyone to carry documents that contradict their identity is unjust and unconstitutional, and further marks transgender people for further mistreatment and discrimination.

The passage of **H.B. 485, H.D. 3, S.D. 1** would address this glaring gap in our current laws, and ultimately promote gender equity and justice.

Dear Committee Members,

I write on behalf of the North Shore Koʻolau Diversity Collective in STRONG SUPPORT for HB485 HD3, which would help ensure that people have a navigable process by which they can update Hawaiʻi marriage certificates to correct basic information which may have changed after their current certificate was issued.

Marriage certificates can be very important documents, and when the information on a marriage certificate such as name or gender/gender marker do not align with someone's other or more-current documentation, people can have serious difficulty completing certain tasks which require a copy of a marriage certificate. Or perhaps worse, if an outdated marriage certificate is provided that contains a clearly misaligned name or gender, it can serve to 'out' an individual or couple who has perhaps gone through transition, and that outing can result in serious discrimination and wrongful denial of benefits.

It is vital that a simple process exist that allows people to make essential updates to their marriage certificate, and I strongly support this measure. Thank you for hearing this measure which will surely make a big difference in the lives of married people in Hawaii!

The North Shore Ko'olau Diversity Collective is a relatively new and growing grassroots effort working to ensure that our rural O'ahu communities are welcoming, inclusive, and supportive of māhū and LGBTQ+ individuals and families, and proactive in challenging bigotry, disrespect, discrimination.

Twenty-four years ago I was lucky to meet the love of my life while in college, and in 2018 we finally married here in Hawai'i. In 2020, my spouse decided to begin the process of transitioning to their new gender identity and legal name change. Marriage Certificates are vital for handling affairs, legal and financial concerns, or for traveling internationally. Some examples of use:

- Sharing health or other insurance benefits
- Applying for a loan or mortgage
- Filing Taxes
- Arranging property succession to a spouse
- Giving tax-free gifts to a spouse
- Custody changes

My spouse and I married on May 1, 2018, here in Hawai'i. In 2020 I began my transition, completing my legal name and gender change in 2021. The process involved updating many documents, after legally changing my name:

- My Hawai'i driver's license
- Passport
- Social Security record and card
- my employer file
- all of my bank and credit accounts
- University undergraduate and graduate record of degrees
- Various Insurance Coverages, etc.
- Medical records

The only government identity record I was not able to update was our Marriage Certificate.

Being able to update a Marriage Certificate with correct name and gender is essential in preventing transgender individuals from being outed when presenting the certificate for the many reasons listed above. When a transgender individual or couple are outed, they risk harassment and discrimination. The appearance of an individual's old name and gender marker is an injustice due to the social stigma and discrimination that transgender people face.

This injustice can be remedied effectively by issuing a corrected marriage certificate listing current legal name and gender. For this reason, I would like to ask you all to support this legislation.

As a future social worker, mental health professional, and member and ally of the LGBTQ+ community, I am in support of this measure. HB 485 will allow individuals to change their gender and/or name on their marriage certificate to represent their identity.

While creating this simple process may not seem like a big deal to cisgendered people, it will make a great difference to transgender folks. Marriage certificates are very important documents that are necessary to use while handling legal and financial matters in terms of sharing health or insurance benefits, applying for loans and mortgages, filing taxes, arraigning retirement benefits, custody changes, etc. If one's name/gender on their marriage certificate does not align with their more current documentation, it may cause great problems such as an inability to complete some of the aforementioned tasks or allow for someone to be "outed" as an individual who has gone through transition, which may result in discrimination due to the person's LGBTQ+ identity and denial of benefits. As a social worker in training, I can testify to severe impacts on mental health that we see from outing and discrimination of LGBTQ+ people.
