#### Testimony COMMENTING on HB485 RELATING TO MARRIAGE.

REP. DELLA BELATTI, CHAIR HOUSE COMMITTEE ON HEALTH & HOMELESSNESS

1 **Fiscal Implications:** Unspecified expense to update vital records systems.

2 Department Testimony: The Department of Health (DOH) discharges a ministerial role with

3 regard to vital records, which is to officially record and preserve certain major life events. The

4 department does not usually make determinations of factual accuracy for vital records, rather

5 accepting prima facie common life events like births, adoptions, deaths, and marriages that are

6 submitted from trusted sources.

7 The department is currently authorized to amend birth certificates for persons who have had

8 appropriate clinical treatment for gender transition as affirmed by a United States licensed

9 physician or physician assistant, pursuant to section 338-17.7(a)(4), Hawaii Revised Statutes.

10 Doh offers the following comments and observations:

11 Sex vs Gender

12 HB485 appears to use "sex" and "gender" interchangeably. Sex, as recognized by the National

13 Center for Health Statistics, is defined by a series of biological markers: chromosomes, gametes,

14 reproductive organs, etc. Gender is a cultural construct governing social expectations of the

sexes that vary with time, place, historically and geographically. For purposes of this measure,

16 neither term should be used.

The current Hawaii marriage certificate identifies "groom" and "bride," denoting a male and female, respectively. HB485 may consider neutral terms, such as "Spouse #1" or "Partner #2," which is likely to achieve the desired effect with the least administrative burden and maximum flexibility. Note that this would require adjustments to information management systems for which there may be costs. Further research is required to determine the authority of DOH to substitute neutral terms for terms that are sex- or gender-affiliated.

#### 7 <u>Issuance vs. Amendment</u>

The department continues to research the relative value of "issuing" a new record, as proposed in HB485, and "amending" an existing marriage certificate. Issuing a new marriage certificate that shall not be marked as amended, closely but not exactly follows the process for amending the sex identifier on a Hawaii birth certificate pursuant to section 338-17(2)(4), HRS. Amending a birth certificate generally commands a higher level of documentary evidence, so further analysis is required to recommend either issuance or amendment for marriage certificates.

Due to this other and procedural considerations, DOH suggests amending chapter 338, HRS,
instead of chapter 572, HRS.

The Department of Health looks forward to assisting the Legislature to develop appropriate
 procedures and criteria for the purposes of this measure.

#### **19 Offered Amendments:**

20 SECTION 1. The legislature finds that according to a 21 2016 report by the Williams Institute on Sexual 22 Orientation and Gender Identity Law and Public Policy, 23 Hawaii has the highest percentage of transgender-24 identifying individuals in the United States. The 25 legislature notes that, in general, transgenderidentifying individuals experience high levels of
discrimination in all aspects of the individual's
life. The legislature also notes that Hawaii has been at
the forefront of implementing policies to protect
transgender people and believes that Hawaii should
continue to take proactive measures.

The legislature further finds that according to a 7 2013 report by the University of Hawaii, gender-8 stereotypical polices and norms continue to stigmatize 9 and exclude transgender people in the 10 State. Additionally, according to the 2018 sexual and 11 gender minority health report by the department of 12 health, the stigmatized minority status of transgender 13 individuals is causing negative and disproportionate 14 health outcomes, fewer economic opportunities, and less 15 sociopolitical power. 16

The legislature recognizes that Act 148, Session 17 Laws of Hawaii 2019, expanded gender options applicable 18 to Hawaii driver's licenses and state identification 19 cards, thus enabling transgender and gender-nonconforming 20 individuals to avoid invasive questioning and 21 discriminatory treatment. Accordingly, as of July 1, 22 2020, any person may specify gender designations as "F", 23 "M", or "X" on a Hawaii driver's license or state 24 identification card. However, under current law, a 25

transgender-identifying individual is [unable to change] 1 limited in changing their gender designation on a 2 marriage certificate. Name changes are permitted only 3 within a four-week period after the marriage or through a 4 court order. This makes it [virtually impossible] 5 difficult and expensive for a transgender-identifying 6 individual to update their marriage certificate to 7 reflect their identity, causing confusion and stress when 8 asked to produce this documentation. 9 Accordingly, the purpose of this Act is to require 10 the department of health to issue new marriage 11 certificates to reflect changes in both name and gender 12 upon receipt of the required supporting documentation. 13 SECTION 2. Chapter [572, 338, Hawaii Revised 14 Statutes, is amended by adding a new section to part I to 15 be appropriately designated and to read as follows: 16 [<del>"§572-</del>] "§338-17 New certificates of 17 marriage; issuance; gender and sex identifiers. (a) 18 The department of health shall permit any person who 19 possesses a valid certificate of marriage that has been 20 21 filed with the department and that includes gender and sex identifiers for the person that differ from the 22 person's changed gender and sex identifiers and, if 23 applicable, a changed name, to apply for a new 24

1	certificate of marriage; provided that the department
2	shall require the applicant to submit the following:
3	(1) An application for a new marriage license to reflect the applicant's change:
4	(A) To the designation of the person as
5	"bride", "groom", or "spouse"; and
6	(B) If applicable, of name;
7	(2) A copy of one of the following documents:
8	(A) The applicant's new certificate of birth
9	reflecting the applicant's change of gender
10	and sex identifier;
11	(B) A government-issued identification
12	document reflecting the applicant's change
13	of gender and sex identifier, including any
14	change of gender accomplished by an order of
15	any court of any state or territory of the
16	United States, the District of Columbia, or
17	any foreign court; or
18	(C) An affidavit attesting, under penalty of
19	perjury, that the request for a change of
20	the designation of the applicant as "bride",
21	"groom", or "spouse" is to conform to the
22	applicant's gender identity and is not made
23	for any fraudulent purpose;

1	(3) If the applicant desires that the new certificate of marriage reflect a different
2	name for the applicant than what is reflected on the original certificate of marriage, a
3 4	<u>certified copy of the applicant's change of name order, obtained under section</u> 574(5(a)(1) or (5), including a certified English translation, if applicable; and
т	<u>or (o(a)(1) or (o)</u> , more and a continued English datisfication, in approaction, and
5	(4) A notarized letter from the non-applicant spouse consenting to the changes to
6	be made to the original certificate of marriage; provided that the notarized letter shall
7	substantially contain the following language:
8	
9	"I, (non-applicant spouse's full name), stipulate to an issuance of a new
10	marriage certificate for myself that reflects my spouse's legal gender, sex, and, if
11	applicable, name."

13	(b) Each new certificate of marriage issued
14	pursuant to this section shall:
15	(1) <u>Reflect the applicant's changed:</u>
16	(A) Designation as "bride", "groom", or
17	"spouse"; and

14	(f) The department of health shall issue a new
15	certificate of marriage to any applicant who has
16	satisfied the requirements of this section regardless of
17	the date of the applicable marriage."
18	SECTION 3. Section 572-13, Hawaii Revised Statutes,
19	is amended by amending subsection (c) to read as follows:
20	"(c) Certified copies of certificate of
21	marriage. The department of health shall deliver one
22	certified copy of the certificate of marriage or the
23	contents or any part thereof as provided in section 338-
24	13 to the persons married. [ <del>The certificate shall be</del>
25	<del>prima facie evidence of the fact of marriage in any</del>
26	<del>proceeding in any court.</del> ]

[The] Upon request, the department of health shall 1 2 [upon request,] furnish to any applicant additional certified copies of the certificate of marriage or any 3 part thereof. 4 [Copies] Except for any certificate of marriage 5 6 replaced, sealed, and filed pursuant to section [<del>572- ,</del>] 338-17 copies of the contents of any 7 certificate on file [in the department,] with, 8 and certified by, the department shall be considered the 9 same as the original for all purposes [the same as the 10 11 original]. The department may prescribe reasonable fees, if 12 any, to be paid for certified copies of certificates." 13 SECTION 4. Statutory material to be repealed is 14 bracketed and stricken. New statutory material is 15 underscored. 16 SECTION 5. This Act shall take effect upon its 17 18 approval.

# <u>Re: H.B. No. 485</u>

The Hawai'i Civil Rights Commission (HCRC) has enforcement jurisdiction over Hawai'i's laws prohibiting discrimination in employment, housing, public accommodations, and access to state and state-funded services. The HCRC carries out the Hawai'i constitutional mandate that no person shall be discriminated against in the exercise of their civil rights.

The HCRC supports H.B. No. 485, which provides for the replacement of marriage certificates for individuals who have changed their gender, sex, and, if applicable, name.

The Legislature previously passed H.B. No 1165 in 2019, enacted as Act 142, expanding gender options on government identification. Recent awareness of the discrimination and other issues faced by transgender and non-binary individuals has provoked greater consciousness of the difficulties with official documents that can arise. This bill would allow transgender individuals who are married to correct their marriage certificates to accurately reflect their gender identity. This bill will advance fair treatment and address discrimination faced by the transgender community.

Recognizing the importance of fair treatment and inclusiveness, the HCRC supports H.B. No. 485.

The need for all vital records documents to be updateable for name and gender changes is vital for fairness to myself and other couples seeking to have their legal marriage certificates reflect their current legal names and genders. Marriage Certificates are vital for handling affairs, legal and financial concerns, or for traveling internationally. Some examples of use:

- Sharing health or other insurance benefits
- Applying for a loan or mortgage
- Filing Taxes

- Giving tax-free gifts to a spouse
- Custody changes

My spouse and I married on May 1, 2018, here in Hawai'i. In 2020 I began my transition, completing my legal name and gender change in 2021. The process involved updating many documents, after legally changing my name:

- My Hawai'i driver's license
- Passport
- Social Security record and card
- my employer file
- all of my bank and credit accounts
- University undergraduate and graduate record of degrees
- Various Insurance Coverages, etc.
- Medical records

The only government identity record I was not able to update was our Marriage Certificate.

Being able to update a Marriage Certificate with correct name and gender is essential in preventing transgender individuals from being outed when presenting the certificate for the many reasons listed above. When a transgender individual or couple are outed, they risk harassment and discrimination. The appearance of an individual's old name and gender marker is an injustice due to the social stigma and discrimination that transgender people face.

This injustice can be remedied effectively by issuing a corrected marriage certificate listing current legal name and gender. For this reason, I would like to ask you all to support this legislation.

As a concerned citizen and public health professional, I strongly support HB 485 which would allow individuals to change their gender and/or name on their marriage certificate to represent their identity. Hawai'i has established laws and policies that allow for people of all genders to get their birth certificate, driver's license and other documents updated, but marriage certificates are not currently included.
