#### RELATING TO EDUCATION

The Department of Budget and Finance (B&F) offers comments on this bill.

House Bill (H.B.) No. 875, H.D. 1: 1) establishes the Hawai'i Teacher

Apprenticeship Program (HTAP) to be administered by the Department of Education

(DOE) to support, recruit, develop, and retain teachers in the DOE's schools;

2) establishes the HTAP Special Fund (HTAPSF) into which funds shall be deposited, including funds appropriated by the Legislature and all moneys received as repayment from individuals due to a breach in contractual agreements under the HTAP established under Section 302A-A; 3) appropriates an undetermined amount of general funds for FY 24 and FY 25 for deposit into the HTAPSF; and 4) appropriates an undetermined amount of special funds for FY 24 and FY 25 to establish and support the HTAP.

As a matter of general policy, B&F does not support the creation of any special fund which does not meet the requirements of Section 37-52.3, HRS. Special funds should: 1) serve a need as demonstrated by the purpose, scope of work and an explanation why the program cannot be implemented successfully under the general

fund appropriation process; 2) reflect a clear nexus between the benefits sought and charges made upon the users or beneficiaries or a clear link between the program and the sources of revenue; 3) provide an appropriate means of financing for the program or activity; and 4) demonstrate the capacity to be financially self-sustaining. Regarding H.B. No. 875, H.D. 1, it is difficult to determine whether the proposed special fund would be self-sustaining.

# Department's Position:

The Hawaii State Department of Education (Department) provides testimony in support of HB 875, HD 1, and the creation of a teacher apprenticeship program.

The ongoing shortage of teachers both locally and nationally has made it challenging to accomplish the objective of having qualified teachers in every classroom. To address this challenge, the Department has utilized a variety of recruitment strategies and continues to actively explore other incentives and new pathways into the teaching profession.

In 2018, the Department and our partners from the University of Hawaii, Leeward Community College, and INPEACE, a non-profit organization supporting native pacific education, initiated a pilot program within the Nanakuli-Waianae complex area to help educational assistants in their journey toward earning college degrees and becoming special education teachers. While not expressly described as a teacher apprenticeship, the pilot program closely aligns with the goals outlined in HB 875, HD 1.

The Department appreciates the support of this measure in helping to achieve the

recently adopted Board of Education Strategic Plan's desired outcome of filling all teacher positions with qualified hires.



Chair Yamashita and Members of the Committee:

The Hawai'i State Teachers Association <u>supports HB 875, HD1</u>, relating to education. The bill establishes and appropriates funds for the Hawai'i teacher apprenticeship program to support, recruit, develop, and retain teachers for schools in Hawai'i.

Our public schools in Hawai'i have been struggling for years with a severe shortage of qualified teachers. During the 2018-2019 school year, there were more than 1,000 emergency hires due to this shortage. Add to this the number of teachers who either leave the profession every year, or relocate to the continent to find work in places where the cost of living is not so high. This has resulted in far few local teachers in classrooms who reflect the socioecomonic, racial, ethnic, and cultural diversity of our students.

An apprectinceship, like the one envisioned in this bill, would help the State take a step toward addressing this serious teacher shortage. This bill has the potential to help increase local teacher recruitment and retention by providing assistance in licensing and gaining in-classroom experience. It could also provide better mentoring experiences and financial support for students working to become qualified licensed teachers here in Hawaii.

We believe it a teacher apprenticeship program could be an essential tool for recruiting, supporting, and retaining high-quality local teachers. Passing this bill will also allow our state to draw down federal funds to assist with the Teacher Apprenticeship program.

To take care of the needs of our public schools in Hawai'i, and our students, the Hawaii State Teachers Association asks your committee to **support** this bill.

#### HB875 HDI - RELATING TO EDUCATION

Chair Yamashita, Vice Chair Kitagawa, and Members of the Committee:

Thank you for the opportunity to provide testimony in support of HB875 HD1 relating to the creation of a teacher apprenticeship program.

Hawai'i P-20 Partnerships for Education (Hawai'i P-20) supports HB875 HD1.

Hawai'i's public schools have continued to face a severe shortage of qualified teachers. This bill would create an apprenticeship program that would increase recruitment and retention of local teachers by providing financial support for postsecondary education, as well as support for licensing and in-classroom experience. If passed, HB875 HD1 would complement ongoing efforts across the State to strengthen the teacher workforce pipeline.

Hawai'i P-20 works with education partners across the State to strengthen the education pipeline from early childhood through postsecondary education and training. We collaborate with our partners to create seamless pathways along the pipeline in order to better prepare our students to meet current and future workforce needs.

Hawai'i P-20 is committed to strengthening the teacher workforce pipeline. We are dedicating resources to begin a pilot program for neighbor-island high school students who want to pursue a teaching career in Hawai'i. Although we have a lot to learn about apprenticeships in teaching, we are optimistic that implementing a structured apprenticeship model can be part of the solution. We look forward to supporting this initiative and are committed to working with our partners to help solve the State's teacher shortage.

My name is Dr. Terry Lock. I am with the University of Hawai'i at Mānoa (UHM) College of Education (COE) and serve as the director of the Hawai'i Early Childhood Educator Excellence and Equity (ECE<sup>3</sup>) Project.

I am in support of HB875 HD1 as a teacher apprenticehip program is one solution to address the teacher shortage problem in our state public school system in Hawai'i.

In addition, to address the very critical shortage in teaching staff among community-based preschools and child care programs, including Head Start and Early Head Start, in our state, there needs to be a state early childhood educator apprenticeship program.

Currently, the project that I oversee has conducted research on early childhood educator apprenticeship programs and provided funding to UH System's Honolulu Community College's early childhood education program to work closely with Keiki O Ka Āina (KOKA) to design Hawai'i's first Early Childhood Education Apprenticeship Program.

Therefore, I am in support of HB875 HD1 and would recommend that our state also support early childhood educator apprenticeships.

## Support for HB875, Relating to Education

Aloha Chair, Yamashita, Vice-Chair Kitagawa, and Members of the Committee,

My name is Budde Cabael and I am completing my final year as a graduate student at the University of Hawaii at Manoa, Thompson School of Social Work and Public Health where I will earn a Master of Social Work with a specialty focus on Child and Family Practice. I am testifying in support of HB875. As an outdoor educator and program administrator at Waimea Valley, a previous substitute teacher for the Windward school district, also a previous part time teacher at Kahuku High and Intermediate School, and a former ethics instructor for children, youth, and adults my teaching experience is robust and established in exceeding two decades. The historical and cultural trauma inherited by the children that populate our public schools has influenced the observable distrust for systemic representatives like our teachers. That apparent barrier for effective instruction is exacerbated for out of state teachers of our keiki, being either surmountable or a wall that they figuratively smash into. The difference of either outcome depends on their awareness of that barrier and determination to achieving community trust and acceptance. While in my undergraduate coursework, I had aspirations of earning my teaching license and entering the Hawaii public school system. My reservations were fueled by the experience of friends who entered public school teaching and felt overwhelmed by the insufficient support and economic strain during their workforce training.

Establishing and supporting the design of a Hawaii teacher apprenticeship program intended to support, recruit, develop and retain teachers for Hawaii public schools as HB875 proposes, will initiate a cyclical motion of empowerment. Community educators will have a clear path to teaching licensure and long term placement. Students will be led by members of their respective communities, and the quality of continuity of instruction will strengthen Hawaii's schools overall. Again, I repeat my support for HB875, Relating to Education.
