Testimony of DAWN N. S. CHANG Chairperson

In consideration of SENATE BILL 1549 RELATING TO THE DEPARTMENT OF LAND AND NATURAL RESOURCES

Senate Bill 1549 proposes to appropriate funds to the Department of Land and Natural Resources (Department) Division of Forestry and Wildlife to manage hotspots at trailheads as part of the Nā Ala Hele Trail and Access Program (Program). The Department strongly supports this measure provided that its passage does not replace or adversely impact priorities indicated the Department's Executive Budget request.

The Department acknowledges the Hawai'i Tourism Authority's Destination Management Action Plan initiative, which identified a series of destination "hotspots" across the state that are presenting management challenges to the agencies tasked with managing the hotspot areas. Program staff are currently actively engaged in a strategic planning effort to address the challenges associated with visitor use and have initiated programs and projects statewide to help mitigate the impacts of a rapid rise in outdoor recreation.

The funding proposed by this Act will allow the Department to put personnel and planning efforts in motion to address a number of these hotspots, including trailheads in the Koke'e region of Kaua'i, the Maunawili Falls and Ka'iwa Ridge trails on O'ahu, multiple areas on Maui, Naha Trail on Lāna'i, and Pololū Valley, Waipi'o Valley, and Maunakea on Hawai'i island. The positions proposed will increase the Program staff by over 50% statewide, enabling enhanced, active, ongoing management of the Division of Forestry and Wildlife's recreational inventory.

Aloha Madame Chair and Members of the Committee on Land and Water

The Hawai'i Island Group of the Sierra Club of Hawai'i has voted to be in strong support of Senate Bill 1549, relating to funding for the Nā Ala Hele program of the Department of Land and Natural Resources.

Nā Ala Hele is the State of Hawai'i Trail and Access Program, created to manage public resources related to hiking. The program manages trail access and conducts trail maintenance in order to provide important public services including recreational opportunities, experiences related to cultural history and historic trails, and economic opportunities where possible for commercial trail vendors. Nā Ala Hele trails are also important for access into natural areas for management, research, hunting, and wildfire response.

One of the primary missions of the Sierra Club is "To explore, enjoy, and protect the wild places of the earth...". The Nā Ala Hele program and its staff share in this mission.

We know that nature improves our mental, physical, and social health. With more than 100 hikes and service projects to care for Hawai'i's special places each year, our trained leaders have worked with the Nā Ala Hele program and its staff to create opportunities for everyone to experience the transformative power of the outdoors—from trekking and restoring trails, such as the Ala Loa Trails of each island, to reforestation in Hakalau and the Waikōloa Dry Forest on the island of Hawai'i.

The resources, information, and support provided by the program and staff of Nā Ala Hele to residents and visitors alike have been and are essential to their health and well-being. It has contributed immeasurably to the fact the residents of Hawai'i are continually ranked as the healthiest in the nation and so we ask the members of the Senate Committee on Water and Land to vote in support SB1549.

Comments:

This legislation is long overdue, but it's reach is too limited. The problems surrounding trails and trailhead have gone on for years, it is getting worse, and the state has failed to do much of anything for many trails because of lack of funding. As a hiker, I find this aggravating, especially as I see more and more unmanaged trails permanently closed. Trails are being closed, just as the number of hikers is increasing. Surveys have indicated hiking is the most popular land recreation in the state, yet hikers are losing access to spectacular trails because DLNR isn't given the funding to manage and fix problems associated with our trails. Neighbors next to popular trails complain, often rightfully so, because trails aren't managed, and the solution is one that results in a huge loss for hikers—the closing of these trails. We need to fund management and maintenance, not just personnel to supervise and police hotspots like trail heads. That approach is completely inadequate and doesn't solve much. The State really needs to invest funds to permanently take care of our resources.

Management should include things like relocating trailheads out of neighborhoods, and providing parking and restroom facilities for trails. Charge fees for the parking and fees for entry to popular trails. If necessary, provide security and park staff, and restroom facilities. Please start providing funding for management to DLNR and stop closing our precious hiking trails. Local hikers really value these trails. They shouldn't lose access to them because of the tremendous increase in tourism, and the advent of social media telling the world about our favorite, treasured trails.

Twenty to thirty years ago my family and I, like everyone else, could access any trail on Oahu without encountering parking problems and crowds. People were respectful, there wasn't abuse and overuse of the trails, people didn't bother the nearby neighbors, and it was a wonderful experience in nature.

I live around the corner from the Ka Iwa Ridge Trail (Lanikai Pillbox trail) in Lanikai and have witnessed that situation deteriorate over the years. We used to hike that trail regularly and often we had it to ourselves, or would pass only a few others on the trail. This is a trail that needs relocation of the trailhead out of Lanikai, entry by reservation and fees for non-residents, and parking and restroom facilities provided somewhere in Enchanted Lake near Kalanianole Hwy. All of this cost money, but it is critically necessary.

I am a member of Hui Maunawili Kawainui Coalition and we have been working with DLNR to protect and preserve Maunawili Valley, including the Maunawili Trail. We advocated to

temporarily close down that trail to stop the destruction, overuse and abuse of the trail, loss of native species, damage to ancient loi terraces, vandalism at Queen's Retreat, and pollution of the watershed, especially Maunawili Stream, and stop the filth and trash and disrepect of sacred places by hikers. The disturbances to the neighbors next to the trailhead was unacceptable and they suffered severe loss of their quality of life. We are working with DLNR to restore the area, relocate the trail away from sensitive archaeological areas, relocate the trailhead outside of the neighborhood, and provide parking and restrooms and require historical, environmental, cultural education prior to any entry. There will be managment and maintenance and security for the trail. Entry will be by reservation only, no doubt when the trail reopens, and there will be fees for nonresidents. Entry for this trail may become very restricted to entry for stewardship and education only.

Christian Palmer, an environmental anthropologist who has actively hiked throughout the state for the past thirty years, wrote in a 2021 Civil Beat article that he estimates almost half of our trails are currently closed. Many of these trails are not part of the Na Ala Hele trail system, but it makes keeping Na Ala Hele trails open and managed and maintained even more critical for hikers.

Many trails have been closed down because of liability issues, but we have an average of 65 drownings in the ocean every year and we aren't closing beaches. One of the safest trails on the island, Haiku Stairs, is being labeled "dangerous" because the city wants to tear it down because of the problems hikers have created for the nearby neighbors. Haiku Stairs is one of the most spectacular hikes in the world, historically significant, a very popular hike, yet somehow the City has been unable to apply very simple management solutions, such as restricted entry by reservation, parking outside of the nearby neighborhood, water fountains and restrooms, etc. to solve the problems surrounding this hike. Management of trails is not rocket science. We don't have to tear down something as incredibly unique and spectacular and world class as Haiku Stairs because of some problems in a small neighborhood on the island. That is absurd.

Other places around the nation and the world have figured out how to manage and protect their valuable natural resources. Hawaii has begun, but we have a long ways to go and we need to step it up, invest the monies, and help DLNR Department of Forestry and Wildlife secure, maintain and manage our trails, protect nearby neighborhoods, and keep trails open for the benefit and enjoyment of local residents, and visitors as well.
