Chair Dela Cruz, Vice-Chair Keith-Agaran, and Members of the Committee:

The Department of Taxation ("Department") offers the following <u>comments</u> regarding S.B. 606, S.D.1, for your consideration.

S.B. 606, S.D.1, seeks to amend section 237-24.3(6), Hawaii Revised Statutes, to exempt the sale of hearing aids, sold by a hospital, infirmary, medical clinic, health care facility, pharmacy, or licensed practitioner from the general excise tax. This exemption will not apply to any amounts that are received for *services* related to the sale of hearing aids. This bill has a defective effective date of December 31, 2050.

The Department appreciates that the Committee on Health and Human Services defined the term "hearing aid" in the bill, as requested.

If the effective date is updated, the Department requests that it be amended to January 1, 2024.

Assuming the measure has an effective date of July 1, 2023, as originally proposed, the Department estimates a revenue loss to the general fund as follows (\$ millions):

BILL NUMBER: SB 606 SD 1

INTRODUCED BY: Senate Committee on Health and Human Services

EXECUTIVE SUMMARY: Exempts from the general excise tax, gross receipts received from the sale of hearing aids.

SYNOPSIS: Amends section 237-24.3(6), HRS, allow the exemption for prescription drugs and prosthetic devices to apply to hearing aids.

Defines "hearing aid" the same as in section 451A-1, HRS.

EFFECTIVE DATE: December 31, 2050.

STAFF COMMENTS: Existing law, namely section 237-24.3(6), exempts sales of prescription drugs and prosthetic devices. Over-the-counter medicines and products, whether to promote ocular, auditory, or dental health, are not currently exempt.

Perhaps the bill is intended to provide relief for individuals with disabilities and kupuna with limited incomes by exempting hearing aids from Hawaii's general excise tax. The same rationale could be applied to glasses and dental work, so it is questionable why auditory devices are being singled out for special treatment.

### RELATING TO HEARING AIDS

Chair Dela Cruz, Vice Chair Keith-Agaran and members of the Committee, my name is Peter Fritz. I use hearing aids and I am testifying **in support** of S.B. 606 SD1. This bill exempts hearing aids from the general excise tax ("GET") making hearing aids more affordable.

Exempting hearing aids from the GET makes hearing aids more affordable. Enabling more citizens to purchase hearing aids will reduce the risks and expenses from untreated hearing loss and could result in lower health insurance premiums.

<u>Untreated hearing loss can result in longer hospitalizations, readmissions and more visits to an emergency room.</u> Untreated hearing loss accounted for 3.57 percent of people significantly injured in a fall, 3.2 percent of all cases of dementia, and 6.88 percent of those seeking treatment for depression according to a study covering a 10-year period.¹ Enabling more people to purchase hearing aids can reduce these risks.

Correcting hearing loss has broad medical benefits. Hearing health is a critical component of overall health and well-being. Hearing loss, if left untreated, can lead to an increase in cognitive decline, as well as exacerbate social isolation. Over time, both of these factors can contribute to dementia risk.

Hearing loss is known to be the largest modifiable risk factor for developing dementia. According to an analysis published in <a href="The Lancet">The Lancet</a> in 2017, Vol. 390, No. 10113, preventing or treating hearing loss in midlife has the potential to diminish the incidence of dementia by 9 percent.

Depending on the technology, hearing aids can cost about \$4,000 to \$8,000 for a pair.<sup>2</sup> The GET on a pair of hearing aids costing \$6000 is approximately \$283. Excluding hearing aids from the GET makes hearing aids less expensive.

Hawaii should join the majority of states that exclude hearing aids from taxation.
