Representative Herkes, for the Committee on Consumer Protection & Commerce presented a report (Stand. Com. Rep. No. 1) recommending that H.B. No. 107, pass Second Reading and be referred to the Committee on Finance.

Representative Marumoto rose to speak in support of the measure with reservations, stating:

"I would like to express reservations on Standing Committee Report No. 1.

"I did vote for this measure because apparently refund splitting is allowed and performed by the Federal Government. However, I now have reservations because the State Department of Taxation said it would have to devise new forms to comply with this law and reconfigure computer programs to allow refunds to be sent to two places. It seems to be a great deal of trouble to accommodate the few people who will want to split their taxpayer refunds, I guess, only once a year. It seems to me that these few people could receive their refunds and mail it to the second party or to the second financial institution. Thank you."

Representative Herkes rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. The items that were brought up by the previous speaker should be addressed by the Committee on Finance. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 107, entitled: "A BILL FOR AN ACT RELATING TO TAXATION," passed Second Reading and was referred to the Committee on Finance with Representatives Berg and Har being excused.

Representative Herkes, for the Committee on Consumer Protection & Commerce presented a report (Stand. Com. Rep. No. 2) recommending that H.B. No. 373, pass Second Reading and be referred to the Committee on Judiciary.

On motion by Representative Caldwell, seconded by Representative B. Oshiro and carried, the report of the Committee was adopted and H.B. No. 373, entitled: "A BILL FOR AN ACT RELATING TO SCRAP DEALERS," passed Second Reading and was referred to the Committee on Judiciary with Representatives Berg and Har being excused.
