The intent was never to make money for the State, but it was to help build the rail system. And, if we're talking about \$5 million or \$6 million here, that will help build the rail system, especially over a 15 year period, so I hope that we move this bill forward. Mahalo."

Representative Ward rose to speak in support of the measure, stating:

"Mr. Speaker, I rise with mild support. This bill is better than the other one in that it cuts down from 10 percent down to five percent. But in the Finance Committee we heard that it's only \$2 million per year that it takes to actually collect this money and we're actually collecting more than we need by double. So, we've gone to better, but I think we can do even much better than we've done here. Thank you."

Representative Chong rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 724, entitled: "A BILL FOR AN ACT RELATING TO COUNTY SURCHARGE ON STATE GENERAL EXCISE TAX," passed Second Reading and

Representative McKelvey rose to speak in support of the measure, stating:

"Thank you very much. I rise in support, Mr. Speaker. For the clarifications of the previous speaker, the Department of Transportation did support the bill, however, they felt that we need to plan for an ITS, intelligence traffic system first. That would be the fiber-optic, the cameras and such. And by developing such a plan, they could then go to the federal government and get federal money for the project. Their concern was that by building the Traffic Control Center first, without the outlying infrastructure, that we wouldn't get federal funds and that we would be putting the cart before the horse. So, I hope we can get your support on this. Mahalo."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1605, entitled: "A BILL FOR AN ACT RELATING TO TRAFFIC CONTROL," passed Second Reading and was referred to the Committee on Finance, with Representative Thielen being excused.

"Mr. Speaker, we should go back to Stand. Com. Rep. No. 310. This is relating to Voluntary Employees' Beneficiary Association Trust, the VEBA Trust. This is going to extend the date that was set, I guess, in 2005. It's a pilot program. I don't have the bill with me today, but it seems to me it extends it out. I don't want to say it's about ten years. It's quite a long ways.

"There's still the problem of adverse selection. The bill in the Committee Report talks about cost savings. I think we will have the opposite effect, but it also doesn't ask for any reporting. The original pilot program asks for reporting, but because of problems with HSTA, it was slow to get started, so obviously there's been no reporting. It's barely started. But I do have reservations about extending the date out as far as we have. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1746, entitled: "A BILL FOR AN ACT RELATING TO VOLUNTARY EMPLOYEES' BENEFICIARY ASSOCIATION TRUSTS," passed Second Reading and was referred to the Committee on Finance, with Representative Thielen being excused.

Representative Sonson, for the Committee on Labor & Public Employment presented a report (Stand. Com. Rep. No. 311) recommending that H.B. No. 859, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

Representative Caldwell moved that the report of the Committee be adopted, and that H.B. No. 859, HD 1, pass Second Reading and

be referred to the Committee on Finance, seconded by Representative B. Oshiro.

Representative Meyer rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. The biggest problem in Committee was that most employers felt that it took away the powers of the employers. We're talking the counties and State. I have strong reservations."

Representative Finnegan rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Marumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 859, HD 1, entitled: "A BILL FOR AN ACT RELATING TO PUBLIC EMPLOYEES," passed Second Reading and was referred to the Committee on Finance, with Representative Thielen being excused.

Representative Cabanilla, for the Committee on International Affairs presented a report (Stand. Com. Rep. No. 312) recommending that H.B. No. 34, be referred to the Committee on Finance.

Representative Caldwell moved that the report of the Committee be adopted, and that H.B. No. 34, be referred to the Committee on Finance, seconded by Representative B. Oshiro.

Representative Green rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. Very brief comment in support. This bill has to do with divesting Hawaii's ERS dollars from Darfur where there is just a catastrophic amount of human loss and tragedy going on. We may not have a lot of money invested in that region. Whatever we can do as a message or a symbol for the rest of the country, I think we should do and divest from that country. I think that any contribution we make monetarily there, will only make matters worse, so, thank you for considering this Members."

Representative Cabanilla rose to speak in support of the measure,

"Mr. Speaker, I just want to add a little bit of up-to-date information on that effort. I'm standing in support. I just wanted to state that the Sudanese Government has purchased advanced Phantom Jet fighters and high attack helicopters from Russia. The same as seen in the movie, *Rambo III*, and they're going to use these fighter planes to bomb villages and kill men, women and children with complete disregard to human rights and international law. I ask my colleagues to support this measure. I have some drawings in my office drawn by children whose families were killed by these atrocities, and I invite my colleagues to come and see those pictures that were drawn by these children. Thank you, Mr. Speaker."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 34, entitled: "A BILL FOR AN ACT RELATING TO THE EMPLOYEES' RETIREMENT SYSTEM," was referred to the Committee on Finance, with Representative Thielen being excused.

Representative Yamashita, for the Committee on Economic Development & Business Concerns presented a report (Stand. Com. Rep. No. 313) recommending that H.B. No. 102, HD 1, be referred to the Committee on Finance.

On motion by Representative Caldwell, seconded by Representative B. Oshiro and carried, the report of the Committee was adopted and H.B. No. 102, HD 1, entitled: "A BILL FOR AN

ACT RELATING TO HUMAN SERVICES," was referred to the Committee on Finance, with Representative Thielen being excused.

Representative Yamashita, for the Committee on Economic Development & Business Concerns presented a report (Stand. Com. Rep. No. 314) recommending that H.B. No. 863, be referred to the Committee on Finance.

Representative Marumoto rose to speak in opposition to the measure stating:

"Mr. Speaker, I register a no vote on Stand Com. Report 314. This would allow the prevailing wage law to control private projects, not public works. Thank you."

Representative Meyer rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, I also rise in opposition to this measure. There should be a separation between the private and the public sector. This is a big intrusion into private contracts. Thank you."

Representative Ching rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 863, entitled: "A BILL FOR AN ACT RELATING TO PUBLIC WORK PROJECTS," was referred to the Committee on Finance with Representatives Ching, Marumoto, Meyer and Ward voting no, and with Representative Thielen being excused.

Representative Yamashita, for the Committee on Economic Development & Business Concerns presented a report (Stand. Com. Rep. No. 315) recommending that H.B. No. 1931, pass Second Reading and be referred to the Committee on Finance.

On motion by Representative Caldwell, seconded by Representative B. Oshiro and carried, the report of the Committee was adopted and H.B.
