If we're always just hiking it up along with the federal program, things are on auto-pilot and we don't have control over it. Also, the Earned Income Tax Credit is for people with children. And while I know that there are so many people here in Hawaii that need tax relief, this just doesn't hit as many as an increased tax deduction would. Thank you."

The purpose of this bill, Mr. Speaker, is to help nonprofit organizations secure grant funds and perform capital improvements for programs that provide substantial community benefits by providing an exemption to nonprofit corporations from the 15-year limit on the grant of county concessions or concession space.

"This bill is borne out of the fact that many non-profits who are doing the work of government for the people of Maui invest a lot of money and time into the buildings they are leasing not only benefit of the people themselves, but also for the government as well. This is because the government – which are the owners of these buildings – will also be the beneficiaries of these efforts, since the non-profit is taking care of the money and manpower to do these projects so that the counties and, by extension the taxpayers, don't have to come up with the funds to do these types of repairs and improvements.

"It is fundamentally unfair to expect a non-profit, which by the name itself shows they are making no money beyond their expenses, to put all of their valuable resources into the repair and improvement of these buildings to do all of this work and then all of sudden be displaced because of an arbitrary time limit in the law.

"This bill, Mr. Speaker, would also have a secondary, but equally important benefit to the people of Hawaii. Many of the structures that are leased to these non-profits by the county are important historical structures that have a special place in history to the people of our islands. In fact, the genesis of this bill came from a situation where a non-profit in Maui has been leasing the historic Iao Theater in Wailuku and has been making improvements to this historically significant building only to be faced with eviction because of the current law. Because of their fine efforts this significant structure has been saved from being dilapidated and now stands in its former glory and can be used and enjoyed by people today and appreciated by people now and tomorrow. With the Heritage Day coming upon us, I can think of no other finer way to show that we are indeed serious about historic preservation and celebrating our past then to move this bill forward so that the important work being done to save and restore these buildings can continue."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1756, entitled: "A BILL FOR AN ACT RELATING TO COUNTY CONCESSIONS," passed Second Reading and was placed on the calendar for Third Reading with Representatives Takamine, Takumi and Thielen being excused

Representative M. Oshiro, for the Committee on Finance presented a report (Stand. Com. Rep. No. 957) recommending that H.B. No. 1434, pass Second Reading and be placed on the calendar for Third Reading.

On motion by Representative Caldwell, seconded by Representative B. Oshiro and carried, the report of the Committee was adopted and H.B. No. 1434, entitled: "A BILL FOR AN ACT RELATING TO INCOME TAX CREDIT," passed Second Reading and was placed on the calendar for Third Reading with Representatives Takamine, Takumi and Thielen being excused.

Representative M. Oshiro, for the Committee on Finance presented a report (Stand. Com. Rep. No. 958) recommending that H.B. No. 238, pass Second Reading and be placed on the calendar for Third Reading.

Representative Caldwell moved that the report of the Committee be adopted, and that H.B. No. 238, pass Second Reading and be placed on the calendar for Third Reading, seconded by Representative B. Oshiro.

Representative Brower rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Meyer rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. I'm rising with strong reservations on that same issue and will reserve my comments for Third Reading."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 238, entitled: "A BILL FOR AN ACT RELATING TO THE SALE OF REAL PROPERTY," passed Second Reading and was placed on the calendar for Third Reading with Representative Brower voting no, and with Representatives Takamine, Takumi and Thielen being excused.

Representatives Waters and Magaoay, for the Committee on Judiciary and the Committee on Legislative Management presented a report (Stand. Com. Rep. No. 959) recommending that H.B. No. 1909, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

Representative Caldwell moved that the report of the Committees be adopted, and that H.B. No. 1909, HD 1, pass Second Reading and be placed on the calendar for Third Reading, seconded by Representative B. Oshiro.

Representative Marumoto rose to speak in support of the measure, stating:

"I rise to speak in favor of Stand. Com. Rep. No. 959, which has to do with the Legislative Ethics Committee. The name of the bill is Relating to Standards of Conduct. I want to thank the Chairman for putting in the Committee Report that the bill will eventually reflect a balanced membership, because the first draft that we had seen, there were two Majority members, and one Minority member. I would assume that balanced means an equal number of Minority and Majority members, however many that would be.

"Also, I think if my colleague were here, Representative Thielen, she would ask that a ban on fundraisers be added to this bill. But otherwise, I think it's a good start."

Representative Finnegan rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. On this measure, please note my reservations and I will give my comments on Third Reading."

Representative Ward rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Chair. I rise with reservations on this measure. Mr. Chair, I think with the other bill that we may or may not hear regarding ethics, this particular naming of a Standard of Conduct Committee, I think is cumbersome in its name. Why don't we just name it the Ethics Committee? I think that's one thing I have reservations about.

"The other thing is that, in all due respect, Mr. Speaker, it puts you and the President of the Senate as the great arbiters of which you can put any of us into the State Ethics Commission according to your particular decision. And notwithstanding what my colleague from East Honolulu said, until I see it in writing that we have equal bipartisan representation, this bill is flawed by virtue of its lack of balance in terms of membership.

"So those are some concerns. I think we're edging up on 1909, which had a head start. At least it had a hearing. It had some possible corrections by membership, and by virtue of the US Senate and the US House have an equal membership, and having those as not under the charge of either the President or the Speaker of the House. It's a more egalitarian way of which ethics should be above political party. It should be above politics. I think we're in the right

direction. We just need to refine it. And that's the reason for my reservations. Thank you."

Representative B. Oshiro rose to speak in support of the measure, stating:

"Mr. Speaker, I rise in strong support of this bill. Just to briefly counter some of the prior characterizations. I think this really is a monumental step forward. Just to put some perspective on this. People don't realize that Hawaii is actually one of the top-rated states when it comes to an ethics law. We have an independent Ethics Commission that handles potential ethics violations. They're completely separate and they do their own work, investigations and findings.

"What this does is set up an alternative procedure for things that may not fall under Ethics Commission violations. And that's why it is a different name. It's called a Standards of Conduct Committee. And so I really support naming it something else, because what we don't want to do is create a dual jurisdiction or confusion, especially for people out there in the public. What we want people to be assured of, is that we will have an internal structure that will deal with standards of conduct and potential violations. That's why I'm in strong support of this.

"One of the other criticisms I think, has to do with the membership or make up of the Committee and I think that's a premature discussion at this point. It's left blank. It's something that we continue to look at. Like every other Committee that we have in this body, it's made up proportionally based off of the Majority and Minority membership. So the question is, what makes this one any different when it's going to be looking at substantive issues? Whether it should be based off of pure partisanship, saying that every issue has a partisan take to it, or taint to it, and that's why we need a partisan membership. Or whether we can rise above it and be as we are in this august body and decide to deal with things on their merits. If we can do that, then I don't think we need to be apportioning things based off of partisanship. Thank you."

Representative Ward rose to respond, stating:

"Mr. Speaker. Just a brief retort to that. If history's any guide, we know that the State Ethics Commission has always been there. We always go to them. So to have the referral of this Committee as the first instinct to go to them is repeating history. Because if you look at the history of conflict of interest, which hopefully this bill will have something to do with, 99.9999 percent of the time, there's no conflict. So if we're going to get to the matter of the issue, we've got to police ourselves. The State Ethics Commission has not been able to do that. And if we're going to police ourselves, we have to be serious about it and we have to get into these issues by looking at ourselves on an equal basis, not on a partisan basis."

The motion was put to vote by the Chair and carried, and the report of the Committees was adopted and H.B. No. 1909, HD 1, entitled: "A BILL FOR AN ACT RELATING TO STANDARDS OF CONDUCT," passed Second Reading, and was placed on the calendar for Third Reading with Representatives Takamine, Takumi and Thielen being excused.

Representative M. Oshiro, for the Committee on Finance presented a report (Stand. Com. Rep. No. 960) recommending that H.B. No. 110, HD 1, pass Second Reading and be placed on the calendar for Third Reading.

On motion by Representative Caldwell, seconded by Representative B. Oshiro and carried, the report of the Committee was adopted and H.B. No. 110, HD 1, entitled: "A BILL FOR AN ACT RELATING TO HOUSING," passed Second Reading and was placed on the calendar for Third Reading with Representatives Takamine, Takumi and Thielen being excused.

Representative Waters, for the Committee on Judiciary presented a report (Stand. Com. Rep. No. 961) recommending that H.B. No. 1152, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

On motion by Representative Caldwell, seconded by Representative B. Oshiro and carried, the report of the Committee was adopted and H.B. No. 1152, HD 1, entitled: "A BILL FOR AN ACT RELATING TO SENTENCING," passed Second Reading, and was placed on the calendar for Third Reading with Representatives Takamine, Takumi and Thielen being excused.

Representative M. Oshiro, for the Committee on Finance presented a report (Stand. Com. Rep. No. 962) recommending that H.B. No. 840, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

Representative Caldwell moved that the report of the Committee be adopted, and that H.B. No. 840, HD 1, pass Second Reading and be placed on the calendar for Third Reading, seconded by Representative B. Oshiro.

Representative Morita rose to speak in support of the measure with reservations, stating:

"On Stand. Com. Rep. No. 962, H.B. 840, HD 1, I have some reservations on this bill and I just would like to explain my position to the Members. As Chair of your Committee on Energy and Environmental Protection, the tax credit measures that I pass out usually have undergone scrutiny through a cost-benefit analysis. On this specific bill, we haven't looked at its cost-benefit analysis. My basic position at this time is that anybody that can afford a fuel cell, which is very expensive, doesn't need a tax credit. So it's very hard to support a measure like this. But I will go with reservations and I'm open to further discussion on this measure."

Representative Meyer rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. I'm rising with some strong reservations on that same measure. There was testimony in the Finance Committee that in trying to get the hydrogen out of water, a great deal of energy is used to get it. So it's not in the same league with solar and wind. Thank you."

Representative Belatti: rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. I rise with reservations. I voted with reservations in the Finance Committee in part because I was concerned that this did not get the vetting of the Committee on Energy and Environmental Protection. And I know that this House is struggling to create a comprehensive package that will address many of the issues that we're facing as a State regarding energy. Just reservations, Mr. Speaker."

Representative Evans rose in support of the measure with reservations, and asked that the remarks of Representative Morita be entered in the Journal as her own, and the Chair "so ordered." (By reference only.)

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 840, HD 1, entitled: "A BILL FOR AN ACT RELATING TO RENEWABLE ENERGY TECHNOLOGIES," passed Second Reading, and was placed on the calendar for Third Reading with Representatives Takamine, Takumi and Thielen being excused.

Representative M. Oshiro, for the Committee on Finance presented a report (Stand. Com. Rep. No. 963) recommending that H.B. No. 1171, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

On motion by Representative Caldwell, seconded by Representative B. Oshiro and carried, the report of the Committee was adopted and H.B. No. 1171, HD 1, entitled: "A BILL FOR AN ACT RELATING TO GOVERNMENT," passed Second Reading, and was placed on the calendar for Third Reading with Representatives Takamine, Takumi and Thielen being excused.

At 12:27 o'clock p.m., the Chair declared a recess subject to the call of the Chair.

The House of Representatives reconvened at 12:27 o'clock p.m.

As a representative of Generation X, I am determined to continue striving for peace throughout the world just as the leaders before me.

"I was pleased when I learned that the Hawaii Federation of Junior Young Buddhist Association was working on a peace resolution. After talking to their advisor, I decided to introduce a peace day bill on their behalf. I was touched to know that young leaders in the next generation, Generation Y had the same dream of attaining a more peaceful world.

"House Bill 345 would establish September 21st of each year as "Peace Day" to promote peace programs, improve international relations, and increase educational awareness of peace. If we all work towards this goal of a more peaceful world, we will see priceless results and touch many lives. Thank you."

"Mr. Speaker, I rise in support of this legislation which officially recognizes the Asian or Lunar New Year.

"This is very similar to HB 941, which I submitted, officially recognizing the Asian New Year, calling for an observance, but not a holiday.

"The Asian New Year, known in China as the Spring Festival, or the Lunar New Year, is the most important of the traditional Eastern holidays. The festival proper begins on the first day of the first lunar month in the Chinese calendar and ends on the 15th day, on the Lantern Festival. The beginnings of the Chinese calendar date back thousands of years.

"The New Year falls on different dates each year, between January 21 and February 20, occurring at the time of the full moon. The New Year is celebrated worldwide in areas with large populations of Asians. It is considered a major holiday in Asia by ethnic groups strongly influenced by Chinese culture such as Koreans, Hmong, Mongolians, Vietnamese, Tibetans, the Nepalese and the Bhutanese. The New Year is also the time of the largest human migration, when overseas Chinese all around the world travel home to observe the occasion with their families.

"According to legend, in ancient China, the *nian*, a man-eating beast from the mountains, could silently infiltrate houses to prey on humans. The people believed that the *nian* was sensitive to loud noises and the color red, so they scared it away with explosions, fireworks and the liberal use of the color red. These customs led to the first New Year's celebrations.

"I believe that the desire is strong among Hawaii's population for recognition of the Lunar New Year. Among those supporting this recognition are Dr. Chuck Yim Gee, Dean Emeritus of the School of Travel Industry Management at the University, Lily and Larry Chang of the Chinese Community Broadcasting Co., Karl Kao of the World Journal Newspaper, Joseph Chow of the Sing Tao Newspaper, Johnson Choi, President of the Hong Kong-China-Hawaii Chamber of Commerce, and many others too numerous to mention.

"Because of the prominence of Hawaii's Chinese population and the emphasis on promoting tourism from China, several other legislators also introduced bills to establish a Chinese Lunar New Year Day or Week observance. These are: Senate Bill No. 247 establishing the Asian Lunar New Year Commemoration Week, House Bill No. 941, recognizing the Asian Lunar New Year Day, and House Bill No. 1103, a companion measure to SB 247, establishing the Asian Lunar New Year Commemoration Week.

"I am gratified that this bill will accomplish that goal, and I give it my full support."
