Thursday, March 15, 2007

The House of Representatives of the Twenty-Fourth Legislature of the State of Hawaii, Regular Session of 2007, convened at 12:09 o'clock p.m., with the Speaker presiding.

The invocation was delivered by Representative Ryan I. Yamane, after which the Roll was called showing all members present with the exception of Representatives Herkes, M. Oshiro, Takamine and Thielen, who were excused.

On motion by Representative B. Oshiro, seconded by Representative Meyer and carried, reading of the Journal was dispensed with and the Journal of the Twenty-Fourth Day was approved. (Representatives Herkes, M. Oshiro, Takamine and Thielen were excused.)

Representative Shimabukuro, for the Committee on Human Services & Housing presented a report (Stand. Com. Rep. No. 1222) recommending that S.B. No. 600, pass Second Reading and be referred to the Committee on Consumer Protection & Commerce.

On motion by Representative Caldwell, seconded by Representative B. Oshiro and carried, the report of the Committee was adopted and S.B. No. 600, entitled: "A BILL FOR AN ACT RELATING TO LEASEHOLD CONVERSION," passed Second Reading and was referred to the Committee on Consumer Protection & Commerce with Representatives Herkes, Takamine and Thielen being excused.

Representative Green, for the Committee on Health presented a report (Stand. Com. Rep. No. 1223) recommending that S.B. No. 58, SD 2, as amended in HD 1, pass Second Reading and be referred to the Committee on Consumer Protection & Commerce.

On motion by Representative Caldwell, seconded by Representative B. Oshiro and carried, the report of the Committee was adopted and S.B. No. 58, SD 2, HD 1, entitled: "A BILL FOR AN ACT RELATING TO DENTISTS," passed Second Reading and was referred to the Committee on Consumer Protection & Commerce with Representatives Herkes, Takamine and Thielen being excused.

Representative Green, for the Committee on Health presented a report (Stand. Com. Rep. No. 1224) recommending that S.B. No. 1253, as amended in HD 1, pass Second Reading and be referred to the Committee on Economic Development & Business Concerns.

Representative Caldwell moved that the report of the Committee be adopted, and that S.B. No. 1253, HD 1, pass Second Reading and be referred to the Committee on Economic Development & Business Concerns, seconded by Representative B. Oshiro.

Representative Green rose to disclose a potential conflict of interest, stating:

"Mr. Speaker, I'd like to recuse myself from voting on S.B. 1253, SCR 1224. I'm an ER doctor that works in HHSC Hospital and they contract with me."

The Chair ruled, stating:

"At this point there is no conflict because you are a part of a class of doctors serving the Corporation."

Representative B. Oshiro rose to disclose a potential conflict of interest, stating:

"Mr. Speaker, I similarly ask for a ruling on a potential conflict at my law firm. I do represent HHSC and I advise them on procurement matters," and the Chair ruled, "no conflict."

Representative Evans rose to speak in support of the measure with reservations, stating:

"On Stand. Com. Rep. No. 1224, with strong reservations."

Representative Awana rose in support of the measure with reservations, and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Awana's written remarks are as follows:

"Thank you, Mr. Speaker. I am in support with reservations. Although I believe that products and services are needed to adequately provide the best care to patients, I question the logic that states bypassing procurement procedures will necessarily accomplish this task. Those under the Hawaii Health System Corporation should continue to be held accountable as do other State agencies. It may take extra planning and forecasting to obtain the desired results, but if other agencies need to, so should they.

"There is a reason for procurement. Procurement keeps the market competitive. In addition, non-bid contracts are frowned upon, causes suspicion, and creates an air of deception by the general public. Mr. Speaker, passing such legislation, I believe, may cast a dark cloud on this legislative body. Thank you, Mr. Speaker."

Representative Finnegan rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 1253, HD 1, entitled: "A BILL FOR AN ACT RELATING TO HAWAII HEALTH SYSTEMS CORPORATION CONTRACTS," passed Second Reading and was referred to the Committee on Economic Development & Business Concerns with Representatives Herkes, Takamine and Thielen being excused.
