Representative Caldwell moved that the reports of the Committee be adopted, and that H.R. No. 48, HD 1, and H.C.R. No. 69, HD 1, be referred to the Committee on Human Services & Housing, seconded by Representative B. Oshiro.

Representative Meyer rose in opposition to both measures, and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Meyer's written remarks are as follows:

"I'm in opposition on HR 48, HD1. This Resolution urges the State of Hawaii to adopt the United Nations Convention on the Rights of the Child. I think it should first be noted in what sort of company we put ourselves in when we ratify any United Nations convention. For instance, North Korea, which is perhaps the most repressive and unfree nation on earth, a nation that systematically starves, indoctrinates, and enslaves its citizens, has adopted the following U.N. conventions: the Covenant on Economic, Social, and Cultural Rights; the Covenant on Civil and Political Rights; the Convention on the Elimination of All Forms of Discrimination against Women; and the Convention on the Rights of the Child. This, from a regime which systematically denies all economic, social, cultural, civil and political rights to its subjects, and which grants both women and children the same opportunity to starve to death as men.

"Maybe this was the only nation that was allowed to sign these lofty-sounding declarations despite clear and convincing proof that they did the exact opposite of what the conventions say they've committed to doing. Perhaps Saudi Arabia, which severely oppresses women, would not be permitted to be a signatory to the Convention on the Elimination of All Forms of Discrimination against Women? Nope, a signatory since October of 2000. Surely Sudan, a country that allows the torture and murder of residents of Darfur in an egregious act of ethnic cleansing, would not be permitted to be a signatory to the Convention against the Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment? Nope, a signatory since June of 1986. OK, at least Sudan wouldn't be allowed to sign, or remain a signatory to, the Convention on the Elimination of All Forms of Racial Discrimination, given the incompatibility of ethnic cleansing with such a noble goal? Nope, a signatory since April of 1977.

"But, suppose for the moment we ignore the travesty of letting any and every country on earth sign, and remain signatories to, U.N. conventions that they continuously and openly violate – shouldn't the State of Hawaii sign the Convention on the Rights of the Child anyway, if that convention reflects how we seek to treat children? Funny you should ask. If you look at the text of the convention, Article 1 defines a child as "every human being below the age of eighteen years", with no lower age limit given. Since the Hawaii Revised Statutes don't recognize unborn human beings as citizens, we'd be in violation of Article 1.

"Article 3 would have us "ensure that the institutions, services and facilities responsible for the care or protection of children shall conform to the standards established by competent authorities, particularly in the areas of safety and health". Presumably we would have to whittle down the public school repair and maintenance backlog to eliminate the numerous safety and health hazards posed by deferred maintenance, not to mention bringing our student academic performance somewhere above the bottom of the pack nationwide, before we could presume to be in compliance with Article 3.

"Article 4 would commit Hawaii to "undertake all appropriate legislative, administrative, and other measures" to protect, among other things, our "economic" rights. Since it is unlikely that the majority party would be willing to delete the large chunks of the HRS that interfere with economic rights, we'd be in violation of Article 4, too.

"Article 6 says that we would have to "recognize that every child has the inherent right to life" and that we "shall ensure to the maximum possible the survival and development of the child." Since we allow unborn human beings recognized as children in Article 1 to be killed without consequence, we'd fall well short of compliance with Article 6, too. Children under the treaty would have the right to freedom of association – preventing parents from prohibiting their children from getting involved in gangs. Children would be guaranteed the freedom of thought, conscience, and religion, empowering them to reject their parent's religious beliefs. Most of the provisions of the U.N.'s convention on the rights of the child interfere with the parent-child relationship, practically putting them on an equal basis, with the U.N. through this treaty dictating the do's and don'ts for parents.

"I could go on and on here, through all 54 articles, but suffice it to say that we comply with these articles in much the same sense that North Korea, Saudi Arabia, and Sudan comply with the conventions they've signed. Let's not engage in such hypocrisy. Let's vote "no" because it is clear we would not comply and it is not in the interest of our families to sign such a treaty."

No. 69, HD 1, entitled: "HOUSE CONCURRENT RESOLUTION URGING THE ADOPTION OF THE UNITED NATIONS' CONVENTION ON THE RIGHTS OF THE CHILD AS A GUIDELINE FOR ADDRESSING CONCERNS RELATED TO HAWAII'S KEIKI," was referred to the Committee on Human Services & Housing with Representative Meyer voting no, and with Representatives Hanohano, Nakasone, Nishimoto, Saiki, Takamine and Thielen being excused.

Representatives Takumi and Ito, for the Committee on Education and the Committee on Water, Land, Ocean Resources & Hawaiian Affairs presented a report (Stand. Com. Rep. No. 1530), recommending that H.C.R. No. 107, as amended in HD 1, be referred to the Committee on Legislative Management. On motion by Representative Caldwell, seconded by Representative B. Oshiro and carried, the report of the Committees was adopted and H.C.R. Representative Ward rose to speak in opposition to both measures, stating:

"Mr. Speaker, I rise in opposition to Stand. Com. Rep. Nos. 1539 and 1540. Mr. Speaker, I rise because we still have to give the private sector a chance to get healthcare in America. I think we haven't exhausted all the options and this one says, 'Congress we've not been able to do anything and we're trying to ask you to do it.' What I think is if we look at our own State, we've tried to bend over and we have bent over backwards to make sure everybody is taken into healthcare and has healthcare. We know by the emergency appropriations. We know by the clinics. We know by even the other day that the Chair of the Health Committee even showed us a beautiful model of a mobile clinic. If any of you have ever seen the MASH 4077, this is equivalent of what we could have in the islands. So, I think instead of saying, 'Well, let's give up.' Throw our hands up and say, 'Government, you've got to do it." I think we still have to get the private/public sector a chance to work it out. The way Hawaii is doing it, we can be a model for the others. Thank you, Mr. Speaker.

Representative Evans rose in support of both measures with reservations, and asked that the remarks of Representative Ward be entered in the Journal as her own, and the Chair "so ordered." (By reference only.)

Representative Marumoto rose in opposition to both measures and asked that the remarks of Representative Ward be entered in the Journal as his own, and the Chair "so ordered." (By reference only.)

Representative Finnegan rose in opposition to both measures and asked that the remarks of Representative Ward be entered in the Journal as his own, and the Chair "so ordered." (By reference only.)

Representative Ching rose in opposition to both measures and asked that the remarks of Representative Ward be entered in the Journal as his own, and the Chair "so ordered." (By reference only.)

Representative Meyer rose in opposition to both measures and asked that the remarks of Representative Ward be entered in the Journal as his own, and the Chair "so ordered." (By reference only.)

Representative Rhoads rose to speak in support of both measures, stating:

"Mr. Speaker, in support. I wanted to respond to some of the comments that the Representative from Queen's Gate had mentioned. The private sector has had since time in memorial to provide health insurance for all its citizens and it's failed miserably. The market is not the solution in this case. The market is the problem. Thank you."

Representative Pine rose to speak in opposition to both measures, stating:

"Yes, just in opposition. I know we've debated this measure many times before. I'm just more concerned about the cost and the availability of healthcare for everybody. I think Hawaii is doing a great job, but this is being compared to Canada as a role model in some discussions. There's a lot of problems of access to healthcare because of the long wait and actually getting good care, so I'm just a little concerned about that."

Representative Ward rose to respond, stating:

"Just a footnote comment. For those who have a passport and have been overseas, everyone knows in their heart, their mind and their body that we have the best healthcare system in the world, bar none. Bar Canada, bar Sweden. And we have to make it better. But compared to the other systems, it's like what Churchill said about democracy, 'Well, it's probably not the best, but compared to all the others, it's the best that we've got.' And that's the way I think it is with the healthcare system. It's the best in the world."

Representative Shimabukuro rose in support of both measures and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Shimabukuro's written remarks are as follows:

"Mr. Speaker, I am in strong support of HCR 173 and HR 136, regarding the United States Health Insurance Act (HR 676).

"HR 676 is also known as the Enhanced and Expanded Medicare for All Bill. The simple logic of solving the nation's healthcare crisis by extending Medicare coverage to all Americans is gaining momentum across the nation. A comprehensive, universal, single payer system using existing private healthcare providers will provide tremendous savings in cost of care and improvements in the delivery of care.

"HR 676 establishes a new American national health insurance program by creating a single payer healthcare system. The bill would create a publicly financed, privately delivered healthcare program that uses the already existing Medicare program by expanding and improving it to all U.S. residents, and all residents living in U.S. Territories. The goal of the legislation is to ensure that all Americans, guaranteed by law, will have access to the highest quality and cost effective health care services regardless of one's employment, income, or healthcare status.

"With over 42 million uninsured Americans, and another 40 million who are under insured, the time has come to change our inefficient and costly fragmented health care system. The USNHI program would reduce overall annual health care spending by over \$50 billion in the first year. In addition, because it implements effective methods of cost-control, health spending is contained over time, ensuring affordable health care to future generations.

"In its first year, single-payer will save over \$150 billion on paperwork and \$50 billion by using rational bulk purchasing of medications. These savings are more than enough to cover all the uninsured, improve coverage for everyone else, including medication coverage and long-term care.

"Employers who currently provide coverage for their employees pay an average of 8.5% of payroll towards health coverage, while many employers can't afford to provide coverage at all. Under this Act, all employers will pay a modest 3.3% payroll tax per employee, while eliminating their payments towards private health plans. The average cost to an employer for an employee earning \$35,000 per year will be reduced to \$1,155, less than \$100 per month.95% of families will pay less for health care under national health insurance than they do today. Seniors and younger people will all have the comprehensive medication coverage they need.

"Kentucky has already passed a resolution in support of HR 676. By unanimous voice vote, the Kentucky General Assembly passed a resolution on February 7, 2007 calling on Congress to enact HR 676. The resolution directs the House Clerk to send a copy of the official document to the Kentucky Congressional delegation and to President Bush. (The Kentucky resolution is available at http://www.lrc.ky.gov/record/07RS/HR81/bill.doc).

"Over 225 trade union organizations including 39 Central Labor Councils and 7 AFL-CIO state federations have endorsed HR 676. Hawaii should join these organizations and the state of Kentucky by passing HCR 173 and HR 136. We need to let Congress know that 42 million uninsured people in America is unacceptable. We can do better."

Representative Green rose to speak in support of both measures, stating:

"Thank you, Mr. Speaker. I'm in support. Just with a comment that we don't, unfortunately, have the best healthcare system in the world. We rank frequently 15th, 20th, 30th, in some cases, when it comes to infant mortality and suffering on many issues, and so we have a long way to go. I would say we're the best country in the world, but we don't have the best healthcare system in the world. I think we should bring those two things together. Thank you, Mr. Speaker."

The motion was put to vote by the Chair and carried, and the reports of the Committees were adopted and H.R. Representatives Green and Shimabukuro, for the Committee on Health and the Committee on Human Services & Housing presented two reports:

Representative Lee rose in support of both measures and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Lee's written remarks are as follows:

"Mr. Speaker, I am in support of this measure. Mr. Speaker, breast cancer is the most common cancer among American women and cervical cancer is the second most common cancer among women worldwide. These cancers are more deadly among low-income groups because they are less likely to have access to routine screenings. We all know that screening and early detection can be the difference between life and death. Through the Hawaii Breast and Cervical Cancer Control Program (HBCCCP), the Department of Health screens populations disproportionately affected by cervical cancer. Since its inception, DOH reports that "approximately 5,000 women have been screened; 126 breast cancers diagnosed and 90 pre-cancerous or cancerous conditions of the cervix diagnosed." Without HBCCCP, these cancers would have most likely been undetected and these women would probably have lost their lives.

"Unfortunately, this program is only funded through federal moneys which might begin to decrease in the future. These Resolutions request the Governor to establish a program to provide coverage of cancer screening for women fifty to sixty-four years of age who are low-income or have no or insufficient health insurance. Screening and early detection work and I urge my colleagues to vote in favor of these Resolutions. Thank you."

Representative Evans rose and asked that the Clerk record an aye vote with reservations for her on both measures, and the Chair "so ordered."

Representative Lee rose and asked that the Clerk record an aye vote with reservations for her on both measures, and the Chair "so ordered."

Representative Green rose and asked that the Clerk record a no vote for him on both measures, and the Chair "so ordered."

Representative Meyer rose in support of the measure with reservations on both measures, and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Meyer's written remarks are as follows:

"I am in support with reservations on HR 249, HD1. This Resolution authorizes a state-province relationship between the State of Hawaii and the province in Vietnam containing Hue City. While I support the concept of encouraging democracy and the protection of human rights in Vietnam, I do not think that Vietnam has yet broken its ties with the communist regime. Corruption is a way of life, with the exploitation of children and women tolerated by government leaders. There is a high degree of lawlessness which does not render Thua Thien-Hue as a good candidate for us to recognize in a sisterstate affiliation."

Representative Awana rose and asked that the Clerk record an aye vote with reservations for her on both measures, and the Chair "so ordered."

Representative Sonson rose and asked that the Clerk record a no vote for him on both measures, and the Chair "so ordered."

Representative Cabanilla rose to speak in support of both measures, stating:

"Mr. Speaker, I realize there are a lot of votes with reservations and a couple of no votes, but I would just like to express that I rise in support of these Resolutions that would treat the persons of Vietnam with compassion.

"The subject of these Resolutions reminded me of the American Bar Association event I attended last year that featured United States Supreme Court Justice Anthony Kennedy whereby the promotion of democracy into arenas not having it is the calling of the day. Meaning, however we can formulate democracy in societies that do not embrace it, that is the challenge and barrier we must overcome. For all the injustices that transpired in Vietnam by no means does the Resolutions introduced excuse them. Rather, it exposes our generosity and ability to live by the creed that where there is injustice to one, no matter where, all of humanity suffers.

"We know the injustices, yet, rather than ignore them, it was our intent, by way of these Resolutions to partner with Vietnam to illustrate how justice is lived and adhered to in Hawaii. Hopefully, as we intended, a new spark ignites a new generation by way of the partnership proposed between the State and their Province which would bring to them a greater understanding of humanity and democracy as a result. To embrace the expansion of democracy into Vietnam through a sister-state relationship as was proposed in these Resolutions, is an act worthy of passage in my opinion. Bringing a taste of democracy, not by war, but by partnership to the next generation of Vietnamese that we're not the murders is a noble act worthy of my support, and I hope you and I can agree on that cause as a just cause.

\_\_\_\_I also want to add Mr. Speaker, that I would like to dedicate these Resolutions to my predecessor, the Honorable <u>Heléne</u> Hale, who was very passionate in passing this measure last year. Thank you."

\_\_Representative Ward rose to speak in support of the measure with reservations, stating:

----"Mr. Speaker, by default I stand as the only VietnmanVietnam veteran, or the only veteran that served in Vietnam. I was a translator/interpretorinterpreter, and I rise conflicted with this particular <u>R</u>esolution."

The Chair addressed Representative Ward, stating:

"Are you standing with reservations?"

Representative Ward responded, stating:

"Representative Takai said, 'kanalua' in Committee. Can I rise with kanalua?"

Speaker Say: "Kanalua is with reservations. Please proceed."

Representative Ward continued, stating:

\_\_\_\_That shows where the conflict is. Because as a veteran, the war is over. Let's get on with life. But there's a lot of hurt and those who served, who came to the Committee, who said, <u>'Y</u>ou know the butchery that we went through.<u>Y</u>ou know the death that we experienced.<u>'</u> The Vietnamese who are here say, 'The Communists are not giving us any liberty, there's no freedom.' Eventually, we have to get on with our life.

\_\_\_\_One of the Vietnamese points is that's there is so much in our favor to do this, because that the economy is growing gangbusters. The most popular country there is America and Americans. So, we have to get beyond it. This is a small nudge, but I'm not sure if it should go beyond this Floor today. - Thank you."

<u>Representative Har rose and asked that the Clerk record an aye</u> vote with reservations for her on both measures, and the Chair "so ordered."

<u>Representative Ching rose and asked that the Clerk record an aye</u> vote with reservations for her on both measures, and the Chair "so ordered."

<u>Representative McKelvey rose and asked that the Clerk record an</u> aye vote with reservations for him on both measures, and the Chair "so ordered."

<u>Representative Tokioka rose and asked that the Clerk record an aye</u> vote with reservations for him on both measures, and the Chair "so ordered."

<u>Representative Finnegan rose and asked that the Clerk record an</u> aye vote with reservations for her on both measures, and the Chair "so ordered."

\_ Representative Ito rose and asked that the Clerk record a no vote for him on both measures, and the Chair "so ordered." The motion was put to vote by the Chair and carried, and the reports of the Committee were adopted and H.R. No. 249, HD 1, entitled: "HOUSE RESOLUTION ENCOURAGING THE PROLIFERATION OF DEMOCRACY, PROTECTION OF HUMAN RIGHTS AND ECONOMIC OPENNESS IN VIETNAM BY MEANS OF A SISTER-PROVINCE AFFILIATION WITH THE PROVINCE OF THUA THIEN-HUE IN VIETNAM," was referred to the Committee on Tourism & Culture with Representatives Green, Ito and Sonson, voting no, and with Representatives Hanohano, Nakasone, Nishimoto, Saiki, Takamine and Thielen being excused; and

H.C.R. No. 314, HD 1, entitled: "HOUSE CONCURRENT RESOLUTION ENCOURAGING THE PROLIFERATION OF DEMOCRACY, PROTECTION OF HUMAN RIGHTS AND ECONOMIC OPENNESS IN VIETNAM BY MEANS OF A SISTER-PROVINCE AFFILIATION WITH THE PROVINCE OF THUA THIEN-HUE IN VIETNAM," was referred to the Committee on Tourism & Culture with Representatives Green, Ito and Sonson, voting no, and with Representatives Hanohano, Nakasone, Nishimoto, Saiki, Takamine and Thielen being excused.

Representative Sonson, for the Committee on Labor & Public Employment presented two reports:

(Stand. Com. Rep. No. 1571) recommending that H.R. No. 61, be adopted; and

(Stand. Com. Rep. No. 1572) recommending that H.C.R. No. 85, be adopted.

Representative Caldwell moved that the reports of the Committee be adopted, and that H.R. No. 61 and H.C.R. No. 85, be adopted, seconded by Representative B. Oshiro.

\_\_Representative Meyer\_<u>rose to speak in opposition to both</u> measures, stating:

"Thank you, Mr. Speaker. I'm rising in opposition to these two measures. These <u>R</u>esolutions are urging the United States Congress to pass the proposed Employee Free Choice Act. That is really kind of an Orwellian' title, the Employees Free Choice Act, because this Act would deprive the employees of their freedom to freely choose without coercion whether to join a labor union.

\_\_\_\_Currently, voting on whether to join a union is done by secret ballot. No one knows how anyone votes. This card check bill would eliminate a fundamental protection of the rights of workers. In essence, union representatives would be free to strong-arm employees individually in the employer's parking lot, in bars, restaurants, in their homes, to sign a card saying the employee favored the idea of unionizing the business. And if you decline to sign, the union organizers could keep sending people to badger or threaten you over and over again in the hope that you would finally sign the card just so they would leave you alone. If you kept on refusing to sign despite this relentless pressure, the organizers would know you were opposed to the union and they could retaliate against you.

\_\_\_\_Why should a person's right in a union election be any less than during a political election?. A cornerstone of our democracy is the right to a secret ballot. This bill, so-called the Employee Free Choice Act is anything but. Even if you really care about voter privacy or preventing voter coercion, these types of bills are fundamentally unfair. They allow labor union organizers to use cross check procedures to certify a union, but they don't allow employers to use a check cross procedures to decertify existing unions.

\_\_\_\_These bills aren't about fairness or helping workers. They're about union bosses seeking to increase their power by using onesided organizing tactics to force unwilling employees into a union where they will be required to pay compulsory dues. These bills would benefit union bosses at the expense of the right to confidential ballots enjoyed by workers for over a half a century. So what is driving the push for this one-sided legislation?

\_\_\_\_\_We, here in the State Legislature, also have a number of bills calling for the same type of mechanism to organize union shops. Why? Because union membership has been dropping every year since 1979. Until\_nationally now, only 7.4% among private employers are unionized.

"This past election we saw a change in the leadership in Congress. The Majority Party is now the Democrat Party. Since 1994 it's been a Republican Party. I would say that the union bosses who helped these people mightily during the last election have come to get what they feel is their due. Get the Congress to pass this, and in that way, start to get more companies unionized. I have more to say on this, but I will do that at another time. Thank you."

\_\_Representative Takumi\_rose to speak in support of both measures, stating:

—"Thank you very much, Mr. Speaker. In support. Just a couple of points, Mr. Speaker. I'm just kind of amazed that we're talking about how union bosses, I suppose we could say union thugs, are going to intimidate workers when they seek- their constitutional right to form a union and all the rest of it.

\_\_\_Let me just first say, it did pass the U.S. House of Representatives. It is now in the U.S. Senate where it is expected to pass. The previous speaker mentioned that it is controlled by the Democrats. It did pass the U.S. House with a bipartisan vote. And the last time I looked, every single member of the Congress was elected by registered voters in their respective states, not by labor unions *per se*.\_\_That's why Democrats are now in control of the U.S. Senate and U.S. House, because that's what voters in each of those states decided. I'm not going to second guess the collective wisdom of those voters.

\_\_\_Let me get to the heart of the real point here, though. It's the same point the U.S. Labor Secretary Elaine Chao recently made when she said that a worker's right to a secret ballot election is an intrinsic right in our democracy. Sounds good. Mr. Speaker, let's take some other countries. Kazakhstan, for example, Mr. Speaker, uses a secret ballot when they choose their leaders. I wonder if any of us here would say that the nation of Kazakhstan uses the same kind of process in electing their leadership, the same kind of American standard of free and fair elections. I hope we say that the answer to that is no. Let's not confuse the symbol for the substance.

"The representation election in the American work place doesn't work as well. Yes, there is a secret ballot, but the playing field in which that secret ballot takes place is so uneven that workers are literally sliding off that playing field. Let's look at a typical union election, Mr. Speaker. Workers sign up to have a vote and then what takes place? Months, sometimes years transpire before that secret ballot election takes place. In the best of all worlds, in an idealistic situation, the employer says, 'You know, workers, you do have that right to an election and it's a hands-off situation. I'll let you alone and I'll leave you to your own devices. You're all mature adults. You're free to make up your own mind on whether or not you want an exclusive bargaining agent to represent your interest.'

\_\_\_\_Unfortunately, it doesn't happen that way. According to Cornell University scholar Ms. Kate Bronfenbrenner, management forces employees to attend group anti-union presentations, in 92% of union organizing drives. And, Mr. Speaker, in my previous life, when I was a union organizer, I can attest to the fact that management in the vast majority of cases, if not 100% of the cases, conducts these types of meetings either in a group setting or one on one. An employer will tell workers that their jobs are at stake.\_\_\_\_That the company doesn't need to put up with 'troublemakers'. Short of threatening someone's family or life, I would think threatening someone's job is intimidating, to say the least. Indeed, in 1988 and 1989, public sector employers illegally fired employees with union activities in 25% of all efforts to exercise their right to organize a union which resulted in thousands of workers getting fired on the job for merely exercising that right.

<u>"The</u> previous speaker talked about the decrease in union membership and that is true. <u>But let's not confuse the cause and the</u> effect. The reason for that is that in the majority of cases when the union loses that election, it's because of intimidation by the employer, not by the union. Some 60 million U.S. workers say they would join the union if they could, and this is based on research conducted by Peter Hart Associates in 2006. Sixty million workers in this country. But when they tried to attempt to do so, what did they face? Employer intimidation, harassment, and retaliation.

\_\_\_\_These Resolutions before us merely suggest that the Congress ought to take a look at this. And as I said, the House has already done so and I suspect the Senate will do so as well. So the workers are free to exercise their right to do what the law says. After all, Mr. Speaker, even the President of Kazakhstan doesn't have it that good. Thank you."

<u>Representative Ching rose in opposition to both measures and asked that the remarks of Representative Meyer be entered in the Journal as her own, and the Chair "so ordered." (By reference only.)</u>

The motion was put to vote by the Chair and carried, and the reports of the Committee were adopted and H.R. No. 61, entitled: "HOUSE RESOLUTION URGING THE UNITED STATES CONGRESS TO PASS THE PROPOSED EMPLOYEE FREE CHOICE ACT," was adopted with Representatives Ching and Meyer voting no, and with Representatives Hanohano, Nakasone, Nishimoto, Saiki, Takamine and Thielen being excused; and

H.C.R. No. 85, entitled: "HOUSE CONCURRENT RESOLUTION URGING THE UNITED STATES CONGRESS TO PASS THE PROPOSED EMPLOYEE FREE CHOICE ACT," was adopted with Representatives Ching and Meyer voting no, and with Representatives Hanohano, Nakasone, Nishimoto, Saiki, Takamine and Thielen being excused.

Representative Shimabukuro, for the Committee on Human Services & Housing presented two reports:

(Stand. Com. Rep. No. 1573) recommending that H.R. No. 107, be adopted; and

(Stand. Com. Rep. No. 1574) recommending that H.C.R. No. 133, be adopted.

Representative Caldwell moved that the reports of the Committee be adopted, and that H.R. No. 107 and H.C.R. No. 133, be adopted, seconded by Representative B. Oshiro.

\_\_Representative Lee rose to speak in support of both measures, stating:

"On Stand. Com. Rep. Nos., 1573 and 1574 I rise in support and I would like to insert written comments. I'd just like to say that because we may not see this again, that this is a very important issue. I've stood on this Floor many times and given speeches about the importance of breastfeeding, but this is a Resolution which gives support to another Legislature to pass a Breastfeeding Bill of Rights, and I hope someday that we can pass one in Hawaii. Thank you."

# Representative Lee's written remarks are as follows:

Mr. Speaker, I am in support of these measures. Mr. Speaker, studies have shown that breastfed infants are healthier than bottle-fed babies. We also know that it is cheaper to breastfeed than it is to buy formula. In fact, a United States Department of Agriculture analysis estimates that at least \$3,600,000,000 could be saved nationally if only fifty per cent of mothers breastfed their infants until they were

at least six months old. Furthermore, women who receive appropriate, culturally sensitive information and support about breastfeeding during and immediately following their childbirth delivery are eight times more likely to continue breastfeeding for at least six weeks compared to women who received little or no post delivery support about breastfeeding.

"It is therefore important for information about breastfeeding to be available to women. This resolution supports Senate Bill No. 1674 and Assembly Bill No. 3782 of the New York State Legislature, which proposes to codify every woman's right to be informed about the benefits of breastfeeding and to have an environment that is conducive to what all pediatricians agree to be the safest and healthiest choice for newborn and infant feeding. These bills propose adoption of a statement of rights, known as the breastfeeding mothers' bill of rights, to: provide mothers with basic breastfeedingrelated rights before, during and after the birth of their baby; require that the statement of rights be conspicuously posted in a public place in maternal health care facilities, nurseries, maternity floors, and post-delivery recovery rooms; and require assistance from lactation specialists in the hospital and after discharge.

"This is an important statement and I urge my colleagues to support these Resolutions. Thank you."

The motion was put to vote by the Chair and carried, and the reports of the Committee were adopted and H.R. No. 107, entitled: "HOUSE RESOLUTION SUPPORTING THE BREASTFEEDING MOTHERS' BILL OF RIGHTS OFFERED AS SENATE BILL NO. 1674 AND ASSEMBLY BILL NO. 3782 IN THE NEW YORK STATE LEGISLATURE," was adopted, with Representatives Hanohano, Nakasone, Nishimoto, Saiki, Takamine and Thielen being excused; and

H.C.R. No. 133, entitled: "HOUSE CONCURRENT RESOLUTION SUPPORTING THE BREASTFEEDING MOTHERS' BILL OF RIGHTS OFFERED AS SENATE BILL NO. 1674 AND ASSEMBLY BILL NO. 3782 IN THE NEW YORK STATE LEGISLATURE," was adopted, with Representatives Hanohano, Nakasone, Nishimoto, Saiki, Takamine and Thielen being excused.

Representative Shimabukuro, for the Committee on Human Services & Housing presented a report (Stand. Com. Rep. No. 1575) recommending that H.R. No. 113, as amended in HD 1, be adopted.
